The letter $\mathbb{K}$ usually denotes either the real field $\mathbb{R}$ or the complex field $\mathbb{C}$. The positive real numbers are denoted by $\mathbb{R}_{+}:=(0, \infty)$

## Chapter 1

## Banach spaces

### 1.1 Metric spaces

We repeat the definition of a metric space.
Definition 1.1. A metric space $(M, d)$ is a non-empty set $M$ together with a map

$$
d: M \times M \rightarrow \mathbb{R}
$$

such that for all $x, y, z \in M$ :
(i) $d(x, y)=0 \Longleftrightarrow x=y$
(ii) $d(x, y)=d(y, x)$
(iii) $d(x, y) \leq d(x, z)+d(z, y)$.

The last inequality is called triangle inequality. Usually the metric space $(M, d)$ is denoted simply by $M$.

Note that the triangle inequality together with the symmetry of $d$ implies

$$
d(x, y) \geq 0, \quad x, y \in M
$$

since $0=d(x, x) \leq d(x, y)+d(y, x)=2 d(x, y)$.
It is easy to check that

$$
|d(x, y)-d(y, z)| \leq d(x, z), \quad x, y, z \in M .
$$

A subset $N \subset M$ is called bounded if

$$
\operatorname{diam} N:=\sup \{d(x, y): x, y \in N\}<\infty .
$$

Let $r>0$ and $x \in M$. Then
$B_{r}(x):=\{y \in M: d(x, y)<r\}=$ : open ball with centre $x$ and radius $r$,
$K_{r}(x):=\{y \in M: d(x, y) \leq r\}=:$ closed ball with centre $x$ and radius $r$,
$S_{r}(x):=\{y \in M: d(x, y)=r\}=:$ sphere with centre $x$ and radius $r$.
Examples. - $\mathbb{R}$ with the $d(x, y)=|x-y|$ is a metric space.

- Let $X$ be a set and define $d: X \times X \rightarrow \mathbb{R}$ by $d(x, y)=0$ for $x=y$ and $d(x, y)=1$ for $x \neq y$. Then $(X, d)$ is a metric space. $d$ is called the discrete metric on $X$.

Let $(M, d)$ be a metric space. Recall that the metric $d$ induces a topology on $M$ a set $U \subseteq M$ is open if and only if for every $p \in U$ there exists an $\varepsilon>0$ such that $B_{\varepsilon}(p) \subseteq U$. In particular, the open balls are open and closed balls are closed subsets of $M$. Let $x \in M$. A subset $U \subseteq M$ is called a neighbourhood of $x$ if ther exists an open set $U_{x}$ such that $x \in U_{x} \subseteq U$.
It is easy to see that the topology generated by $d$ has the Hausdorff property, that is, for every $x \neq y \in M$ there exist neighbourhoods $U_{x}$ of $x$ and $U_{y}$ of $y$ with $U_{x} \cap U_{y}=\emptyset$.
Recall that a set $N \subseteq M$ is called dense in $M$ if $\bar{N}=M$, where $\bar{N}$ denotes the closure of $N$.

Definition 1.2. A sequence $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq M$ converges to $x \in M$ if and only if $\lim _{n \rightarrow \infty} d\left(x_{n}, x\right)=0$, that is,

$$
\forall \varepsilon>0 \quad \exists N \in \mathbb{N}: \quad n \geq N \Longrightarrow d\left(x_{n}, x\right)<\varepsilon
$$

The limit $x$ is unique. A sequence $\left(x_{n}\right)_{n \in \mathbb{N}}$ is a Cauchy sequence in $M$ if and only
if if

$$
\forall \varepsilon>0 \quad \exists N \in \mathbb{N}: \quad m, n \geq N \Longrightarrow d\left(x_{n}, x_{m}\right)<\varepsilon
$$

Definition 1.3. A metric space in which every Cauchy sequence is convergent, is called a complete metric space.

Definition 1.4. Let ( $X, \mathcal{O}_{X}$ ) and ( $Y, \mathcal{O}_{Y}$ ) be topological spaces.
(i) A function $f: X \rightarrow Y$ is called continuous if and only if $f^{-1}(U)$ is open in $X$ for every $U$ open in $Y$.
(ii) An bijective function $f: X \rightarrow Y$ is called a homeomorphism if and only if $f$ and $f^{-1}$ are contiunous.
The following lemma is often useful.
Lemma 1.5. Let $(M, d)$ be a complete metric space and $N \subseteq M$. Then $N$ is closed in $M$ if and only if $\left(N,\left.d\right|_{M}\right)$ is complete.

## Remarks. - Every convergent sequence is a Cauchy sequence.

- Every Cauchy sequence is bounded. Recall that a sequence $\left(x_{n}\right)_{n \in \mathbb{N}}$ is bounded if the set $\left\{x_{n}: n \in \mathbb{N}\right\}$ is bounded.

Not every metric space is complete, but every metric space can be completed in the following sense.
Definition 1.6. Let $\left(M, d_{M}\right)$ and $\left(N, d_{N}\right)$ be metric spaces. A map $f: M \rightarrow N$ is called an isometry if and only if $d_{N}(f(x), f(y))=d_{M}(x, y)$ for all $x, y \in M$. The spaces $M$ and $N$ are called isometric if there exists a bijective isometry $f: M \rightarrow N$
Note that an isometry is necessarily injective since $x \neq y$ implies $f(x) \neq f(y)$ because $d(f(x), f(y))=d(x, y) \neq 0$, and that every isometry is continuous.
Theorem 1.7. Let $(M, d)$ be a metric space. Then there exists a complete metric space $(\widehat{M}, \widehat{d})$ and an isometry $\varphi: M \rightarrow \widehat{M}$ such that $\overline{\varphi(M)}=\widehat{M} . \widehat{M}$ is called completion of $M$; it is unique up to isometry.

## Proof. Let

$$
\mathcal{C}_{M}:=\left\{\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq M:\left(x_{n}\right)_{n \in \mathbb{N}} \text { is a Cauchy sequence in } M\right\}
$$

be the set of all Cauchy sequences in $M$. We define the equivalence relation $\sim$ on $\mathcal{C}_{M}$ by

$$
x \sim y \quad \Longleftrightarrow \quad d\left(x_{n}, y_{n}\right) \rightarrow 0, n \rightarrow \infty
$$

for all $x=\left(x_{n}\right)_{n \in \mathbb{N}}, y=\left(y_{n}\right)_{n \in \mathbb{N}} \in \mathcal{C}_{M}$. It is easy to check that $\sim$ is indeed a equivalence relation (reflexivity and symmetry follow directly from properties (i) and (ii) of the definition of a metric and transitivity of $\sim$ is a consequence of the triangle inequality).
Let $\widehat{M}:=\mathcal{C}_{M} / \sim$ the set of all equivalence classes. The equivalence class containing $x=\left(x_{n}\right)_{n \in \mathbb{N}}$ is denoted by $[x]$. On $\widehat{M}$ we define

$$
\begin{equation*}
\widehat{d}: \widehat{M} \times \widehat{M} \rightarrow \mathbb{R}, \quad \widehat{d}([x],[y])=\lim _{n \rightarrow \infty} d\left(x_{n}, y_{n}\right) \tag{1.1}
\end{equation*}
$$

We have to show that $\widehat{d}$ is well-defined.
Let $\left(x_{n}\right)_{n \in \mathbb{N}} \in[x]$ and $\left(y_{n}\right)_{n \in \mathbb{N}} \in[y]$. Then

$$
\left|d\left(x_{n}, y_{n}\right)-d\left(x_{m}, y_{m}\right)\right| \leq\left|d\left(x_{n}, y_{n}\right)-d\left(x_{m}, y_{n}\right)\right|+\left|d\left(x_{m}, y_{n}\right)-d\left(x_{m}, y_{m}\right)\right|
$$

$$
\leq d\left(x_{n}, x_{m}\right)+d\left(y_{n}, y_{m}\right) \rightarrow 0, \quad m, n \rightarrow \infty
$$

Since $\left(d\left(x_{n}, y_{n}\right)\right)_{n \in \mathbb{N}}$ is a Cauchy sequence in the complete space $\mathbb{R}$, the limit in (1.1) exists.

Moreover, for $\left(\tilde{x}_{n}\right)_{n \in \mathbb{N}} \in[x]$ and $\left(\tilde{y}_{n}\right)_{n \in \mathbb{N}} \in[y]$ it follows that

$$
\begin{aligned}
\left|d\left(x_{n}, y_{n}\right)-d\left(\tilde{x}_{n}, \tilde{y}_{n}\right)\right| & \leq\left|d\left(x_{n}, y_{n}\right)-d\left(\tilde{x}_{n}, y_{n}\right)\right|+\left|d\left(\tilde{x}_{n}, y_{n}\right)-d\left(\tilde{x}_{n}, \tilde{y}_{n}\right)\right| \\
& \leq d\left(x_{n}, \tilde{x}_{n}\right)+d\left(y_{n}, \tilde{y}_{n}\right) \rightarrow 0, \quad n \rightarrow \infty .
\end{aligned}
$$

Hence $\widehat{d}$ is well-defined.
Let

$$
\varphi: M \rightarrow \widehat{M}, \quad \varphi(x)=\left[(x)_{n \in \mathbb{N}}\right]
$$

We will show that $(\widehat{M}, \widehat{d})$ is a complete metric space, that $\varphi$ is an isometry and that $\overline{\varphi(M)}=\widehat{M}$ in several steps.
Step 1: $(\widehat{M}, \widehat{d})$ is a metric space.
Proof. Let $[x],[y],[z] \in \widehat{M}$. Then

- $0=\widehat{d}([x],[y])=\lim _{n \rightarrow \infty} d\left(x_{n}, y_{n}\right) \quad \Longleftrightarrow \quad x \sim y \quad \Longleftrightarrow \quad[x]=[y]$.
- $\widehat{d}([x],[y])=\lim _{n \rightarrow \infty} d\left(x_{n}, y_{n}\right)=\lim _{n \rightarrow \infty} d\left(y_{n}, x_{n}\right)=\widehat{d}([y],[x])$.
- $\widehat{d}([x],[y])=\lim _{n \rightarrow \infty} d\left(x_{n}, y_{n}\right) \leq \lim _{n \rightarrow \infty} d\left(x_{n}, z_{n}\right)+d\left(z_{n}, y_{n}\right)=\widehat{d}([x],[z])+\widehat{d}([z],[y])$.

Step 2: $\varphi$ is an isometry.
Proof. This follows immediately from the definition.
Step 3: $\overline{\varphi(M)}=\widehat{M}$.
Proof. Let $\left(x_{n}\right)_{n \in \mathbb{N}} \in[x] \in \widehat{M}$ and $\varepsilon>0$. Then there exists an $N \in \mathbb{N}$ such that $d\left(x_{n}, x_{m}\right)<\frac{\varepsilon}{2}, m, n \geq N$. Let $z:=x_{N} \in M$. Then

$$
\widehat{d}(\varphi(z),[x])=\lim _{n \rightarrow \infty} d\left(x_{N}, x_{n}\right) \leq \frac{\varepsilon}{2}<\varepsilon .
$$

Next we show that $(\widehat{M}, \widehat{d})$ is complete. Let $\left(\hat{x}_{n}\right)_{n \in \mathbb{N}}$ be a Cauchy sequence in $\widehat{M}$. Since $\varphi(M)$ is dense in $\widehat{M}$ there exists a sequence $z=\left(z_{n}\right)_{n \in \mathbb{N}} \subseteq M$ such that

$$
\widehat{d}\left(\widehat{x}_{n}, z_{n}\right)<\frac{1}{n}, \quad n \in \mathbb{N} .
$$

The sequence $z$ is a Cauchy sequence in $M$ because

$$
\begin{aligned}
d\left(z_{n}, z_{m}\right)=\widehat{d}\left(\varphi\left(z_{n}\right), \varphi\left(z_{m}\right)\right) & \leq \widehat{d}\left(\varphi\left(z_{n}\right), \hat{x}_{n}\right)+\widehat{d}\left(\hat{x}_{n}, \hat{x}_{m}\right)+\widehat{d}\left(\hat{x}_{m}, \varphi\left(z_{m}\right)\right) \\
& <\frac{1}{n}+\widehat{d}\left(\hat{x}_{n}, \hat{x}_{m}\right)+\frac{1}{m} \rightarrow 0, \quad m, n \rightarrow \infty .
\end{aligned}
$$

The sequence $\left(\hat{x}_{n}\right)_{n \in \mathbb{N}}$ converges to $[z]$ because

$$
\widehat{d}\left(\hat{x}_{n}, z\right) \leq \widehat{d}\left(\hat{x}_{n}, \varphi\left(z_{n}\right)\right)+\widehat{d}\left(\varphi\left(z_{n}\right), z\right)<\frac{1}{n}+\lim _{m \rightarrow \infty} d\left(z_{n}, z_{m}\right) \rightarrow 0, \quad n \rightarrow \infty .
$$

We have shown that $\varphi(M)$ is a dense subset of the complete metric space ( $\widehat{M}, \widehat{d}$ ) and that $\varphi$ is an isometry.
$d_{N}$ ) be
Finally, we have to show that $\widehat{M}$ is unique (up to isometry). Let ( $N, d_{N}$ ) be complete metric space and $\psi: M \rightarrow N$ an isometry such that $\overline{\psi(M)}=N$. Then the map

$$
T: \varphi(M) \rightarrow \psi(M), \quad T(\varphi(x))=\psi(x)
$$

can be extended to a surjective isometry $\bar{T}: \overline{\varphi(M)}=\widehat{M} \rightarrow N$ by

$$
\bar{T} x=\bar{T}\left(\lim _{n \rightarrow \infty} x_{n}\right):=\lim _{n \rightarrow \infty} T x_{n}
$$

for $x=\lim _{n \rightarrow \infty} x_{n}$ with $x_{n} \in \varphi(M), n \in \mathbb{N}$.
Examples. - $\mathbb{C}^{n}$ with $d(x, y)=\max \left\{\left|x_{j}-y_{j}\right|: j=1, \ldots, n\right\}$ is a complete metric space.

- $\mathbb{C}^{n}$ with $d(x, y)=\sqrt{\left|x_{1}-y_{1}\right|^{2}+\cdots+\left|x_{n}-y_{n}\right|^{2}}$ is a complete metric space.
- Let $C([a, b])$ be the set of all continuous functions on the interval $[a, b]$. For $f, g \in C([a, b])$ let

$$
\begin{aligned}
& d_{1}(f, g):=\max \{|f(x)-g(x)|: x \in[a, b]\}, \\
& d_{2}(f, g):=\int_{a}^{b}|f(x)-g(x)| \mathrm{d} x .
\end{aligned}
$$

Then $d_{1}$ and $d_{2}$ are metrics on $C([a, b]) .\left(C([a, b]), d_{1}\right)$ is complete, $\left(C([a, b]), d_{2}\right)$ is not complete.

Remark. The completion of $\left(C([a, b]), d_{2}\right)$ is $L_{1}(a, b)$ (the set of all Lebesgue integrable functions on ( $a, b$ )).
Definition 1.8. A metric space is called separable if it contains a countable dense subset.

Proposition 1.9. Let $(M, d)$ be a separable metric space and $N \subseteq M$. Then $N$ is separable.

Proof. We have to show that there exists a countable set $B \subseteq N$ such that $\bar{B} \supseteq N$ where the closure is taken with respect to the metric on $M$. By assumption on $M$ there exists a countable set $A:=\left\{x_{n}: n \in \mathbb{N}\right\} \subseteq M$ such that $\bar{A}=M$. Let $J:=\left\{(n, m) \in \mathbb{N} \times \mathbb{N}: \exists y \in N\right.$ with $\left.d\left(x_{n}, y\right)<\frac{1}{m}\right\}$. For every $(n, m) \in J$ choose a $y_{n, m} \in N$ and define $B:=\left\{y_{n, m}:(n, m) \in J\right\}$. Obviously, $B$ is a countable subset of $N$. To show that $B$ is dense in $N$ it suffices to show that for every $y \in N$ and $k \in \mathbb{N}$ there exists a $b \in B$ such that $d(b, y)<\frac{1}{k}$. By definition of $A$ there exists a $x_{n} \in A$ such that $d\left(x_{n}, y\right)<\frac{1}{2 k}$. In particular, $(n, 2 k) \in J$. It follows that $d\left(y_{n, 2 k}, y\right) \leq d\left(y_{n, 2 k}, x_{n}\right)+d\left(x_{n}, y\right)<\frac{1}{k}$.

### 1.2 Normed spaces

Definition 1.10. Let $X$ be a vector space over $\mathbb{K}$. A norm on $X$ is a map

$$
\|\cdot\|: X \rightarrow \mathbb{R}
$$

such that for all $x, y \in X, \alpha \in \mathbb{K}$
(i) $\|x\|=0 \quad \Longleftrightarrow \quad x=0$,
(ii) $\|\alpha x\|=|\alpha|\|x\|$,
(iii) $\|x+y\| \leq\|x\|+\|y\|$.

Remarks. - Note that the implication $\Leftarrow$ in (i) follows from (ii) because $\|0\|=$ $\|2 \cdot 0\|=2\|0\|$.

- Note that $\|x\| \geq 0$ for all $x \in X$ because $0=\|x-x\| \leq 2\|x\|$. The last inequality follows from the triangle inequality (iii) and (ii) with $\alpha=-1$.

Remark. A function [•]: $X \rightarrow \mathbb{R}$ which satisfies only (ii) and (iii) of Definition 1.10 is called a seminorm. As seen in the remark above for norms, a seminorm is nonnegative and satisfies $[0]=0$.

Remark. A norm on $X$ induces a metric on $X$ by setting

$$
d(x, y):=\|x-y\|, \quad x, y \in X .
$$

Hence a norm induces a topology on $X$ via the metric and we have the concept of convergence etc. on a normed space.

Definition 1.11. A complete normed space is called a Banach space.
Obviously, every subspace of a normed space is a normed space by restriction of the orm. A subspace of a Banach space is a Banach space if and only if it is closed

Proposition 1.12. Let $X$ be a normed space. Then the following is equivalent:
(i) $X$ is complete.
(ii) Every absolutely convergent series in $X$ converges in $X$.

Proof. Exercise 1.2.
Example 1.13 (Quotient space). Let $X$ be a Banach space and $M \subseteq X$ a closed subspace. On $X$ we have the equivalence relation

$$
x \sim y \quad \Longleftrightarrow \quad x-y \in M .
$$

For $x \in X$ we denote the equivalence class of $X / M$ containing $x$ by $[x]$. Then $X / M$ is a vector space if we set

$$
[x]+[y]:=[x+y], \quad \alpha[x]:=[\alpha x], \quad x, y \in X, \alpha \in \mathbb{K} .
$$

For $x \in X$ let $\operatorname{dist}(x, M):=\inf \{\|x-m\|: m \in M\}$.

- $(X / M,\|\cdot\| \sim)$ is a normed space with

$$
\|\cdot\|_{\sim}: X / M \rightarrow \mathbb{R}, \quad\|[x]\|_{\sim}:=\operatorname{dist}(x, M) .
$$

Proof. First we show that $\|\cdot\|_{\sim}$ is well-defined. For $x, y \in X$ with $x-y \in M$ we find

$$
\begin{aligned}
\operatorname{dist}(x, M) & =\inf \{\|x-m\|: m \in M\}=\inf \{\|y-(\overbrace{y-x}^{\in M}+m)\|: m \in M\} \\
& =\inf \{\|y-m\|: m \in M\}=\operatorname{dist}(y, M) .
\end{aligned}
$$

Property (ii) in the definition of a norm is easily checked. For property (iii) let $[x],[y] \in X / M$. Then
$\|[x]+[y]\|_{\sim}=\|[x+y]\|_{\sim}=\inf \{\|x+y-m\|: m \in M\}$

$$
\begin{aligned}
& =\inf \left\{\left\|x-m_{x}+y-m_{y}\right\|: m_{x}, m_{y} \in M\right\} \\
& \leq \inf \left\{\left\|x-m_{x}\right\|: m_{x} \in M\right\}+\inf \left\{\left\|y-m_{y}\right\|: m_{y} \in M\right\} \\
& =\|[x]\| \sim+\|[y]\| \sim .
\end{aligned}
$$

It is clear that $[x]=0$ implies $\|[x]\| \sim=0$. Now assume that $\|[x]\|_{\sim}=0$ We have to show that $x \in M$. By definition of dist there exists a sequenc $\left(m_{n}\right)_{n \in \mathbb{N}}$ such that $\left\|x-m_{n}\right\| \rightarrow 0$, that is, $\left(m_{n}\right)_{n \in \mathbb{N}}$ converges to $x$. Since $M$ is closed, it follows that $x \in M$.

- Let $X$ be a Banach space and $M$ a closed subspace. Then $X / M$ is Banach space with the norm defined in Example 1.13.

Proof. We already saw that $X / M$ is normed space. It remains to prove completeness. Let $\left(\left[x_{n}\right]\right)_{n \in \mathbb{N}}$ be a Cauchy sequence.
First we show that we can assume $\left\|\left[x_{n}\right]-\left[x_{m}\right]\right\| \sim \leq 2^{-n}$ for all $m \geq n$ : Choose $N_{1} \in \mathbb{N}$ such that $\left\|\left[x_{N_{1}}\right]-\left[x_{m}\right]\right\| \sim<2^{-1}$ for all $m \geq N_{1}$. Next choose $N_{2}>N_{1}$ $N_{1} \in \mathbb{N}$ such that $\left.\| x_{N_{1}}\right]-x_{m}\| \| \sim 2^{-1}$ for all $m \geq N_{1}$. Next choose $N_{2}>N_{1}$
such that $\left\|\left[x_{N_{2}}\right]-\left[x_{m}\right]\right\| \sim \leq 2^{-2}$ for all $m \geq N_{2}$. Continuing this process,
 converges if and only if it contains a convergent subsequence, it suffices to prove convergence of the subsequence constructed above prove convergence of the subsequence constructed above.
By dut $x_{n+1} \mid \sim+$
all $n>m$

$$
\left\|x_{n}-x_{m}\right\|=\left\|\sum_{j=m}^{n-1} x_{n+1}-x_{n}\right\| \leq \sum_{j=m}^{n-1}\left\|x_{n+1}-x_{n}\right\|<2 \sum_{j=m}^{n-1} 2^{-j} .
$$

Therefore $x:=\lim _{n \rightarrow \infty} x_{n}$ exists and

$$
\left\|\left[x_{n}\right]-[x]\right\|_{\sim}=\left\|\left[x_{n}-x\right]\right\|_{\sim} \leq\left\|x_{n}-x\right\| \rightarrow 0, \quad n \rightarrow \infty
$$

Remark 1.14. (i) In the proof above we used that, by definition of $\|\cdot\|_{\sim}$, fo every $x \in X$ and every $\varepsilon>0$ there exists an $\tilde{x} \in[x]$ such that $\|\tilde{x}\|<\|[x]\|_{\sim}+\varepsilon$. Equivalently, there exists an $m \in M$ such that $\|x+m\|<\|[x]\| \sim+\varepsilon$.
(ii) Obviously, $\|x\| \geq\|[x]\|_{\sim}$ for every $x \in X$.

Examples 1.15. (i) Finite dimensional normed spaces. $\mathbb{C}^{n}$ and $\mathbb{R}^{n}$ are complete normed spaces with

$$
\|\cdot\|_{\infty}: \mathbb{K}^{n} \rightarrow \mathbb{R}, \quad\|x\|_{\infty}=\max \left\{\left|x_{j}\right|: j=1, \ldots, n\right\}
$$

Let $1 \leq p<\infty$. Then $\mathbb{C}^{n}$ and $\mathbb{R}^{n}$ are complete normed spaces with

$$
\|\cdot\|_{p}: \mathbb{C}^{n} \rightarrow \mathbb{R}, \quad\|x\|_{p}=\left(\sum_{j=1}^{n}\left|x_{j}\right|^{p}\right)^{\frac{1}{p}}
$$

The triangle inequality $\|x+y\|_{p} \leq\|x\|_{p}+\|y\|_{p}$ is called the Minkowski inequality (see Section 1.3).
(ii) Let $T$ be a set and define

$$
\ell_{\infty}(T):=\{x: T \rightarrow \mathbb{K} \text { bounded map }\} .
$$

Obviously, $\ell_{\infty}(T)$ is a vector space. Let

$$
\|x\|_{\infty}:=\sup \{|x(t)|: t \in T\}, \quad x \in \ell_{\infty}
$$

be the supremum norm. Then $\left(\ell_{\infty}(T),\|\cdot\|_{\infty}\right)$ is a Banach space.
Proof. Exercise 1.4.
$\square$
(iii) Sequence spaces.

- $\ell_{\infty}:=\ell_{\infty}(\mathbb{N})$ is a Banach space.
- For $1 \leq p<\infty$ let

$$
\ell_{p}:=\ell_{p}(\mathbb{N}):=\left\{\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq \mathbb{K}: \sum_{n=1}^{\infty}\left|x_{n}\right|^{p}<\infty\right\}
$$

and

$$
\|x\|_{p}:=\left(\sum_{n=1}^{\infty}\left|x_{n}\right|^{p}\right)^{\frac{1}{p}}, \quad x \in \ell_{p}
$$

With the usual component-by-component addition and multiplication with a scalar, $\ell_{p}$ is a vector space and $\left(\ell_{p},\|\cdot\|_{p}\right)$ is a Banach space.
Proof. First we show that $\ell_{p}$ is a vector space. For $\alpha \in \mathbb{K}$ and $x, y \in \ell_{p}$ we have

$$
\sum_{n=1}^{\infty}\left|\alpha x_{n}\right|^{p}=|\alpha|^{p} \sum_{n=1}^{\infty}\left|x_{n}\right|^{p}<\infty
$$

and

$$
\begin{aligned}
\sum_{n=1}^{\infty}\left|x_{n}+y_{n}\right|^{p} & \leq \sum_{n=1}^{\infty}\left(2 \max \left\{\left|x_{n}\right|,\left|y_{n}\right|\right\}\right)^{p}=2^{p} \sum_{n=1}^{\infty}\left(\max \left\{\left|x_{n}\right|,\left|y_{n}\right|\right\}\right)^{p} \\
& \leq 2^{p} \sum_{n=1}^{\infty}\left|x_{n}\right|^{p}+\left|y_{n}\right|^{p}=2^{p}\left(\|x\|_{p}^{p}+\|y\|_{p}^{p}\right)<\infty .
\end{aligned}
$$

Hence $\ell_{p}$ is a $\mathbb{K}$-vector space. Properties (i) and (ii) in the definition of a norm are easily verified. The triangle inequality is the Minkowski inequality (see Section 1.3).
To show that $\left(\ell_{p},\|\cdot\|_{p}\right)$ is complete, let $\left(x_{n}\right)_{n \in \mathbb{N}}$ be a Cauchy sequence in $\ell_{p}$. Set $x_{n}=\left(x_{n, m}\right)_{m \in \mathbb{N}}$. Then the sequence of the $m$-th components is a Cauchy sequence in $\mathbb{K}$ because

$$
\left|x_{n, m}-x_{k, m}\right|<\left\|x_{n}-x_{k}\right\|_{p}, \quad m \in \mathbb{N} .
$$

Since $\mathbb{K}$ is complete, the limit $y_{m}:=\lim _{n \rightarrow \infty} x_{n, m}$ exists. Let $y:=\left(y_{m}\right)_{m \in \mathbb{N}}$. We will show that $y \in \ell_{p}$ and that $x_{n} \xrightarrow{\|\cdot\|_{p}} y$. Let $\varepsilon>0$ and $N \in \mathbb{N}$ such that $\left\|x_{n}-x_{k}\right\|<\varepsilon$ for all $k, n \geq N$. For every $M \in \mathbb{N}$

$$
\sum_{j=1}^{M}\left|x_{n, j}-x_{k, j}\right|^{p} \leq\left\|x_{n}-x_{k}\right\|_{p}^{p}<\varepsilon^{p} .
$$

Taking the limit $k \rightarrow \infty$ on the left hand side yields

$$
\sum_{j=1}^{M}\left|x_{n, j}-y_{j}\right|^{p}<\varepsilon^{p}
$$

Taking the limit $M \rightarrow \infty$ on the left hand side finally gives

$$
\sum_{j=1}^{\infty}\left|x_{n, j}-y_{j}\right|^{p} \leq \varepsilon^{p}<\infty,
$$

in particular, $x_{n}-y \in \ell_{p}$. Since $\ell_{p}$ is a vector space, we obtain $y=x_{n}+(y-$ $\left.x_{n}\right) \in \ell_{p}$ and $\left\|x_{n}-y\right\|_{p} \leq \varepsilon$. That $\left(x_{n}\right)_{n \in \mathbb{N}}$ converges to $y$ follows from the inequality above since $\varepsilon$ can be chosen arbitrarily
(iv) $\mathscr{L}_{p}$ spaces: See measure theory.
(v) Subspaces of $\ell_{\infty}$. Let

$$
\begin{aligned}
d & :=\left\{x=\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq \mathbb{K}: x_{n} \neq 0 \text { for at most finitely many } n\right\}, \\
c_{0} & :=\left\{x=\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq \mathbb{K}: \lim _{n \rightarrow \infty} x_{n}=0\right\}, \\
c & :=\left\{x=\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq \mathbb{K}: \lim _{n \rightarrow \infty} x_{n} \text { exists }\right\},
\end{aligned}
$$

Obviously, the inclusions $d \subsetneq c_{0} \subsetneq c \subsetneq \ell_{\infty}$ hold. Moreover, it can be shown that $c_{0}$ and $c$ are closed subspaces of $\ell_{\infty}$ and that $d$ is a non-closed subspace of $\ell_{\infty}$. In particular, $\left(c_{0},\|\cdot\|_{\infty}\right)$ and $\left(c,\|\cdot\|_{\infty}\right)$ are Banach spaces, $\left(d,\|\cdot\|_{\infty}\right)$ is not a Banach space (see Exercise 1.5).
(vi) Spaces of continuous functions. For metric space $T$ (e.g. an interval in $\mathbb{R}$ ) let
$C(T):=\{f: T \rightarrow \mathbb{K}: f$ is continuous $\}$,
$B(T):=\{f: T \rightarrow \mathbb{K}: f$ is bounded $\}$,
$B C(T):=C(T) \cap B(T)$.
For $f \in B(T)$ let

$$
\|f\|_{\infty}:=\sup \{|f(t)|: t \in T\}
$$

In Analysis 1 it was shown that $\left(B(T),\|\cdot\|_{\infty}\right)$ and $\left(B C(T),\|\cdot\|_{\infty}\right)$ are Banach spaces. Note that $C(T)=B C(T)$ for a compact metric space $T$.
(vii) Spaces of differentiable functions. Let $[a, b]$ a real interval. We can define several norms on the vector space

$$
C^{1}([a, b]):=\{f:[a, b] \rightarrow \mathbb{K}: f \text { is continuously differentiable }\} .
$$

- $\left(C^{1}([a, b]),\|\cdot\|_{\infty}\right)$ is not a Banach space.

Proof. For $n \in \mathbb{N}$ let $f_{n}:[-1,1] \rightarrow \mathbb{K}, f_{n}(t):=\left(t^{2}+n^{-2}\right)^{\frac{1}{2}}$. Then the $f_{n}$ converge to $g:[-1,1] \rightarrow \mathbb{K}, g(t)=|t|$ in the $\|\cdot\|_{\infty}$-norm. But $g \notin C^{1}([a, b])$ Hence $C^{1}([a, b])$ is not closed as a subspace of the Banach space $C([a, b])$, so it is not a Banach space.

- For $f \in C^{1}([a, b])$ let

$$
\|f\|_{(1)}:=\|f\|_{\infty}+\left\|f^{\prime}\right\|_{\infty} .
$$

Then $\left(C^{1}([a, b]),\|\cdot\|_{(1)}\right)$ is a Banach space. Note that the right hand side is finite because by assumption $f^{\prime}$ is continuous.

Proof. Let $\left(x_{n}\right)_{n \in \mathbb{N}}$ be a Cauchy sequence in $\left(C^{1}([a, b]),\|\cdot\|_{(1)}\right)$. Then there exist $x, y \in C([a, b])$ such that $x_{n} \rightarrow x$ and $x_{n}^{\prime} \rightarrow y$ in the supremum norm. A well-known theorem in analysis implies $x^{\prime}=y$, hence $x_{n} \rightarrow x$ in $\|\cdot\|_{(1)}$. $\quad \square$

In the following, $C^{1}([a, b])$ will always be considered to be equipped with the norm $\|\cdot\|_{(1)}$ unless stated otherwise.

Theorem 1.16. Let $X$ be a Banach space, $Y$ a closed subspace and $N$ a finite dimensional subspace of $X$. Then $Y+N$ is a closed subspace. In particular, every finite-dimensional subspace is closed.
Proof. Obviously, $Y+N$ is a subspace of $X$. To proof that it is closed, we proceed by induction. Therefore we can assume without restriction that $\operatorname{dim} N=1$. Let $z \in X$ such that $N=\{\lambda z: \lambda \in \mathbb{K}\}$ and $\left(x_{n}\right)_{n \in \mathbb{N}}=\left(y_{n}+a_{n} z\right)_{n \in \mathbb{N}}$ a Cauchy sequence in $Y+N$.
$C$ ase 1. $\left(a_{n}\right)_{n \in \mathbb{N}}$ is bounded. Then it contains a convergent subsequence $\left(a_{n_{k}}\right)_{k \in \mathbb{N}}$ Then the sequence $\left(y_{n_{k}}\right)_{k \in \mathbb{N}}=\left(x_{n_{k}}-a_{n_{k}} z\right)_{k \in \mathbb{N}}$ converges because it is the sum of two convergent sequences.
Case 2. $\left(a_{n}\right)_{n \in \mathbb{N}}$ is unbounded. Then there exists a subsequence $\left(a_{n_{k}}\right)_{k \in \mathbb{N}}$ with $\lim \left|a_{n_{k}}\right|=\infty$. Since $\left(x_{n_{k}}\right)_{k \in \mathbb{N}}$ is bounded, it follows that

$$
\left\|z+\frac{1}{a_{n_{k}}} y_{n_{k}}\right\|=\left\|\frac{1}{a_{n_{k}}} x_{n_{k}}\right\| \rightarrow 0, \quad n \rightarrow \infty .
$$

Hence $d(z, Y)=0$. Since $Y$ is closed, this implies $z \in Y$, therefore $N+Y=Y$ is closed in $X$.
Finally, choosing $Y=\{0\}$ shows that every finite-dimensional subspace is closed.
Note that the sum of two closed subspaces is not necessarily closed, see as the following example shows. Another example can be found in [Hal98, §15].
Example. In $\ell_{1}$ consider the subspaces

$$
\begin{aligned}
& U:=\left\{\left(x_{n}\right)_{n \in \mathbb{N}} \in \ell_{1}: x_{2 n}=0, n \in \mathbb{N}\right\} \\
& V:=\left\{\left(x_{n}\right)_{n \in \mathbb{N}} \in \ell_{1}: x_{2 n-1}=n x_{2 n}, n \in \mathbb{N}\right\} .
\end{aligned}
$$

Obvioulsy, $U$ and $V$ are closed subspaces of $\ell_{1}$. Let $\mathrm{e}_{n}$ be the $n$th unit vector in $\ell_{1}$. Let $m \in \mathbb{N}$. Then $\mathrm{e}_{2 m-1} \in U \subseteq V+U$ and $\mathrm{e}_{2 m}=\left(\mathrm{e}_{2 m}+\frac{1}{m} \mathrm{e}_{2 m-1}\right)-\frac{1}{m} \mathrm{e}_{2 m-1} \in$ $V+U$. Since span $\left\{\mathrm{e}_{n}: n \in \mathbb{N}\right\}$ is a dense subset of $\ell_{1}$, it follows that $\frac{1}{V+U}=\ell_{1}$. Now we will show that $V+U \neq \ell_{1}$. Let

$$
x=\left(x_{n}\right)_{n \in \mathbb{N}}, \quad x_{n}= \begin{cases}\frac{1}{n^{2}}, & n \text { even }, \\ 0, & n \text { odd } .\end{cases}
$$

Clearly $x \in \ell_{1}$. Suppose that there exist $v=\left(v_{n}\right)_{n \in \mathbb{N}} \in V, u=\left(u_{n}\right)_{n \in \mathbb{N}} \in U$ such that $x=v+u$. It follows for all $m \in \mathbb{N}$

$$
\begin{aligned}
\frac{1}{(2 m)^{2}} & =x_{2 m}=v_{2 m}+u_{2 m}=v_{2 m}, \\
0 & =x_{2 m-1}=v_{2 m-1}+u_{2 m-1}=m v_{2 m}+u_{2 m-1}=\frac{1}{4 m^{2}}+u_{2 m-1},
\end{aligned}
$$

impliying that $u_{2 m-1}=-\frac{1}{4 m^{2}}, m \in \mathbb{N}$, hence $u \neq \ell_{1}$. Therefore $x \neq V+U$.
Definition 1.17. Let $X$ be a normed space and $\|\cdot\|_{1}$ and $\|\cdot\|_{2}$ be norms on $X$ They are called equivalent norms if there exist $m, M>0$ such that

$$
\begin{equation*}
m\|x\|_{1} \leq\|x\|_{2} \leq M\|x\|_{1}, \quad x \in X . \tag{1.2}
\end{equation*}
$$

Theorem 1.18. Let $\|\cdot\|_{1}$ and $\|\cdot\|_{2}$ be norms on a vector space $X$. The the following are equivalent:
(i) $\|\cdot\|_{1}$ and $\|\cdot\|_{2}$ are equivalent.
(ii) A sequence $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq X$ converges with respect to $\|\cdot\|_{1}$ if and only if it converges with respect to $\|\cdot\|_{2}$ and in this case the $\|\cdot\|_{1}$-limit and the $\|\cdot\|_{2}$ limit are equal.
(iii) A sequence $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq X$ converges to 0 with respect to $\|\cdot\|_{1}$ if and only if it converges with respect to $\|\cdot\|_{2}$.

Proof. (i) $\Longrightarrow$ (ii) $\Longrightarrow$ (iii) is clear.
"(iii) $\Longrightarrow$ (i)": Obviously it suffices to show the existence of $M \in \mathbb{R}$ such that (1.2) is true. Assume no such $M$ exists. Then there exists a sequence $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq X$ such that $\left\|x_{n}\right\|_{1}=1$ and $\left\|x_{n}\right\|_{2}>n\left\|x_{n}\right\|_{1}=n$. Let $y_{n}:=n^{-1} x_{n}$. Then $y_{n} \xrightarrow{\|\cdot\|_{1}} 0$, so by assumption also $y_{n} \xrightarrow{\|\cdot\|_{2}} 0$. This contradicts $\left\|y_{n}\right\|_{2}>1$ for all $n \in \mathbb{N}$.

The theorem above implies in particular, that the topologies generated by equivalent norms coincide. Moreover, the identity map id $:\left(X,\|\cdot\|_{1}\right) \rightarrow\left(X,\|\cdot\|_{2}\right)$ is uniformly continuous for equivalent norms

Example 1.19. On $C^{1}([a, b])$ define the norm

$$
\|f\|_{(2)}:=\sup \left\{\max \left\{|x(t)|,\left|x^{\prime}(t)\right|\right\}: t \in[a, b]\right\} .
$$

and let $\|\cdot\|_{(1)}$ be as in Example 1.15 (7). It is not hard to see that

$$
\|x\|_{(1)} \leq\|x\|_{(2)} \leq 2\|x\|_{(1)}, \quad x \in C^{1}([a, b]) .
$$

## Theorem 1.20. All norms on $\mathbb{K}^{n}$ are equivalent

Proof. Let $\left\{\mathrm{e}_{1}, \ldots, \mathrm{e}_{n}\right\}$ be a basis of $\mathbb{K}^{n}$. For $x=\sum_{j=1}^{n} \alpha_{n} \mathrm{e}_{n}$ define

$$
\|x\|_{2}:=\left(\sum_{j=1}^{n}\left|\alpha_{j}\right|^{2}\right)^{\frac{1}{2}} .
$$

Obviously, $\|\cdot\|_{2}$ is a norm on $X$ and it suffices to show that every norm on $X$ is equivalent to $\|\cdot\|_{2}$. Let $\|\cdot\|$ be a norm on $X$ and $x=\sum_{j=1}^{n} \alpha_{n} \mathrm{e}_{n}$. Using triangle inequality for $\|\cdot\|$ and Hölder's inequality, we obtain

$$
\begin{equation*}
\|x\|=\left\|\sum_{j=1}^{n} \alpha_{j} \mathrm{e}_{j}\right\| \leq \sum_{j=1}^{n}\left|\alpha_{j}\right|\left\|\mathrm{e}_{j}\right\| \leq\left(\sum_{j=1}^{n}\left|\alpha_{j}\right|^{2}\right)^{\frac{1}{2}}\left(\sum_{j=1}^{n}\left\|\mathrm{e}_{j}\right\|^{2}\right)^{\frac{1}{2}}=C\|x\|_{2} \tag{1.3}
\end{equation*}
$$

with constant $C:=\left(\sum_{j=1}^{n}\left\|\mathrm{e}_{j}\right\|^{2}\right)^{\frac{1}{2}}$ independent of $x$.
Note that $\|\cdot\|_{2}: X \rightarrow \mathbb{R}$ is continuous, hence $S:=\left\{x \in X:\|x\|_{2}=1\right\}$ is closed being the preimage of the closed set $\{1\}$ in $\mathbb{R}$. In addition, $S$ is bounded, therefore $S$ is compact by the theorem of Heine-Borel. Now consider the map $T:\left(X,\|\cdot\|_{2}\right) \rightarrow \mathbb{R}, T x=\|x\|$. By (1.3), $T$ is uniformly continuous, so its restriction to the compact set $S$ has a minimum $m$ and a maximum $M$. Since $\|\cdot\|$ is a norm, $m>0$ (otherwise there would exist an $x \in S$ with $\|x\|=0$, thus $x=0$ but $0 \notin S$ ) Therefore

$$
m\|x\|_{2}=m \leq\|x\| \leq M=M\|x\|_{2}, \quad x \in S,
$$

and by the homogeneity of the norms

$$
m\|x\|_{2} \leq\|x\| \leq M\|x\|_{2}, \quad x \in X
$$

The theorem above implies that all norms a a finite-dimensional $\mathbb{K}$-vector space are equivalent. Moreover, it follows that every finite normed space is complete because $\mathbb{K}^{n}$ with the Euclidean norm is complete and that a subset of a finite dimensional normed space is compact if and only if it is bounded and closed (Theorem of HeineBorel for $\mathbb{K}^{n}$ with the Euclidean metric). In particular, the unit ball in a finite dimensional space is compact.
This is no longer true in infinite dimensional normed spaces. In fact, the unit ball is compact if and only if the dimensions of the space is finite. For the proof we use the following theorem which is also of independent interest, as it shows that in a certain sense quotient spaces can work as a substitute for the orthogonal complement in inner product spaces (see ??).

Theorem 1.21 (Riesz's lemma). Let $X$ be a normed space, $Y \subseteq X$ a closed subspace with $Y \neq X$ and $\varepsilon>0$. Then there exists an $x \in X$ such with $\|x\|=1$ and $\operatorname{dist}(x, Y)>1-\varepsilon$.

Proof. If $Y=\{0\}$ or $\varepsilon \geq 1$, the assertion is clear. Now assume $0<\varepsilon<1$. Note that in this case $\frac{1}{1-\varepsilon}>1$. Since $Y$ is closed and different from $X$, the quotient space $X / Y$ is not trivial. Hence there exists an $\xi \in X$ such that $\|[\xi]\| \sim=1$. By Remark 1.14 there exists $y \in Y$ such that

$$
1=\|[\xi]\| \sim \leq\|\xi+y\|<\frac{1}{1-\varepsilon} .
$$

Let $x=\|\xi+y\|^{-1}(\xi+y)$. Obviously, $\|x\|=1$ and for every $z \in Y$
$\|x-z\|=\|\xi+y\|^{-1}\|\xi+\underbrace{y-\|\xi+y\| z}_{\in Y}\| \geq\|\xi+y\|^{-1}\|[\xi]\|_{\sim}=\|\xi+y\|^{-1}>1-\varepsilon$.
Hence $d(x, Y)=\inf \{\|x-z\|: z \in Y\}>1-\varepsilon$.
Theorem 1.22. For a normed space $X$ the following are equivalent:
(i) $\operatorname{dim} X<\infty$,
(ii) $B_{X}:=\{x \in X:\|x\| \leq 1\}$ is compact.
(iii) Every bounded sequence in $X$ contains a convergent subsequence.

Proof."(i) $\Longrightarrow$ (ii)" follows from Theorem 1.20.
"(ii) $\Longrightarrow$ (i)": Assume that $B_{X}$ is compact. Then there are $x_{1}, \ldots, x_{n} \in X$ with $\left\|x_{j}\right\| \leq 1, j=1, \ldots, n$, such that

$$
\begin{equation*}
B_{X} \subseteq \bigcup_{j=1}^{n} B_{\frac{1}{2}}\left(x_{j}\right) . \tag{1.4}
\end{equation*}
$$

Let $U=\operatorname{span}\left\{x_{1}, \ldots, x_{n}\right\}$. If $U \neq X$, then, by Riesz's lemma, there exists an $x \in X$ such that $\|x\|=1$ and $\operatorname{dist}(x, U)>\frac{1}{2}$, in contradiction to (1.4). Therefore $\operatorname{dim} X=\operatorname{dim} U \leq n$.
"(ii) $\Longrightarrow$ (iii)": If $B_{X}$ is compact, then obviously for every $\alpha \geq 0$ also $\alpha B_{X}:=$ $\left\{\alpha x: x \in B_{X}\right\}$ is compact. Since every bounded sequence is a subset of some $\alpha B_{X}$, it must contain a convergent subsequence.
"(iii) $\Longrightarrow$ (i)": Assume that $\operatorname{dim} X=\infty$. Choose $x_{1} \in X$ with $\left\|x_{1}\right\|=1$ and set $U_{1}:=\operatorname{span}\left\{x_{1}\right\} \neq X$. By Riesz's lemma there exists an $x_{2} \in X$ with $\left\|x_{2}\right\|=1$ and $\operatorname{dist}\left(x_{2}, U_{1}\right)>\frac{1}{2}$, in particular $\left\|x_{1}-x_{2}\right\|>\frac{1}{2}$. Set $U_{2}:=\operatorname{span}\left\{x_{1}, x_{2}\right\} \neq X$ Continuing this way, we obtain a sequence $x=\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq X$ with $\left\|x_{n}-x_{m}\right\|>\frac{1}{2}$ for all $n, m \in \mathbb{N}$ with $n \neq m$. Therefore, the sequence $x$ does not contain a convergent subsequence, hence $B_{X}$ is not compact (Recall that a compact metric space is sequentially compact).

Let $X$ be a vector space and $\Lambda$ a set. A family $\left(x_{\lambda}\right)_{\lambda \in \Lambda} \subseteq X$ is called linearly independent if every finite subset is linearly independent. A Hamel basis (or an elgebraic basis) of $X$ is a family $\left(x_{\lambda}\right)_{\lambda \in \Lambda} \subset X$ that is linearly independent and such that every element $x \in X$ is a (finite! ) linear combination of the $x_{\lambda}$. The existence of a Hamel basis can be shown with Zorn's lemma

Definition 1.23. Let $X$ be a normed space. A family $\left(x_{n}\right)_{n \in \mathbb{N}}$ is a Schauder basis of $X$ if every $x \in X$ can be written uniquely as

$$
\sum_{n=1}^{\infty} \alpha_{n} x_{n} \quad \text { with } \alpha_{n} \in \mathbb{K} .
$$

Definition 1.24. Let $(X,\|\cdot\|)$ be a normed space over $\mathbb{K}$. A subset $Y \subseteq X$ is said to be a total subset of $X$ if

$$
\overline{\operatorname{span}(Y)}=X
$$

that is, if the set of all linear combinations of elements of $Y$ is dense in $X$

Theorem 1.25. A normed space $(X,\|\cdot\|)$ is separable if and only if it contains a countable total subset.

Proof. Let $A$ be a dense countable subset of $X$. Then obviously $\overline{\operatorname{span} A}=X$, that is, $A$ is a total subset of $X$.
Now assume that $A$ is countable total subset of $X$. Let $B:=\left\{\lambda a_{n}: n \in \mathbb{N}, \lambda \in \widetilde{\mathbb{Q}}\right\}$ where $\widetilde{\mathbb{Q}}:=\mathbb{Q}$ if $X$ is a $\mathbb{R}$-vector space and $\widetilde{\mathbb{Q}}:=\mathbb{Q}+\mathrm{i} \mathbb{Q}$ if $X$ is a $\mathbb{C}$-vector space. In both cases $B$ is countable. We will show that $\bar{B}=X$. Let $x \in X$ and $\varepsilon>0$. Since $A$ is a total subset of $X$, there exist $a_{1}, \ldots, a_{n} \in A$ and $\lambda_{1}, \ldots, \lambda_{n} \in \mathbb{K}$ such that

$$
\left\|x-\sum_{j=1}^{n} \lambda_{j} a_{j}\right\|<\frac{\varepsilon}{2} .
$$

Since $\widetilde{Q}$ is dense in $\mathbb{K}$, there exist $\mu_{1}, \ldots, \mu_{n} \in \widetilde{\mathbb{Q}}$ such that

$$
\left|\mu_{j}-\lambda_{j}\right|<\frac{\varepsilon}{2}\left(\sum_{j=1}^{n}\left\|a_{j}\right\|\right)^{-1}, \quad j=1, \ldots, n .
$$

Then $y:=\sum_{j=1}^{n} \mu_{j} a_{j} \in \operatorname{span} A$ and

$$
\begin{aligned}
\|x-y\| & \leq\left\|x-\sum_{j=1}^{n} \lambda_{j} a_{j}\right\|+\left\|y-\sum_{j=1}^{n} \lambda_{j} a_{j}\right\|<\frac{\varepsilon}{2}+\left\|\sum_{j=1}^{n}\left|\mu_{j}-\lambda_{j}\right| a_{j}\right\| \\
& \leq \frac{\varepsilon}{2}+\underset{j=1}{\max }\left|\mu_{j}-\lambda_{j}\right| \sum_{j=1}^{n}\left\|a_{n}\right\|<\frac{\varepsilon}{2}+\frac{\varepsilon}{2}=\varepsilon .
\end{aligned}
$$

Note that every normed space with a Schauder basis is separable, but not every separable normed space has a Schauder basis.

Examples 1.26. (i) $\ell_{p}$ is separable for $1 \leq p<\infty$.
Proof. Let $e_{n}:=(0, \ldots, 0,1,0 \ldots)$ be the $n$th unit vector in $\ell_{p}$. We will show that $\left\{e_{n}: n \in \mathbb{N}\right\}$ is a total subset of $\ell_{p}$. Let $x=\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq \ell_{p}$. Then

$$
\left\|x-\sum_{j=1}^{n} x_{j} e_{j}\right\|_{p}=\left\|\sum_{j=n+1}^{\infty} x_{j} e_{j}\right\|_{p} \rightarrow 0, \quad n \rightarrow \infty .
$$

(ii) $\ell_{\infty}$ is not separable

Proof. Recall that the set $A:=\left\{\left(x_{n}\right)_{n \in \mathbb{N}}: x_{n} \in\{0,1\}\right\}$ is not countable. Obviously, $A \subseteq \ell_{\infty}$. Let $B$ be a dense subset of $\ell_{\infty}$. Then for every $x \in A$ there exists an $b_{x} \in B$ such that $\left\|x-b_{x}\right\|_{\infty}<\frac{1}{2}$. Since $\|x-y\|_{\infty}=1$ for $x \neq y \in A$, it follows that $B$ has at least the cardinality of $A$, that is, there exists no countable dense subse of $\ell_{p}$.
(iii) $C[a, b]$ is separable since by the theorem of Weierstraß the set of polynomials

$$
\left\{[a, b] \rightarrow \mathbb{R}, x \mapsto x^{n}: n \in \mathbb{N}\right\}
$$

is a total subset of $C[a, b]$.

### 1.3 Hölder and Minkowski inequality

In this section we prove Hölder's inequality and Minkowski's inequality. For the proof we use Young's inequality.

Theorem 1.27. Let $p, q \in(1, \infty)$ such that

$$
\frac{1}{p}+\frac{1}{q}=1
$$

Then for all $a, b \geq 0$

$$
\begin{equation*}
a b \leq \frac{1}{p} a^{p}+\frac{1}{q} b^{q} . \tag{1.5}
\end{equation*}
$$

Proof. If $a b=0$, then inequality (1.5) is clear. Now assume $a b>0$. Since the logarithm is concave and $\frac{1}{p}+\frac{1}{q}=1$ is follows that

$$
\ln \left(\frac{1}{p} a^{p}+\frac{1}{q} b^{q}\right) \geq \frac{1}{p} \ln \left(a^{p}\right)+\frac{1}{q} \ln \left(b^{q}\right)=\ln (a)+\ln (b)=\ln (a b) .
$$

Application of the monotonically increasing function $\exp : \mathbb{R} \rightarrow \mathbb{R}$ yields (1.5). $\square$ Theorem 1.28 (Hölder's inequality). Let $1 \leq p \leq \infty$ and $q=\frac{p}{p-1}$, i.e.,

$$
\frac{1}{p}+\frac{1}{q}=1
$$

(setting $\frac{1}{\infty}=0$ ). If $x \in \ell_{p}$ and $y \in \ell_{q}$, then $z=\left(x_{n} y_{n}\right)_{n \in \mathbb{N}} \in \ell_{1}$ and

$$
\begin{equation*}
\|z\|_{1} \leq\|x\|_{p}\|y\|_{q} \tag{1.6}
\end{equation*}
$$

Proof. If $x=0$ or $y=0$ then the inequality (1.6) clearly holds. Also the cases $p=1$ and $p=\infty$ are clear.
Now assume $x, y \neq 0$ and $1<p<\infty$. The Young inequality (1.6) with

$$
a=\frac{\left|x_{j}\right|}{\|x\|_{p}}, \quad b=\frac{\left|y_{j}\right|}{\|y\|_{q}}
$$

yields

$$
\frac{\left|x_{j}\right|\left|y_{j}\right|}{\|x\|_{p}\|y\|_{q}} \leq \frac{1}{p} \frac{\left|x_{j}\right|^{p}}{\|x\|_{p}^{p}}+\frac{1}{q} \frac{\left|y_{j}\right|^{q}}{\|y\|_{q}^{q}} .
$$

Taking the sum over gives

In the special case $p=q=2$ we obtain the Cauchy-Schwarz inequality.
Corollary 1.29 (Cauchy-Schwarz inequality). For $x=\left(x_{n}\right)_{n \in \mathbb{N}}, y=\left(y_{n}\right)_{n \in \mathbb{N}} \in$ $\ell_{2}$ the Hölder inequality implies

$$
|\langle x, y\rangle|:=\left|\sum_{j=1}^{\infty} x_{j} \overline{y_{j}}\right| \leq\|x\|_{2}\|y\|_{2} .
$$

Theorem 1.30 (Minkowski inequality). For $1 \leq p \leq \infty$ and $x, y \in \ell_{p}$ Minkowski's inequality holds:

$$
\begin{equation*}
\|x+y\|_{p} \leq\|x\|_{p}+\|y\|_{p} \tag{1.7}
\end{equation*}
$$

Proof. If $x+y=0$ then (1.7) clearly holds. Also the cases $p=1$ and $p=\infty$ are easy to check.
Now assume $x+y \neq 0$ and $1<p<\infty$. Let $q \in(1, \infty)$ such that $\frac{1}{p}+\frac{1}{4}=1$. The triangle inequality in $\mathbb{K}$ and Hölder's inequality (1.6) yield for all $M \in \mathbb{N}$ :

```
\(\sum_{j=1}^{M}\left|x_{j}+y_{j}\right|^{p}=\sum_{j=1}^{M}\left|x_{j}+y_{j}\right| \cdot\left|x_{j}+y_{j}\right|^{p-1}\)
    \(\leq \sum_{j=1}^{M}\left|x_{j}\right|\left|x_{j}+y_{j}\right|^{p-1}+\sum_{j=1}^{M}\left|y_{j}\right|\left|x_{j}+y_{j}\right|^{p-1}\)
    \(\leq\left(\sum_{j=1}^{M}\left|x_{j}\right|^{p}\right)^{\frac{1}{p}}\left(\sum_{j=1}^{M}\left|x_{j}+y_{j}\right|^{(p-1) q}\right)^{p}+\left(\sum_{j=1}^{M}\left|y_{j}\right|^{p}\right)^{\frac{1}{p}}\left(\sum_{j=1}^{M}\left|x_{j}+y_{j}\right|^{(p-1) q}\right)^{\frac{1}{q}}\)
    \(\leq\left(\|x\|_{p}+\|x\|_{p}\right)\left(\sum_{j=1}^{M}\left|x_{j}+y_{j}\right|^{p}\right)^{\frac{1}{q}}\)
```

Note that $\left(\sum_{j=1}^{M}\left|x_{j}+y_{j}\right|^{p}\right)^{\frac{1}{q}} \neq 0$ for $M$ large enough. Hence the above inequality yields

$$
\left(\sum_{j=1}^{M}\left|x_{j}+y_{j}\right|^{p}\right)^{\frac{1}{p}} \leq\|x\|_{p}+\|x\|_{p}
$$

using $p-\frac{p}{q}=p\left(1-\frac{1}{q}\right)=1$. Taking the limit $M \rightarrow \infty$ finally proves (1.7).

## Chapter 2

## Bounded maps; the dual space

### 2.1 Bounded linear maps

Definition 2.1. Let $X, Y$ be normed spaces over the same field $\mathbb{K}$. The set of al linear continuous maps $X \rightarrow Y$ is denoted by $L(X, Y)$, i. e.,

$$
L(X, Y)=\{T: X \rightarrow Y: T \text { linear and continuous }\}
$$

and $L(X):=L(X, X)$.
Recall that the following is equivalent:
(i) $T: X \rightarrow Y$ is continuou
(ii) $\lim _{n \rightarrow \infty} T x_{n}=T \lim _{n \rightarrow \infty} x_{n}$ for every convergent sequence $\left(x_{n}\right)_{n \in \mathbb{N}} \in X$
(iii) $\forall x_{0} \in X \forall \varepsilon>0 \exists \delta>0:\left\|x-x_{0}\right\|<\delta \Longrightarrow\left\|T x-T x_{0}\right\|<\varepsilon$
(iv) $U \subseteq Y$ open $\Longrightarrow T^{-1}(U)=\{x \in X: f(x) \in U\}$ open in $X$.

Definition 2.2. Let $X, Y$ be normed spaces over the same field $\mathbb{K}$. For a linear map $T: X \rightarrow Y$ define the operator norm

$$
\|T\|:=\sup \{\|T x\|: x \in X,\|x\|=1\}
$$

If $\|T\|<\infty$ then $T$ is called a bounded linear operator and $\|T\|$ is the operator norm of $\|T\|$.

Remark 2.3. (i) For a continuous linear map $T: X \rightarrow Y$

$$
\|T x\| \leq\|T\|\|x\|, \quad x \in X .
$$

Proof. The inequality is obvious for $x=0$ or $\|x\|=1$. For $x \in X \backslash\{0\}$ let $\widetilde{x}=\|x\|^{-1} x$. By definition of $\|T\|$ we find $\|T x\|=\|x\|\|T \widetilde{x}\| \leq\|x\|\|T\|$. Note that the inequality is also true if $T$ is unbounded and $x \neq 0$.
(ii) The following is easy to check:

$$
\begin{aligned}
\|T\| & =\sup \{\|T x\|: x \in X,\|x\|=1\} \\
& =\sup \{\|T x\|: x \in X,\|x\| \leq 1\} \\
& =\sup \left\{\frac{\|T x\|}{\|x\|}: x \in X, x \neq 0\right\} \\
& =\inf \{M \in \mathbb{R}: \forall x \in X\|T x\| \leq M\|x\|\} .
\end{aligned}
$$

Remark 2.4. (i) For $S, T \in L(X, Y)$ and $\lambda \in \mathbb{K}$ we define

$$
(\lambda T+S): X \rightarrow Y, \quad(\lambda T+S) x:=\lambda T x+S x
$$

Since the sum and composition of continuous functions is continuous, and $(\lambda T+S$ obviously is linear, $L(X, Y)$ is a vector space.
It will be shown in Theorem 2.6 that $\|\cdot\|$ is indeed a norm. Note the the operator norm depends on the norms on $X$ and $Y$. This is can be made explicit using the notation $\|T\|_{L_{(X, Y)}}$, or similar notation.
(ii) Let $X, Y, Z$ be normed spaces and $T \in L(X, Y), S \in L(Y, Z)$. Then

$$
S T: X \rightarrow Z, \quad S T x:=S(T x) .
$$

Obviously, $S T \in L(X, Z)$ as composition of continuous linear functions and $\|S T\| \leq\|S\|\|T\|$ because by Remark 2.3

$$
\|S T x\| \leq\|S\|\|T x\| \leq\|S\|\|T\|\|x\|, \quad x \in X
$$

In particular, $L(X)$ is an algebra.
Theorem 2.5. Let $X, Y$ be normed spaces, $T: X \rightarrow Y$ linear. The following is equivalent:
(i) $T$ is continuous.
(ii) $T$ is continuous in 0
(iii) $T$ is bounded.
(iv) $T$ is uniformly continuous.

Proof. The implications (iii) $\Longrightarrow$ (iv) $\Longrightarrow$ (i) $\Longrightarrow$ (ii) are obvious.
" (ii) $\Longrightarrow$ (iii)": Assume that $T$ is not bounded. Then there exists a sequence $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq X$ such that $\left\|x_{n}\right\|=1$ and $\left\|T x_{n}\right\|>n$ for all $n \in \mathbb{N}$. Let $y_{n}:=n^{-1} x_{n}$ Then $y_{n} \rightarrow 0$ but $\left\|T y_{n}\right\|>1$ for all $n \in \mathbb{N}$ in contradiction to the continuity of $T$ in 0 .

Theorem 2.6. Let $X, Y$ be normed spaces.
(i) $L(X, Y)$ is a normed space.
(ii) If $Y$ is Banach space, then $L(X, Y)$ is a Banach space

Proof. (i) In Remark 2.4 we have seen that $L(X, Y)$ is a vector space. From definition of the operator norm it is clear that $\|T\|=0$ if and only if $T=0$ and that $\|\lambda T\|=|\lambda|\|T\|$ for all $\lambda \in \mathbb{K}$. To prove the triangle inequality let $S, T \in L(X, Y)$ and $x \in X$.

$$
\|(S+T) x\|=\|S x+T x\| \leq\|S x\|+\|T x\| \leq\|S\|+\|T\| .
$$

Taking the supremum over all $x \in X$ with $\|x\|=1$ yields $\|S+T\| \leq\|S\|+\|T\|$.
(ii) Let $\left(T_{n}\right)_{n \in \mathbb{N}}$ be a Cauchy sequence in $L(X, Y)$. For $x \in X$, the sequence $\left(T_{n} x\right)_{n \in \mathbb{N}}$ is a Cauchy sequence in $Y$ because

$$
\left\|T_{n} x-T_{m} x\right\| \leq\left\|T_{n}-T_{m}\right\|\|x\| .
$$

Since $Y$ is complete, we can define

$$
T: X \rightarrow Y, \quad T x:=\lim _{n \rightarrow \infty} T_{n} x
$$

It is easy to check that $T$ is linear. That $T$ is bounded and $T_{n} \rightarrow T$ follows as in Example 1.13(2): For $\varepsilon>0$ exists an $N \in \mathbb{N}$ such that

$$
\left\|T_{n}-T_{m}\right\|<\frac{\varepsilon}{2}, \quad n, m \geq N
$$

In particular, for all $x \in X$ it follows for $n \geq N$ that

$$
\left\|T x-T_{n} x\right\| \leq\left\|T x-T_{m} x\right\|+\left\|T_{m} x-T_{n} x\right\| \leq\left\|T x-T_{m} x\right\|+\frac{\varepsilon}{2}, \quad m \in \mathbb{N}
$$

Taking the limit $m \rightarrow \infty$ on the right hand side yields $\left\|T x-T_{n} x\right\| \leq \frac{\varepsilon}{2}<\varepsilon$. It Taking the $h m \rightarrow \infty$ on the right hand side yields $\left\|x-I_{n} x\right\| \leq \frac{\varepsilon}{2}<\varepsilon$. It
follows that $T-T_{n}$ is a bounded linear map. Since $L(X, Y)$ is a vector space, also $T=T_{n}+\left(T-T_{n}\right)$ is a bounded linear map. In addition, (2.1) shows that $T_{n} \rightarrow T$, $T=I_{n}+$
$n \rightarrow \infty$.

Examples 2.7. In the following examples, the linearity of the operator under consideration is easy to check.
(i) Let $X$ be a normed space. Then the identity id : $X \rightarrow X$ is bounded and $\|$ id $\|=1$.
(ii) Let $1 \leq p \leq \infty$. The left shift and the right shift on $\ell_{p}$ are defined by

$$
\begin{array}{ll}
R: \ell_{p} \rightarrow \ell_{p}, & \left(x_{1}, x_{2}, x_{3} \ldots\right)_{n \in \mathbb{N}} \mapsto\left(0, x_{1}, x_{2}, \ldots\right), \\
L: \ell_{p} \rightarrow \ell_{p}, & \left(x_{1}, x_{2}, x_{3} \ldots\right)_{n \in \mathbb{N}} \mapsto\left(x_{2}, x_{3}, \ldots\right) .
\end{array}
$$

Obviously, $R$ and $L$ are well-defined and linear. Moreover, $R$ is an isometry because $\|R x\|_{p}=\|x\|_{p}$; in particular $\|R\|=1$.
The left shift is not an isometry because, e. g., $\|L(1,0,0, \ldots)\|_{p}=\|0\|_{p}=0<$ $1=\|(1,0,0, \ldots)\|_{p}$. It is easy to see that $\|L x\|_{p} \leq\|x\|_{p}, x \in \ell_{p}$, implying that $\|L\| \leq 1$. Since $\|L(0,1,0,0 \ldots)\|_{p}=\|(1,0,0 \ldots)\|_{p}=\|(0,1,0,0 \ldots)\|_{p}$ we also have $\|L\| \geq 1$, so that altogether $\|L\|=1$.
Note that $L R=\operatorname{id}_{\ell_{p}}$ but $R L \neq \operatorname{id}_{\ell_{p}}$.
(iii) $T: C^{1}\left([0,1],\|\cdot\|_{C^{1}}\right) \rightarrow C\left([a, b],\|\cdot\| \|_{\infty}\right), T x=x^{\prime}$ with $\|x\|_{C^{1}}:=\|x\|_{\infty}+\left\|x^{\prime}\right\|_{\infty}$. The operator $T$ is bounded and $\|T\|=1$.

Proof. The operator $T$ is bounded with $\|T\| \leq 1$ because $\|T x\|_{\infty}=\left\|x^{\prime}\right\|_{\infty} \leq$ $\|x\|_{\infty}+\left\|x^{\prime}\right\|_{\infty} \leq\|x\|_{C^{1}}$ for all $x \in X$.
To proof that $\|T\| \geq 1$ let $x_{n}:[0,1] \rightarrow \mathbb{R}, x_{n}(t):=\frac{1}{n} \exp (-n t)$. Obviously, $x_{n} \in C^{1}([0,1]),\left\|x_{n}\right\|_{C^{1}}=\frac{1}{n}+1$ and $\left\|T x_{n}\right\|_{\infty}=1$. It follows that

$$
\begin{aligned}
&\|T\|=\sup \left\{\|T x\|_{\infty}\right. \\
&=\sup \left\{\frac{1}{1+\frac{1}{n}}: n \in C^{1}([0,1]) \backslash\{0\}\right\} \geq \sup \left\{\left\|T x_{n}\right\|_{\infty}\right. \\
&\left\|x_{n}\right\|_{C^{1}}: n \in \mathbb{N}\} \\
&
\end{aligned}
$$

(iv) $T: C^{1}\left([0,1],\|\cdot\|_{\infty}\right) \rightarrow C\left([a, b],\|\cdot\|_{\infty}\right), T x=x^{\prime}$ is not bounded.

Proof. As in the example above let $x_{n}:[0,1] \rightarrow \mathbb{R}, x_{n}(t):=\frac{1}{n} \exp (-n t)$. It follows that

$$
\begin{aligned}
\sup \left\{\frac{\|T x\|_{\infty}}{\|x\|_{\infty}}: x \in C^{1}([0,1]) \backslash\{0\}\right\} & \geq \sup \left\{\frac{\left\|T x_{n}\right\|_{\infty}}{\left\|x_{n}\right\|_{\infty}}: n \in \mathbb{N}\right\} \\
& =\sup \left\{\frac{1}{\frac{1}{n}}: n \in \mathbb{N}\right\}=\infty
\end{aligned}
$$

$\square$

Lemma 2.8. let $X, Y$ be normed spaces, $X$ finite-dimensional. Then every linear map $T: X \rightarrow Y$ is bounded.

Proof. Let $\mathrm{e}_{1}, \ldots, \mathrm{e}_{n}$ be a basis of $X$. Since on $X$ all norms are equivalent, we can assume that

$$
\left\|\sum_{j=1}^{n} \alpha_{j} \mathrm{e}_{j}\right\|=\sum_{j=1}^{n}\left|\alpha_{j}\right|
$$

Let $M:=\max \left\{\left\|T \mathrm{e}_{j}\right\|: j=1, \ldots, n\right\}$. Then $T$ is bounded with $\|T\| \leq M$ because for $x=\sum_{j=1}^{n} \alpha_{j} \mathrm{e}_{j} \in X$

$$
\|T x\|_{Y}=\left\|\sum_{j=1}^{n} \alpha_{j} T \mathrm{e}_{j}\right\|_{Y} \leq \sum_{j=1}^{n}\left|\alpha_{j}\right|\left\|T \mathrm{e}_{j}\right\|_{Y} \leq M \sum_{j=1}^{n}\left|\alpha_{j}\right|=M\|x\|_{X}
$$

Theorem 2.9. Let $X, Y$ be normed spaces, $Y$ a Banach space. Let $D \subseteq X$ be a dense subspace of $X$ and $T \in L(D, Y)$. Then there exists exactly one continuous extension $\widehat{T}: X \rightarrow Y$ of $T$. The extension is bounded with $\|\widehat{T}\|=\|T\|$.

Proof. For $x \in X$ choose a sequence $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq D$ which converges to $x$. The sequence is a Cauchy sequence in $D$, hence, by the uniform continuity of $T,\left(T x_{n}\right)_{n \in \mathbb{N}}$ is a Cauchy sequence in $Y$, and therefore it converges in $Y$ because $Y$ is complete. Let $\left(\xi_{n}\right)_{n \in \mathbb{N}}$ be another Cauchy sequence in $D$ which converges to $x$. By what was said before, $\left(T \xi_{n}\right)$ converges in $Y$. Then $\lim _{n \rightarrow \infty}\left\|T x_{n}-T \xi_{n}\right\|=\lim _{n \rightarrow \infty}\left\|T\left(x_{n}-\xi_{n}\right)\right\| \leq$ $\lim _{n \rightarrow \infty}\|T\|\left\|\left(x_{n}-\xi_{n}\right)\right\|=\|T\| \lim _{n \rightarrow \infty}\left\|\left(x_{n}-\xi_{n}\right)\right\|=0$, the following operator is well ${ }^{n \rightarrow \infty}$ defined:
$\widetilde{T}: X \rightarrow Y, \quad \widetilde{T} x:=\lim _{n \rightarrow \infty} T x_{n} \quad$ for any $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq D$ which converges to $x$.
It is not hard to see that $\widetilde{T}$ is a linear extension of $T$ and that $\|\widetilde{T}\| \geq\|T\|$. To see that indeed equality holds, we only need to observe that by definition of $\widetilde{T}$

$$
\overline{\{\|T x\|: x \in D,\|x\|=1\}}=\overline{\{\|\widetilde{T} x\|: x \in X,\|x\|=1\}}
$$

hence the suprema of both sets without the closure are equal (and equal to the supremum of the closed sets). Since $\widetilde{T}$ is linear and bounded by $\|T\|$, it is continuous Assume that $S$ is an arbitrary continuous extension of $T$. For $x \in X$ and a sequence $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq D$ which converges to $x$ we find

$$
S x=\lim _{n \rightarrow \infty} S x_{n}=\lim _{n \rightarrow \infty} T x_{n}=\lim _{n \rightarrow \infty} \widehat{T} x_{n}=\widehat{T} x
$$

Therefore, $\widehat{T}$ is the unique continuous extension of $T$.
Finally we give a criterion for the invertibility of a bounded linear operator.

Theorem 2.10 (Neumann series). Let $X$ be a normed space and $T \in E(X)$ such that $\sum_{n=0}^{\infty} T^{n}$ converges. Then id $-T$ is invertible in $L(X)$ and

$$
\begin{equation*}
(\mathrm{id}-T)^{-1}=\sum_{n=0}^{\infty} T^{n} . \tag{2.2}
\end{equation*}
$$

In particular, if $X$ is a Banach space and $\|T\|<1$, then id $-T$ is invertible and

$$
\left\|(\operatorname{id}-T)^{-1}\right\| \leq(1-\|T\|)^{-1}
$$

Proof. The proof is analogous to the proof for the convergence of the geometric series. We define the partial sums $S_{m}:=\sum_{n=0}^{m} T^{n}, m \in \mathbb{N}_{0}$. Then

$$
\begin{equation*}
(\mathrm{id}-T) S_{m}=S_{m}(\mathrm{id}-T)=\mathrm{id}-T^{m+1}, \quad m \in \mathbb{N}_{0} \tag{2.3}
\end{equation*}
$$

Note that:
(i) $T^{m} \rightarrow 0$ for $m \rightarrow \infty$ because $\sum_{m=0}^{\infty} T^{m}$ converges.
(ii) $S_{m} \rightarrow \sum_{n=0}^{\infty} T^{n}$ for $m \rightarrow \infty$ by assumption.
(iii) For fixed $R \in L(X)$ the maps $L(X) \rightarrow L(X), S \mapsto R S$ and $S \mapsto S R$ respectively are continuous.

Hence taking the limit $m \rightarrow \infty$ in (2.3) gives

$$
(\mathrm{id}-T) \sum_{n=0}^{\infty} T^{n}=\left(\sum_{n=0}^{\infty} T^{n}\right)(\mathrm{id}-T)=\mathrm{id}
$$

implying that id $-T$ is invertible and that (2.2) holds.
Now assume that $X$ is a Banach space and that $\|T\|<1$. Then $\sum_{n=0}^{\infty} T^{n}$ converges in norm because $\left\|T^{n}\right\| \leq\|T\|^{n}$. In particular, $\left(\sum_{j=0}^{m} T^{j}\right)_{m \in \mathbb{N}}$ is a Cauchy sequence in $L(X)$. Since $L(X)$ is complete by assumption on $X$ and Theorem 2.6 the series converges. By the first part of the proof, id $-T$ is invertible and formula (2.2) holds.

Application 2.11 (Volterra integral equation). Let $k \in C\left([0,1]^{2}\right)$ and $y \in$ $C([0,1])$. We ask if the equation

$$
\begin{equation*}
x(s)-\int_{0}^{s} k(s, t) x(t) \mathrm{d} t=y(s), \quad s \in[0,1] . \tag{2.4}
\end{equation*}
$$

has solution $x \in C([0,1])$. If a solution exists, is it unique? Can the norm of the solution be estimated in terms of $y$ ?

Solution. Note that equation (2.4) can be written as an equation in the Banach space $C([0,1])$ :

$$
x-K x=y
$$

where
$K: C([0,1]) \rightarrow C([0,1]), \quad(K x)(s):=\int_{0}^{s} k(s, t) x(t) \mathrm{d} t, s \in[0,1]$.

Obviously, $K$ is a well-defined linear operator and for all $x \in C([0,1], s \in[0,1]$

$$
\begin{aligned}
|K x(s)| & =\left|\int_{0}^{s} k(s, t) x(t) \mathrm{d} t\right| \leq \int_{0}^{s}|k(s, t)||x(t)| \mathrm{d} t \leq s\|k\|_{\infty}\|x\|_{\infty}, \\
\left|K^{2} x(s)\right| & =\left|\int_{0}^{s} k(s, t) \int_{0}^{t} k\left(t, t_{1}\right) x\left(t_{1}\right) \mathrm{d} t_{1} \mathrm{~d} t\right| \leq\|k\|_{\infty}^{2}\|x\|_{\infty} \int_{0}^{s} \int_{0}^{t} \mathrm{~d} t_{1} \mathrm{~d} t \\
& =\|k\|_{\infty}^{2}\|x\|_{\infty} \frac{s^{2}}{2}
\end{aligned}
$$

Repeating this process, it follows that

$$
\left|K^{n} x(s)\right| \leq \frac{s^{n}}{n!}\|k\|_{\infty}^{n}\|x\|_{\infty}, \quad s \in[0,1], x \in C([0,1]), n \in \mathbb{N}
$$

which shows that $\left\|K^{n}\right\| \leq \frac{\|k\| \infty}{n!}$. In particular, $\sum_{n=0}^{\infty} K^{n}$ converges so that id $-K$ which shows that $\left\|K^{n}\right\| \leq n n$. In particular, $\sum_{n=0}^{\infty} K^{n}$ converges so that id $-K$
is invertible by Theorem 2.10 . Hence equation (2.4) has exactly one solution $x \in$ $C([0,1])$, given by

$$
x=\sum_{n=0}^{\infty} K^{n} y .
$$

Moreover, $\|x\|_{\infty}=\left\|\sum_{n=0}^{\infty} K^{n} y\right\|_{\infty} \leq \sum_{n=0}^{\infty}\left\|K^{n}\right\|\|y\|_{\infty} \leq \sum_{n=0}^{\infty} \frac{\|k\|_{\infty}}{n!}\|y\|_{\infty}=$ $\mathrm{e}\|k\|_{\infty}\|y\|_{\infty}$.

### 2.2 The dual space and the Hahn-Banach theorem

Definition 2.12. Let $X$ be a normed space. $X^{\prime}:=L(X, \mathbb{K})$ is the dual space of $X$; elements in the dual space are called functionals.

Note that in general the algebraic dual space, i. e., the space of all linear maps $X \rightarrow \mathbb{K}$ in general is larger than the topological dual space defined above. Theorem 2.6 implies immediately:

Proposition 2.13. The dual space of a normed space $X$ with the norm

$$
\left\|x^{\prime}\right\|=\sup \left\{\left|x^{\prime}(x)\right|: x \in X,\|x\| \leq 1\right\}, \quad x^{\prime} \in X^{\prime},
$$

is a Banach space.

Definition 2.14. Let $X$ be normed space. $p: X \rightarrow \mathbb{R}$ is a sublinear functional on $X$ (or a seminorm) if
(i) $p(\lambda x)=|\lambda| p(x), \quad \lambda \in \mathbb{K}, x \in X$,
(ii) $p(x+y) \leq p(x)+p(y), \quad x, y \in X$.

A sublinear functional $p$ is called bounded if there exists an $M \in \mathbb{R}$ such that

$$
p(x) \leq M\|x\|, \quad x \in X .
$$

For example, every norm on $X$ is sublinear. If $\varphi: X \rightarrow \mathbb{K}$ is linear, then

$$
X \rightarrow \mathbb{R}, \quad x \mapsto|\varphi(x)|
$$

is sublinear.
The next fundamental theorem shows that every normed space admits non-trivial functionals (except when $X=\{0\}$ ).

Theorem 2.15 (Hahn-Banach theorem). Let $X$ be normed space and $p: X \rightarrow$ $\mathbb{R}$ sublinear. Let $Y \subseteq X$ a subspace and $\varphi_{0}$ a linear functional on $Y$ (that is, $\left.\varphi_{0} \in Y^{\prime}\right)$ with

$$
\left|\varphi_{0}(y)\right| \leq p(y), \quad y \in Y .
$$

Then $\varphi_{0}$ has an extension to a functional $\varphi$ on $X$ (that is, $\varphi \in X^{\prime}$ and $\varphi_{0}(y)=\varphi(y)$ for all $y \in Y$ ) and

$$
\begin{equation*}
|\varphi(x)| \leq p(x), \quad x \in X . \tag{2.5}
\end{equation*}
$$

Proof. For $Y=X$ there is nothing to show. Now assume $Y \neq X$. We distinguish between the real and the complex case. First assume that $X$ is a real vector space. We divide the proof in two steps.
Step 1. Let $z_{0} \in X \backslash Y$ and $Z:=\operatorname{span}\left\{z_{0}, Y\right\}$. We will show that $\varphi_{0}$ can be extended to some $\psi \in Z^{\prime}$ such that (2.5) holds for all $z \in Z$.
Obviously, every linear extension of $\psi$ must be of the form

$$
\psi_{c}\left(y+\lambda z_{0}\right)=\varphi_{0}(y)+\lambda c, \quad \lambda \in \mathbb{R}, y \in Y
$$

for some $c \in \mathbb{R}$. We have to find $c$ such that $\left|\psi_{c}(z)\right| \leq p(z), z \in Z$, that is,

$$
\begin{equation*}
\left|\psi_{c}\left(y+\lambda z_{0}\right)\right| \leq p\left(y+\lambda z_{0}\right), \quad y \in Y, \lambda \in \mathbb{R} . \tag{2.6}
\end{equation*}
$$

By assumption on $\varphi_{0}$

$$
\varphi_{0}(x)-\varphi_{0}(y)=\varphi_{0}(x-y) \leq p(x-y) \leq p\left(x+z_{0}\right)+p\left(y+z_{0}\right), \quad y, x \in Y
$$

implying

$$
-\varphi_{0}(y)-p\left(y+z_{0}\right) \leq-\varphi_{0}(x)+p\left(x+z_{0}\right), \quad y, x \in Y,
$$

so that
$a:=\sup \left\{-\varphi_{0}(x)-p\left(x+z_{0}\right): x \in Y\right\} \leq \inf \left\{-\varphi_{0}(x)+p\left(x+z_{0}\right): x \in Y\right\}:=b$.
Now let $c \in[a, b]$ arbitrary. We show that then $\psi_{c}$ is an extension of $\varphi_{0}$ as desired. Let $z=y+\lambda z_{0} \in Z$ with $y \in Y$ and $\lambda \in \mathbb{R}$. Obviously $\psi_{c}$ is continuous in 0 , hence $\psi_{c} \in Z^{\prime}$.
We have to show (2.6). For $\lambda=0$ equation (2.6) clearly holds. For $\lambda \neq 0$ :

$$
\begin{array}{ll}
\lambda>0: & \lambda c \leq \lambda b \leq \lambda\left(-\varphi_{0}\left(\frac{1}{\lambda} y\right)+p\left(\frac{1}{\lambda} y+z_{0}\right)\right)=-\varphi_{0}(y)+p\left(y+\lambda z_{0}\right), \\
\lambda<0: & \lambda c \leq \lambda a \leq \lambda\left(-\varphi_{0}\left(\frac{1}{\lambda} y\right)-p\left(\frac{1}{\lambda} y+z_{0}\right)\right)=-\varphi_{0}(y)+p\left(y+\lambda z_{0}\right) .
\end{array}
$$

In both cases we obtain $\psi_{c}(z)=\psi_{c}\left(y+\lambda z_{0}\right)=\varphi_{0}(y)+\lambda c \leq p\left(y+\lambda z_{0}\right)=p(z)$.
Application to $-z$ yields $-\psi_{c}(z)=\psi_{c}(-z) \leq p(-z)=p(z)$. In summary, we have $|\psi(z)| \leq p(z), z \in Z$.
Step 2. Let $\Phi$ be the set of all proper extensions of $\varphi_{0}$ such that $|\varphi(x)| \leq p(x)$ for all $x \in \mathcal{D}(\varphi)$ (the domain of $\varphi$ ). By Step $1, \Phi$ is not empty and partially ordered ${ }_{\text {by }}^{\text {all } x}$

$$
\varphi_{1}<\varphi_{2} \Longleftrightarrow \varphi_{2} \text { is an extension of } \varphi_{1} .
$$

Every totally ordered subset $\Phi_{0}$ has the upper bound

$$
\mathcal{D}(f)=\bigcup_{\psi \in \Phi_{0}} \mathcal{D}(\psi), \quad f(x)=\psi(x) \text { for } x \in \mathcal{D}(\psi) .
$$

By Zorn's lemma, $\Phi$ contains a maximal element $\varphi$. This $\varphi$ is defined on $X$ because otherwise, by Step 1, it would not be maximal.
For the proof of the complex case: Exercise 5.1.
Now we assume that $X$ is a complex vector space. Consider $X$ as a vector space over $\mathbb{R}$ and define the $\mathbb{R}$-linear functional

$$
V_{0}: Y \rightarrow \mathbb{R}, \quad V_{0}(y)=\operatorname{Re}(\varphi(y)) .
$$

Obviously, $V_{0}$ is continuous. It is also $\mathbb{R}$-linear because for all $x, y \in Y$ and $\alpha \in \mathbb{R}$
$V_{0}(\alpha x+y)=\operatorname{Re}\left(\varphi_{0}(\alpha x+y)\right)=\operatorname{Re}\left(\alpha \varphi_{0}(x)+\varphi_{0}(y)\right)=\alpha \operatorname{Re}\left(\varphi_{0}(x)\right)+\operatorname{Re}\left(\varphi_{0}(y)\right)$ $=\alpha V_{0}(x)+V_{0}(y)$.
In addition, $V_{0}$ is bounded by the sublinear functional $p$

$$
\left|V_{0}(y)\right|=\left|\operatorname{Re}\left(\varphi_{0}(y)\right)\right| \leq\left|\varphi_{0}(y)\right| \leq p(y), \quad y \in Y
$$

By what we have already shown, there exists a $\mathbb{R}$-linear extension $V \in L(X, \mathbb{R})$ of $V_{0}$ with $|V(x)| \leq p(x), x \in X$. Now define

$$
\varphi: X \rightarrow \mathbb{C}, \quad \varphi(x)=V(x)-\mathrm{i} V(\mathrm{i} x) .
$$

$\varphi$ has the following properties:
(i) $\varphi$ is an extension of $\varphi_{0}$. To see this, let $y \in Y$

$$
\begin{aligned}
\varphi(y) & =V_{0}(y)-\mathrm{i} V_{0}(\mathrm{i} y)=\operatorname{Re}\left(\varphi_{0}(y)\right)-\mathrm{i} \operatorname{Re}\left(\varphi_{0}(\mathrm{i} y)\right)=\operatorname{Re}\left(\varphi_{0}(y)\right)-\mathrm{i} \operatorname{Re}\left(\mathrm{i} \varphi_{0}(y)\right) \\
& =\operatorname{Re}\left(\varphi_{0}(y)\right)+\mathrm{i} \operatorname{Im}\left(\varphi_{0}(y)\right)=\varphi_{0}(y) .
\end{aligned}
$$

(ii) $\varphi$ is $\mathbb{C}$-linear. To show this, let $x, y \in X$ and $\zeta=a+\mathrm{i} b$ with $a, b \in \mathbb{R}$.
$\varphi(x+y)=V(x+y)-\mathrm{i} V(\mathrm{i}(x+y))=V(x)+V(y)-\mathrm{i} V(\mathrm{i} x)-\mathrm{i} V(\mathrm{i} y)$ $=\varphi(x)+\varphi(y)$,
$\varphi(\zeta x)=\varphi(a x)+\varphi(\mathrm{i} b x)=V(a x)-\mathrm{i} V(\mathrm{i} a x)+V(\mathrm{i} b x)-\mathrm{i} V\left(\mathrm{i}^{2} b x\right)$

$$
=a[V(x)-\mathrm{i} V(\mathrm{i} x)]+b[V(\mathrm{i} x)+\mathrm{i} V(x)]
$$

$$
=(a+\mathrm{i} b)[V(x)-\mathrm{i} V(\mathrm{i} x)]=\zeta \varphi(x) .
$$

(iii) $\varphi$ is bounded by $p$. To prove this, let $x \in X$ and $\alpha \in \mathbb{R}$ such that

$$
|\varphi(x)|=\mathrm{e}^{\mathrm{i} \alpha} \varphi(x)=\operatorname{Re}\left(\varphi\left(\mathrm{e}^{\mathrm{i} \alpha} x\right)\right)=V\left(\left(\mathrm{e}^{\mathrm{i} \alpha} x\right)\right) \leq p\left(\left(\mathrm{e}^{\mathrm{i} \alpha} x\right)\right)=p(x) .
$$

In conclusion, $\varphi$ is a $\mathbb{C}$-linear continuous extension of $\varphi_{0}$ which is bounded by $p$ as desired.

The Hahn-Banach theorem has some important corollaries.
Corollary 2.16. Let $X$ be a normed space, $Y \subseteq X$ a subspace and $\varphi_{0} \in Y^{\prime}$. Then there exists an extension $\varphi \in X^{\prime}$ of $\varphi_{0}$ such that $\|\varphi\|=\left\|\varphi_{0}\right\|$.

Proof. The map $p: X \rightarrow \mathbb{R}, p(x)=\left\|\varphi_{0}\right\|\|x\|$ is a sublinear functional on $X$ and $\left|\varphi_{0}(y)\right| \leq\left\|\varphi_{0}(y)\right\|\|y\|=p(y)$ for all $y \in Y$. By the Hahn-Banach theorem, $\varphi_{0}$ can be extended to a $\varphi \in X^{\prime}$ with $|\varphi(x)| \leq p(x)=\left\|\varphi_{0}\right\|\|x\|$, so that $\|\varphi\| \leq\left\|\varphi_{0}\right\|$. On other hand $\|\varphi\| \geq\left\|\varphi_{0}\right\|$ holds because $\varphi_{0}$ is a restriction of $\varphi$.

The next corollary shows that $X^{\prime}$ does not consist only of the trivial functional and that it separates points in $X$.
Corollary 2.17. Let $X$ be a normed space, $x \in X, x \neq 0$. Then there exists a $\varphi \in X^{\prime}$ such that $\varphi(x)=\|x\|$. In particular for all $x, y \in X$ :
(i) $x=0 \Longleftrightarrow \forall \varphi \in X^{\prime} \varphi(x)=0$,
(ii) $x \neq y \Longrightarrow \exists \varphi \in X^{\prime} \varphi(x) \neq \varphi(y)$.

Proof. Let $Y:=\operatorname{span}\{x\}$ and $\varphi_{0} \in Y^{\prime}$ defined by $\varphi_{0}(\lambda x)=\lambda\|x\|$. Then $\varphi_{0}(x)=$ $\|x\|$ and $\left\|\varphi_{0}\right\|=1$. By Corollary 2.16 there exists an extension $\varphi \in X^{\prime}$ of $\varphi_{0}$ with the desired properties. Statement (i) is clear; (ii) follows when (i) is applied to $x-y$.
Corollary 2.18. Let $X, Y$ be a normed spaces.
(i) $\|x\|=\sup \left\{\varphi(x): \varphi \in X^{\prime},\|\varphi\|=1\right\}, x \in X$.
(ii) For $T: X \rightarrow Y$ linear

$$
\|T\|=\sup \left\{\varphi(T x): x \in X,\|x\|=1, \varphi \in Y^{\prime},\|\varphi\|=1\right\}
$$

Proof. (i) For all $\varphi \in X^{\prime}$ with $\|\varphi\|=1:\|x\|=\|\varphi\|\|x\| \geq|\varphi(x)|$, hence $\|x\| \geq$ $\sup \left\{\varphi(x): \varphi \in X^{\prime},\|\varphi\|=1\right\}$. To show that in fact we have equality, we recall that formula in (i) is proved Note the the supremum is in fact a maximum. Hence the formula in (i) is proved
(ii) Let $M:=\sup \left\{\varphi(T x): x \in X,\|x\|=1, \varphi \in Y^{\prime},\|\varphi\|=1\right\}$. We have to show $M=\|T\|$. Obviously, $M=\infty$ if and only if $\|T\|=\infty$. Now assume $\|T\|<\infty$. Let $\varepsilon>0$. Then there exists an $x \in X$ with $\|x\|=1$ and $\|T x\| \geq\|T\|-\varepsilon$. Choose a $\varphi \in X^{\prime}$ such that $\|\varphi\|=1$ and $\varphi(T x)=\|T x\|$. Then $M \geq \varphi(T x)=\|T\|-\varepsilon$. Since $\varepsilon$ is arbitrary, it follows that $M \geq\|T\|$. The revers inequality follows from

$$
\varphi(T x) \leq\|\varphi\|\|T x\| \leq\|\varphi\|\|T\|\|x\|=\|T\|, \quad x \in X,\|x\|=1, \varphi \in X^{\prime},\|\varphi\|=1 . \square
$$

Corollary 2.19. Let $X$ be a normed space, $Y \subseteq X$ a closed subspace. For every $x_{0} \in X \backslash Y$ exists $\varphi \in X^{\prime}$ such that $\left.\varphi\right|_{Y}=0$ and $\varphi\left(x_{0}\right)=1$.

Proof. Let $\pi: X \rightarrow X / Y$ be the canonical projection. Then $\pi(y)=0, y \in Y$, and $\pi\left(x_{0}\right) \neq 0$. Since $X$ is a normed space by Example 1.13, there exists a $\psi \in(X / Y)^{\prime}$ such that $\varphi\left(\pi\left(x_{0}\right)\right) \neq 0$ and $\varphi\left(\pi\left(x_{0}\right)\right)=1$. Obviously $\varphi=\psi \circ \pi \in X^{\prime}$ and has the desired properties.

Corollary 2.20. Let $X$ be a normed space, $Y \subseteq X$ a subspace. Then the following are equivalent:
(i) $\bar{Y}=X$,
(ii) $\left(\left.\varphi\right|_{Y}=0 \Longrightarrow \varphi=0\right), \quad \varphi \in X^{\prime}$.

Theorem 2.21. Let $X$ be a normed space.

$$
X^{\prime} \text { separable } \Longrightarrow X \text { separable. }
$$

Proof. By Proposition 1.9 the unit sphere $S_{X^{\prime}}:=\left\{x^{\prime} \in X^{\prime}:\left\|x^{\prime}\right\|=1\right\}$ is separable. Choose dense subset $\left\{x_{n}^{\prime}: n \in \mathbb{N}\right\}$ of $S_{X^{\prime}}$. and $x_{n} \in S_{X}:=\{x \in X:\|x\|=1\}$ with $\left\|x_{n}^{\prime}\left(x_{n}\right)\right\|>\frac{1}{2}$. Let $U=\overline{\operatorname{span}\left\{x_{n}: n \in \mathbb{N}\right\}}$. We will show $U=X$. Assume this is
not true. By Corollary 2.19 there exists an $x^{\prime} \in S_{X^{\prime}}$ such that $x^{\prime} \neq 0$ and $\left.x^{\prime}\right|_{U}=0$. Let $n \in \mathbb{N}$ such that $\left\|x_{n}^{\prime}-x^{\prime}\right\|<\frac{1}{4}$. This leads to the contradiction
$\frac{1}{2} \leq\left|x_{n}^{\prime}\left(x_{n}\right)\right| \leq\left|x_{n}^{\prime}\left(x_{n}\right)-x^{\prime}\left(x_{n}\right)\right|+\left|x^{\prime}\left(x_{n}\right)\right| \leq\left\|x_{n}^{\prime}-x^{\prime}\right\|+\left|x^{\prime}\left(x_{n}\right)\right|<\frac{1}{4} . \quad \square$

### 2.3 Examples of dual spaces

Theorem 2.22. (i) Let $1 \leq p<\infty$ and $q$ such that

$$
\frac{1}{p}+\frac{1}{q}=1
$$

with the convention $\frac{1}{\infty}=0 . q$ is called the Hölder conjugate of $p$.
The following map is an isometric isomorphism:

$$
T: \ell_{q} \rightarrow\left(\ell_{p}\right)^{\prime}, \quad(T x) y=\sum_{n=0}^{\infty} x_{n} y_{n} \quad \text { for } x=\left(x_{n}\right) \in \ell_{q}, y=\left(y_{n}\right) \in \ell_{p} .
$$

(ii) The following map is an isometric isomorphism:

$$
T: \ell_{1} \rightarrow\left(c_{0}\right)^{\prime}, \quad(T x) y=\sum_{n=0}^{\infty} x_{n} y_{n} \quad \text { for } x=\left(x_{n}\right) \in \ell_{1}, y=\left(y_{n}\right) \in c_{0}
$$

Proof. (i) Let $1<p<\infty$. T is well-defined by Hölder's inequality and

$$
|(T x) y|=\left|\sum_{n=0}^{\infty} x_{n} y_{n}\right| \leq\|x\|_{q}\|y\|_{p}
$$

Linearity and injectivity of $T$ is clear. The inequality above gives

$$
\begin{equation*}
\|T x\| \leq\|x\|_{q}, \quad x \in \ell_{q} . \tag{2.7}
\end{equation*}
$$

It remains to show surjectivity of $T$ and that $\|T x\| \geq\|x\|, x \in \ell_{q}$. To this end let $y^{\prime} \in\left(\ell_{p}\right)^{\prime}$ and set $x_{n}:=y^{\prime}\left(\mathrm{e}_{n}\right), n \in \mathbb{N}$, where $\mathrm{e}_{n}$ is the $n$th unit vector in $\ell_{p}$. We will show that $x:=\left(x_{n}\right)_{n \in \mathbb{N}} \in \ell_{q}$ and that $T x=y^{\prime}$. For $y^{\prime}=0$ this is clear. Now assume that $y^{\prime} \neq 0$. For $n \in \mathbb{N}$ define

$$
t_{n}:= \begin{cases}\frac{\left|x_{n}\right|^{q}}{x_{n}}, & x_{n} \neq 0 \\ 0, & x_{n}=0\end{cases}
$$

Using $p q-p=q$ we find

$$
\sum_{n=1}^{N}\left|t_{n}\right|^{p}=\sum_{n=1}^{N}\left|x_{n}\right|^{\mid(q-1)}, \quad N \in \mathbb{N} .
$$

Hence, for all $N \in \mathbb{N}$,

$$
\begin{aligned}
\sum_{n=1}^{N}\left|x_{n}\right|^{q} & =\sum_{n=1}^{N} x_{n} t_{n}=\sum_{n=1}^{N} t_{n} y^{\prime}\left(\mathrm{e}_{n}\right)=y^{\prime}\left(\sum_{n=1}^{N} t_{n} \mathrm{e}_{n}\right) \leq\left\|y^{\prime}\right\|\left\|\sum_{n=1}^{N} t_{n} \mathrm{e}_{n}\right\|_{p} \\
& =\left\|y^{\prime}\right\|\left(\sum_{n=1}^{N}\left|t_{n}\right|^{p}\right)^{\frac{1}{p}} \leq\left\|y^{\prime}\right\|\left(\sum_{n=1}^{N}\left|x_{n}\right|^{q}\right)^{\frac{1}{p}} .
\end{aligned}
$$

For $N$ large enough, the last factor in the line above is not zero, so, using $1-\frac{1}{p}=\frac{1}{q}$, we obtain

$$
\left(\sum_{n=1}^{N}\left|x_{n}\right|^{q}\right)^{\frac{1}{q}} \leq\left\|y^{\prime}\right\|
$$

implying that $x \in \ell_{q}$. Since $(T x) \mathrm{e}_{n}=x_{n} \mathrm{e}_{n}=y^{\prime} \mathrm{e}_{n}, n \in \mathbb{N}$, and $\left\{\mathrm{e}_{n}: n \in \mathbb{N}\right\}$ a implying that $x \in \ell_{q}$. Since $\left(T x \mathrm{e}_{n}=x_{n} \mathrm{e}_{n}=y^{\prime} \mathrm{e}_{n}, n \in \mathbb{N}\right.$, and $\left\{\mathrm{e}_{n}: n \in \mathbb{N}\right\}$ a
total subset of $\ell_{p}$, it follows that $T x=y^{\prime}$. In particular, with the inequality above, $\|x\|_{q} \leq\left\|y^{\prime}\right\|=\|T x\|$. Together with (2.7) it follows that $\|T x\|=\|x\|$, that is, $T$ is $\|x\|_{q} \leq\left\|y^{\prime}\right\|=$
an isometry.
The proof for $p=1$ is similar
(ii) Well-definedness and injectivity of $T$ are clear. Moreover $\|T x\| \leq\|x\|_{1}$ for every $x \in \ell_{1}$ because

$$
\left|\sum_{n=0}^{\infty} x_{n} y_{n}\right| \leq\|y\|_{\infty} \sum_{n=0}^{\infty}\left|x_{n}\right|=\|y\|_{\infty}\|x\|_{1}, \quad y \in c_{0}, x \in \ell_{1} .
$$

To show that $T$ is surjective, let $y^{\prime} \in\left(c_{0}\right)^{\prime}$ and let $x_{n}:=y_{n}\left(\mathrm{e}_{n}\right)$ where $\mathrm{e}_{n}$ is the $n$th unit vector in $c_{0}$. For $n \in \mathbb{N}$ choose $\alpha_{n} \in \mathbb{R}$ such that $\left|y^{\prime}\left(e_{n}\right)\right|=\exp \left(\mathrm{i} \alpha_{n}\right) y^{\prime}\left(e_{n}\right)$. It follows that

$$
\begin{aligned}
\sum_{n=0}^{\infty}\left|x_{n}\right| & =\sum_{n=0}^{\infty}\left|y^{\prime}\left(\mathrm{e}_{n}\right)\right|=\sum_{n=0}^{\infty} \exp \left(\mathrm{i} \alpha_{n}\right) y^{\prime}\left(\mathrm{e}_{n}\right)=y^{\prime}\left(\sum_{n=0}^{\infty} \exp \left(\mathrm{i} \alpha_{n}\right) \mathrm{e}_{n}\right) \\
& \leq\left\|y^{\prime}\right\|\left\|\sum_{n=0}^{\infty} \exp \left(\mathrm{i} \alpha_{n}\right) \mathrm{e}_{n}\right\|_{\infty}=\left\|y^{\prime}\right\| .
\end{aligned}
$$

Hence $x \in \ell_{1}$ and $\|x\|_{1} \leq\left\|y^{\prime}\right\|$. As before, since $\left\{\mathrm{e}_{n}: n \in \mathbb{N}\right\}$ is a total subset of $c_{0}$ it follows that $T x=y^{\prime}$ and the proof is complete. (Note however, that $\left\{\mathrm{e}_{n}: n \in \mathbb{N}\right\}$ is not dense in $\ell_{\infty}$.)
The theorem above shows that

$$
\begin{aligned}
& \left(\ell_{p}\right)^{\prime} \cong \ell_{q}, \quad 1 \leq p<\infty \\
& \left(c_{0}\right)^{\prime} \cong \ell_{1} .
\end{aligned}
$$

Remark. Note that $\left(\ell_{\infty}\right)^{\prime} \not \equiv \ell_{1}$. To see this, assume that $\left(\ell_{\infty}\right)^{\prime} \cong \ell_{1}$. Since $\ell_{1}$ is separable, Theorem 2.21 would imply that also $\ell_{\infty}$ is separable, in contradiction to Example 1.26 .

Other important examples are given without proof in the following theorems.
Theorem 2.23. Let $(\Omega, \Sigma, \mu)$ be a $\sigma$-finite measure space. Let $1 \leq p<\infty$ and $q$ such that $\frac{1}{p}+\frac{1}{q}=1$. Then

$$
T: \mathscr{L}_{q}(\Omega) \rightarrow\left(\mathscr{L}_{p}(\Omega)\right)^{\prime}, \quad(T f)(g)=\int_{\Omega} f \bar{g} \mathrm{~d} \mu, \quad f \in \mathscr{L}_{q}(\Omega), g \in \mathscr{L}_{p}(\Omega)
$$

is an isometric isometry.
Theorem 2.24 (Riesz's representation theorem). Let $K$ be a compact metric space and $M(K)$ the set of all regular Borel measures with finite variation, that is $\|\mu\|<\infty$ with
$\|\mu\|:=\sup \left\{\sum_{V \in \mathcal{Z}}|\mu(V)|: \mathcal{Z}\right.$ partition of $\mathcal{K}$ in pairwise disjoint measurable sets $\}$

Let $1 \leq p<\infty$ and $q$ such that $\frac{1}{p}+\frac{1}{q}=1$. Then

$$
T: M(K) \rightarrow(C(K))^{\prime}, \quad(T \mu)(g)=\int_{\Omega} g \mathrm{~d} \mu, \quad \mu \in M(K), g \in C(K)
$$

is an isometric isometry.
For a proof, see [Rud87, Theorem 6.19].
The theorems above show that

$$
\begin{aligned}
&\left(\mathscr{L}_{p}\right)^{\prime} \cong \mathscr{L}_{q}, \quad 1 \leq p<\infty, \\
&(C(K))^{\prime} \cong M(K) . \\
&
\end{aligned}
$$

### 2.4 The Banach space adjoint and the bidual

Definition 2.25. Let $X, Y$ be normed spaces and $T \in L(X, Y)$. The Banach space adjoint of $T$ is

$$
T^{\prime}: Y^{\prime} \rightarrow X^{\prime}, \quad\left(T^{\prime} y^{\prime}\right) x:=y^{\prime}(T x), \quad y^{\prime} \in Y^{\prime}, x \in X .
$$

Obviously, $T^{\prime}$ is linear and continuous as composition of continuous functions, hence $T^{\prime} \in L\left(Y^{\prime}, X^{\prime}\right)$ and the following diagram commutes


## Theorem 2.26. Let $X, Y, Z$ be normed spaces.

(i) The map $L(X, Y) \rightarrow L\left(Y^{\prime}, X^{\prime}\right), T \mapsto T^{\prime}$, is linear and isometric, that is, $\left\|T^{\prime}\right\|=\|T\|$. In general, it is not surjective.
(ii) $(S T)^{\prime}=T^{\prime} S^{\prime}$ for $S \in L(Y, Z)$ and $T \in L(X, Y)$.

Proof. (i) Linearity of $T \mapsto T^{\prime}$ is clear. Immediately by the definition of $T^{\prime}$ we have that

$$
\left\|T^{\prime} y^{\prime}\right\|=\left\|y^{\prime} \circ T\right\| \leq\left\|y^{\prime}\right\|\|T\|, \quad y^{\prime} \in Y^{\prime}
$$

hence $\left\|T^{\prime}\right\| \leq\|T\|$. By Corollary $2.18\|T\|$ is

$$
\|T\|=\sup \left\{y^{\prime}(T x): x \in X,\|x\|=1, y^{\prime} \in Y^{\prime},\left\|y^{\prime}\right\|=1\right\} .
$$

For every $\varepsilon>0$ there exist $x \in X,\|x\|=1, y^{\prime} \in Y^{\prime}$ such that $\|T\|-\varepsilon<y^{\prime}(T x)=$ $\left(T^{\prime} y^{\prime}\right)(x) \leq\left\|T^{\prime}\right\|\left\|y^{\prime}\right\|\|x\|=\left\|T^{\prime}\right\|$, so $\|T\| \leq\left\|T^{\prime}\right\|$.
(ii) For all $z^{\prime} \in Z^{\prime}$ and $x \in X$ we have $\left((S T)^{\prime} z^{\prime}\right)(x)=z^{\prime}(S T(x))=z^{\prime}(S(T x))=$
$\left(S^{\prime} z^{\prime}\right)(T x)=T^{\prime}\left(S^{\prime} z^{\prime}\right) x=\left(T^{\prime} S^{\prime}\right)\left(z^{\prime}\right)(x)$, hence $(S T)^{\prime}=T^{\prime} S^{\prime}$.

Example 2.27. Let $1 \leq p<\infty$. The adjoint of the left shift

$$
L: \ell_{p} \rightarrow \ell_{p}, \quad L\left(x_{1}, x_{2}, x_{3}, \ldots\right)=\left(x_{2}, x_{3}, \ldots\right)
$$

is the right shift.

Proof. Let $\frac{1}{p}+\frac{1}{q}=1$ and $y=\left(y_{n}\right)_{n \in \mathbb{N}} \in l_{q} \cong\left(l_{p}\right)^{\prime}$. Then for all $x=\left(x_{n}\right)_{n \in \mathbb{N}} \in l_{p}$ :

$$
\begin{align*}
\left(L^{\prime} y\right) x & =y(L x)=\sum_{n=1}^{\infty} y_{n}(L x)_{n}=\sum_{n=1}^{\infty} y_{n} x_{n+1}=\sum_{n=2}^{\infty} y_{n-1} x_{n}=\sum_{n=2}^{\infty}(R y)_{n} x_{n} \\
& =\sum_{n=1}^{\infty}(R y)_{n} x_{n}=(R y) x .
\end{align*}
$$

Definition 2.28. Let $X$ be a normed space. $X^{\prime \prime}:=\left(X^{\prime}\right)^{\prime}$ is the bidual of $X$.
For every $x \in X$ the linear map

$$
J_{X}(x): X^{\prime} \rightarrow \mathbb{K}, \quad J_{X}(x) x^{\prime}:=x^{\prime} x
$$

is linear and bounded by $\|x\|$, hence $J_{X}(x) \in X^{\prime \prime}$.
Theorem 2.29. The map

$$
J_{X}: X \rightarrow X^{\prime \prime}, \quad J_{X}(x) x^{\prime}=x^{\prime} x, \quad x^{\prime} \in X^{\prime}
$$

is a linear isometry. In general, it is not surjective.
Proof. We have seen above that $J_{X}$ is well-defined, linear and $\left\|J_{X}(x)\right\| \leq\|x\|$, $x \in X$. Now let $x \in X$ and choose $\varphi_{x} \in X^{\prime}$ such that $\varphi_{x}(x)=\|x\|$ (Corollary 2.17). It follows that $\left\|J_{X}(x) \varphi_{x}\right\|=\left|\varphi_{x}(x)\right|=\|x\|$, hence $\left\|J_{X}(x)\right\| \geq 1$.
The preceding theorem gives another easy proof that every normed space $X$ can be completed (see Theorem 1.7).

Corollary 2.30. Every normed space is isometrically isomorphic to a dense subspace of a Banach space.
Proof. By the theorem above, $X$ is isometrically isomorphic to $J_{X}(X) \subseteq X^{\prime \prime}$. Since $X^{\prime \prime}$ is complete (Theorem 2.6), the closure $\overline{J_{X}(X)}$ is a Banach space.
Definition 2.31. A Banach space is called reflexive if $J_{X}$ is surjective.
Examples 2.32. (i) Every finite-dimensional normed space is reflexive.
(ii) $\ell_{p}$ is reflexive for $1<p<\infty$ by Theorem 2.22.
(iii) $c_{0}$ and $\ell_{1}$ are not reflexive.

Note that there are non-reflexive Banach spaces $X$ such that $X \cong X^{\prime \prime}$ (but $J_{X}$ is not surjective).

Lemma 2.33. Let $X, Y$ be normed spaces and $T \in L(X, Y)$. Then $T^{\prime \prime} \circ J_{X}=J_{Y} \circ T$, that is, the following diagram commutes:


Proof. For $x \in X$ and $y^{\prime} \in Y^{\prime}$
$\left[T^{\prime \prime}\left(J_{X}(x)\right)\right]\left(y^{\prime}\right)=\left(J_{X}(x)\right)\left(T^{\prime} y^{\prime}\right)=T^{\prime} y^{\prime} x=y^{\prime}(T x)=\left(J_{Y}(T x)\right) y^{\prime}=\left[\left(J_{Y} \circ T\right)(x)\right] y^{\prime}$.

If $X$ and $Y$ are identified with subspaces of $X^{\prime \prime}$ and $Y^{\prime \prime}$ via the canonical maps
$J_{X}$ and $J_{Y}$, then $T^{\prime \prime}$ is an extension of $T$. Note that with this identification $S \in$ $J_{X}$ and $J_{Y}$, then $T^{\prime \prime}$ is an extension of $T$. Note that with this identification $S \in$ $L\left(Y^{\prime}, X^{\prime}\right)$ is adjoint operator of some $T \in L(X, Y)$ if and only if $S^{\prime}(X) \subseteq Y$.
Lemma 2.34. Let $X$ be a normed space. Then $J_{X}^{\prime} \circ J_{X^{\prime}}=\mathrm{id}_{X^{\prime}}$.
Proof. Note that $J_{X^{\prime}}: X^{\prime} \rightarrow X^{\prime \prime \prime}$ and $J_{X}^{\prime}: X^{\prime \prime \prime} \rightarrow X^{\prime}$. For $x \in X, x^{\prime} \in X^{\prime}$

$$
\left[\left(J_{X}^{\prime} \circ J_{X^{\prime}}\right) x^{\prime}\right](x)=\left[J_{X^{\prime}} x^{\prime}\right]\left(J_{X}(x)\right)=\left[J_{X} x\right] x^{\prime}=x^{\prime} x .
$$

Theorem 2.35. (i) Every closed subspace of a reflexive normed space is reflexive.
(ii) A Banach space $X$ is reflexive if and only if $X^{\prime}$ is reflexive.

Proof. (i) Let $U$ be a closed subspace of a reflexive normed space $X$ and let $u^{\prime \prime} \in U^{\prime \prime}$. We have to find a $u \in U$ such that $J_{X}(u)=u^{\prime \prime}$. Let $x_{0}^{\prime \prime}: X^{\prime} \rightarrow K, x_{0}^{\prime \prime}\left(x^{\prime}\right)=$ $u^{\prime \prime}\left(\left.x^{\prime}\right|_{U}\right)$. Obviously, $x_{0}^{\prime \prime}$ is linear and bounded because

$$
\left|x_{0}^{\prime \prime}\left(x^{\prime}\right)\right|=\left|u^{\prime \prime}\left(\left.x^{\prime}\right|_{U}\right)\right| \leq\left\|u^{\prime \prime}\right\|\left\|\left.x^{\prime}\right|_{U}\right\| \leq\left\|u^{\prime \prime}\right\|\left\|x^{\prime}\right\|
$$

hence $x_{0}^{\prime \prime} \in X^{\prime \prime}$. Since $X$ is reflexive there exists an $x_{0} \in X$ such that $J_{X}\left(x_{0}\right)=x_{0}^{\prime \prime}$. Assume that $x_{0} \notin U$. Since $U$ is closed, there exists a $\varphi \in X^{\prime}$ such that $\left.\varphi\right|_{U}=0$ and $\varphi\left(x_{0}\right)=1$ (Corollary 2.19). On the other hand $\varphi\left(x_{0}\right)=0$ by choice of $x_{0}$ because

$$
x^{\prime}\left(x_{0}\right)=x_{0}^{\prime \prime}\left(x^{\prime}\right)=J_{X}\left(x_{0}\right) x^{\prime}=u^{\prime \prime}\left(\left.x^{\prime}\right|_{U}\right), \quad x^{\prime} \in X^{\prime}
$$

Therefore $x_{0} \in U$. It remains to be shown that $J_{U}\left(x_{0}\right)=u^{\prime \prime}$, that is

$$
u^{\prime \prime}\left(u^{\prime}\right)=u^{\prime}\left(x_{0}\right), \quad u^{\prime} \in U^{\prime}
$$

Let $u^{\prime} \in U^{\prime}$ and choose an arbitrary extension $\varphi \in X^{\prime}$ (Corollary 2.16). By definition of $x_{0}$ it follows that

$$
u^{\prime \prime}\left(u^{\prime}\right)=u^{\prime \prime}\left(\left.\varphi\right|_{U}\right)=x_{0}^{\prime \prime}(\varphi)=\varphi\left(x_{0}\right)=u^{\prime}\left(x_{0}\right) .
$$

(ii) Let $X$ be reflexive. We have to show that $J_{X^{\prime}}: X^{\prime} \rightarrow X^{\prime \prime \prime}$ is surjective. Let $x_{0}^{\prime \prime \prime} \in X^{\prime \prime \prime}$. The map $x_{0}^{\prime}: X \rightarrow \mathbb{K}, x_{0}^{\prime}(x)=x_{0}^{\prime \prime \prime}\left(J_{X}(x)\right)$ is linear and bounded, hence $x_{0}^{\prime} \in X^{\prime}$. We will show that $J_{X^{\prime}}\left(x_{0}^{\prime}\right)=x_{0}^{\prime \prime \prime}$. Let $x^{\prime \prime} \in X^{\prime \prime}$. Since $X$ is reflexive there exists an $x \in X$ such that $J_{X}(x)=x^{\prime \prime}$. Therefore

$$
J_{X^{\prime}}\left(x_{0}^{\prime}\right) x^{\prime \prime}=x^{\prime \prime}\left(x_{0}^{\prime}\right)=J_{X}(x)\left(x_{0}^{\prime}\right)=x_{0}^{\prime} x=x_{0}^{\prime \prime \prime}\left(J_{X}(x)\right)=x_{0}^{\prime \prime \prime}\left(x^{\prime \prime}\right),
$$

hence indeed $J_{X^{\prime}}\left(x_{0}^{\prime}\right)=x_{0}^{\prime \prime \prime}$.
Now assume that $X^{\prime}$ is reflexive. By what was is already proved, $X^{\prime \prime}$ is reflexive. Since $X$ is a closed subspace of $X^{\prime \prime}$ via the canonical map $J_{X}, X$ is reflexive by part (i) of the theorem.

Corollary 2.36. A reflexive normed space $X$ is separable if and only if $X^{\prime}$ is separable.
Proof. That separability of $X^{\prime}$ implies separability of $X$ was shown in Theorem 2.21. If $X$ is separable and reflexive, then also $X^{\prime \prime}$ is separable. By Theorem $2.35 X^{\prime}$ is reflexive, so we can again apply Theorem 2.21 to obtain that $X^{\prime}$ is separable. $\square$

Definition 2.37. Let $X$ be a normed space. A sequence $\left(x_{n}\right)_{n \in \mathbb{N}}$ converges weakly to $x_{0} \in X$ if and only if

$$
\lim _{n \rightarrow \infty} x^{\prime}\left(x_{n}\right)=x^{\prime}\left(x_{0}\right), \quad x^{\prime} \in X^{\prime}
$$

Notation: $x_{n} \xrightarrow{w} x$ or $w_{n \rightarrow \infty} \lim _{n \rightarrow \infty} x_{n}=x$.
If it should be emphasised that a sequence converges with respect to the norm in the given Banach space, then the sequence is called norm convergent. Sometimes the notion strongly convergent is used. Note, however, that in spaces of linear operators the term "strong convergence" has another meaning (see Defintion 3.12).
The next remark shows that strong convergence is indeed stronger than weak con-
vergence. vergence.
Remarks 2.38. (i) If the weak limit of a sequence exists, then it is unique, because, by the Hahn-Banach theorem, the dual space separates points (Corollary 2.17). (ii) Every convergent sequence is weakly convergent with the same limit.
(iii) A weakly convergent sequence is not necessarily convergent. Consider for example the sequence of the unit vectors $\left(\mathrm{e}_{n}\right)_{n \in \mathbb{N}}$ in $c_{0}$. Let $\varphi \in c_{0}^{\prime} \cong \ell_{1}$. Then $\lim _{n \in \mathbb{N}} \varphi\left(\mathrm{e}_{n}\right)=0$ but the sequence of the unit vectors does not converge in norm.

Example 2.39. Let $\left(x_{n}\right)_{n \in \mathbb{N}}$ be a bounded sequence in $C([0,1])$. Then the following is equivalent:
(i) $\left(x_{n}\right)_{n \in \mathbb{N}}$ converges weakly to $y \in C[(0,1)]$.
(ii) $\left(x_{n}\right)_{n \in \mathbb{N}}$ converges pointwise to $y \in C[(0,1)]$.

Proof. "(i) $\Longrightarrow$ (ii)" It is easy to see that for every $t_{0} \in[0,1]$ the point evaluation $x \mapsto x\left(t_{0}\right)$ is a bounded linear functional. Hence for all $t \in[0,1]$ the sequence $\left(x_{n}(t)_{n \in \mathbb{N}}\right.$ converges to some $y(t)$. By assumption, $[0,1] \rightarrow \mathbb{K}, t \mapsto y(t)$ belongs to $C([0,1])$.
"(ii) $\Longrightarrow$ (i)" follows from Riesz's representation theorem (Theorem 2.24) and the Lebesgue convergence theorem (see ??)

Theorem 2.40. Every bounded sequence in a reflexive normed space contains a weakly convergent subsequence.

Proof. Let $X$ be a reflexive normed space and $x=\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq X$ be a bounded sequence.
First we assume that $X$ is separable. By theorem 2.36, also $X^{\prime}$ is separable. Let $\left\{\varphi_{n}: n \in \mathbb{N}\right\}$ be a dense subset of $X^{\prime}$. We will construct a subsequence $y=\left(y_{n}\right)_{n \in \mathbb{N}}$ of $x$ such that for every $j \in \mathbb{N}$ the sequence $\left(\varphi_{j}\left(y_{n}\right)\right)_{n \in \mathbb{N}}$ converges. The sequence $\left(\varphi_{1}\left(x_{n}\right)\right)_{n \in \mathbb{N}}$ is bounded, so it contains a convergent subsequence

$$
\left(\varphi_{1}\left(x_{n_{1}, 1}\right), \varphi_{1}\left(x_{n_{1}, 2}\right), \varphi_{1}\left(x_{n_{1}, 3}\right), \ldots\right)
$$

Now the sequence $\left(\varphi_{2}\left(x_{n_{1}, j}\right)\right)_{j \in \mathbb{N}}$ is bounded, so it contains a convergent subsequence

$$
\left(\varphi_{2}\left(x_{n_{2}, 1}\right), \varphi_{2}\left(x_{n_{2}, 2}\right), \varphi_{2}\left(x_{n_{2}, 3}\right), \ldots\right)
$$

Continuing like this, we obtain a sequence of subsequences $x_{n_{m}}=\left(x_{n_{m}, j}\right)_{j \in \mathbb{N}}, m \in \mathbb{N}$ such that $\left(\varphi_{m}\left(x_{n_{m}, j}\right)\right)_{j \in \mathbb{N}}$ converges. Now the "diagonal sequence" $y$ with $y_{m}:=$ $x_{n_{m}, m}$ has the desired property.

Now we will show that $y$ is weakly convergent. Let $x^{\prime} \in X^{\prime}$ and $\varepsilon>0$. Choose an $k \in \mathbb{N}$ such that $\left\|x^{\prime}-\varphi_{k}\right\|<\frac{\varepsilon}{4 M}$ where $M:=\sup \left\{\left\|x_{n}\right\|: n \in \mathbb{N}\right\}<\infty$. Let $N \in \mathbb{N}$ such that $\left|\varphi_{k}\left(y_{n}\right)-\varphi_{k}\left(y_{m}\right)\right|<\frac{\varepsilon}{2}, m, n \geq N$. It follows for $m, n \geq N$ :

$$
\begin{aligned}
\left|x^{\prime}\left(y_{n}\right)-x^{\prime}\left(y_{m}\right)\right| & \leq\left|x^{\prime}\left(y_{n}\right)-\varphi_{k}\left(y_{n}\right)\right|+\left|\varphi_{k}\left(y_{n}\right)-\varphi_{k}\left(y_{m}\right)\right|+\left|\varphi_{k}\left(y_{m}\right)-x^{\prime}\left(y_{m}\right)\right| \\
& \leq 2 M\left\|x^{\prime}-\varphi_{k}\right\|+\left|\varphi_{k}\left(y_{n}\right)-\varphi_{k}\left(y_{m}\right)\right|
\end{aligned}
$$

$$
<\frac{\varepsilon}{2}+\frac{\varepsilon}{2}=\varepsilon .
$$

This implies that $\left(x^{\prime}\left(y_{n}\right)\right)_{n \in \mathbb{N}}$ is a Cauchy sequence in $\mathbb{K}$, hence it converges. To show that $\left(y_{n}\right)_{n \in \mathbb{N}}$ converges weakly, define the map

$$
\psi: X^{\prime} \rightarrow \mathbb{K}, \quad \psi\left(x^{\prime}\right)=\lim _{n \rightarrow \infty} x^{\prime}\left(y_{n}\right)
$$

By what is already shown, $\psi$ is well-defined and linear. It is also bounded because

$$
\left|\psi\left(x^{\prime}\right)\right|=\left|\lim _{n \rightarrow \infty} x^{\prime}\left(y_{n}\right)\right|=\lim _{n \rightarrow \infty}\left|x^{\prime}\left(y_{n}\right)\right| \leq \lim _{n \rightarrow \infty}\left\|x^{\prime}\right\|\left\|\left(y_{n}\right)\right\| \leq M\left\|x^{\prime}\right\|
$$

Hence $\psi \in X^{\prime \prime}$. Since $X$ is reflexive, there exists a $y_{0} \in X$ such that $x^{\prime}\left(y_{0}\right)=$ $\psi\left(x^{\prime}\right)=\lim _{n \rightarrow \infty} x^{\prime}\left(y_{n}\right)$. Hence $\left(y_{n}\right)_{n \in \mathbb{N}}$ converges weakly to $y_{0}$.
Now assume that $X$ is not separable. Let $Y:=\overline{\operatorname{span}\left\{x_{n}: n \in \mathbb{N}\right\}}$ where $\left(x_{n}\right)_{n \in \mathbb{N}}$ is the bounded sequence in $X$ chosen at the beginning of the proof. $Y$ is separable (Theorem 1.25) and reflexive (Theorem 2.35). Hence, by the first step of the proof, there exists a subsequence $\left(y_{n}\right)_{n \in \mathbb{N}} \subseteq Y$ of $\left(x_{n}\right)_{n \in \mathbb{N}}$ and a $y_{0}$ such that $y_{n} \xrightarrow{w} y_{0}$ in $Y$. Let $x^{\prime} \in X^{\prime}$. Then $\left.x^{\prime}\right|_{Y^{\prime}} \in Y^{\prime}$, hence $\lim _{n \rightarrow \infty} x^{\prime}\left(y_{n}\right)=\left.\lim _{n \rightarrow \infty} x^{\prime}\right|_{Y^{\prime}}\left(y_{n}\right)=\left.x^{\prime}\right|_{Y^{\prime}}\left(y_{0}\right)=$ $x^{\prime}\left(y_{0}\right)$. Therefore we also have $y_{n} \xrightarrow{w} y_{0}$ in $X$.

## Definition 3.2. Let $(X, d)$ be a metric space

- $A \subseteq X$ is called nowhere dense in $X$, if $\bar{A}$ does not contain an open set.
- $A \subseteq X$ is of first category if it is the countable union of nowhere dense sets.
- $A \subseteq X$ is of second category if it is not of first category.

Note that $A$ is nowhere dense if and only if $X \backslash \bar{A}$ is dense in $X$.
An equivalent formulation of
Theorem 3.3 (Baire's category theorem). A complete metric space is of second category in itself.

Examples 3.4. $\mathbb{Q}$ is of first category in $\mathbb{R} . \mathbb{R}$ is of second category in $\mathbb{R}$.

### 3.2 Uniform boundedness principle

Definition 3.5. Let $(X, d)$ be a metric space. A family $\mathcal{F}=\left(f_{\lambda}\right)_{\lambda \in \Lambda}$ of maps $X \rightarrow \mathbb{R}$ is called uniformly bounded if there exists an $M \in \mathbb{R}$ such that

$$
\left|f_{\lambda}(x)\right| \leq M, \quad x \in X, \lambda \in \Lambda
$$

The next theorem shows that a family of pointwise bounded continuous functions on a complete metric space is necessarily uniformly continuous on a certain ball.

Theorem 3.6 (Uniform boundedness principle). Let $X$ be a complete metric space, $Y$ a normed space and $\mathcal{F} \subseteq C(X, Y)$ a family of continuous functions which is pointwise bounded, i.e.,

$$
\forall x \in X \quad \exists C_{x} \geq 0 \quad \forall f \in \mathcal{F} \quad\|f(x)\|<C_{x} .
$$

Then there exists an $M \in \mathbb{R}, x_{0} \in X$ and $r>0$ such that

$$
\begin{equation*}
\forall x \in B_{r}\left(x_{0}\right) \quad \forall f \in \mathcal{F} \quad\|f(x)\|<M . \tag{3.2}
\end{equation*}
$$

Proof. For $n \in \mathbb{N}$ let

$$
A_{n}:=\bigcap_{f \in \mathcal{F}}\{x \in X:\|f(x)\| \leq n\} .
$$

Note that for every $n \in \mathbb{N}$ the set $\{x \in X:\|f(x)\| \leq n\}$ is closed because $f$ and $\|\cdot\|$ Note thatinuous. Since all $A_{n}$ are intersections of closed sets, they are closed $\|$ are continuous. Since all $A_{n}$ are intersections of closed sets, they are closed. Let
$x \in X$. Since $\mathcal{F}$ is pointwise bounded, there exists an $n_{x} \in \mathbb{N}$ such that $x \in A_{n_{x}}$, $x \in X$. Since $\mathcal{F}$ is pointwise bounded, there exists an $n_{x} \in \mathbb{N}$ such that $x \in A_{n_{x}}$,
hence $X \subseteq \cup_{n \in \mathbb{N}} A_{n}$. By Baire's theorem exists an $N \in \mathbb{N}, x_{0} \in X, r>0$ such that $B_{r}\left(x_{0}\right) \subseteq A_{N}$, that is, (3.2) is satisfied with $M=N$.
The Banach-Steinhaus theorem is obtained in the special case of linear bounded functions.
Theorem 3.7 (Banach-Steinhaus theorem). Let $X$ be a Banach space, $Y$ a normed space and $\mathcal{F} \subseteq L(X, Y)$ a family of continuous linear functions which is pointwise bounded, i.e.,

$$
\forall x \in X \quad \exists C_{x} \geq 0 \quad \forall f \in \mathcal{F} \quad\|f(x)\|<C_{x} .
$$

Then there exists an $M \in \mathbb{R}$ such that

$$
\|f\|<M, \quad f \in \mathcal{F} .
$$

Proof. By the uniform boundedness principle there exists an open ball $B_{r}\left(x_{0}\right) \subseteq X$ and an $M^{\prime} \in \mathbb{R}$ such that $\|f(x)\|<M^{\prime}$ for all $x \in B_{r}\left(x_{0}\right)$ and $f \in \mathcal{F}$. For $x \in X$ with $\|x\|=1$ and $f \in \mathcal{F}$ we find

$$
\begin{aligned}
\|f(x)\| & =\frac{1}{r}\|f(r x)\|=\frac{1}{r}\left\|f\left(x_{0}\right)-f\left(x_{0}-r x\right)\right\| \\
& \leq \frac{1}{r}(\left\|f\left(x_{0}\right)\right\|+\|f(\underbrace{x_{0}-r x}_{\in B_{r}\left(x_{0}\right)})\|) \leq \frac{2 M^{\prime}}{r}=: M
\end{aligned}
$$

showing that $\mathcal{F}$ is uniformly bounded by $M$.
Corollary 3.8. Let $X$ be a normed space and $A \subseteq X$. Then the following are equivalent:
(i) $A$ is bounded.
(ii) For every $x^{\prime} \in X^{\prime}$ the set $\left\{x^{\prime}(a): a \in A\right\}$ is bounded.

Proof. " $(\mathrm{i}) \Longrightarrow$ (ii)" is clear.
"(ii) $\Longrightarrow$ (i)" The family $\left(J_{X}(a)\right)_{a \in A} \subseteq X^{\prime \prime}$ is pointwise bounded by assumption. By the Banach-Steinhaus theorem there exists a $M \in \mathbb{R}$ such that

$$
\|a\|=\left\|J_{X}(a)\right\| \leq M, \quad a \in A
$$

Hence $A$ is bounded.
Corollary 3.9. Every weakly convergent sequence in a normed space is bounded.
Proof. Let $X$ be a normed space and $\left(x_{n}\right)_{n \in \mathbb{N}}$ be a weakly convergent sequence in $X$. By hypothesis, for every $x^{\prime} \in X^{\prime}$ the set $\left\{x^{\prime}\left(x_{n}\right): n \in \mathbb{N}\right\}$ is bounded. Therefore by Corollary 3.8 , the set $\left\{x_{n}: n \in \mathbb{N}\right\}$ is bounded.

The following theorem follows directly from Theorem 2.40 and Corollary 3.9.
Theorem 3.10. Let $(X,\|\cdot\|)$ be a normed space, $\left(x_{n}\right)_{n \in \mathbb{N}}$ and $x_{0} \in X$. Then the following is equivalent:
(i) $x_{0}=w-\lim _{n \rightarrow \infty} x_{n}$.
(ii) $\left(x_{n}\right)_{n \in \mathbb{N}}$ is bounded and there exists a total subset $M^{\prime} \subseteq X^{\prime}$ such that

$$
\lim _{n \rightarrow \infty} f\left(x_{n}\right)=f\left(x_{0}\right), \quad f \in M^{\prime} .
$$

Corollary 3.11. Let $X$ be Banach space and $A^{\prime} \subseteq X^{\prime}$. Then the following is equivalent:
(i) $A^{\prime}$ is bounded.
(ii) For all $x \in X$ the set $\left\{a^{\prime}(x): a^{\prime} \in A^{\prime}\right\}$ is bounded.

Proof. The implication "(i) $\Longrightarrow$ (ii)" is clear. The other direction follows directly from the Banach-Steinhaus theorem.

Note that for "(ii) $\Longrightarrow$ (i)" the assumption that $X$ is a Banach space is necessary For example, let $d=\left\{x=\left(x_{n}\right)_{n \in \mathbb{N}}: x_{n} \neq 0\right.$ for at most finitely many $\left.n\right\} \subseteq \ell_{\infty}$ $d$ is a non-complete normed space (see Example $1.15(5)$ ). For $m \in \mathbb{N}$ define the linear function $\varphi_{m}: d \rightarrow \mathbb{K}$ by $\varphi_{m}\left(\mathrm{e}_{n}\right)=m \delta_{m, n}$ where $\delta_{m, n}$ is the Kronecker delta. Obviously $\varphi_{m} \in d^{\prime}$ and $\left\|\varphi_{m}\right\|=m$, hence the family $\left(\varphi_{m}\right)$ is not bounded in $d^{\prime}$, but for every fixed $x \in d$ the set $\left\{\varphi_{m}(x): m \in M\right\}$ is.

Definition 3.12. Let $X, Y$ be normed spaces, $\left(T_{n}\right)_{n \in \mathbb{N}} \in L(X, Y)$ a sequence of bounded linear operators and $T \in L(X, Y)$.
(i) $\left(T_{n}\right)_{n \in \mathbb{N}}$ converges to $T$, denoted by $\lim _{n \rightarrow \infty} T_{n}=T$, if and only if

$$
\lim _{n \rightarrow \infty}\left\|T_{n}-T\right\|=0
$$

(ii) $\left(T_{n}\right)_{n \in \mathbb{N}}$ converges strongly to $T$, denoted by $s-\lim _{n \rightarrow \infty} T_{n}=T$ or $T_{n} \xrightarrow{s} T$, if and only if

$$
\lim _{n \rightarrow \infty}\left\|T_{n} x-T x\right\|=0, \quad x \in X
$$

(iii) $\left(T_{n}\right)_{n \in \mathbb{N}}$ converges weakly to $T$, denoted by $w_{n \rightarrow \infty} \lim _{n \rightarrow \infty} T_{n}=T$ or $T_{n} \xrightarrow{w} T$, if and only if

$$
\lim _{n \rightarrow \infty}\left|\varphi\left(T_{n} x\right)-\varphi(T x)\right|=0, \quad x \in X, \varphi \in Y^{\prime}
$$

Remark. (i) The limits are unique if they exist
(ii) Convergence in norm implies strong convergence and the limits are equal Strong convergence implies weak convergence and the limits are equal.
The reverse implications are not true:

- Let $X=\ell_{2}(\mathbb{N}), T_{n}: X \rightarrow X, T_{n} x=\left(x_{1}, \ldots, x_{n}, 0, \ldots\right)$ for $x=\left(x_{m}\right)_{m \in \mathbb{N}}$. Then $T$ converges strongly to id but $\left\|T_{n}-\mathrm{id}\right\|=1$ for all $n \in \mathbb{N}$, so that $\left(T_{n}\right)_{n \in \mathbb{N}}$ does not converge to id in norm.
- Let $X=\ell_{2}(\mathbb{N}), T_{n}: X \rightarrow X, T_{n} x=\left(0, \ldots, 0, x_{1}, x_{2}, \ldots\right)$ ( $n$ leading zeros) for $x=\left(x_{m}\right)_{m \in \mathbb{N}}$. Then $T$ converges weakly to 0 but $\left\|T_{n} x\right\|=1$ for all $n \in \mathbb{N}$, so that $\left(T_{n}\right)_{n \in \mathbb{N}}$ does not converge strongly to 0 .
Proposition 3.13. Let $X$ be a Banach space, $Y$ be a normed space and $\left(T_{n}\right)_{n \in \mathbb{N}} \subseteq$ $L(X, Y)$ such that for all $x \in X$ the limit $T x:=\lim _{n \in \mathbb{N}} T_{n} x$ exists. Then $T \in L(X, Y)$.
Proof. It is clear that $T$ is well-defined and linear. By the uniform boundedness principle, there exists an $C \in \mathbb{R}$ such that $\left\|T_{n}\right\|<C$ for all $n \in \mathbb{N}$. Now let $x \in X$ with $\|x\|=1$. Then $\|T x\|=\lim _{n \rightarrow \infty}\left\|T_{n} x\right\| \leq \sup _{n \in \mathbb{N}}\left\|T_{n}\right\|\|x\| \leq C$ which implies that $T \in L(X, Y)$.

We finish this section with a result on strong convergence of positive operators on a space of continuous functions. An operator $T$ on a function space is called positivity preserving if $T f \geq 0$ for every $f \geq 0$ in the domain of $T$.

Theorem 3.14 (Korovkin). Let $X=C[0,2 \pi]$ the space of the continuous functions on $[0,2 \pi]$ and let $x_{j} \in X$ with $x_{0}(t)=1, x_{1}(t)=\cos (t), x_{2}(t)=\sin (t)$ for $t \in[0,2 \pi]$. Let $\left(T_{n}\right)_{n \in \mathbb{N}} \subseteq L(X)$ be a sequence of positivity preserving operators such that $T_{n} x_{j} \rightarrow x_{j}$ for $n \rightarrow \infty$ and $j=0,1,2$. Then $\left(T_{n}\right)_{n \in \mathbb{N}}$ converges strongly to id, that is, $T_{n} x \rightarrow x$ for all $x \in X$.

Proof. We define the auxiliary functions

$$
y_{t}(s)=\sin ^{2} \frac{t-s}{2}, \quad t, s \in[0,2 \pi] .
$$

Note that $y_{t}(s)=\frac{1}{2}(1-\cos (s) \cos (t)-\sin (s) \sin (t))$, hence $y_{t} \in \operatorname{span}\left\{x_{0}, x_{1}, x_{2}\right\}$, in particular $T_{n} y_{t} \rightarrow y_{t}$ for $n \rightarrow \infty$.
Now fix $x \in X$ and $\varepsilon>0$. Since $x$ is uniformly continuous there exists a $\delta>0$ such that for all $s, t \in[0,2 \pi]$

$$
y_{t}(s)=\sin ^{2} \frac{t-s}{2}<\delta \quad \Longrightarrow \quad|x(t)-x(s)|<\varepsilon .
$$

Setting $\alpha=\frac{2\|x\|_{\infty}}{\delta}$ we obtain that

$$
|x(t)-x(s)| \leq \varepsilon+\alpha y_{t}(s), \quad s, t \in[0,2 \pi]
$$

because either $s, t$ are such that $y_{t}(s)<\delta$, then $|x(t)-x(s)|<\delta$ by definition of $\delta$; or $y_{t}(s) \geq \delta$, then $|x(t)-x(s)| \leq 2\|x\|_{\infty}=\alpha \delta \leq \alpha y_{t}(s)$. Hence we have that

$$
\begin{array}{llr} 
& -\varepsilon-\alpha y_{t}(s) \leq x(t)-x(s) \leq \varepsilon+\alpha y_{t}(s), & s, t \in[0,2 \pi] \\
\Longrightarrow & -\varepsilon x_{0}-\alpha y_{t} \leq x(t) x_{0}-x \leq \varepsilon x_{0}+\alpha y_{t}, & t \in[0,2 \pi]
\end{array}
$$

and since $T_{n}$ is positive and $y_{t}$ is a positive function

$$
-\varepsilon T_{n} x_{0}-\alpha T_{n} y_{t} \leq x(t) T_{n} x_{0}-T_{n} x \leq \varepsilon T_{n} x_{0}+\alpha T_{n} y_{t}, \quad t \in[0,2 \pi] .
$$

Since $T_{n} x_{0} \rightarrow x_{0}$ and $T_{n} y_{t} \rightarrow \frac{1}{2}\left(1-\cos (t) x_{1}-\sin (t) x_{2}\right)$ for $n \rightarrow \infty$, we can find $N \in \mathbb{N}$ large enough such that $\varepsilon T_{n} x_{0}+\alpha T_{n} y_{t}<\varepsilon x_{0}+\alpha y_{t}+\varepsilon$ for all $n \geq N$, hence

$$
\left|x(t) T_{n} x_{0}-T_{n} x\right| \leq \varepsilon x_{0}+\alpha y_{t}+\varepsilon, \quad t \in[0,2 \pi], n \geq N
$$

Hence $x T_{n} x_{0}-T_{n} x_{0}$ converges to 0 in norm in $X$ because by the inequality above

$$
\left|x(t)\left(T_{n} x_{0}\right)(t)-\left(T_{n} x\right)(t)\right| \leq \varepsilon+\alpha y_{t}(t)+\varepsilon=2 \varepsilon, \quad t \in[0,2 \pi], n \geq N
$$

That $T_{n} x \rightarrow x$ follows now from

$$
\left\|x-x T_{n} x_{0}\right\|_{\infty}+\left\|x T_{n} x_{0}-T_{n}\right\|_{\infty} \leq\|x\|\left\|x_{0}-T_{n} x_{0}\right\|_{\infty}+\left\|x T_{n} x_{0}-T_{n}\right\|_{\infty}
$$

## Fourier Series

Definition 3.15. Let $x: \mathbb{R} \rightarrow \mathbb{R}$ a $2 \pi$-periodic integrable function. The Fourier series of $x$ is

$$
S(x, t)=\frac{a_{0}}{2}+\sum_{k=1}^{\infty}\left(a_{k} \cos (k t)+b_{k} \sin (k t)\right)
$$

where

$$
\begin{array}{ll}
a_{k}:=\frac{1}{\pi} \int_{-\pi}^{\pi} x(s) \cos (k s) \mathrm{d} s, & k \in \mathbb{N}_{0} \\
b_{k}:=\frac{1}{\pi} \int_{-\pi}^{\pi} x(s) \sin (k s) \mathrm{d} s, & k \in \mathbb{N}
\end{array}
$$

Note that the Fourier series is a formal series only. In the following we will prove theorems on convergence of the Fourier series.
First we will use methods from Analysis 1 to show that for a continuously differentiable periodic function its Fourier series converges uniformly to the function. Next we will use the uniform boundedness principle to show that there exist continuous
functions whose Fourier series does not converge pointwise everywhere. Finally, the Korovkin theorem implies that the arithmetic means of the partial sums of the Fourier series of a periodic function converges uniformly to the function.
For a given $2 \pi$-periodic function and $n \in \mathbb{N}$ we define the $n$th partial sum

$$
\begin{equation*}
s_{n}(x, t)=\frac{a_{0}}{2}+\sum_{k=1}^{n}\left(a_{k} \cos (k t)+b_{k} \sin (k t)\right) . \tag{3.3}
\end{equation*}
$$

## Lemma 3.16.

$$
s_{n}(x, t)=\frac{1}{\pi} \int_{-\pi}^{\pi} x(s+t) D_{n}(s) \mathrm{d} s \quad \text { with } \quad D_{n}(s)= \begin{cases}\frac{\sin \left(\left(n+\frac{1}{2}\right) s\right)}{2 \sin \left(\frac{2}{2}\right)}, & s \neq 0,  \tag{3.4}\\ n+\frac{1}{2} & s=0 .\end{cases}
$$

$D_{n}$ is called Dirichlet kernel. $D_{n}$ is continuous and

$$
\begin{equation*}
\frac{1}{\pi} \int_{-\pi}^{\pi} D_{n}(s) \mathrm{d} s=1 \tag{3.5}
\end{equation*}
$$

Proof. Using the trigonometric identity $\cos (a) \cos (b)+\sin (a) \sin (b)=\cos (a-b)$ and that $x$ is $2 \pi$-periodic we obtain

$$
\begin{aligned}
s_{n}(x, t) & =\frac{a_{0}}{2}+\sum_{k=1}^{n}\left(a_{k} \cos (k t)+b_{k} \sin (k t)\right) \\
& =\frac{1}{\pi} \int_{-\pi}^{\pi} x(s)\left(\frac{1}{2}+\sum_{k=1}^{n}(\cos (k s) \cos (k t)+\sin (k s) \sin (k t))\right) \mathrm{d} s \\
& =\frac{1}{\pi} \int_{-\pi}^{\pi} x(s)\left(\frac{1}{2}+\sum_{k=1}^{n} \cos (k(s-t))\right) \mathrm{d} s \\
& =\frac{1}{\pi} \int_{-\pi}^{\pi} x(s+t)\left(\frac{1}{2}+\sum_{k=1}^{n} \cos (k s)\right) \mathrm{d} s .
\end{aligned}
$$

Now we calculate for $s \neq 0$

$$
\begin{aligned}
\frac{1}{2}+\sum_{k=1}^{n} \cos (k s) & =\frac{1}{2}+\frac{1}{2} \sum_{k=1}^{n}\left(\mathrm{e}^{1 s}+\mathrm{e}^{-\mathrm{i} k s}\right)=\frac{1}{2} \sum_{k=-n}^{n} \mathrm{e}^{\mathrm{i} k s}=\frac{\mathrm{e}^{-\mathrm{i} n s}}{2} \sum_{k=0}^{2 n} \mathrm{e}^{\mathrm{i} k s} \\
& =\frac{\mathrm{e}^{-\mathrm{i} n s}}{2} \frac{\mathrm{e}^{\mathrm{1} 2 n s}-1}{\mathrm{e}^{1 s}-1}=\frac{1}{2} \frac{\mathrm{e}^{\mathrm{i}\left(n+\frac{1}{2}\right) s}-\mathrm{e}^{-\mathrm{i}\left(n+\frac{1}{2}\right) s}}{\mathrm{e}^{1 / s / 2}-\mathrm{e}^{-1 s / 2}}=\frac{\sin \left(\left(n+\frac{1}{2}\right) s\right)}{2 \sin \frac{s}{2}}=D_{n}(s) .
\end{aligned}
$$

Note that $\lim _{s \rightarrow 0} D_{n}(s)=n+\frac{1}{2}=\frac{1}{2}+\sum_{k=1}^{n} \cos (0)$. For the proof of (3.5) let $x=1$ a constant function on $\mathbb{R}$. Then, by (3.3),

$$
\frac{1}{\pi} \int_{-\pi}^{\pi} D_{n}(s) \mathrm{d} s=s_{n}(x, t)=x(t)=1
$$

Theorem 3.17. Let $x: \mathbb{R} \rightarrow \mathbb{R}$ be a $2 \pi$-periodic continuously differentiable func tion. Then the Fourier series of $x$ converges uniformly to $x$.

Proof. Let $x: \mathbb{R} \rightarrow \mathbb{R}$ a $2 \pi$-periodic continuously differentiable function. Let $\varepsilon>0$
and $h \in(0, \pi)$ such that $h<\frac{\varepsilon}{\pi\left\|x^{\prime}\right\|_{\infty}}$. Using (3.4) and (3.5) it follows that

$$
\begin{aligned}
\left|x(s)-s_{n}(x, t)\right| & =\left|\frac{1}{\pi} \int_{-\pi}^{\pi}(x(s+t)-x(t)) D_{n}(s) \mathrm{d} s\right| \\
& \leq \frac{1}{\pi}(\underbrace{\left|\int_{-\pi}^{-h} \ldots \mathrm{~d} s\right|}_{=: A_{n}(t)}+\underbrace{\int_{-h}^{h}|\ldots| \mathrm{d} s}_{=: B_{n}(t)}+\underbrace{\left|\int_{h}^{\pi} \ldots \mathrm{d} s\right|}_{=: C_{n}(t)}) .
\end{aligned}
$$

We have to show that $A_{n}(t), B_{n}(t)$ and $C_{n}(t)$ tend to 0 for $n \rightarrow \infty$ uniformly in $t$ Using the mean value theorem and that $\frac{\pi}{2} \sigma \leq \sin (\sigma)$ for $\sigma \in[0, \pi / 2]$ we obtain

$$
\begin{aligned}
B_{n}(t) & =\int_{-h}^{h} \frac{|x(s+t)-x(t)|}{2 \sin \left|\frac{s}{2}\right|} \underbrace{\left|\sin \left(\left(n+\frac{1}{2}\right) s\right)\right|}_{\leq 1} \mathrm{~d} s \leq \int_{-h}^{h} \frac{\left\|x^{\prime}\right\||s|}{2 \sin \left|\frac{s}{2}\right|} \mathrm{d} s \\
& \leq 2 h\left\|x^{\prime}\right\|_{\infty} \frac{\pi}{2}<\frac{\varepsilon}{2} .
\end{aligned}
$$

Define the auxiliary function

$$
f_{t}(s)=\frac{x(s+t)-x(t)}{2 \sin \left(\frac{s}{2}\right)}, \quad s \in[h, \pi], t \in[0, \pi] .
$$

The functions $f_{t}$ are continuously differentiable and $\left\|f_{t}\right\|_{\infty} \leq \frac{2\|x\|_{\infty}}{2 \sin (h / 2)}=: M_{1}$, $\left\|f_{t}^{\prime}\right\|_{\infty} \leq \frac{\left\|x^{\prime}\right\|_{\infty}}{2 \sin (h / 2)}=: M_{2}$. Note that the bounds do not depend on $t$. Integrating by parts, we find

$$
\begin{aligned}
C_{n}(t) & =\left|\int_{h}^{\pi} f_{t}(s) \sin \left(\left(n+\frac{1}{2}\right) s\right) \mathrm{d} s\right| \\
& \left.=\left|-\frac{\cos \left(\left(n+\frac{1}{2}\right) s\right)}{n+\frac{1}{2}} f_{t}(s)\right|_{h}^{\pi}+\int_{h}^{\pi} \frac{\cos \left(\left(n+\frac{1}{2}\right) s\right)}{n+\frac{1}{2}} f_{t}^{\prime}(s) \mathrm{d} s \right\rvert\, \\
& \leq \frac{1}{n+\frac{1}{2}}\left(2 M_{1}+(\pi-h) M_{2}\right)=: \frac{M}{n+\frac{1}{2}} .
\end{aligned}
$$

Note that $M^{\prime}$ does not depend on $t$. When we choose $N$ such that $\frac{M}{n+\frac{1}{2}}<\frac{\varepsilon}{2}$ we obtain finally $\left|x(s)-s_{n}(x, t)\right|<\varepsilon$ for all $t \in \mathbb{R}$, that is, $\left\|x-s_{n}(x, \cdot)\right\|_{\infty}<\varepsilon . \quad \square$
Theorem 3.18. There exists a $2 \pi$-periodic continuous function $x$ whose Fourier series does not converge everywhere pointwise to $x$.

Proof. We identify the $2 \pi$-periodic functions on $\mathbb{R}$ with

$$
X:=\{x \in C([-\pi, \pi]): x(-\pi)=x(\pi)\} .
$$

Clearly $\left(X,\|\cdot\|_{\infty}\right)$ is a Banach space.
Note that for fixed $t \in[-\pi, \pi]$ and $n \in \mathbb{N}$

$$
s_{n}(\cdot, t): X \rightarrow \mathbb{K}
$$

is linear and bounded, hence an element in $X^{\prime}$.
Assume that for every $x \in X$ its Fourier series converges pointwise to $x$. Then for every $x \in X$ and $t \in[-\pi, \pi]$ the sequence $\left(s_{n}(x, t)\right)_{n \in \mathbb{N}}$ is bounded (because it converges to $x(t)$ ). By the uniform boundedness principle there exists $C_{t}$ such that $\left\|s_{n}(\cdot, t)\right\| \leq C_{t}$ for all $n \in \mathbb{N}$. In particular, we have

$$
\left\|s_{n}(\cdot, 0)\right\| \leq C_{0}, \quad n \in \mathbb{N} .
$$

It is easy to see that

$$
\left\|s_{n}(x, 0)\right\|=\frac{1}{\pi}\left|\int_{-\pi}^{\pi} x(s) D_{n}(s) \mathrm{d} s\right| \leq \frac{1}{\pi}\|x\|_{\infty} \int_{-\pi}^{\pi}\left|D_{n}(s)\right| \mathrm{d} s
$$

hence $\left\|s_{n}(\cdot, 0)\right\| \leq \int_{-\pi}^{\pi}\left|D_{n}(s)\right| \mathrm{d} s$. On the other hand, the function $y(s)=\operatorname{sign}\left(D_{n}(s)\right)$ can be approximated by continuous functions $y_{m}$ with $\left\|y_{m}\right\|=1$ such that
$\left\|s_{n}\left(y_{m}, 0\right)\right\|=\frac{1}{\pi} \int_{-\pi}^{\pi} x(s) D_{n}(s) \mathrm{d} s \rightarrow \frac{1}{\pi} \int_{-\pi}^{\pi} \operatorname{sign}\left(D_{n}(s)\right) D_{n}(s) \mathrm{d} s=\frac{1}{\pi} \int_{-\pi}^{\pi}\left|D_{n}(s)\right| \mathrm{d} s$ so that finally we obtain

$$
\left\|s_{n}(\cdot, 0)\right\|=\frac{1}{\pi} \int_{-\pi}^{\pi}\left|D_{n}(s)\right| \mathrm{d} s<C_{0}, \quad n \in \mathbb{N}
$$

However $\left\|s_{n}(\cdot, 0)\right\| \rightarrow \infty$ for $n \rightarrow \infty$ because

$$
\begin{aligned}
\int_{-\pi}^{\pi}\left|D_{n}(s)\right| \mathrm{d} s & =2 \int_{0}^{\pi} \frac{\left|\sin \left(\left(n+\frac{1}{2}\right) s\right)\right|}{2 \sin \frac{s}{2}} \mathrm{~d} s \geq 2 \int_{0}^{\pi} \frac{\left|\sin \left(\left(n+\frac{1}{2}\right) s\right)\right|}{s} \mathrm{~d} s \\
& =2 \int_{0}^{\pi\left(n+\frac{1}{2}\right)} \frac{|\sin \sigma|}{\sigma} \mathrm{d} \sigma \geq 2 \sum_{k=0}^{n-1} \int_{k \pi}^{(k+1) \pi} \frac{|\sin \sigma|}{\sigma} \mathrm{d} \sigma \\
& \geq 2 \sum_{k=0}^{n-1} \frac{1}{\pi(k+1)} \int_{k \pi}^{(k+1) \pi}|\sin \sigma| \mathrm{d} \sigma=4 \pi \sum_{k=0}^{n-1} \frac{1}{\pi(k+1)} . \\
& =4 \sum_{k=1}^{n} \frac{1}{k} .
\end{aligned}
$$

Hence the theorem is proved.
$\square$
Finally we show that the arithmetic mean of the partial sums of the Fourier series of a continuous function converge.

## Theorem 3.19 (Fejér). As before let

$$
X:=\{x \in C([-\pi, \pi]): x(-\pi)=x(\pi)\}
$$

and let $T_{n} \in L(X)$ defined by

$$
T_{n} x=\frac{1}{n} \sum_{k=0}^{n-1} s_{n}(x, \cdot) .
$$

Then $\left(T_{n}\right)_{n \in \mathbb{N}}$ converges strongly to id (i.e. $T_{n} x \rightarrow x$ for $n \rightarrow \infty, x \in X$ )
Proof. Note that the $T_{n}$ are well-defined and that for all $x \in X$ and $t \in[-\pi, \pi]$

$$
T_{n} x(t)=\frac{1}{n} \sum_{k=0}^{n-1} \int_{-\pi}^{\pi} x(s+t) D_{k}(s) \mathrm{d} s=\frac{1}{n \pi} \int_{-\pi}^{\pi} \frac{x(s+t))}{2 \sin \frac{s}{2}} \sum_{k=0}^{n-1} \sin \left(\left(k+\frac{1}{2}\right) s\right) \mathrm{d} s .
$$

We simplify the sum in the integrand

$$
\begin{aligned}
\sum_{k=0}^{n-1} \sin \left(\left(k+\frac{1}{2}\right) s\right) & =\operatorname{Im} \sum_{k=0}^{n-1} \mathrm{e}^{\mathrm{i}\left(k+\frac{1}{2}\right) s}=\operatorname{Im}\left(\mathrm{e}^{\mathrm{i} \frac{s}{2}} \sum_{k=0}^{n-1} \mathrm{e}^{\mathrm{i} k s}\right)=\operatorname{Im}\left(\mathrm{e}^{\left.\mathrm{i} \frac{s}{2} \frac{\mathrm{e}^{\mathrm{i} n s}-1}{\mathrm{e}^{\mathrm{i} s}-1}\right)}\right. \\
& =\operatorname{Im} \frac{\mathrm{e}^{\mathrm{i} n s}-1}{\mathrm{e}^{\mathrm{i} s / 2}-\mathrm{e}^{-\mathrm{i} s / 2}}=\operatorname{Im} \frac{\mathrm{e}^{\mathrm{i} n s / 2}\left(\mathrm{e}^{\mathrm{i} n s / 2}-\mathrm{e}^{\mathrm{i} n s / 2}\right)}{\mathrm{e}^{\mathrm{i} s / 2}-\mathrm{e}^{-\mathrm{i} s / 2}} \\
& =\operatorname{Im} \frac{2 \mathrm{i}(\cos (n s / 2)+\mathrm{i} \sin (n s / 2)) \sin (n s / 2)}{2 \mathrm{i} \sin (s / 2)}=\frac{\sin ^{2}(n s / 2)}{\sin (s / 2)} .
\end{aligned}
$$

## If we define the Fejér kernel

$$
F_{n}(s):= \begin{cases}\frac{1}{2 n} \frac{\sin ^{2}(n s / 2)}{\sin (s / 2)}, & s \neq 0, \\ \frac{1}{2 n} & s=0,\end{cases}
$$

we can write $T_{n} x$ as

$$
T_{n} x(t)=\frac{1}{\pi} \int-\pi^{\pi} F_{n}(s) x(s+t) \mathrm{d} s
$$

Note that all $F_{n}$ are positive functions, hence the $T_{n}$ are positive operators. To show the theorem, it suffices to show that $T_{n} x_{j} \rightarrow x_{j}$ for $x_{0}(t)=1, x_{1}(t)=\cos (t)$, $x_{2}(t)=\sin (t)$ (Korovkin theorem). Using (3.3) it follows that $s_{k}\left(x_{0}, \cdot\right)=x_{0}$ for all $k \in \mathbb{N}_{0}$ and that

$$
\begin{aligned}
& s_{0}\left(x_{1}, \cdot \cdot\right)=s_{0}\left(x_{2}, \cdot\right)=0, \\
& s_{k}\left(x_{2}, \cdot\right)=x_{1}, \quad s_{k}\left(x_{1}, \cdot\right)=x_{2},
\end{aligned}
$$

Since $T_{n} x_{0}=x_{0}, T_{n} x_{j}=\frac{n-1}{n} x_{j}$ for $j=1,2$ and $n \in \mathbb{N}$ the theorem is proved. $\quad \square$

### 3.3 The open mapping theorem

Definition 3.20. A map $f$ between metric spaces $X$ and $Y$ is called open if the image of an open set in $X$ is an open set in $Y$.

Note that an open map does not necessarily map closed sets to closed sets. For example, the projection $\pi: \mathbb{R} \times \mathbb{R} \rightarrow \mathbb{R}, \pi((s, t))=s$, is open. The set $A:=$ $\{(s, t) \in \mathbb{R} \times \mathbb{R}: s \geq 0, s t \geq 2\}$ is closed in $\mathbb{R} \times \mathbb{R}$ but $\pi(A)=(0, \infty)$ is open in $\mathbb{R}$.
Lemma 3.21. Let $X, Y$ be Banach spaces and $T \in L(X, Y)$ such that

$$
B_{Y}(0, r) \subseteq \overline{T\left(B_{X}(0,1)\right)}
$$

for some $r>0$. Then for every $\varepsilon \in(0,1)$

$$
B_{Y}(0,(1-\varepsilon) r) \subseteq T\left(B_{X}(0,1)\right)
$$

Here $B_{X}\left(x_{0}, r\right):=\left\{x \in X:\left\|x-x_{0}\right\|<r\right\}$ and $B_{Y}\left(y_{0}, r\right):=\left\{y \in Y:\left\|y-y_{0}\right\|<r\right\}$ are open balls in $X$ and $Y$ respectively.

The lemma says that if $T\left(B_{X}(0,1)\right)$ is dense in $B_{Y}(0, r)$, then, for any $0<\rho<r$ the ball $B_{Y}(0, \rho)$ is contained in $T\left(B_{X}(0,1)\right)$.
Proof. Note that the assertion is equivalent to

$$
B_{Y}(0, r) \subseteq(1-\varepsilon)^{-1} T\left(B_{X}(0,1)\right)=T\left(B_{X}\left(0,(1-\varepsilon)^{-1}\right)\right)
$$

Fix $\varepsilon>0$ and $y_{0} \in B_{Y}(0, r)$. We have to show that there exists an $x_{0} \in X$ with $\left\|x_{0}\right\|<(1-\varepsilon)^{-1}$ and $y_{0}=T\left(x_{0}\right)$. By assumption, $B_{Y}(0, r) \subseteq \overline{T\left(B_{X}(0,1)\right)}$. Hence there exists an $x_{1} \in B_{X}(0,1)$ such that $\left\|y_{0}-T x_{1}\right\|<\varepsilon r$. By scaling, we know that $T\left(B_{X}(0, \varepsilon)\right)$ is dense in $B_{Y}(0, \varepsilon r)$. Since $y_{0}-T x_{1} \in B_{Y}(0, \varepsilon r)$, there exists an $x_{2} \in B_{X}(0, \varepsilon)$ ) $B_{Y}\left(0, \varepsilon^{2} r\right)$, there exists an $x_{3} \in B_{X}\left(0, \varepsilon^{2}\right)$ such that $\left\|y_{0}-T x_{1}-T x_{2}-T x_{3}\right\|<\varepsilon^{3} r$
Continuing in this way, we obtain a sequence $\left(x_{n}\right)$ Continuing in this way, we obtain a sequence $\left(x_{n}\right)_{n \in \mathbb{N}}$ such that

$$
\begin{equation*}
\left\|x_{n}\right\|<\varepsilon^{n-1}, \quad\left\|y_{0}-\sum_{k=1}^{n} T x_{k}\right\|<r \varepsilon^{n}, \quad n \in \mathbb{N} . \tag{3.6}
\end{equation*}
$$

It follows that $x_{0}:=\sum_{k=1}^{\infty} x_{k}$ exists and lies in $B\left(0,(1-\varepsilon)^{-1}\right)$ because $\sum_{k=1}^{\infty}\left\|x_{k}\right\|<$ $\sum_{k=1}^{\infty} r \varepsilon^{k-1}=r(1-\varepsilon)^{-1}$. Since $T$ is continuous, we know that

$$
T\left(x_{0}\right)=T\left(\sum_{k=1}^{\infty} x_{k}\right)=\sum_{k=1}^{\infty} T x_{k} .
$$

By (3.6) it follows that $\sum_{k=1}^{n} T x_{k}$ converges to $y_{0}$ for $n \rightarrow \infty$. Hence $T x_{0}=y_{0}$ and the statement is proved.

In the proof of the open mapping theorem we use the following fact.
Remark. Let $T: X \rightarrow Y$ be a linear map between normed spaces $X$ and $Y$ and assume that $T_{X}(B(0,1))$ is dense in $B_{Y}(y, \delta)$ for some $y \in Y$ and $\delta>0$. Then $T_{X}(B(0,1))$ is dense in $B_{Y}(0, \delta)$

Proof. Obviously it suffices to show that $T\left(B_{X}(0,2)\right)$ is dense in $B_{Y}(0,2 \delta)$. Since $T$ is linear, it follows immediately that $T_{X}(B(0,1))$ is dense in $B_{Y}(-y, \delta)$. Let $z \in B_{Y}(0,2 \delta)$ and $\varepsilon>0$. Note that $y-z / 2 \in B_{Y}(y, \delta)$ and $-y-z / 2 \in B_{Y}(-y, \delta)$. Choose $x_{1}, x_{2} \in B_{X}(0,1)$ such that $\left\|T x_{1}-(y-z / 2)\right\|<\varepsilon / 2$ and $\left\|T x_{2}-(-y-z)\right\|<$ $\varepsilon / 2$. Since $x_{1}+x_{2} \in B_{X}(0,2)$ and

$$
\left\|T\left(x_{1}+x_{2}\right)-z\right\| \leq\left\|T x_{1}-(y-z / 2)\right\|+\left\|T x_{2}-(-y-z / 2)\right\|<\varepsilon,
$$

it follows that $z \in \overline{T\left(B_{X}(0,2)\right)}$ because $\varepsilon$ can be chosen arbitrarily small.

Theorem 3.22 (Open mapping theorem). Let $X, Y$ be Banach spaces and $T \in L(X, Y)$. Then $T$ is open if and only if it is surjective.

Proof. If $T$ is open, then it is obviously surjective.
Now assume that $T$ is surjective. We use the notation of the preceding lemma. By assumption

$$
Y=\bigcup_{k=1}^{\infty} \overline{T\left(B_{X}(0, k)\right)} .
$$

Since $Y$ is complete, by Baire's category theorem there must exist an $n \in \mathbb{N}$ and $y \in Y$ and $\varepsilon>0$ such $B_{Y}(y, \varepsilon) \subseteq \overline{T\left(B_{X}(0, n)\right)}$, in other words, $T\left(B_{X}(0,1)\right)$ is dense in $B_{Y}(y / n, \varepsilon / n)$. By the remark above $T\left(B_{X}(0,1)\right)$ is dense in $B_{Y}(0, \varepsilon / n)$, so by Lemma $3.21 B_{Y}(0, \delta) \subseteq T\left(B_{X}(0,1)\right)$ for all $\delta<\varepsilon / n$.
Now let $U \subseteq X$ be an open set and $u \in U$. Then there exists an open ball $B_{X}(0, \varepsilon)$ such that $u+B_{X}(0, \varepsilon) \subseteq U$. By what was shown above, there exists an $\delta>0$ such that $T u+B_{Y}(0, \delta) \subseteq T u+T\left(B_{X}(0, \varepsilon)\right)=T\left(u+B_{X}(0, \varepsilon)\right) \subseteq T(U)$.
The open mapping theorem has the following important corollaries.
Corollary 3.23. Let $X, Y$ be Banach spaces and $T \in L(X, Y)$ a bijection. Then $T^{-1}$ exists and is continuous.
Proof. By the open mapping theorem $T$ is open, so its inverse $T^{-1}$ is continuous.
Corollary 3.24. Let $X, Y$ be Banach spaces and $T \in L(X, Y)$ injective. Then $T^{-1}: \operatorname{rg}(T) \rightarrow X$ is continuous if and only if $\operatorname{rg}(T)$ is closed.

Proof. If $\operatorname{rg}(T)$ is closed in $Y$ then it is a Banach space. So by the previous lemma, $T: X \rightarrow \operatorname{rg}(T)$ has a continuous inverse. On the other hand, if $T^{-1}: \operatorname{rg}(T) \rightarrow X$ is continuous, then $T$ is an isomorphism between $X$ and $\operatorname{rg}(T)$, so $\operatorname{rg}(T)$ is complete, hence closed in $Y$.

Corollary 3.25. Let $X$ be $a \mathbb{K}$-vector space and $\|\cdot\|_{1}$ and $\|\cdot\|_{2}$ norms on $X$ such that $X$ is complete with respect to both norms. Assume that there exists an $\alpha>0$ such that $\|x\|_{2} \leq \alpha\|x\|_{1}$ for all $x \in X$. Then the two norms are equivalent.
Proof. Let $T:\left(X,\|\cdot\|_{1}\right) \rightarrow\left(X,\|\cdot\|_{2}\right), T x=x$. T is surjective and bounded by $\alpha$, so it is continuous. By the open mapping theorem, its inverse is continuous, hence bounded. The statement follows now from $\|x\|_{1}=\left\|T^{-1} x\right\|_{1} \leq\left\|T^{-1}\right\|\|x\|_{2}$ $x \in X$.

### 3.4 The closed graph theorem

Let $X, Y$ be normed spaces. Then $X \times Y$ is a normed space with either of the norms

$$
\begin{array}{ll}
\|\cdot\|: X \times Y \rightarrow \mathbb{R}, & \|(x, y)\|=\|x\|+\|y\|, \\
\|\cdot\|: X \times Y \rightarrow \mathbb{R}, & \|(x, y)\|=\sqrt{\|x\|^{2}+\|y\|^{2}} .
\end{array}
$$

Note that the two norms defined above are equivalent.
Definition 3.26. Let $X, Y$ be normed spaces, $\mathcal{D}$ a subspace of $X$ and $T: \mathcal{D} \rightarrow Y$ linear. $T$ is called closed if its graph

$$
\mathrm{G}(T):=\{(x, T x): x \in \mathcal{D}\} \subseteq X \times Y
$$

is closed in $X \times Y . T$ is closable if $\overline{G(T)}$ is the graph of an operator $\bar{T}$. The operator $\bar{T}$ is called the closure of $T$.
$\mathcal{D}$ is called the domain of $T$, also denoted by $\operatorname{dom} T$. Sometimes the notations $T: X \supseteq \mathcal{D} \rightarrow Y$ or $T(X \rightarrow Y)$ are used.
Obviously, the graph $\mathrm{G}(T)$ is a subspace of $X \times Y$.
Lemma 3.27. Let $X, Y$ normed space and $\mathcal{D} \subseteq X$ a subspace. Then $T: X \supseteq \mathcal{D} \rightarrow$ $Y$ is closed if and only if for every sequence $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq \mathcal{D}$ the following is true:

$$
\begin{align*}
&\left(x_{n}\right)_{n \in \mathbb{N}} \text { and }\left(T x_{n}\right)_{n \in \mathbb{N}} \text { converge } \\
& \quad \Longrightarrow x_{0}:=\lim _{n \rightarrow \infty} x_{n} \in \mathcal{D} \text { and } \lim _{n \rightarrow \infty} T x_{n}=T x_{0} . \tag{3.7}
\end{align*}
$$

Proof. Assume that $T$ is closed and let $\left(x_{n}\right)_{n \in \mathbb{N}}$ such that $\left(x_{n}\right)_{n \in \mathbb{N}}$ and $\left(T x_{n}\right)_{n \in \mathbb{N}}$ converge. Then $\left(\left(x_{n}, T x_{n}\right)\right)_{n \in \mathbb{N}} \subseteq G(T)$ converges in $X \times Y$. Since $G(T)$ is closed $\lim _{n \rightarrow \infty}\left(x_{n}, T x_{n}\right)=\left(x_{0}, y_{0}\right) \in G(T)$. By definition of $G(T)$ this implies $\lim _{n \rightarrow \infty} x_{n}=$ $x_{0} \in \mathcal{D}(T)$ and $T x_{0}=y_{0}=\lim _{n \rightarrow \infty} T x_{n}$.
Now assume that (3.7) holds and let $\left(\left(x_{n}, T x_{n}\right)\right)_{n \in \mathbb{N}} \subseteq G(T)$ be a sequence that converges in $X \times Y$. Then both $\left(x_{n}\right)_{n \in \mathbb{N}}$ and $\left(T x_{n}\right)_{n \in \mathbb{N}}$ converge, hence $x_{0}:=$ $\lim _{n \rightarrow \infty} x_{n} \in \mathcal{D}$ and $\lim _{n \rightarrow \infty} T x_{n}=T x_{0}$ which shows that $\lim _{n \rightarrow \infty}\left(x_{n}, T x_{n}\right)=\left(x_{0}, T x_{0}\right) \in$ $\stackrel{n \rightarrow \infty}{G(T)}$, hence $G(T)$ is closed.

Lemma 3.28. Let $X, Y$ normed space and $\mathcal{D} \subseteq X$ a subspace. Then $T: \mathcal{D} \rightarrow Y$ is closable if and only if for every sequence $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq \mathcal{D}$ the following is true:

$$
\begin{equation*}
\lim _{n \rightarrow \infty} x_{n}=0 \text { and }\left(T x_{n}\right)_{n \in \mathbb{N}} \text { converges } \Longrightarrow \lim _{n \rightarrow \infty} T x_{n}=0 \tag{3.8}
\end{equation*}
$$

The closure $\bar{T}$ of $T$ is given by

$$
\begin{gather*}
\mathcal{D}(\bar{T})=\left\{x \in X: \exists\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq \mathcal{D} \text { with } \lim _{n \rightarrow \infty} x_{n}=x \text { and }\left(T x_{n}\right)_{n \in \mathbb{N}} \text { converges }\right\}, \\
\bar{T} x=\lim _{n \rightarrow \infty}\left(T x_{n}\right) \quad \text { for }\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq \mathcal{D} \text { with } \lim _{n \rightarrow \infty} x_{n}=x . \tag{3.9}
\end{gather*}
$$

Proof. Assume that $T$ is closable. Then $\overline{G(T)}$ is the graph of a linear function. Hence for a sequence $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq \mathcal{D}$ with $\lim _{n \rightarrow \infty} x_{n}=0$ and $\lim _{n \rightarrow \infty} T x_{n}=y$ for some $y \in Y$ it follows that $(0, y) \in \overline{G(T)}=G(\bar{T})$. Hence $y=\bar{T} 0 \stackrel{n \rightarrow \infty}{=} 0$ because $\bar{T}$ is linear.

Now assume that (3.8) holds and define $\bar{T}$ as in (3.9). $\bar{T}$ is well-defined because for sequences $\left(x_{n}\right)_{n \in \mathbb{N}}$ and $\left(\tilde{x}_{n}\right)_{n \in \mathbb{N}}$ in $\mathcal{D}$ with $\lim _{n \rightarrow \infty} x_{n}=\lim _{n \rightarrow \infty} \tilde{x}_{n}=x$ such that $\left(\bar{T} x_{n}\right)_{n \in \mathbb{N}}$ and $\left(\bar{T} \tilde{x}_{n}\right)_{n \in \mathbb{N}}$ in $\mathcal{D}$ converge, it follows that $\left(x_{n}-\tilde{x}_{n}\right)_{n \in \mathbb{N}}$ converges to 0 . Since $\bar{T}\left(x_{n}-\tilde{x}_{n}\right)=T\left(x_{n}-\tilde{x}_{n}\right)$ converges, it follows by assumption that $\lim _{n \rightarrow \infty} \bar{T} x_{n}-\lim _{n \rightarrow \infty} \bar{T} \tilde{x}_{n}=\lim _{n \rightarrow \infty} \bar{T}\left(x_{n}-\tilde{x}_{n}\right)=0$. Linearity of $\bar{T}$ is clear. By definition, ${ }^{n \rightarrow \infty}(\bar{T})$ is the closure of $G(T)$, so $\bar{T}$ is the closure of $T$.

Remarks 3.29. Let $X, Y$ be normed spaces.
(i) Every $T \in L(X, Y)$ is closed.
(ii) If $T$ is closed and injective, then $T^{-1}$ is closed.

Proof. Closedness of $\{(x, T x): x \in X\} \subseteq X \times Y$ implies closeness of $\left\{\left(T^{-1} y, y\right):\right.$
$y \in \operatorname{rg}(T)\} \subset X \times Y$. $y \in \operatorname{rg}(T)\} \subseteq X \times Y$
(iii) $\frac{\text { If } T: \mathcal{D}}{\mathcal{D}(T)} \supseteq X \rightarrow Y$ is linear and continuous, then $T$ is closable and $\mathcal{D}(\bar{T})=$

Examples 3.30. (i) A continuous operator that is not closed.
Let $X$ be normed space, $S \in L(X)$ and $\mathcal{D}$ a dense subset of $X$ with $X \backslash \mathcal{D} \neq \emptyset$. (For example, $d$ is dense in $c_{0}$.) Then $T:=\left.S\right|_{\mathcal{D}}$ is continuous because it is the restriction of a continuous function, but is not closed. To see this, fix an $x_{0} \in X \backslash \mathcal{D}$ and choose a sequence $\left(x_{n}\right)_{n \in \mathbb{N}} \subset \mathcal{D}$ which converges to $x_{0}$. The $\left(T x_{n}\right)_{n \in \mathbb{N}}$ converges (to $S x_{0}$ ). If $T$ would be closed, this would imply that $x_{0} \in \mathcal{D}$, contradicting the choice of $x_{0}$.
(ii) A closed operator that is not continuous. Let $X=C([-1,1]), \mathcal{D}=C^{1}([-1,1]) \subseteq C([-1,1])$ and $T: X \supseteq \mathcal{D} \rightarrow X, T x=$ $x^{\prime}$. Then $T$ is closed and not continuous.

Proof. Let $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq \mathcal{D}$ such that $\left(x_{n}\right)_{n \in \mathbb{N}}$ and $\left(T x_{n}\right)_{n \in \mathbb{N}}$ converge. From a well-known theorem in Analysis 1 it follows that $x_{0}:=\lim _{n \rightarrow \infty} x_{n}$ is differentiable and $T x_{0}=x_{0}^{\prime}=\left(\lim _{n \rightarrow \infty} x_{n}\right)^{\prime}=\lim _{n \rightarrow \infty} x_{n}^{\prime}=\lim _{n \rightarrow \infty} T x_{n}$.
That $T$ is not continuous was already shown in Example 2.7 (iv) (choose $\left.x_{n}(t)=\frac{1}{n} \exp (-n(t+1))\right)$.
(iii) Let $X=\mathscr{L}_{2}(-1,1), \mathcal{D}=C^{1}([0,1]) \subseteq \mathscr{L}_{2}([0,1])$ and $T: X \supseteq \mathcal{D} \rightarrow X, T x=$ $x^{\prime}$. Then $T$ is not closed.
Proof. Let $x_{n}:[-1,1] \rightarrow \mathbb{R}, x_{n}(t)=\left(t^{2}+n^{-2}\right)^{\frac{1}{2}}$. Then $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq \mathcal{D}$ and $x_{n} \rightarrow g$ for $n \rightarrow \infty$
derivatives converges where $g(t)=|t|, t \in[-1,1]$. The sequence of the derivatives converges

$$
x_{n}^{\prime}(t)=\frac{t}{\left(t^{2}+n^{-1}\right)^{\frac{1}{2}}} \rightarrow h(t)= \begin{cases}1, & t>0 \\ -1, & t<0 \\ 0, & t=0\end{cases}
$$

Obviously $h \in \mathscr{L}_{2}(-1,1)$. If $T$ would be closed, it would follow that $g \in$ $C^{1}([-1,1])$, a contradiction.
Definition 3.31. Let $X, Y$ be Banach spaces, $\mathcal{D} \subseteq X$ a subspace and $T: X \supseteq$ $\mathcal{D} \rightarrow Y$ a linear operator. Then

$$
\|\cdot\|_{T}: \mathcal{D} \rightarrow \mathbb{R}, \quad\|x\|_{T}=\|x\|+\|T x\|
$$

is called the graph norm of $T$.
It is easy to see that $\|\cdot\|_{T}$ is a norm on $\mathcal{D}$. Moreover, the norm defined above is equivalent to the norm $\|x\|_{T}^{\prime}=\sqrt{\|x\|^{2}+\|T x\|^{2}}$ on $\mathcal{D}$. Most of the time, the graph norm defined in Definition 3.31 is easier to use in calculations. However, the norm with the square root is sometimes more useful when operators in Hilbert spaces are considered.
Lemma 3.32. Let $X, Y$ be Banach spaces, $\mathcal{D} \subseteq X$ a subspace and $T: X \supseteq \mathcal{D} \rightarrow Y$ a closed linear operator. Then
(i) $\left(\mathcal{D},\|\cdot\|_{T}\right)$ is a Banach space.
(ii) $\widetilde{T}:\left(\mathcal{D},\|\cdot\|_{T}\right) \rightarrow Y, \widetilde{T} x=T x$, is continuous.

Proof. (i) To show completeness of $\left(\mathcal{D},\|\cdot\|_{T}\right)$ let $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq \mathcal{D}$ be a Cauchy se-
quence with respect to $\|\cdot\|_{T}$. Then, by definition of the graph norm, $\left(x_{n}\right)_{n \in \mathbb{N}}$ is a Cauchy sequence in $X$ and $\left(T x_{n}\right)_{n \in \mathbb{N}}$ is a Cauchy sequence in $Y$. Since $X$ and $Y$ are complete, the sequences converge. Hence, by the closeness of $T$, $\|\cdot\|-\lim _{n \rightarrow \infty} x_{n}=: x_{0} \in \mathcal{D}$ and $x_{n} \xrightarrow{\|\cdot\|_{T}} x_{0}$.
(ii) The statement follows from $\|\widetilde{T} x\|_{Y} \leq\|x\|_{X}+\|T x\|_{Y}=\|x\|_{T}, x \in \mathcal{D}$.
$\square$

Lemma 3.33. Let $X, Y$ be Banach spaces, $\mathcal{D} \subseteq X$ a subspace and $T: X \supseteq \mathcal{D} \rightarrow Y$ a closed surjective operator. Then $T$ is open. If, in addition, $T$ is injective, then $T^{-1}$ is continuous.

Proof. By Lemma 3.32 and the open mapping theorem (Theorem 3.22) the operator $i \widetilde{T}:\left(\mathcal{D},\|\cdot\|_{T}\right) \rightarrow Y, \widetilde{T} x=T x$, is open. Let $U \subseteq \mathcal{D}$ open with respect to the norm in $X$. Then $U$ is also open with respect to the graph norm because obviously $i:\left(\mathcal{D},\|\cdot\|_{T}\right) \rightarrow(\mathcal{D},\|\cdot\|), i x=x$, is bounded, hence continuous. Hence $T(U)=\widetilde{T}(U)$ is open in $Y$.
Now assume in addition that $T$ is injective. Then $\widetilde{T}^{-1}: Y \rightarrow\left(\mathcal{D},\|\cdot\|_{T}\right)$ is continuous by the inverse mapping theorem. Since $i$ is continuous, also $T^{-1}=\left(\widetilde{T} \circ i^{-1}\right)^{-1}=$ $i \circ \widetilde{T}^{-1}$ is continuous.

Lemma 3.34. Let $X, Y$ be Banach spaces, $\mathcal{D} \subseteq X$ a subspace and $T: X \supseteq \mathcal{D} \rightarrow Y$ $a$ closed injective linear operator such that $T^{-1}: \operatorname{rg}(T) \rightarrow X$ is continuous. Then $\operatorname{rg}(T)$ is closed.
Proof. Let $\left(y_{n}\right)_{n \in \mathbb{N}}$ be a Cauchy sequence in $\operatorname{rg}(T)$ with $y_{0}:=\lim _{n \rightarrow \infty} y_{n}$. and $x_{n}:=$ $T^{-1} y_{n}, n \in \mathbb{N}$. Then $\left(x_{n}\right)_{n \in \mathbb{N}}$ is a Cauchy sequence in $\mathcal{D}$ because $\left\|x_{n}-x_{m}\right\|=$ $\left\|T^{-1} y_{n}-T^{-1} y_{m}\right\| \leq\left\|T^{-1}\right\|\left\|y_{n}-y_{m}\right\|$. Hence $\left(x_{n}\right)_{n \in \mathbb{N}}$ converges in $X$ and its limit $x_{0}$ belongs to $\mathcal{D}$ and $y_{0}=\lim _{n \rightarrow \infty} y_{n}=T x_{0} \in \operatorname{rg}(T)$ because $T$ is closed.

Theorem 3.35 (Closed graph theorem). Let $X, Y$ be Banach spaces and $T$ : $X \rightarrow Y$ be a closed linear operator. Then $T$ is bounded.

Proof. Note that the projections

$$
\begin{array}{ll}
\pi_{1}: G(T) \rightarrow X, & \pi_{1}(x, T x)=x \\
\pi_{2}: G(T) \rightarrow Y, & \pi_{2}(x, T x)=T x
\end{array}
$$

are continuous and that $\pi_{1}$ is bijective. By assumption the graph $G(T)$ is closed in $X \times Y$, hence a Banach space, so $\pi_{1}$ is open by the open mapping theorem (Theorem 3.22). Hence $T=\pi_{2} \circ \pi_{1}^{-1}$ is continuous.

Lemma 3.36. Let $X, Y$ be Banach spaces, $\mathcal{D} \subseteq X$ a subspace and $T: \mathcal{D} \rightarrow Y$ linear. Then the following are equivalent:
(i) $T$ is closed and $\mathcal{D}(T)$ is closed.
(ii) $T$ is closed and $T$ is continuous.
(iii) $\mathcal{D}(T)$ is closed and $T$ is continuous.

Proof. (i) $\Longrightarrow$ (ii) follows from the closed graph theorem because by assumption $\mathcal{D}$ is Banach space.
(ii) $\Longrightarrow$ (iii) and (iii) $\Longrightarrow$ (i) are clear.

Example 3.37. An everywhere defined linear operator that is not closed.
Let $X$ be an infinite dimensional Banach space and $\left(x_{\lambda}\right)_{\lambda \in \Lambda}$ an algebraic basis of
$X$. Without restriction we can assume $\left\|x_{\lambda}\right\|=1, \lambda \in \Lambda$. Choose $\mathbb{N} \rightarrow \Lambda, n \mapsto \lambda_{n}$ be an injection. Then the operator

$$
T: X \rightarrow X, \quad T(x)=\sum_{n \in \mathbb{N}} n c_{\lambda_{n}} x_{\lambda_{n}} \quad \text { for } \quad x=\sum_{\lambda \in \Lambda} c_{\lambda_{n}} x_{\lambda_{n}} \in X,
$$

is well-defined. Assume that $T$ is closed. By the closed graph theorem $T$ must be bounded, but $\left\|T x_{\lambda_{n}}\right\|=\left\|n x_{\lambda_{n}}\right\|=n$ while $\left\|x_{\lambda_{n}}\right\|=1, n \in \mathbb{N}$ contradicting the boundedness of $T$.

### 3.5 Projections in Banach spaces

Definition 3.38. Let $X$ be a vector space. $P: X \rightarrow X$ is called a projection (on $\operatorname{rg}(P))$ if $P^{2}=P$.

Note that if $P$ is a projection, then also id $-P$ is a projection because $(\text { id }-P)^{2}=$ id $-2 P+P^{2}=\mathrm{id}-P$.

Lemma 3.39. Let $X$ be a normed space and $P \in L(X)$ a projection. Then the following holds:
(i) Either $P=0$ or $\|P\| \geq 1$.
(ii) $\operatorname{ker}(P)$ and $\operatorname{rg}(P)$ are closed.
(iii) $X$ is isomorphic to $\operatorname{ker} P \oplus \operatorname{rg}(P)$.

Proof. (i) Note that $\|P\|=\left\|P^{2}\right\| \leq\|P\|^{2}$, hence $0 \leq\|P\|-\|P\|^{2}=\|P\|(1-\|P\|)$. (ii) Since $P$ is continuous, $\operatorname{ker}(P)=P^{-1}(\{0\})$ is closed. To see that $\operatorname{rg}(P)$ is closed, it suffices to show that $\operatorname{rg}(P)=\operatorname{ker}(\mathrm{id}-P)$. Indeed, $x \in \operatorname{ker}(\mathrm{id}-P)$ implies $x=P x \in \operatorname{rg}(P)$ and $y \in \operatorname{rg}(P)$ implies $(P-\mathrm{id}) y=P y-y=y-y=0$, hence $y \in \operatorname{ker}(\mathrm{id}-P)$.
(iii) Obviously $x \mapsto((\mathrm{id}-P) x, P x) \in \operatorname{ker}(P) \oplus \operatorname{rg}(P)$ is well defined, linear, bijective and continuous because id $-P$ and $P$ are continuous. By the inverse mapping theorem then also the inverse operator is continuous which shows that $X$ and $\operatorname{ker}(P) \oplus \operatorname{rg}(P)$ are isomorphic.

Theorem 3.40. Let $X$ be a normed space, $U \subseteq X$ a finite dimensional subspace. Then there exists a linear continuous projection $P$ of $X$ to $U$ with $\|P\| \leq \operatorname{dim} U$.

Proof. From linear algebra we know that there exist bases $\left(u_{1}, \ldots, u_{n}\right)$ of $U$ and $\left(\varphi_{1}, \ldots, \varphi_{n}\right)$ of $U^{\prime}$ such that $\left\|u_{k}\right\|=\left\|\varphi_{k}\right\|=1$ and $\varphi_{j}\left(u_{k}\right)=\delta_{j k}, j, k=1, \ldots, n$. By the Hahn-Banach theorem the $\varphi_{k}$ can be extended to linear functionals $\psi_{k}$ on $X$ with $\left\|\varphi_{k}\right\|=\left\|\psi_{k}\right\|$. We define

$$
P: X \rightarrow X, \quad P x=\sum_{k=1}^{n} \varphi_{k}(x) u_{k} .
$$

Obviously $P$ is a linear bounded projection on $U$ and $\|P x\| \leq \sum_{k=1}^{n}\left\|\varphi_{k}\right\|\|x\|\left\|u_{k}\right\|=$ $\sum_{k=1}^{n}\|x\|=n\|x\|$.

Theorem 3.41. Let $X$ be Banach space, $U, V \subseteq X$ closed subspaces such that $X$ and $U \oplus V$ are algebraically isomorphic. Then the following holds:
(i) $X$ is isomorphic to $V \oplus U$ with $\|(u, v)\|=\|u\|+\|v\|$.
(ii) There exists a continuous linear projection of $X$ on $U$.
(iii) $V$ is isomorphic to $X / U$.

Proof. (i) Since $U$ and $V$ are Banach spaces, their sum $U \oplus V$ is a Banach space The map $U \oplus V \rightarrow X,(u, v) \mapsto u+v$ is linear, continuous and bijective. Hence by the inverse mapping theorem, also the inverse is continuous.
(ii) $P: X \rightarrow U, u+v \mapsto u$ is the desired projection.
(iii) The map $V \mapsto X / V, v \mapsto[v]$ is linear, bijective and continuous. Since $U$ is closed, $X / U$ is a Banach space. By the inverse mapping theorem it follows that $V$ and $X / U$ are isomorphic.

Definition 3.42. let $X$ be a Banach space. A closed subspace $U i$ of $X$ is called complemented if there exists a continuous linear projection on $U$.

Remark 3.43. Note that not every closed subspace of a Banach space is complemented in the sense of the theorem above. For example, $c_{0}$ is not complemented as subspace of $\ell_{\infty}$.

### 3.6 Weak convergence

Definition 3.44. Let $X$ be a set and $\mathcal{U}=\left(U_{\lambda}\right)_{\lambda \in \Lambda}$ a family of subsets of sets in Definition 3.44. Let $X$ be a set and $U=\left(U_{\lambda}\right)_{\lambda \in \Lambda}$ a family of subsets of sets in
$X$. The smallest topology on $X$ such that all $U_{\lambda}$ are open is called the topology generated by $\mathcal{U}$, denoted by $\tau(\mathcal{U})$.

Obviously $\tau(\mathcal{U})$ exists and is the intersection of topologies containing all $U_{\lambda}$.
Lemma 3.45. Let $X$ be a set, $\mathcal{U}=\left(U_{\lambda}\right)_{\lambda \in \Lambda}$ a family of subsets of $X$. Then the topology generated by $\mathcal{U}$ consists of all sets of the form

$$
\begin{equation*}
\bigcup_{\gamma \in \Gamma} \bigcap_{k=1}^{n} U_{\gamma, k} \tag{3.10}
\end{equation*}
$$

that is, of arbitrary unions of finite intersections of sets in the family $\mathcal{U}$.
Proof. Let $\tau(\mathcal{U})$ be the topology generated by $\mathcal{U}$ and $\sigma(\mathcal{U})$ the system of sets described in (3.10). It is not hard to see that $\sigma(\mathcal{U})$ is a topology containing $\mathcal{U}$, hence containing $\tau(\mathcal{U})$. On the other hand, all sets of the form (3.10) are open in $\tau(\mathcal{U})$ so $\sigma(\mathcal{U}) \subseteq \tau(\mathcal{U})$.
Definition 3.46. Let $X$ be a set, $\Lambda$ be an index set and for every $\lambda \in \Lambda$ let $\left(Y_{\lambda}, \tau_{\lambda}\right)$ be a topological space. Consider a family $\mathcal{F}=\left(f_{\lambda}: X \rightarrow Y_{\lambda}\right)$ of functions. The smallest topology on $X$ such that all $f_{\lambda}$ are continuous, is called the initial topology on $X$, denoted by $\sigma(X, \mathcal{F})$
Note that $\tau(\mathcal{F})=\tau\left(\left\{f_{\lambda}^{-1}\left(U_{\lambda}\right): \lambda \in \Lambda, U_{\lambda} \in \tau_{\lambda}\right\}\right.$.
Definition 3.47. Let $X$ be a normed space. The topology $\sigma\left(X, X^{\prime}\right)$ is called the weak topology on $X$. The topology $\sigma\left(X^{\prime}, X\right)$ is called the weak* topology on $X$ when $X$ is identified with a subset of $X^{\prime \prime}$ by the canonical map $J_{X}$.

Note that $\sigma\left(X^{\prime}, X\right) \subseteq \sigma\left(X^{\prime}, X^{\prime \prime}\right) \subseteq \sigma_{\|\cdot\|}$.
Lemma 3.48. Let $X$ be a normed space. $A$ sequence $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq X$ is weakly con vergent to some $x_{0} \in X$ (in the sense of Definition 2.37) if and only if it converges in the weak topology $\sigma\left(X, X^{\prime}\right)$.

Proof. Assume that $\left(x_{n}\right)_{n \in \mathbb{N}}$ is weakly convergent with $x_{0}:=w$ - $\lim _{n \rightarrow \infty} x_{n}$ and let $U$ be a $\sigma\left(X, X^{\prime}\right)$-open set containing $x_{0}$. Then there exist $\varphi_{1}, \ldots, \varphi_{n}$ such that

$$
x_{0} \in \bigcap_{k=1}^{n} \varphi_{j}^{-1}\left(V_{j}\right) \subseteq U
$$

with $V_{j}$ open subsets in $\mathbb{R}$ containing $\varphi_{j}\left(x_{0}\right)$. Since $\lim _{n \rightarrow \infty} \varphi\left(x_{n}\right)=\varphi\left(x_{0}\right)$ for all $\varphi \in X^{\prime}$, we can choose an $N \in \mathbb{N}$ such that $\varphi_{j}\left(x_{n}\right) \stackrel{n \rightarrow \infty}{\in} U_{j}$ for all $n \geq N$ and all $j=1, \ldots, n$. Hence $x_{n} \in \bigcap_{k=1}^{n}\left\{\varphi_{j}^{-1}\left(V_{j}\right)\right\} \subseteq U$ for all $n \geq N$.
Now assume that $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq X$ converges to $x_{0}$ in the weak topology. Since by definition of $\sigma\left(X, X^{\prime}\right)$ all functionals $\varphi \in X^{\prime}$ are continuous, it follows that $\left(\varphi\left(x_{n}\right)\right)_{n \in \mathbb{N}}$
converges to $\varphi\left(x_{0}\right)$ for every $\varphi \in X^{\prime}$.

Lemma 3.49. Let $X$ be a normed space, $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq X$ and $\left(\varphi_{n}\right)_{n \in \mathbb{N}} \subseteq X^{\prime}$.
(i) $x_{0}=w$ - $\lim _{n \rightarrow \infty} x_{n} \quad \Longrightarrow \quad\left\|x_{0}\right\| \leq \liminf _{n \rightarrow \infty} x_{n}$.
(ii) $\varphi_{0}=w *-\lim _{n \rightarrow \infty} \varphi_{n} \quad \Longrightarrow \quad\left\|\varphi_{0}\right\| \leq \liminf _{n \rightarrow \infty} \varphi_{n}$.

Proof. (i) For $x_{0}=0$ the assertion is clear. By the Hahn-Banach theorem there exists an $\varphi \in X^{\prime}$ such that $\varphi\left(x_{0}\right)=\left\|x_{0}\right\|$ and $\|\varphi\|=1$. Hence

$$
\left\|x_{0}\right\|=\left\|\lim _{n \rightarrow \infty} \varphi\left(x_{n}\right)\right\| \leq \liminf _{n \rightarrow \infty}\|\varphi\|\left\|x_{n}\right\|=\liminf _{n \rightarrow \infty}\left\|x_{n}\right\| .
$$

(ii) Let $\varepsilon>0$. Then there exists an $x \in X$ with $\|x\|=1$ such that $\left\|\varphi_{0}\right\|-\varepsilon<$ $\left\|\varphi_{0}(x)\right\|$. The statement follows as above
$\left\|\varphi_{0}\right\|-\varepsilon<\left\|\varphi_{0}(x)\right\|=\lim _{n \rightarrow \infty}\left\|\varphi_{n}(x)\right\| \leq \liminf _{n \rightarrow \infty}\left\|\varphi_{n}\right\|\|x\|=\liminf _{n \rightarrow \infty}\left\|\varphi_{n}\right\| . \quad \square$
Definition 3.50. Let $X$ be a topological space. A function $f: X \rightarrow \mathbb{R}$ is called upper semicontinuous if $\limsup _{x_{n} \rightarrow x} f\left(x_{n}\right) \leq f(x)$. It is called lower semicontinuous if $\liminf _{x_{n} \rightarrow x} f\left(x_{n}\right) \geq f(x)$.

Hence the lemma above states that $\|\cdot\|$ is lower semicontinuous in the weak topology.
Definition 3.51. For $\lambda \in \Lambda$ let ( $X_{\lambda}, \tau_{\lambda}$ ) be topological spaces. Define

$$
X:=\prod_{\lambda \in \Lambda} X_{\lambda}:=\left\{f: \Lambda \rightarrow \bigcup_{\lambda \in \Lambda} X_{\lambda}: f(\lambda) \in X_{\lambda}, \lambda \in \Lambda\right\} .
$$

The product topology on $X$ is the weakest topology such that for every $\lambda \in \Lambda$ the projection

$$
\pi_{\lambda}: X \rightarrow X_{\lambda}, \quad \pi_{j}(f)=f(j)
$$

## is continuous

Lemma 3.52. Let $X$ as above with the product topology. Let $\mathcal{O} \subseteq \mathbb{P}(X)$ be the family of all sets $U \subseteq X$ such that for every $u \in U$ there exist $\lambda_{j} \in \Lambda, U_{j} \subseteq X_{\lambda_{j}}$ open, $j=1, \ldots, n$, such that

$$
u \in\left\{s \in X: s\left(\lambda_{j}\right) \in U_{j}, j=1, \ldots, n\right\}=\bigcap_{j=1}^{n} \underbrace{\pi_{\lambda_{j}}^{-1}\left(U_{j}\right)}_{\text {open in } \mathcal{O}} \subseteq U .
$$

Then $\mathcal{O}$ is the product topology on $X$.
Proof. This is a special case of Lemma 3.48.
Theorem 3.53 (Banach-Alaoglu). Let $X$ be a normed space. Then the closed unit ball $K_{1}^{\prime}:=\left\{\varphi \in X^{\prime}:\|\varphi\| \leq 1\right\}$ is weak $*$-compact.

Proof. For $x \in X$ define the set $A_{x}:=\{z \in \mathbb{K}:|z| \leq\|x\|\}$ and let $A:=\prod_{x \in X} A_{x}$ together with the product topology. By Tychonoff's theorem $A$ is compact. Note that elements $a \in A$ are maps $X \rightarrow \mathbb{K}$ with $|a(x)| \leq\|x\|, x \in X$. Hence $K_{1}^{\prime} \subseteq A$ because $|\varphi(x)| \leq\|\varphi\|\|x\| \leq\|x\|$ for every $\varphi \in K_{1}^{\prime}$. The product topology on $A$ is the weakest topology on $A$ such that for every $x \in X$ the map $\pi_{x}: A \rightarrow \mathbb{K}, a \mapsto a(x)$ is continuous. Hence the topology on $K_{1}^{\prime}$ induced by $A$ is exactly the weak *-topology on $K_{1}^{\prime}$. So it suffices to show that $K_{1}^{\prime}$ is closed in $A$ with the product topology.

$$
\begin{aligned}
& \text { Let } \varphi \in \overline{K_{1}^{\prime}} \text { and let } x, y \in X \text { and } \varepsilon>0 \text {. Then } \\
& \qquad U:=\{a \in A:|a(x+y)-\varphi(x+y)|<\varepsilon,|a(x)-\varphi(x)|<\varepsilon,|a(y)-\varphi(y)|<\varepsilon\}
\end{aligned}
$$

$$
\text { is an open neighbourhood of } \varphi \text {. Hence there exists an } g \in K_{1}^{\prime} \in U \cap K_{1}^{\prime} \text {. Since } g \text { is }
$$ linear, it follows that

$$
\begin{aligned}
|\varphi(x+y)-\varphi(x)-\varphi(y)| & =|\varphi(x+y)-\varphi(x)-\varphi(y)-g(x+y)+g(x)+g(y)| \\
& \leq|\varphi(x+y)-g(x+y)|+|\varphi(x)-g(x)|+|\varphi(y)-g(y)|<3 \varepsilon .
\end{aligned}
$$

Since $\varepsilon$ was arbitrary, this implies $\varphi(x+y)=\varphi(x)+\varphi(y)$. Similarly it can be shown that $\varphi(\lambda x)=\lambda \varphi(x)$ for $\lambda \in \mathbb{K}$ and $x \in X$. It follows that $\varphi$ is linear. Since $\varphi \in A$, it follows that $\|\varphi\| \leq 1$, hence $\varphi \in K_{1}^{\prime}$.

## Chapter 4

## Hilbert spaces

### 4.1 Hilbert spaces

Definition 4.1. Let $X$ be a $\mathbb{K}$-vector space. A map

$$
\langle\cdot, \cdot\rangle: X \times X \rightarrow \mathbb{K}
$$

is a sesquilinear form on $X$ if for all $x, y, z \in X, \lambda \in \mathbb{K}$
(i) $\langle\lambda x+y, z\rangle=\lambda\langle x, z\rangle+\langle y, z\rangle$,
(ii) $\langle x, \lambda y+z\rangle=\bar{\lambda}\langle x, y\rangle+\langle x, z\rangle$.

The inner product is called

- hermitian $\Longleftrightarrow\langle x, y\rangle=\overline{\langle y, x\rangle}, \quad x, z \in X$,
- positive semidefinite $\Longleftrightarrow\langle x, x\rangle \geq 0, \quad x \in X$
- positive (definite) $\Longleftrightarrow\langle x, x\rangle>0, \quad x \in X \backslash\{0\}$

Definition 4.2. A positive definite hermitian sesquilinear form on a $\mathbb{K}$-vector $X$ is called an inner product on $X$ and $(X,\langle\cdot, \cdot\rangle)$ is called an inner product space (or pre-Hilbert space).

Note that $\langle x, x\rangle \in \mathbb{R}, x \in X$, for a hermitian sesquilinear form $X$ because $\langle x, x\rangle=$ $\overline{\langle x, x\rangle}$.

Lemma 4.3 (Cauchy-Schwarz inequality). Let $X$ be $a \mathbb{K}$-vector space with inner product $\langle\cdot, \cdot\rangle$. Then for all $x, y \in X$

$$
\begin{equation*}
|\langle x, y\rangle|^{2} \leq|\langle x, x\rangle||\langle y, y\rangle|, \tag{4.1}
\end{equation*}
$$

with equality if and only if $x$ and $y$ are linearly dependent.
Proof. For $x=0$ or $y=0$ there is nothing to show. Now assume that $y \neq 0$. For all $\lambda \in \mathbb{K}$

$$
0 \leq\langle x+\lambda y, x+\lambda y\rangle=\langle x, x\rangle+\lambda\langle y, x\rangle+\bar{\lambda}\langle x, y\rangle+|\lambda|^{2}\langle y, y\rangle
$$

In particular, when we choose $\lambda=-\frac{\langle x, y\rangle}{\langle y, y\rangle}$ we obtain

$$
\begin{aligned}
0 \leq\langle x+\lambda y, x+\lambda y\rangle & =\langle x, x\rangle-\frac{|\langle y, x\rangle|^{2}}{\langle y, y\rangle}-\frac{|\langle x, y\rangle|^{2}}{\langle y, y\rangle}+\frac{|\langle x, y\rangle|^{2}}{\langle y, y\rangle} \\
& =\langle x, x\rangle-\frac{|\langle x, y\rangle|^{2}}{\langle y, y\rangle}
\end{aligned}
$$

which proves (4.1). If there exist $\alpha, \beta \in K$ such that $\alpha x+\beta y=0$, then obviously equality holds in (4.1). On the other hand, if equality holds, then $\langle x+\lambda y, x+\lambda y\rangle=0$ with $\lambda$ chosen as above, so $x$ and $y$ are linearly dependent.

Note that (4.1) is true also in a space $X$ with a semidefinite hermitian sesquilinea form but equality in (4.1) does not imply that $x$ and $y$ are linearly dependent.

Lemma 4.4. An inner product space $(X,\langle\cdot, \cdot\rangle)$ becomes a normed space by setting $\|x\|:=\langle x, x\rangle^{\frac{1}{2}}, x \in X$.

Proof. The only property of a norm that does not follow immediately from the definition of $\|\cdot\|$ is the triangle inequality. To prove the triangle inequality, choose $x, y \in X$. Using the Cauchy-Schwarz inequality, we find

$$
\begin{align*}
\|x+y\|^{2} & =\|x\|^{2}+2 \operatorname{Re}\langle x, y\rangle+\|y\|^{2} \leq\|x\|^{2}+2|\langle x, y\rangle|+\|y\|^{2} \\
& \leq\|x\|^{2}+2\|x\|\|y\|+\|y\|^{2}=(\|x\|+\|y\|)^{2} .
\end{align*}
$$

In the following, we will always consider inner product spaces endowed with the topology induced by the norm.

Definition 4.5. A complete inner product space is called a Hilbert space
Lemma 4.6. Note that the scalar product on a inner product space $X$ is a continuous map $X \times X \rightarrow \mathbb{K}$ when $X \times X$ is equipped with the norm $\|(x, y)\|=\|x\|_{X}+\|y\|_{X}$.

Proof. The statement follows from

$$
\left|\left\langle x_{1}, x_{2}\right\rangle-\left\langle y_{1}, y_{2}\right\rangle\right|=\left|\left\langle x_{1}, x_{2}-y_{2}\right\rangle-\left\langle y_{1}-x_{1}, y_{2}\right\rangle\right|
$$

$$
\leq\left\|x_{1}\right\|\left\|x_{2}-y_{2}\right\|-\left\|y_{1}-x_{1}\right\|\left\|y_{2}\right\| .
$$

The polarisation formula allows to express the inner product of two elements of $X$ in terms of their norms.

Theorem 4.7 (Polarisation formula). Let $X$ be an inner product space over $\mathbb{K}$ and $x, y \in X$. Then

$$
\begin{array}{ll}
\langle x, y\rangle=\frac{1}{4}\left(\|x+y\|^{2}-\|x-y\|^{2}\right), & \text { if } \mathbb{K}=\mathbb{R}, \\
\langle x, y\rangle=\frac{1}{4}\left(\|x+y\|^{2}-\|x-y\|^{2}+\mathrm{i}\|x+\mathrm{i} y\|^{2}-\mathrm{i}\|x-\mathrm{i} y\|^{2}\right), & \text { if } \mathbb{K}=\mathbb{C} .
\end{array}
$$

Proof. Straightforward calculation.
A necessary and sufficient criterion for a normed space to be an inner product space is the following.

Theorem 4.8 (Parallelogram identity). Let $X$ be normed space. Then the norm on $X$ is generated by an inner product if and only if for all $x, y \in X$ the parallelogram identity is satisfied:

$$
\|x+y\|^{2}+\|x-y\|^{2}=2\|x\|^{2}+2\|y\|^{2} .
$$

In this case, the inner product is given by the polarisation formula.

Proof. Assume that the norm is generated by the inner product $\langle\cdot, \cdot\rangle$ and let $\|x\|=$ $\langle x, x\rangle^{\frac{1}{2}}$. Then for all $x, y \in X$ parallelogram identity holds:

$$
\begin{aligned}
\|x+y\|^{2}+\|x-y\|^{2} & =\|x\|^{2}+\|y\|^{2}+2 \operatorname{Re}\langle x, y\rangle+\|x\|^{2}+\|y\|^{2}-2 \operatorname{Re}\langle x, y\rangle \\
& =2\|x\|^{2}+2\|y\|^{2}
\end{aligned}
$$

Now assume that the norm on $X$ is such that the parallelogram identity holds and for $x, y \in X$ define $\langle x, y\rangle$ by the polarisation formula. We prove that $\langle\cdot, \cdot\rangle$ is an inner product on $X$ in the case $\mathbb{K}=\mathbb{C}$. The case $\mathbb{K}=\mathbb{R}$ can be proved analogously.

- Positivity.

$$
\begin{aligned}
4\langle x, x\rangle & =\|x+x\|^{2}-\|x-x\|^{2}+\mathrm{i}\|x+\mathrm{i} x\|^{2}-\mathrm{i}\|x-\mathrm{i} x\|^{2} \\
& =4\|x\|^{2}+\mathrm{i}\|x+\mathrm{i} x\|^{2}-\mathrm{i}\|\mathrm{i} x+x\|^{2}=4\|x\|^{2} \geq 0 .
\end{aligned}
$$

- Hermiticity.

$$
4\langle x, y\rangle=\|x+y\|^{2}-\|x-y\|^{2}+\mathrm{i}\|x+\mathrm{i} y\|^{2}-\mathrm{i}\|x-\mathrm{i} y\|^{2}
$$

$$
=\|y+x\|^{2}-\|y-x\|^{2}+\mathrm{i}\|-\mathrm{i} x+y\|^{2}-\mathrm{i}\|\mathrm{i} x+y\|^{2}=4 \overline{\langle y, x\rangle} .
$$

- Additivity

$$
\begin{aligned}
& 4(\langle x, y\rangle+\langle x, z\rangle) \\
&=\|x+y\|^{2}-\|x-y\|^{2}+\mathrm{i}\|x+\mathrm{i} y\|^{2}-\mathrm{i}\|x-\mathrm{i} y\|^{2} \\
&+\|x+z\|^{2}-\|x-z\|^{2}+\mathrm{i}\|x+\mathrm{i} z\|^{2}-\mathrm{i}\|x-\mathrm{i} z\|^{2} \\
&=\left\|x+\frac{y+z}{2}+\frac{y-z}{2}\right\|^{2}-\left\|x-\frac{y+z}{2}-\frac{y-z}{2}\right\|^{2} \\
&+\left\|x+\frac{y+z}{2}-\frac{y-z}{2}\right\|^{2}-\left\|x-\frac{y+z}{2}+\frac{y-z}{2}\right\|^{2} \\
&+\mathrm{i}\left\|x+\mathrm{i} \frac{y+z}{2}+\mathrm{i} \frac{y-z}{2}\right\|^{2}-\mathrm{i}\left\|x-\mathrm{i} \frac{y+z}{2}-\mathrm{i} \frac{y-z}{2}\right\|^{2} \\
&+\mathrm{i}\left\|x+\mathrm{i} \frac{y+z}{2}-\mathrm{i} \frac{y-z}{2}\right\|^{2}-\mathrm{i}\left\|x-\mathrm{i} \frac{y+z}{2}+\mathrm{i} \frac{y-z}{2}\right\|^{2} \\
&= 2\left\|x+\frac{y+z}{2}\right\|^{2}+2\left\|\frac{y-z}{2}\right\|^{2}-2\left\|x-\frac{y+z}{2}\right\|^{2}-2 \|^{y-z} \\
& 2
\end{aligned} \|^{2} .
$$

If we choose $z=0$ we find $\langle x, y\rangle=2\left\langle x, \frac{y}{2}\right\rangle$, hence

$$
\langle x, y\rangle+\langle x, z\rangle=2\left\langle x, \frac{y+z}{2}\right\rangle=\langle x, y+z\rangle .
$$

- Homogeneity. From the additivity we obtain $\langle\lambda x, y\rangle=\lambda\langle x, y\rangle$ for all $\lambda \in \mathbb{Q}$. Note that $\langle\mathrm{i} x, y\rangle=\mathrm{i}\langle x, y\rangle$, hence homogeneity is proved for $\lambda \in \mathbb{Q}+\mathrm{i} \mathbb{Q}$. Hence for fixed $x, y \in \mathbb{C}$ the two continuous functions $\mathbb{C} \rightarrow \mathbb{C}, \lambda \mapsto \lambda\langle x, y\rangle$ and $\mathbb{C} \rightarrow \mathbb{C}, \lambda \mapsto\langle\lambda x, y\rangle$ must be equal because they are equal on the dense subset $\mathbb{Q}+\mathbb{Q} \mathbb{Q}$ of $\mathbb{C}$.

Theorem 4.9. The completion of an inner product space is an inner product space. Proof. By continuity of the norm, the parallelogram identity holds on the completion $\bar{X}$ of an inner product space $X$. So $\bar{X}$ is an inner product space.
Examples 4.10. (i) $\mathbb{R}^{n}$ and $\mathbb{C}^{n}$ with the Euclidean inner product

$$
\langle x, y\rangle=\sum_{k=1}^{n} x_{k} \overline{y_{k}}, \quad x=\left(x_{k}\right)_{k=1}^{n}, y=\left(y_{k}\right)_{k=1}^{n},
$$

are inner product spaces.
(ii) $\ell_{2}(\mathbb{N})$ with

$$
\langle x, y\rangle=\sum_{k=1}^{\infty} x_{k} \overline{y_{k}}, \quad x=\left(x_{k}\right)_{k \in \mathbb{N}}, y=\left(y_{k}\right)_{k \in \mathbb{N}},
$$

is an inner product space.
(iii) Let $\mathcal{R}([0,1])$ be the vector space of the Riemann integrable functions on the interval $[0,1]$. Then

$$
\langle f, g\rangle=\int_{0}^{1} f(t) \overline{g(t)} \mathrm{d} t, \quad f, g \in \mathcal{R}([0,1]),
$$

defines a sesquilinear form on $\mathcal{R}([0,1])$ which is not positive definite, since, for example, $\chi_{\{0\}} \neq 0$, but $\left\langle\chi_{\{0\}}, \chi_{\{0\}}\right\rangle=0$.
The restriction of $\langle\cdot, \cdot\rangle$ to the space of the continuous functions $C([0,1])$ is an inner product which is not complete (its closure is the space $\mathscr{L}_{2}([0,1])$ ).

### 4.2 Orthogonality

Definition 4.11. Let $X$ be an inner product space.
(i) Elements $x, y \in X$ are called orthogonal, denoted by $x \perp y$, if and only if $\langle x, y\rangle=0$
(ii) Subsets $A, B \subseteq X$ are called orthogonal, denoted by $A \perp B$, if and only if $\langle a, b\rangle=0$ for all $a \in A, b \in B$.
(iii) The orthogonal complement of a set $M \subseteq X$ is

$$
M^{\perp}:=\{x \in X: x \perp m, m \in M\}
$$

Remarks 4.12. (i) Pythagoras' theorem holds: $\|x+y\|^{2}=\|x\|^{2}+\|y\|^{2}$ if $x \perp y$.
(ii) For every set $M \subseteq X$ its orthogonal complement $M^{\perp}$ is a closed subspace of $X$.
(iii) $A \subseteq\left(A^{\perp}\right)^{\perp}$ for every subset $A \subseteq X$.
(iv) $A^{\perp}=(\operatorname{span} A)^{\perp}$ for every subset $A \subseteq X$.

Theorem 4.13 (Projection theorem). Let $H$ be a Hilbert space, $M \subseteq H$ nonempty closed and convex subset and $x_{0} \in H$. Then there exists exactly one $y_{0} \in M$ such that $\left\|x_{0}-y_{0}\right\|=\operatorname{dist}\left(x_{0}, M\right)$.

Proof. Recall that dist $\left(x_{0}, M\right):=\inf \left\{\left\|x_{0}-y\right\|: y \in M\right\}$. If $x_{0} \in M$ then the assertion is clear (choose $y_{0}=x_{0}$ ).
Now assume that $x_{0} \notin M$. Without restriction we may assume $x_{0}=0$.
Existence of $y_{0}$. Let $d:=\operatorname{dist}\left(x_{0}, M\right)=\inf \{\|y\|: y \in M\}$. Then there exists a sequence $\left(y_{n}\right)_{n \in \mathbb{N}} \subseteq M$ such that $\lim _{n \rightarrow \infty}\left\|y_{n}\right\|=d$. We will show that $\left(y_{n}\right)_{n \in \mathbb{N}}$ is a
Cauchy sequence. Note that $\left\|\frac{y_{n}+y_{m} \rightarrow \infty}{2}\right\|^{2} \geq d^{2}$ because $\frac{y_{n}+y_{m}}{2} \in M$ by the convexity of $M$. Hence the parallelogram identity (Theorem 4.8) yields

$$
\begin{aligned}
\left\|\frac{y_{n}-y_{m}}{2}\right\|^{2} & \leq\left\|\frac{y_{n}-y_{m}}{2}\right\|^{2}+\left\|\frac{y_{n}+y_{m}}{2}\right\|^{2}-d^{2} \\
& =\frac{1}{2}\left(\left\|y_{n}\right\|^{2}+\left\|y_{m}\right\|^{2}\right)-d^{2} \longrightarrow 0, \quad n, m \rightarrow \infty .
\end{aligned}
$$

Since $X$ is a Banach space, $\left(y_{n}\right)_{n \in \mathbb{N}}$ converges to some $y_{0} \in X$, and since $M$ is closed, $y_{0} \in M$.
Uniqueness of $y_{0}$. Assume that there are $y_{0}, \tilde{y}_{0} \in M$ such that $\left\|y_{0}\right\|=\left\|\tilde{y}_{0}\right\|=d=$ $\operatorname{dist}\left(x_{0}, M\right)$. The parallelogram identity yields

$$
d^{2} \leq\left\|\frac{y_{0}+\tilde{y}_{0}}{2}\right\|^{2} \leq\left\|\frac{y_{0}+\tilde{y}_{0}}{2}\right\|^{2}+\left\|\frac{y_{0}-\tilde{y}_{0}}{2}\right\|^{2}=\frac{1}{2}\left(\left\|y_{0}\right\|^{2}+\left\|\tilde{y}_{0}\right\|^{2}\right)=d^{2} .
$$

It follows that $\left\|y_{0}-\tilde{y}_{0}\right\|=0$, so $y_{0}=\tilde{y}_{0}$.
Lemma 4.14. Let $M$ be a closed and convex subset of a Hilbert space $H$ and fix $x_{0} \in H$. For $y_{0} \in M$ the following are equivalent:
(i) $\left\|x_{0}-y_{0}\right\|=\operatorname{dist}\left(x_{0}, M\right)$,
(ii) $\operatorname{Re}\left\langle x_{0}-y_{0}, y-y_{0}\right\rangle \leq 0, \quad y \in M$.

Proof. (i) $\Longrightarrow$ (ii) For $t \in[0,1]$ and $y \in M$ let $y_{t}:=y_{0}+t\left(y-y_{0}\right)$. Then $y_{t} \in M$ by the convexity of $M$ and by assumption on $y_{0}$

$$
\left\|x_{0}-y_{0}\right\|^{2} \leq\left\|x_{0}-y_{t}\right\|^{2}=\left\|x_{0}-y_{0}-t\left(y-y_{0}\right)\right\|^{2}
$$

$$
=\left\|x_{0}-y_{0}\right\|^{2}-2 t \operatorname{Re}\left\langle x_{0}-y_{0}, y-y_{0}\right\rangle+t^{2}\left\|y-y_{0}\right\|^{2}
$$

So for all $t \in(0,1]$

$$
2 \operatorname{Re}\left\langle x_{0}-y_{0}, y-y_{0}\right\rangle \leq t\left\|y-y_{0}\right\|^{2}
$$

which implies $\operatorname{Re}\left\langle x_{0}-y_{0}, y-y_{0}\right\rangle \leq 0$.
(ii) $\Longrightarrow$ (i) Let $y \in M$. By assumption

$$
\left\|x_{0}-y\right\|^{2}=\left\|\left(x_{0}-y_{0}\right)+\left(y_{0}-y\right)\right\|^{2}
$$

$$
=\left\|x_{0}-y_{0}\right\|^{2}+\left\|y_{0}-y\right\|^{2}+2 \operatorname{Re}\left\langle x_{0}-y_{0}, y_{0}-y\right\rangle \geq\left\|x_{0}-y_{0}\right\|^{2} .
$$

Lemma 4.15. Let $U$ be a closed subspace of a Hilbert space $H$ and fix $x_{0} \in H$. For $y_{0} \in U$ the following are equivalent:
(i) $\left\|x_{0}-y_{0}\right\|=\operatorname{dist}\left(x_{0}, U\right)$,
(ii) $x_{0}-y_{0} \perp U$.

Proof. (i) $\Longrightarrow$ (ii) Let $y \in U$. If $y=0$, then obviously $\left\langle x_{0}-y_{0}, y\right\rangle=0$. If $\|y\|=1$ let $\lambda=\|y\|^{-1}\left\langle x_{0}-y_{0}, y\right\rangle$. By assumption

$$
\left\|x_{0}-y_{0}\right\|^{2} \leq\left\|x_{0}-y_{0}-\lambda y\right\|^{2}
$$

$$
=\left\|x_{0}-y_{0}\right\|^{2}-\bar{\lambda}\left\langle x_{0}-y_{0}, y\right\rangle-\lambda\left\langle y, x_{0}-y_{0}\right\rangle+|\lambda|^{2}\|y\|^{2}
$$

$$
=\left\|x_{0}-y_{0}\right\|^{2}+\left(1-2\|y\|^{-2}\right)\left|\left\langle x_{0}-y_{0}, y\right\rangle\right|^{2}
$$

$$
=\left\|x_{0}-y_{0}\right\|^{2}-\left|\left\langle x_{0}-y_{0}, y\right\rangle\right|^{2}
$$

so $\left\langle x_{0}-y_{0}, y\right\rangle=0$. By linearity of $U$ then $x_{0}-y_{0} \perp y$ for all $y \in U$.
(ii) $\Longrightarrow$ (i) Let $y \in U$. By assumption
$\left\|x_{0}-y\right\|^{2}=\left\|\left(x_{0}-y_{0}\right)+\left(y_{0}-y\right)\right\|^{2}=\left\|x_{0}-y_{0}\right\|^{2}+\left\|y_{0}-y\right\|^{2} \geq\left\|x_{0}-y_{0}\right\|^{2} . \quad \square$
Recall that a linear operator $P: X \rightarrow X$ on a Banach space $X$ is called a projection if and only if $P^{2}=P$ (see Definition 3.38).

Theorem 4.16. Let $H$ be a Hilbert space, $U \subseteq H$ a closed subspace with $U \neq$ $\{0\}$. Then there exists a projection $P_{U} \in L(H)$ on $U$ such that $\left\|P_{U}\right\|=1$ and $\operatorname{ker}\left(P_{U}\right)=U^{\perp}$. Also id $-P_{U}$ is continuous projection with $\|$ id $-P_{U} \|=0$ if $U=H$ and $\|$ id $-P_{U} \|=1$ if $U \neq H$. If $U \oplus U^{\perp}$ is equipped with the norm $\|(u, v)\|=$ $\left(\|u\|^{2}+\|v\|^{2}\right)^{\frac{1}{2}}$, then $H=U \oplus U^{\perp}$.
Definition 4.17. $P_{U}$ as in the theorem is called the orthogonal projection on $U$.
Proof of Theorem 4.16. Fix $x_{0} \in H$ and let $P_{U}\left(x_{0}\right):=y_{0}$ the unique element $y_{0} \in U$ such that $\left\|x_{0}-y_{0}\right\|=\operatorname{dist}\left(x_{0}, U\right)$. Then $\operatorname{rg}\left(P_{U}\right)=U$ and $P_{U}^{2}=P_{U}$, hence $P_{U}$ is a projection on $U$
By Lemma 4.15, $P_{U}\left(x_{0}\right)$ is the unique element in $U$ such that $x_{0}-P_{U}\left(x_{0}\right) \in U^{\perp}$

$$
\operatorname{Re}\left\langle x_{0}-P_{U}\left(x_{0}\right), y-P_{U}\left(x_{0}\right)\right\rangle \leq 0, \quad y \in U
$$

We will show that $P_{U}$ is linear. Let $x_{1}, x_{2} \in H$ and $\lambda \in \mathbb{K}$. Since $U^{\perp}$ is a subspace, we obtain

$$
\lambda x_{1}-x_{2}-\left(\lambda P_{U}\left(x_{1}\right)-P_{U}\left(x_{2}\right)\right)=\lambda\left(x_{1}-P_{U}\left(x_{1}\right)\right)-\left(x_{2}-P_{U}\left(x_{2}\right)\right) \in U^{\perp} .
$$

Hence, by definition of $P_{U}$,

$$
P_{U}\left(\lambda x_{1}-x_{2}\right)=\lambda P_{U}\left(x_{1}\right)-P_{U}\left(x_{2}\right) .
$$

We already know that $\operatorname{rg}\left(P_{U}\right)=U . \operatorname{ker}\left(P_{U}\right)=U^{\perp}$ because

$$
P_{U}(x)=0 \Longleftrightarrow x_{0} \in U^{\perp} .
$$

Therefore id $-P_{U}$ is a projection with $\operatorname{rg}\left(\mathrm{id}-P_{U}\right)=U^{\perp}$ and $\operatorname{ker}(\mathrm{id}-U)=U$. By Pythagoras' theorem we obtain

$$
\left\|x_{0}\right\|^{2}=\| P_{U}\left(x_{0}\right)+\left(\text { id }-P_{U}\right)\left(x_{0}\right)\left\|^{2}=\right\| P_{U}\left(x_{0}\right)\left\|^{2}+\right\|\left(\mathrm{id}-P_{U}\right)\left(x_{0}\right) \|^{2} .
$$

In particular, $H=U \oplus U^{\perp}$ with norm as in the statement, and $\left\|P_{U}\right\| \leq 1$ and $\|$ id $-P_{U} \| \leq 1$. Lemma 3.39 implies $\left\|P_{U}\right\|=1, \|$ id $-P_{U} \|=1$ if $U \neq H$ and
$\|$ id $-P_{U} \|=0$ if $U=H$. $\|$ id $-P_{U} \|=0$ if $U=H$.

Lemma 4.18. Let $U$ be a subspace of a Hilbert space $H$. Then $\bar{U}=U^{\perp \perp}$
Proof. By the projection theorem (Theorem 4.16), for every closed subspace $V$

$$
P_{V}=\mathrm{id}-P_{V^{\perp}}=\mathrm{id}-\left(\mathrm{id}-P_{V^{\perp \perp}}\right)=P_{V^{\perp \perp}},
$$

hence $V=V^{\perp \perp}$. Application to $V=\bar{U}$ shows the statement.
Definition 4.19. Let $X, Y$ be vector spaces. A map $X \rightarrow Y$ is called antilinear or conjugate linear if $f(\lambda x+y)=\bar{\lambda} f(x)+f(y)$ for all $\lambda \in \mathbb{K}$ and $x, y \in X$.

Theorem 4.20 (Fréchet-Riesz representation theorem). Let $H$ be a Hilbert space. Then the map

$$
\Phi: H \rightarrow H^{\prime}, \quad y \mapsto\langle\cdot, y\rangle
$$

is an isometric antilinear bijection.
Proof. Obviously $\Phi(0)=0 \in H^{\prime}$. The Cauchy-Schwarz inequality yields

$$
\|\Phi(y)(x)\|=|\langle x, y\rangle| \leq\|x\|\|y\|, \quad x, y \in H,
$$

hence $\|\Phi(y)\| \leq\|y\|$ If $y \neq 0$, then set $x=\|y\|^{-1} y$. Note that $\|x\|=1$ and $\|\Phi(y) x\|=\|y\|$, implying that $\|\Phi(y)\|=\|y\|$. So we have shown that $\Phi$ is welldefined and an isometry. In particular, $\Phi$ is injective.
To show that $\Phi$ is surjective, fix an $\varphi \in H^{\prime}$. If $\varphi=0$, then $\varphi=\Phi(0)$. Otherwise we can assume that $\|\varphi\|=1$. Since $\operatorname{ker}\{\varphi\}$ is closed, there exists a decomposition $H=\operatorname{ker} \varphi \oplus(\operatorname{ker} \varphi)^{\perp}$ Note that $\operatorname{rg}(\varphi)=\mathbb{K}$, hence $\operatorname{dim}(\operatorname{ker} \varphi)^{\perp}=1 \quad$ Choos

 $\operatorname{ker} \varphi \oplus(\operatorname{ker} \varphi)^{\perp}$,

$$
\left\langle x,\left\|y_{0}\right\|^{-2} y_{0}\right\rangle=\lambda=\lambda \varphi(y)+\varphi(u)=\varphi(x),
$$

hence $\varphi=\left\langle\cdot,\left\|y_{0}\right\|^{-1} y_{0}\right\rangle$. Since $\Phi$ is an isometry, it follows that $1=\|\varphi\|=\| \| y_{0}\| \|=$ $\frac{1}{\left\|y_{0}\right\|}$, so $\left\|y_{0}\right\|=1$.

Corollary 4.21. (i) Every Hilbert space is reflexive.
(ii) The dual $H^{\prime}$ of a Hilbert space $H$ is an inner product space by

$$
\langle\Phi(x), \Phi(y)\rangle_{H^{\prime}}=\langle y, x\rangle_{H}
$$

with $\Phi: H \rightarrow H^{\prime}$ as in Theorem 4.20.
Proof. (ii) is clear. Let $\Psi: H^{\prime} \rightarrow H^{\prime \prime}$ as in Theorem 4.20. Then it is easy to check that $\Psi \circ \Phi=J_{H}$, so $J_{H}$ is surjective, implying that $H$ is reflexive.

Corollary 4.22. Let $H$ be a Hilbert space.
(i) A sequence $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq H$ converges weakly to $x_{0} \in H$ if and only if

$$
\left\langle x_{n}-x_{0}, y\right\rangle \rightarrow 0, \quad y \in H .
$$

(ii) Every bounded sequence $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq H$ contains a weakly convergent subse quence.

Proof. (i) follows from the Riesz-Fréchet theorem, and (ii) follows with Theorem 2.40

### 4.3 Orthonormal systems

Definition 4.23. Let $H$ be a Hilbert space. A family $S=\left(x_{\lambda}\right)_{\lambda \in \Lambda}$ of vectors in $H$ is called an orthonormal system if $\left\langle x_{\lambda}, x_{\lambda^{\prime}}\right\rangle=\delta_{\lambda^{\prime}}$. A orthonormal system $S$ is an orthonormal basis (or a complete orthonormal system) if and only if for every orthonormal system $I$

$$
S \subseteq T \Longrightarrow S=T
$$

Examples 4.24. (i) The unit vectors $\left(\mathrm{e}_{n}\right)_{n \in \mathbb{N}}$ in $\ell_{2}(\mathbb{N})$ are a orthonormal system.
(ii) Let $H=L_{2}(-\pi, \pi)$. An orthonormal system in $H$ is

$$
S=\left\{\frac{1}{\sqrt{2 \pi}}\right\} \cup\left\{\frac{1}{\sqrt{\pi}} \sin (n \cdot): n \in \mathbb{N}\right\} \cup\left\{\frac{1}{\sqrt{\pi}} \cos (n \cdot): n \in \mathbb{N}\right\} .
$$

Lemma 4.25 (Gram-Schmidt). Let $H$ be a Hilbert space and $\left(x_{n}\right)_{n \in \mathbb{N}}$ a family of linearly independent vectors. Then there exists a orthonormal system $S=\left(s_{n}\right)_{n \in \mathbb{N}}$ such that $\operatorname{span} S=\operatorname{span}\left\{x_{n}: n \in \mathbb{N}\right\}$.

Proof. Let $s_{1}:=\left\|x_{1}\right\|^{-1} x_{1}$. Next set $y_{2}:=x_{2}-\left\langle x_{1}, s_{1}\right\rangle s_{1}$. Note that $y_{2} \neq 0$ because $x_{2}$ and $x_{1}$ are linearly independent. Let $s_{2}:=\left\|y_{2}\right\|^{-1} y_{2}$. Then $s_{1} \perp s_{2}$ and $\left\|s_{1}\right\|=\left\|s_{2}\right\|=1$. Now for $k \geq 1$ let

$$
y_{n+1}:=x_{n+1}-\sum_{k=1}^{n}\left\langle x_{k}, s_{k}\right\rangle s_{k}, \quad s_{n+1}:=\left\|y_{n+1}\right\|^{-1} y_{n+1} .
$$

Since $x_{1}, \ldots, x_{n+1}$ are linearly independent, $s_{n+1}$ is well-defined. By construction $s_{n+1} \perp s_{j}$ for $j=1, \ldots n$. Note that for every $n \in \mathbb{N}, s_{n} \in \operatorname{span}\left\{x_{1}, \ldots, x_{n}\right\}$ and $x_{n} \in \operatorname{span} S$, hence $\overline{\operatorname{span} S}=\overline{\left\{x_{n}: n \in \mathbb{N}\right\}}$.
Example. Let $H=L_{2}((0,1))$ and $x_{n} \in H$ defined by $x_{n}(t)=t^{n}$. Application of the Gram-Schmidt orthogonalisation yields polynomials $s_{n}(t)=\sqrt{n+\frac{1}{2}} P_{n}(t)$ where $P_{n}(t)=\frac{1}{2^{n} n!} \frac{\mathrm{d}^{n}}{\mathrm{~d} t^{n}}\left(t^{2}-1\right)^{n}$ is the $n$th Legendre polynomial.

Theorem 4.26 (Bessel inequality). Let $H$ be a Hilbert space, $\left\{s_{n}: n \in \mathbb{N}\right\}$ a orthonormal system in $H$. Then

$$
\sum_{n=1}^{\infty}\left|\left\langle x, s_{n}\right\rangle\right|^{2} \leq\|x\|^{2}, \quad x \in H .
$$

Proof. For $N \in \mathbb{N}$ let $x_{N}:=x-\sum_{n=1}^{N}\left\langle x, s_{n}\right\rangle s_{n}$. Since $x_{N} \perp s_{n}$ for $n=1, \ldots, N$, Pythagoras' theorem yields

$$
\|x\|^{2}=\left\|x_{N}\right\|^{2}+\left\|\sum_{n=1}^{N}\left\langle x, s_{n}\right\rangle s_{n}\right\|^{2}=\left\|x_{N}\right\|^{2}+\sum_{n=1}^{N}\left|\left\langle x, s_{n}\right\rangle\right|^{2} \geq \sum_{n=1}^{N}\left|\left\langle x, s_{n}\right\rangle\right|^{2}
$$

Lemma 4.27. Let $H$ be a Hilbert space, $S=\left(s_{\lambda}\right)_{\lambda \in \Lambda}$ a orthonormal system in $H$. Then for every $x \in H$ the set

$$
S_{x}:=\left\{\lambda \in \Lambda:\left\langle x, s_{\lambda}\right\rangle \neq 0\right\}
$$

is at most countable.
Proof. By the Bessel inequality, for every $n \in \mathbb{N}$ the set

$$
S_{x, n}:=\left\{\lambda \in \Lambda:\left|\left\langle x, s_{\lambda}\right\rangle\right| \geq \frac{1}{n}\right\}
$$

is finite. Hence $S_{x}=\bigcup_{n=1}^{\infty} S_{x, n}$ is at most countable.

Definition 4.28. Let $X$ be a normed space, $\left(x_{\lambda}\right)_{\lambda \in \Lambda} \subseteq X$. Then $\sum_{\lambda \in \Lambda} x_{\lambda}$ converges unconditionally to $x \in H$ if and only if $\Lambda_{0}:=\left\{\lambda \in \Lambda: x_{\lambda} \neq 0\right\}$ is at most countable and $\sum_{n=1}^{\infty} x_{\lambda_{n}}=x$ for every enumeration $\Lambda_{0}=\left\{\lambda_{n}: n \in \mathbb{N}\right\}$.
Recall that in finite dimensional Banach spaces unconditional convergence is equivalent to absolute convergence. In every infinite dimensional Banach space, however there exists a unconditionally convergent series that does not converge absolutely (Dvoretzky-Rogers theorem).

Corollary 4.29 (Bessel inequality). Let $H$ be a Hilbert space and $S \subseteq H a$ orthonormal system. Then

$$
\sum_{s \in S}|\langle x, s\rangle| \leq\|x\|^{2}, \quad x \in H
$$

Proof. For fixed $x \in H$, the set $S_{x}=\{s \in S:\langle x, s\rangle \neq 0\}$ is at most count able (Lemma 4.27), so the claim follows from the Bessel inequality for countable orthonormal systems.

Theorem 4.30. Let $H$ be a Hilbert space and $S \subseteq H$ a orthonormal system. Then

$$
P: H \rightarrow H, \quad P x=\sum_{s \in S}\langle x, s\rangle s
$$

is an orthogonal projection on $\overline{\operatorname{spanS}}$ and the series is unconditionally convergent.
Proof. First we proof that the series in the definition of $P$ is unconditionally convergent (this proves then well-definedness of $P$ ). Fix $x \in H$. For fixed $x \in H$, the set $S_{x}=\{s \in S:\langle x, s\rangle \neq 0\}$ is at most countable (Lemma 4.27). Let $S_{x}=\left\{s_{n}: n \in \mathbb{N}\right\}$ be an enumeration of $S_{x}$. Then $\left(\sum_{k=1}^{n}\left\langle x, s_{k}\right\rangle s_{k}\right)_{n \in \mathbb{N}}$ is a Cauchy sequence because

$$
\left\|\sum_{k=N}^{M}\left\langle x, s_{k}\right\rangle s_{k}\right\|^{2}=\sum_{k=N}^{M}\left|\left\langle x, s_{k}\right\rangle\right|^{2} \longrightarrow 0, \quad M, K \rightarrow \infty
$$

by Bessel's inequality. Since $H$ is complete, $y:=\sum_{k=1}^{\infty}\left\langle x, s_{k}\right\rangle s_{k}$ exists. Let $\pi$ $\mathbb{N} \rightarrow \mathbb{N}$ be a permutation. Then also $y_{\pi}:=\sum_{k=1}^{\infty}\left\langle x, s_{\pi}(k)\right\rangle s_{\pi(k)}$ exists. We have to show that $y=y_{\pi}$. For all $z \in H$

$$
\langle y, z\rangle=\sum_{n=1}^{\infty}\left\langle y, s_{n}\right\rangle\left\langle s_{n}, z\right\rangle=\sum_{n=1}^{\infty}\left\langle y, s_{\pi}\right\rangle\left\langle s_{\pi}, z\right\rangle=\left\langle y_{\pi}, z\right\rangle .
$$

We have used that $\sum_{n=1}^{\infty}\left\langle y, s_{n}\right\rangle\left\langle s_{n}, z\right\rangle$ is absolute convergent and can therefore be rearranged, because, by Hölder's inequality and Bessel's inequality

$$
\left(\sum_{n=1}^{\infty}\left|\left\langle y, s_{n}\right\rangle\left\langle s_{n}, z\right\rangle\right|\right)^{2} \leq\left(\sum_{n=1}^{\infty}\left|\left\langle y, s_{n}\right\rangle\right|^{2}\right)\left(\sum_{n=1}^{\infty}\left|\left\langle s_{n}, z\right\rangle\right|^{2}\right) \leq\|y\|^{2}\|z\|^{2}<\infty .
$$

Since $y-y_{\pi} \perp z, z \in H$, it follows that $y=y_{\pi}$. Therefore the series in the definition of $P$ is unconditionally convergent and $P$ is well-defined.
It is clear that $P$ is a linear and $\|P\| \leq 1$ follows from Corollary 4.29. Let $x \in H$ We have to show that $x-P x \in \overline{\operatorname{span} S^{\perp}}$ (Theorem 4.16). This is clear because

$$
\left\langle x-\sum_{s \in S}\langle x, s\rangle, s_{0}\right\rangle=\left\langle x-\sum_{s \in S_{x}}\langle x, s\rangle, s_{0}\right\rangle=0, \quad s_{0} \in S
$$

Theorem 4.31. Let $H$ be a Hilbert space and $S \subseteq H$ a orthonormal system. Then the following is equivalent.
(i) $S$ is a complete orthonormal system.
(ii) $x \perp S \Longrightarrow x=0, \quad x \in H$
(iii) $H=\overrightarrow{\operatorname{span} S}$.
(iv) $x=\sum_{s \in S}\langle x, s\rangle s, \quad x \in H$.
(v) $\langle x, y\rangle=\sum_{s \in S}\langle x, s\rangle\langle s, y\rangle, \quad x, y \in H$.
(vi) Parseval's equality holds: $\|x\|^{2}=\sum_{s \in S}|\langle x, s\rangle|^{2}, \quad x \in H$.

Proof. (i) $\Longrightarrow$ (ii) If there exists an $x \in H$ such that $x \in S^{\perp} \backslash\{0\}$, then $S^{\prime}:=$ $S \cup\left\{\|x\|^{-1} x\right\}$ is a orthonormal system with $S \subsetneq S^{\prime}$, contradicting the maximality of $S$.
(ii) $\Longrightarrow$ (iii) follows from Lemma 4.18.
(iii) $\Longrightarrow$ (iv) By theorem 4.30, $x \mapsto \sum_{s \in S}\langle x, s\rangle_{s}$ is the orthogonal projection on $\overline{\operatorname{span} S}=H$.
(iv) $\Longrightarrow$ (v) straightforward.
(v) $\Longrightarrow$ (vi) Choose $x=y$.
(vi) $\Longrightarrow$ (i) Assume there exists an orthonormal system $S^{\prime} \supsetneq S$. Then for every $s^{\prime} \in S^{\prime} \backslash S$ we get the contradiction

$$
1=\left\|s^{\prime}\right\|^{2}=\sum_{s \in S}\left|\left\langle s^{\prime}, s\right\rangle\right|^{2}=0 .
$$

Now we show that the orthonormal systems in Example 4.24 are complete
Examples 4.32. (i) The set of the unit vectors $\left\{\mathrm{e}_{n}: n \in \mathbb{N}\right\}$ in $\ell_{2}(\mathbb{N})$ are a complete orthonormal system in $\ell_{2}(\mathbb{N})$ because $\left\{\mathrm{e}_{n}: n \in \mathbb{N}\right\}=\ell_{2}(\mathbb{N})$.
(ii) Let $\Gamma$ be a set and define

$$
\begin{aligned}
\ell_{2}(\Gamma):=\{f: \Gamma \rightarrow \mathbb{K}: & f(\gamma) \neq 0 \text { for at most countably many } \gamma \in \Gamma \text { and } \\
& \left.\sum_{\gamma \in \Gamma}|f(\gamma)|^{2}<\infty\right\} .
\end{aligned}
$$

Then $\langle f, g\rangle=\sum_{\gamma \in \Gamma} f(\gamma) \overline{g(\gamma)}$ is a well-defined inner product (note that only countably many terms are $\neq 0$ and the sum is absolutely convergent by Hölder's inequality). As in the case $\Gamma=\mathbb{N}$ it can be shown that $\ell_{2}(\Gamma)$ is a Hilbert space and $\left(f_{\lambda}\right)_{\lambda \in \Gamma}$ where $f_{\lambda}(\gamma)=\delta_{\lambda \gamma}$ (Kronecker delta) is a complete orthonormal system in $\ell_{2}(\Gamma)$.
(iii) Let $H=L_{2}(0,1)$ and

$$
S=\left\{\frac{1}{\sqrt{2 \pi}}\right\} \cup\left\{\frac{1}{\sqrt{\pi}} \sin (n \cdot): n \in \mathbb{N}\right\} \cup\left\{\frac{1}{\sqrt{\pi}} \cos (n \cdot): n \in \mathbb{N}\right\} .
$$

Note that span $S$ is the set of all trigonometric polynomials. Without restric tion we can assume that $\mathbb{K}=\mathbb{R}$. By the theorem of Fejér, the trigonometric polynomials are dense in $C_{2 \pi}:=\{f \in C([-\pi, \pi]): f(-\pi)=f(\pi)\}$ with respect to $\|\cdot\|_{\infty}$, hence also with respect to $\|\cdot\|_{2}$. Since $C_{2 \pi}$ is $\|\cdot\|_{2}$-dense in $L_{2}([-\pi, \pi]), S$ is a total subset of $L_{2}([-\pi, \pi])$.

Lemma 4.33. Let $H$ be an infinite dimensional Hilbert space. Then the following is equivalent.
(i) $H$ is separable.
(ii) Every complete orthonormal system in $H$ is countable.
(iii) There exists an countable complete orthonormal system in $H$.

Proof. (i) $\Longrightarrow$ (ii) Assume $S \subseteq H$ is an uncountable complete orthonormal system in $H$. Let $\varepsilon \in\left(0,2^{-\frac{1}{2}}\right)$ and $s \neq s^{\prime} \in S$. Then $B_{\varepsilon}(s) \cap B_{\varepsilon}\left(s^{\prime}\right)=\emptyset$ because by Pythagoras $\left\|s-s^{\prime}\right\|=\sqrt{\|s\|^{2}+\left\|s^{\prime}\right\|^{2}}=\sqrt{2}$. Let $A$ be a dense subset of $H$. For every $s \in S$ there exists an $a_{s} \in A$ such that $a_{s} \in B_{\varepsilon}(s)$. In particular, $a_{s} \neq a_{s^{\prime}}$ if $s \neq s^{\prime}$, so $A$ cannot be countable, thus $H$ is not separable.
(ii) $\Longrightarrow$ (iii) The existence of a complete orthonormal system in $H$ follows from Zorn's lemma. By assumption, it must be complete.
(iii) $\Longrightarrow$ (i) Let $S$ be a countable orthonormal system in $H$. Then $\overline{\operatorname{span} S}=H$ by Theorem 4.31 and $H$ is separable by Theorem 1.25 .

Lemma 4.34. Let $H$ be Hilbert space and $S$ and $T$ be complete orthonormal system in $H$. Then $|S|=|T|$.

Proof. The statement is proved in linear algebra if $|S|<\infty$. Now assume that $S$ is not finite. For $x \in S$ the set $T_{x}:=\{y \in T:\langle x, y\rangle \neq 0\}$ is at most countable by Lemma 4.27. By Theorem 4.31 (ii) $T \subseteq \bigcup_{x \in S} T_{x}$, hence $|T| \leq|S||\mathbb{N}|=|S|$. Analogously, $|S| \leq|T||\mathbb{N}|=|T|$. By the Schröder-Bernstein theorem then $|S|=$ $|T|$.

Theorem 4.35. Let $H$ be a Hilbert space and $S$ an orthonormal basis of $H$. Then $H \cong \ell_{2}(S)$ (see Example 4.32(ii)).

Proof. Define $T: H \rightarrow \ell_{2}(S)$ by $T x(s)=\langle x, s\rangle, x \in H, s \in S . T$ is well-defined by Bessel's inequality. Then $T: H \rightarrow \ell_{2}(S)$ is linear and isometric by Parseval's equality. To show that $T$ is surjective, let $y \in \ell_{2}(S)$ and define $x:=\sum_{s \in S} y(s) s$. Then $x \in H$ (Theorem 4.30) and $T x=y$.
Note that by construction $\langle T x, T y\rangle=\langle x, y\rangle, x, y \in H$.
Corollary 4.36. If $H$ is a separable Hilbert space, then $H \cong \ell_{2}(\mathbb{N})$.
Corollary 4.37 (Fischer-Riesz theorem). $L_{2}[0,1] \cong \ell_{2}(\mathbb{N})$.

### 4.4 Linear operators in Hilbert spaces

Definition 4.38. Let $H_{1}, H_{2}$ be Hilbert spaces and $\Phi_{j}: H_{j} \rightarrow H_{j}^{\prime}$ the canonical isomorphism in the Fréchet-Riesz representation theorem (Theorem 4.20). Let $T \in$ $L\left(H_{1}, H_{2}\right)$. Its (Hilbert space) adjoint operator is $T^{*}:=\Phi_{1}^{-1} T^{\prime} \Phi_{2} \in L\left(H_{2}, H_{1}\right)$ where $T^{\prime}$ is the Banach space adjoint of $T$ (see Definition 2.25).

Hence $T^{*}$ is characterised by

$$
\langle T x, y\rangle=\left\langle x, T^{*} y\right\rangle, \quad x \in H_{1}, y \in H_{2} .
$$

Theorem 4.39. Let $H_{1}, H_{2}, H_{3}$ be Hilbert spaces, $S, T \in L\left(H_{1}, H_{2}\right), R \in L\left(H_{2}, H_{3}\right)$ and $\lambda \in \mathbb{K}$.
(i) $(\lambda S+T)^{*}=\bar{\lambda} S^{*}+T^{*}$
(ii) $(R T)^{*}=T^{*} R^{*}$
(iii) $T^{*} \in L\left(H_{2}, H_{1}\right)$ and $\left\|T^{*}\right\|=\|T\|$.
(iv) $T^{* *}=T$.
(v) $\left\|T T^{*}\right\|=\left\|T^{*} T\right\|=\|T\|^{2}$
(vi) $\operatorname{ker} T=\left(\operatorname{rg}\left(T^{*}\right)\right)^{\perp}, \operatorname{ker} T^{*}=(\operatorname{rg}(T))^{\perp}$.
(vii) If $T$ is invertible, then $\left(T^{-1}\right)^{*}=\left(T^{*}\right)^{-1}$.

Proof. (i)-(iv) are clear. For the proof of (v) note that for $\|x\|=1$

$$
\|T x\|^{2}=\langle T x, T x\rangle=\left\langle x, T^{*} T x\right\rangle \leq\|x\|\left\|T^{*} T x\right\| \leq\left\|T^{*} T\right\| \leq\left\|T^{*}\right\|\|T\|=\|T\|^{2} .
$$

Taking the supremum over all $x \in H$ with $\|x\|=1$ shows the desired equalities.
(vi) $\operatorname{ker} T=\left(\operatorname{rg} T^{*}\right)^{\perp}$ because for $x \in H$

$$
\begin{aligned}
T x=0 & \Longleftrightarrow \quad \forall y \in H_{2} \quad\langle T x, y\rangle=0 \quad \Longleftrightarrow \quad \forall y \in H_{2} \quad\left\langle x, T^{*} y\right\rangle=0 \\
& \Longleftrightarrow x \perp \operatorname{rg}\left(T^{*}\right) .
\end{aligned}
$$

Then also $\operatorname{ker} T^{*}=\left(\operatorname{rg}\left(T^{* *}\right)\right)^{\perp}=(\operatorname{rg}(T))^{\perp}$.
$\square$
Definition 4.40. Let $H_{1}, H_{2}$ be Hilbert spaces, $T \in L\left(H_{1}, H_{2}\right)$.
(i) $T$ is called unitary if $T$ is invertible and $T T^{*}=\operatorname{id}_{H_{2}}$ and $T^{*} T=\operatorname{id}_{H_{1}}$.
(ii) $T$ is called normal if $H_{1}=H_{2}$ and $T T^{*}=T^{*} T$.
(iii) $T$ is called selfadjoint if $H_{1}=H_{2}$ and $T=T^{*}$.

Remarks. (i) $T$ selfadjoint $\Longrightarrow T$ normal.
(ii) $T \in L\left(H_{1}, H_{2}\right) \Longrightarrow T T^{*}$ and $T^{*} T$ are selfadjoint.

Next we show that a length preserving linear map between Hilbert spaces also preserves angles.

Lemma 4.41. Let $H_{1}, H_{2}$ be Hilbert spaces and $T \in L\left(H_{1}, H_{2}\right)$.
(i) $T$ is an isometry $\Longleftrightarrow\langle T x, T y\rangle=\langle x, y\rangle, x, y \in H_{1}$.
(ii) $T$ is unitary $\Longleftrightarrow T$ is a surjective isometry.

Proof. (i) The direction " $\Leftarrow$ " is clear; " $\Rightarrow$ " follows from the polarisation formula (Theorem 4.7).
(ii) " $\Rightarrow$ " Since $T$ is unitary, if follows that $\operatorname{rg}(T) \supseteq \operatorname{rg}\left(T T^{*}\right)=\operatorname{rg}^{\left(\mathrm{id}_{H_{2}}\right)}=H_{2}$, so $T$ is surjective. $T$ is an isometry because for all $x, y \in H_{1}$

$$
\langle T x, T y\rangle=\left\langle T^{*} T x, y\right\rangle=\langle x, y\rangle
$$

" $\Leftarrow$ " Assume that $T$ as a surjective isometry. Since

$$
\left\langle x, y-T^{*} T y\right\rangle=\langle x, y\rangle-\langle T x, T y\rangle=0, \quad x, y \in H_{1},
$$

it follows that $T^{*} T y=y$, so $T^{*} T=\operatorname{id}_{H_{1}}$. In particular $T^{*}$ is surjective. Now we will show that $T^{*}$ is an isometry. Let $\xi, \eta \in H_{2}$. Then there exist $x, y \in H_{1}$ such that $T x=\xi$ and $T y=\eta$. It follows that

$$
\left\langle T^{*} \xi, T^{*} \eta\right\rangle=\left\langle T^{*} T x, T^{*} T y\right\rangle=\langle x, y\rangle=\langle T x, T y\rangle=\langle\xi, \eta\rangle .
$$

By the same argument as for $T$ we conclude that $\operatorname{id}_{H_{2}}=T^{* *} T^{*}=T T^{*}$

Examples 4.42. (i) Let $H_{1}, H_{2}$ be Hilbert spaces with $\operatorname{dim} H_{1}=\operatorname{dim} H_{2}=n<$ $\infty$. After choice of bases, a linear operator $T: H_{1} \rightarrow H_{2}$ has a representation $\left(a_{i j}\right)_{i j=1}^{n} \in M_{n}(\mathbb{C})$. The matrix corresponding to $T^{*}$ is then $\left(\overline{a_{j i}}\right)_{i j=1}^{n}$.
(ii) Let $H=L_{2}[0,1]$. For $k \in L_{\infty}([0,1] \times[0,1])$ define

$$
T_{k}: L_{2}[0,1] \rightarrow L_{2}[0,1], \quad\left(T_{k} f\right)(t)=\int_{0}^{1} k(s, t) f(s) \mathrm{d} s
$$

Then $T_{k} \in L_{2}[0,1]$ and

$$
T_{k}^{*}: L_{2}[0,1] \rightarrow L_{2}[0,1], \quad\left(T_{k} f\right)(t)=\int_{0}^{1} \overline{k(s, t)} f(s) \mathrm{d} s
$$

that is $T_{k}^{*}=T_{\bar{k}}$.
Theorem 4.43 (Hellinger-Toeplitz). Let $H$ be a Hilbert space, $T: H \rightarrow H$ a linear operator such that

$$
\langle T x, y\rangle=\langle x, T y\rangle, \quad x, y \in H .
$$

Then $T$ is bounded, hence selfadjoint.
Proof. It suffices to show that $T$ is closed because $\mathcal{D}(T)=H$ is closed. Let $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq H$ with $x_{n} \rightarrow 0$ and $T x_{n} \rightarrow y$. Observe that

$$
\|y\|^{2}=\lim _{n \rightarrow \infty}\left\langle T x_{n}, y\right\rangle=\lim _{n \rightarrow \infty}\left\langle x_{n}, T y\right\rangle=\left\langle\lim _{n \rightarrow \infty} x_{n}, T y\right\rangle=\langle 0, T y\rangle=0
$$

so $y=0$. This implies that $T$ is closable, hence closed since $\mathcal{D}(T)=H$.
Theorem 4.44. Let $H$ be a complex Hilbert space. For $T \in L(H)$ the following is equivalent.
(i) $\langle T x, x\rangle \in \mathbb{R}, x \in H$.
(ii) $T$ is selfadjoint.

Proof. (ii) $\Longrightarrow$ (i) follows from

$$
\langle T x, x\rangle=\langle x, T x\rangle=\overline{\langle T x, x\rangle}, \quad x \in H
$$

(i) $\Longrightarrow$ (ii) Let $x, y \in H$ and $\lambda \in \mathbb{C}$.

$$
\begin{aligned}
& A:=\langle T(\lambda x+y), \lambda x+y\rangle=|\lambda|^{2}\langle T x, x\rangle+\|y\|^{2}+\lambda\langle T x, y\rangle+\bar{\lambda}\langle y, T x\rangle, \\
& B:=\overline{\langle T(\lambda x+y), \lambda x+y\rangle}=|\bar{\lambda}|^{2} \overline{\langle T x, x\rangle}+\|y\|^{2}+\bar{\lambda}\langle T x, y\rangle+\lambda\langle y, T x\rangle .
\end{aligned}
$$

By assumption, $A=B$, so in the special cases $\lambda=1$ and $\lambda=\mathrm{i}$ we obtain

$$
\begin{aligned}
& \langle T x, y\rangle+\langle y, T x\rangle=\langle T x, y\rangle+\langle y, T x\rangle \\
& \langle T x, y\rangle-\langle y, T x\rangle=-\langle T x, y\rangle+\langle y, T x\rangle
\end{aligned}
$$

so finally $\langle T x, y\rangle=\langle y, T x\rangle$.

Theorem 4.45. Let $H$ be a Hilbert space, $T \in L(H)$ selfadjoint. Then

$$
\|T\|=\sup _{\|x\| \leq 1}|\langle T x, x\rangle| .
$$

Proof. Let $M:=\sup _{\|x\| \leq 1}|\langle T x, x\rangle|$. Obviously $M \leq\|T\|$ because for $\|x\| \leq 1$

$$
|\langle T x, x\rangle| \leq\|T\|\|x\|^{2} \leq\|T\|
$$

To show the reverse inequality fix $x, y \in H$. Observe that

$$
\langle T(x+y), x+y\rangle-\langle T(x-y), x-y\rangle=2\langle T x, y\rangle+2\langle T y, x\rangle
$$

$$
=2\langle T x, y\rangle+2\langle y, T x\rangle=4 \operatorname{Re}\langle T x, y\rangle
$$

Hence, by the parallelogram identity (Theorem 4.8), for $\|x\| \leq 1,\|y\| \leq 1$,

$$
\begin{aligned}
\operatorname{Re}\langle T x, y\rangle & \leq \frac{1}{4}(|\langle T(x+y), x+y\rangle|+|\langle T(x-y), x-y\rangle|) \\
& \leq \frac{1}{4}\left(M\|x+y\|^{2}+M\|x-y\|^{2}\right)=\frac{M}{2}\left(\|x\|^{2}+\|y\|^{2}\right) \leq M .
\end{aligned}
$$

Now choose $\lambda \in \mathbb{C},|\lambda|=1$ such that $\lambda\langle T x, y\rangle=|\langle T x, y\rangle|$, so

$$
|\langle T x, y\rangle|=\langle T(\lambda x), y\rangle=|\operatorname{Re}\langle T(\lambda x), y\rangle| \leq M, \quad\|x\| \leq 1,\|y\| \leq 1
$$

In particular, $\|\langle\cdot, T x\rangle\| \leq M$, so $\|T x\| \leq 1$ for $\|x\| \leq 1$. This shows $\|T\| \leq M . \quad \square$
Corollary 4.46. Let $H$ be a Hilbert space and $T \in L(H)$ selfadjoint. If $\langle T x, x\rangle=$ $0, x \in H$, then $T=0$.

Note that the condition $\langle T x, x\rangle=0$ automatically implies that $T$ is selfadjoint in the case of a complex Hilbert space. In a real Hilbert spaces $H$ the assumption that $T$ is selfadjoint is necessary for the statement in the corollary. For example, let $T=\left(\left(\begin{array}{cc}0 & 1 \\ -1 & 0\end{array}\right)\right): \mathbb{R}^{2} \rightarrow \mathbb{R}^{2}$ the rotation about $90^{\circ}$. Then $T \neq 0$ but $\langle T x, x\rangle=0$ for all $x \in \mathbb{R}^{2}$.

Lemma 4.47. Let $H$ be a Hilbert space, $T \in L(H)$ a normal operator. Then

$$
\|T x\|=\left\|T^{*} x\right\|, \quad x \in H,
$$

in particular, $\operatorname{ker} T=\operatorname{ker} T^{*}$.
Proof. $0=\left\langle T^{*} T x-T T^{*} x, x\right\rangle=\|T x\|^{2}-\left\|T^{*} x\right\|^{2}$.
Definition 4.48. Let $H$ be a Hilbert space. A bounded selfadjoint operator $T \in$ $L(H)$ is called non-negative, denoted by $T \geq 0$, if $\langle T x, x\rangle \geq 0$ for all $x \in H$. It is called positive, denoted by $T>0$, if $\langle T x, x\rangle>0$ for all $x \in H \backslash\{0\}$. We write $T \leq S$ if and only if $S-T \geq 0$. A sequence $\left(T_{n}\right)_{n \in \mathbb{N}} \in L(H)$ is increasing if and only if $T_{n} \leq T_{n+1}, n \in \mathbb{N}$. A sequence $\left(T_{n}\right)_{n \in \mathbb{N}} \in L(H)$ is decreasing if and only if $\left(-T_{n}\right)_{n \in \mathbb{N}} \in L(H)$ is increasing.
Theorem 4.49. Let H be a Hilbert space. Every monotonic bounded sequence of selfadjoint linear operators on $H$ converges strongly.
Proof. Let $\left(T_{n}\right)_{n \in \mathbb{N}}$ be a bounded monotonic sequence of selfadjoint operators. Without restriction we assume that it is increasing. Let

$$
s_{n m}: H \times H \rightarrow \mathbb{K}, \quad s_{n m}(x, y)=\left\langle\left(T_{n}-T_{m}\right) x, y\right\rangle
$$

is a positive semidefinite sesquilinear form on $H$ if $n \geq m$. Let $M$ be a bound of is a positive semidefinite sesquilinear form on $H$ if $n \geq m$. Let $M$ be a bound of
$\left(T_{n}\right)_{n \in \mathbb{N}}$. Note that then $\left\|T_{n}-T_{m}\right\| \leq 2 M$. Then, using Cauchy-Schwarz inequality, we find for $n \geq m$ and $x \in H$ with $\|x\|=1$

$$
\begin{aligned}
\left\|\left(T_{n}-T_{m}\right) x\right\|^{2} & =\left\langle\left(T_{n}-T_{m}\right) x,\left(T_{n}-T_{m}\right) x\right\rangle=s_{n m}\left(x,\left(T_{n}-T_{m}\right) x\right) \\
& \leq s_{n m}(x, x)^{\frac{1}{2}} s_{n m}\left(\left(T_{n}-T_{m}\right) x,\left(T_{n}-T_{m}\right) x\right)^{\frac{1}{2}} \\
& =\left\langle\left(T_{n}-T_{m}\right) x, x\right)^{\frac{1}{2}}\left\langle\left(T_{n}-T_{m}\right) x,\left(T_{n}-T_{m}\right)^{2} x\right\rangle^{\frac{1}{2}} \\
& \leq\left\langle\left(T_{n}-T_{m}\right) x, x\right)^{\frac{1}{2}}\left\|T_{n}-T_{m}\right\|^{\frac{1}{2}}\left\|T_{n}-T_{m}\right\| \\
& \leq(2 M)^{\frac{3}{2}}\left\langle\left(T_{n}-T_{m}\right) x, x\right\rangle^{\frac{1}{2}} .
\end{aligned}
$$

By assumption $\left(\left\langle T_{n} x, x\right\rangle\right)_{n \in \mathbb{N}}$ is a monotonically increasing bounded sequence in $\mathbb{R}$, hence convergent. It follows that $\left(T_{n} x\right)_{n \in \mathbb{N}}$ is a Cauchy sequence, hence $T$ converges strongly to some $T \in L(H)$ (Proposition 3.13). That $T$ is selfadjoint follows from

$$
\langle T x, y\rangle=\lim _{n \rightarrow \infty}\left\langle T_{n} x, y\right\rangle=\lim _{n \rightarrow \infty}\left\langle x, T_{n} y\right\rangle=\langle x, T y\rangle, \quad x, y \in H
$$

### 4.5 Projections in Hilbert spaces

Proposition 4.50. Let $H$ be a Hilbert space, $P \in L(H)$ a projection. If $P \neq 0$ then the following is equivalent.
(i) $P$ is an orthogonal projection.
(ii) $\|P\|=1$.
(iii) $P$ is selfadjoint.
(iv) $P$ is normal.
(v) $\langle P x, x\rangle \geq 0, x \in H$

Proof. (i) $\Longrightarrow$ (ii) follows from Theorem 4.16.
(ii) $\Longrightarrow$ (i) Let $x \in \operatorname{ker} P$ and $y \in \operatorname{rg}(P)$. Then for all $\lambda \in \mathbb{K}$

$$
\|\lambda y\|^{2}=\|P(x+\lambda y)\|^{2} \leq\|x+\lambda y\|^{2}=\|x\|^{2}+|\lambda|^{2}\|y\|^{2}+2 \operatorname{Re}(\lambda\langle x, y\rangle) .
$$

In particular, $0 \leq\|x\|^{2}+2 \lambda \operatorname{Re}\langle x, y\rangle$ for all $\lambda \in \mathbb{R}$, and $0 \leq\|x\|^{2}+2 \mathrm{i} \lambda \operatorname{Im}\langle x, y\rangle$ for all $\lambda \in \mathrm{i} \mathbb{R}$, hence $\operatorname{Re}\langle x, y\rangle=\operatorname{Im}\langle x, y\rangle=0$.
(i) $\Longrightarrow$ (iii) Observe that $\langle P x, y\rangle=\langle x, P y\rangle$ for all $x, y \in H$ because

$$
\begin{aligned}
& \langle P x, y\rangle=\langle P x, y-P y+P y\rangle=\langle P x, P y\rangle, \\
& \langle x, P y\rangle=\langle x-P x+P x, P y\rangle=\langle P x, P y\rangle .
\end{aligned}
$$

(iii) $\Longrightarrow$ (iv) is clear.
(iv) $\Longrightarrow$ (i) By Lemma 4.47, $\operatorname{ker} P=\operatorname{ker} P^{*}=(\operatorname{rg} P)^{\perp}$.
(i) $\Longrightarrow$ (v) For all $x \in H:\langle P x, x\rangle=\langle P x, x-P x+P x\rangle=\langle P x, P x\rangle \geq 0$.
(v) $\Longrightarrow$ (i) Let $x \in \operatorname{ker} P, y \in \operatorname{rg} P$. Since for all $\lambda \in \mathbb{R}$

$$
0 \leq\langle P(x+\lambda y), x+\lambda y\rangle=\langle\lambda y, x+\lambda y\rangle=\lambda^{2}\|y\|^{2}+\lambda\langle y, x\rangle
$$

it follows that $\langle x, y\rangle=0$.
Lemma 4.51. Let $H$ Hilbert space $H$. A linear operator $P: H \rightarrow H$ is an orthogonal projection if and only if $P^{2}=P$ and $\langle x, P y\rangle=\langle y, P x\rangle$ for all $x, y \in H$.

Proof. Assume that $P$ is an orthogonal projection. Then $P^{2}=P$ and by Proposition $4.50 P$ is selfadjoint.
If $P^{2}=P$ and $\langle x, P y\rangle=\langle y, P x\rangle$ for all $x, y \in H$, then $P$ is a projection. By the theorem of Hellinger-Toeplitz (Theorem 4.43) $P$ is selfadjoint, hence $P$ is an orthogonal projection by Proposition 4.50.

Lemma 4.52. Let $H$ be a Hilbert space, $U_{1}, U_{2} \subseteq H$ closed subspaces and $P_{1}, P_{2}$ the corresponding orthogonal projections. Then the following is equivalent.
(i) $P_{1} P_{2}=P_{2} P_{1}=0$.
(ii) $U_{1} \perp U_{2}$.
(iii) $P_{1}+P_{2}$ is an orthogonal projection.

If one of the equivalent conditions above hold, then $\operatorname{rg}\left(P_{1}+P_{2}\right)=U_{1} \oplus U_{2}$.
Proof. (i) $\Longrightarrow$ (ii) By assumption, $U_{2}=\operatorname{rg} P_{2} \subseteq \operatorname{ker} P_{1}=\left(\operatorname{rg} P_{1}\right)^{\perp}=U_{1}^{\perp}$, hence $U_{1} \perp U_{2}$.
(ii) $\Longrightarrow$ (i) By assumption, $\operatorname{rg} P_{2}=U_{2} \subseteq U_{1}^{\perp}=\operatorname{ker} P_{1}$, hence $P_{1} P_{2}=0$. Since (ii) is symmetric in $U_{1}$ and $U_{2}$, it follows also that $P_{2} P_{1}=0$.
(i),(ii) $\Longrightarrow$ (iii) Observe that $P_{1} P_{2}=P_{2} P_{1}=0$, so $P_{1}+P_{2}$ is a projection because

$$
\left(P_{1}+P_{2}\right)^{2}=P_{1}^{2}+P_{1} P_{2}+P_{2} P_{1}+P_{2}^{2}=P_{1}+P_{2}
$$

Since the sum of two selfadjoint operators is selfadjoint, $P_{1}+P_{2}$ is selfadjoint, hence, by Proposition 4.50 an orthogonal projection.
(iii) $\Longrightarrow$ (i) Since $P_{1}+P_{2}$ is an orthogonal projection, it follows that

$$
P_{1} P_{2}+P_{2} P_{1}=\left(P_{1}+P_{2}\right)^{2}-\left(P_{1}+P_{2}\right)=0
$$

In particular $0=\left(P_{1} P_{2}+P_{2} P_{1}\right) P_{2} x=\left(i d+P_{2}\right) P_{1} P_{2} x$. Note that for $y \in H \backslash\{0\}$ the vectors (id $\left.-P_{2}\right) y$ and $P_{2} y$ are linearly independent, hence (id $\left.+P_{2}\right) y=\left(\right.$ id $\left.-P_{2}\right) y+$ $2 P_{2} y$ is zero if and only if $\left(\right.$ id $\left.-P_{2}\right) y=0$ and $P_{2} y=0$, hence $y=0$. Therefore $\operatorname{rg} P_{1} P_{2} \subseteq \operatorname{ker}\left(\mathrm{id}+P_{2}\right)=\{0\}$.

Lemma 4.53. Let $H$ be a Hilbert space and $P_{1}$ and $P_{2}$ orthogonal projections on subspaces $U_{1}$ and $U_{2}$.
(i) $P_{1} P_{2}$ is an orthogonal projection if and only if $P_{1} P_{2}=P_{2} P_{1}$. In this case, $P_{1} P_{2}$ is an projection on $U_{1} \cap U_{2}$.
(ii) $P_{1}-P_{2}$ is an orthogonal projection if and only if $P_{1} P_{2}=P_{2} P_{1}=P_{2}$.

Proof. (i) If $P_{1} P_{2}$ is an orthonormal projection, then, by Proposition 4.50, $P_{1} P_{2}$ is selfadjoint, that is $P_{1} P_{2}=\left(P_{1} P_{2}\right)^{*}=P_{2}^{*} P_{1}^{*}=P_{2} P_{1}$. On the other hand, if $P_{1}$ and $P_{2}$ commute, then it is easy to verify that $\left(P_{1} P_{2}\right)^{2}=P_{1} P_{2}$ and $\left(P_{1} P_{2}\right)^{*}=P_{1} P_{2}$, hence $P_{1} P_{2}$ is an orthogonal projection. In this case, $\operatorname{rg}\left(P_{1} P_{2}\right)=\operatorname{rg}\left(P_{2} P_{1}\right)$, so $\operatorname{rg}\left(P_{1} P_{2}\right) \subseteq U_{1} \cap U_{2}$. On the other hand, $P_{1} P_{2} x=x$ for every $x \in U_{1} \cap U_{2}$, so also $\operatorname{rg}\left(P_{1} P_{2}\right) \supseteq U_{1} \cap U_{2}$ holds.
(ii) Using Lemma 4.52 we obtain
$P_{1}-P_{2}$ orthonormal projection $\Longleftrightarrow 1-\left(P_{1}-P_{2}\right)$ orthonormal projection $\Longleftrightarrow \quad\left(1-P_{1}\right)+P_{2}$ orthonormal projection $\Longleftrightarrow \quad P_{2}\left(1-P_{1}\right)=\left(1-P_{1}\right) P_{2}=0$ $\Longleftrightarrow \quad P_{2} P_{1}=P_{1} P_{2}=P_{2} . \square$

Lemma 4.54. Let $H$ be a Hilbert space and $P_{1}, P_{2}$ orthogonal projections on $H_{0}$, $H_{1} \subseteq H$. Then the following is equivalent.
(i) $H_{0} \subseteq H_{1}$,
(ii) $\left\|P_{0} x\right\| \leq\left\|P_{1} x\right\|, \quad x \in H$.
(iii) $\left\langle P_{0} x, x\right\rangle \leq\left\langle P_{1} x, x\right\rangle, \quad x \in H$.
(iv) $P_{0} P_{1}=P_{0}$.

Proof. (ii) $\Longleftrightarrow$ (iii) Let $x \in H$ and $P$ an orthogonal projection. Then $\langle P x, x\rangle=$ $\left\langle P^{2} x, x\right\rangle=\langle P x, P x\rangle=\|P x\|^{2}$.
(i) $\Longleftrightarrow$ (iv)

$$
\begin{aligned}
P_{0} P_{1}=P_{0} & \Longleftrightarrow P_{0}\left(\mathrm{id}-P_{1}\right)=0
\end{aligned} \begin{aligned}
& \Longleftrightarrow \operatorname{rg}\left(\mathrm{id}-P_{1}\right) \subseteq \operatorname{ker} P_{0} \\
& \Longleftrightarrow\left(\operatorname{rg} P_{1}\right)^{\perp} \subseteq\left(\operatorname{rg} P_{0}\right)^{\perp} \Longleftrightarrow H_{1}^{\perp} \subseteq H_{0}^{\perp} \\
& \Longleftrightarrow H_{0} \subseteq H_{1} .
\end{aligned}
$$

(iv) $\Longrightarrow$ (ii) For all $x \in H:\left\|P_{0} x\right\|=\left\|P_{0} P_{1} x\right\| \leq\left\|P_{0}\right\|\left\|P_{1} x\right\| \leq\left\|P_{1} x\right\|$.
(iii) $\Longrightarrow$ (i) Let $x \in H_{1}^{\perp}=\operatorname{ker} P_{1}$. Then $0=\left\langle P_{1} x, x\right\rangle \geq\left\langle P_{0} x, x\right\rangle \geq 0$, hence $\left\langle P_{0} x, x\right\rangle=0$. It follows that $\left.P_{0}\right|_{H_{\perp}^{\perp}}=0$ (Corollary 4.46), hence $H_{1}^{\perp} \subseteq \operatorname{ker} P_{0}=$ $H_{0}^{\perp}$.

Lemma 4.55. Let $H$ be a Hilbert space and $\left(P_{n}\right)_{n \in \mathbb{N}}$ a sequence of orthogonal projections with $\left\langle P_{m} x, x\right\rangle \leq\left\langle P_{n} x, x\right\rangle$ for all $x \in X$ and $m<n$. Then $\left(P_{n}\right)_{n \in \mathbb{N}}$ converges strongly to an orthogonal projection.

Proof. By Theorem 4.49 we already know that $s$ - $\lim P_{n}=: P$ exists and is a selfadjoint operator. It remains to be shown that $P$ is a projection, that is, that $P^{2}=P$. For $x \in H$ and $n \in \mathbb{N}$

$$
P^{2} x=\left(P-P_{n}+P_{n}\right)\left(P-P_{n}+P_{n}\right) x=\left(P-P_{n}\right) P x+P_{n}\left(P-P_{n}\right) x+P_{n}^{2} x .
$$

Note that $\left(P-P_{n}\right) P x \rightarrow 0, n \rightarrow \infty$, and also $P_{n}\left(P-P_{n}\right) x$ because $\left\|P_{n}\right\|=1$,
$n \in \mathbb{N}$. Since $P^{2} x=P_{n} x \rightarrow P x$, it follows that $P^{2}=P$.

### 4.6 The adjoint of an unbounded operator

In sections 2.4 and section 4.4 we have defined the adjoint of bounded linear operaIn sections 2.4 and section 4.4 we have defined the adjoint of bounded linear opera-
tors between Banach or Hilbert spaces. Now we define the adjoint of an unbounded tors between Banach or Hibert spaces. Now we define the adjoint of an unbounded
linear operator. Recall that $T(X \rightarrow Y)$ denotes a possibly unbounded linear operators defined on a subspace $\mathcal{D}(T) \subseteq X$.

Definition 4.56. Let $X, Y$ be Banach spaces and $\mathcal{D}(T) \subseteq X$ a dense subspace. For a linear map $T: X \supset \mathcal{D}(T) \rightarrow Y$ we define
$\mathcal{D}\left(T^{\prime}\right):=\left\{\varphi \in Y^{\prime}: x \mapsto \varphi(T x)\right.$ is a bounded linear functional on $\left.\mathcal{D}(T)\right\}$,
Since $\mathcal{D}(T)$ is dense in $X$, the map $\mathcal{D}(T) \rightarrow \mathbb{K}, x \mapsto \varphi(T x)$ has a unique continuous extension $T^{\prime} \varphi \in X^{\prime}$ for $\varphi \in \mathcal{D}\left(T^{\prime}\right)$. Hence the Banach space adjoint $T^{\prime}$

$$
T^{\prime}: Y^{\prime} \supseteq \mathcal{D}\left(T^{\prime}\right) \rightarrow X^{\prime}, \quad\left(T^{\prime} \varphi\right)(x)=\varphi(T x), \quad x \in \mathcal{D}(T), \varphi \in \mathcal{D}\left(T^{\prime}\right) .
$$

is well-defined.

Theorem 4.57. Let $X, Y$ be Banach spaces, $\mathcal{D}(T) \subseteq X$ a dense subspace and $T: X \supseteq \mathcal{D}(T) \rightarrow Y$ be a linear operator. Then $T^{\prime}$ is closed.
Proof. Let $G\left(T^{\prime}\right)=\left\{\left(y^{\prime}, T^{\prime} y^{\prime}\right): \varphi \in \mathcal{D}\left(T^{\prime}\right)\right\} \subseteq Y^{\prime} \times X^{\prime}$ be the graph of $T^{\prime}$.
Note that $\left(y^{\prime}, x^{\prime}\right) \in G\left(T^{\prime}\right)$ if and only if $x^{\prime} x=y^{\prime}(T x)$ for all $x \in \mathcal{D}(T)$. Now let $\left(\left(y_{n}^{\prime}, x_{n}^{\prime}\right)\right)_{n \in \mathbb{N}} \subseteq G\left(T^{\prime}\right)$ a convergent sequence with $\lim _{n \rightarrow \infty}\left(y_{n}^{\prime}, x_{n}^{\prime}\right)=\left(y_{0}^{\prime}, x_{0}^{\prime}\right)$. For all $x \in \mathcal{D}(T)$ it follows that

$$
x_{0}^{\prime} x=\lim _{n \rightarrow \infty} x_{n}^{\prime} x=\lim _{n \rightarrow \infty} y_{n}^{\prime}(T x)=\lim _{n \rightarrow \infty} y_{0}^{\prime}(T x)
$$

thus $\left(y_{0}^{\prime}, x_{0}^{\prime}\right) \in G\left(T^{\prime}\right)$ which implies that $T^{\prime}$ is closed.
Definition 4.58. Let $X, Y$ be Banach spaces. For linear operators $S, T$ from $X$ to $Y$ we write $S \subseteq T$ if $T$ is an extension of $S$, that is, if $\mathcal{D}(S) \subseteq \mathcal{D}(T)$ and $\left.T\right|_{\mathcal{D}(S)}=S$

## Theorem 4.59. Let $X, Y, Z$ be Banach spaces

(i) Let $(S, \mathcal{D}(S))$ and $(T, \mathcal{D}(T))$ be densely defined linear operators $X \rightarrow Y$. If $S \subset T$ then $T^{\prime} \subset S^{\prime}$
(ii) Assume $S(X \rightarrow Y)$ and $T(Y \rightarrow Z)$ are densely defined such that also $T S$ is densely defined. Then $S^{\prime} T^{\prime} \subseteq(T S)^{\prime}$.
(iii) Assume $S(X \rightarrow Y)$ and $T(X \rightarrow Y)$ are densely defined such that also $T+S$ is densely defined. Then $\left(S^{\prime}+T^{\prime}\right) \subseteq(S+T)^{\prime}$
Proof. (i) is clear from the definition of the adjoint operator.
(ii) Let $z^{\prime} \in \mathcal{D}\left(S^{\prime} T^{\prime}\right)$. Then $T^{\prime} z^{\prime} \in \mathcal{D}\left(S^{\prime}\right)$ and the map

$$
\mathcal{D}(S) \rightarrow \mathbb{K}, \quad x \mapsto\left(T^{\prime} z^{\prime}\right)(S x)
$$

is continuous. Then also its restriction

$$
\mathcal{D}(T S) \rightarrow \mathbb{K}, \quad x \mapsto\left(T^{\prime} z^{\prime}\right)(S x)=z^{\prime}(T S x)
$$

is continuous. Note that by assumption $\mathcal{D}(T S)$ is dense in $X$, hence $z^{\prime} \in \mathcal{D}\left((T S)^{\prime}\right.$ and $(T S)^{\prime} z^{\prime}=S^{\prime} T^{\prime} z^{\prime}$.
(iii) Let $y^{\prime} \in \mathcal{D}\left(T^{\prime}+S^{\prime}\right)=\mathcal{D}\left(T^{\prime}\right) \cap \mathcal{D}\left(S^{\prime}\right)$. Then the map

$$
\mathcal{D}(T+S) \rightarrow \mathbb{K}, \quad x \mapsto y^{\prime}(T x)+y^{\prime}(S x)=y^{\prime}((T+S) x)
$$

is continuous. Since by assumption $\mathcal{D}(T+S)$ is dense in $X, y^{\prime} \in \mathcal{D}\left((T+S)^{\prime}\right)$ and
$(T+S)^{\prime} y^{\prime}=\left(T^{\prime}+S^{\prime}\right) y^{\prime}$.
If $S$ and $T$ are bounded, then "=" holds in (ii) and (iii) (Theorem 2.26). Note If $S$ and $T$ are bounded, then $=$ holds in (ii) and (iii) (Iheorem 2.26). Note
that for unbounded linear operators $T^{\prime}+S^{\prime}=(T+S)^{\prime}$ is not necessarily true. For that for unbounded linear operators $T^{\prime}+S^{\prime}=(T+S)^{\prime}$ is not necessarily true. For
example, if $T(X \rightarrow Y)$ is a densely defined unbounded linear operator such that also $T^{\prime}$ is densely defined with $\mathcal{D}\left(T^{\prime}\right) \neq Y^{\prime}$. Then $\mathcal{D}\left(T^{\prime}-T^{\prime}\right) \neq Y^{\prime}=\mathcal{D}(T-T)^{\prime}$.

Corollary 4.60. Let $X$ be a Banach space, $T$ a densely defined linear operator in $X$ with bounded inverse $T^{-1} \in L(X)$. Then $T^{\prime}$ is invertible and

$$
\left(T^{\prime}\right)^{-1}=\left(T^{-1}\right)^{\prime} .
$$

Proof. By Theorem 4.59 (ii) it follows that $\left(T^{-1}\right)^{\prime} T^{\prime} \subseteq\left(T T^{-1}\right)^{\prime}=\mathrm{id}_{X}^{\prime}=\mathrm{id}_{X}$, hence $\left(T^{-1}\right)^{\prime} T^{\prime}=\operatorname{id}_{\mathcal{D}\left(T^{\prime}\right)}$.
Again by Theorem 4.59 (ii) we find $T^{\prime}\left(T^{-1}\right)^{\prime} \subseteq\left(T^{-1} T\right)^{\prime}=\operatorname{id}_{\mathcal{D}(T)}^{\prime}=\operatorname{id}_{X}$, so it suffices to show $\mathcal{D}\left(T^{\prime}\left(T^{-1}\right)^{\prime}\right)=\mathcal{D}\left(T^{\prime}\right)$. Let $\varphi \in \mathcal{D}\left(T^{\prime}\right)$ and $\eta=\left(T^{-1}\right)^{\prime} \varphi$. For every $x \in \mathcal{D}(T)$ it follows that $\eta(T x)=\left(\left(T^{-1}\right)^{\prime} \varphi\right)(T x)=\varphi\left(T^{-1^{\prime}} T x\right)=\varphi(x)$, which implies $\eta \in \mathcal{D}\left(T^{\prime}\right)$, hence $\mathcal{D}\left(T^{\prime}\left(T^{-1}\right)^{\prime}\right)=\mathcal{D}\left(T^{\prime}\right)$.

More general is Theorem 4.65 due to Phillips.
Definition 4.61. Let $X$ be a Banach space. For subspaces $A \subseteq X$ and $B \subseteq X^{\prime}$ we define the annihilators

$$
\begin{aligned}
A^{\circ} & :=\left\{\varphi \in X^{\prime}: \varphi(x)=0, x \in A\right\} \subseteq X^{\prime}, \\
{ }^{\circ} B & :=\{x \in X: \varphi(x)=0, \varphi \in B\} \subseteq X .
\end{aligned}
$$

Remark 4.62. The sets $A^{\circ}$ and ${ }^{\circ} B$ are closed subspaces and ${ }^{\circ}\left(A^{\circ}\right)=\bar{A}$. If $X$ is reflexive, then also $\left({ }^{\circ} B\right)^{\circ}=\bar{B}$.

Proof. Obviously, $A^{\circ}$ and ${ }^{\circ} B$ are subspaces. Let $\left(x_{n}^{\prime}\right)_{n \in \mathbb{N}} \subseteq A^{\circ}$ be a convergent sequence. Then $x_{0}^{\prime}:=\lim _{n \rightarrow \infty} x_{n}^{\prime} \in A^{\circ}$ because $x_{0}^{\prime} x=\lim _{n \rightarrow \infty} x_{n}^{\prime} x=0$ for all $x \in A$. Let $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq{ }^{\circ} B$ be a convergent sequence. Then $x_{0}:=\lim _{n \rightarrow \infty} x_{n} \in{ }^{\circ} B$ because $\varphi x_{0}=\lim _{n \rightarrow \infty} \varphi x_{n}=0$ for all $\varphi \in B$.
Now we show that ${ }^{\circ}\left(A^{\circ}\right)=\bar{A}$. Since obviously $A \subseteq{ }^{\circ}\left(A^{\circ}\right)$, also $\bar{A} \subseteq{ }^{\circ}\left(A^{\circ}\right)$. Assume that there exists an $a \in{ }^{\circ}\left(A^{\circ}\right) \backslash \bar{A}$. By a corollary to the Hahn-Banach theorem (Corollary 2.19) there exists a $\varphi \in X^{\prime}$ such that $\left.\varphi\right|_{\bar{A}}=0$ and $\varphi(a) \neq 0$. Therefore $\varphi \in A^{\circ}$, so by definition of ${ }^{\circ}\left(A^{\circ}\right)$, also $\varphi(a)=0$.
$\left({ }^{\circ} B\right)^{\circ}=\bar{B}$ follows if we identify $X$ with $X^{\prime \prime}$ using the canonical map $J_{X}$. $\square$
Lemma 4.63. Let $X, Y$ be Banach space, $Y \neq\{0\}$ and $T(X \rightarrow Y)$ a densely defined closed linear operator and $y_{0} \in Y \backslash\{0\}$. Then there exists a $\varphi \in \mathcal{D}\left(T^{\prime}\right)$ such that $\varphi\left(y_{0}\right) \neq 0$, in particular, $\mathcal{D}\left(T^{\prime}\right) \neq\{0\}$.

Proof. By assumption, the graph $G(T)$ of $T$ is closed and $\left(0, y_{0}\right) \neq G(T)$. Hence, by a corollary to the Hahn-Banach theorem (Corollary 2.19) there exists $\psi \in(X \times Y)$ such that $\left.\psi\right|_{G(T)}=0$ and $\psi\left(\left(0, y_{0}\right)\right) \neq 0$. Let $\varphi: Y \rightarrow \mathbb{K}, \varphi(y)=\psi((0, y))$. Obviously $\varphi \in Y^{\prime}$ and $\varphi\left(y_{0}\right) \neq 0$. Moreover, $\varphi \in \mathcal{D}\left(T^{\prime}\right)$ because for all $x \in \mathcal{D}(T)$

$$
\varphi(T x)=\psi((0, T x))=\psi((x, T x)-(x, 0))=\psi((x, T x))-\psi((x, 0))
$$

$$
=-\psi((x, 0))
$$

Theorem 4.64. Let $X$ and $Y$ be Banach spaces. For a densely defined closed linear operator $T(X \rightarrow Y)$ the following holds:
(i) $\operatorname{rg}(T)^{\circ}=\overline{\operatorname{rg}(T)}^{\circ}=\operatorname{ker} T^{\prime}$.
(ii) $\overline{\operatorname{rg} T}={ }^{\circ}\left(\operatorname{ker} T^{\prime}\right)$.
(iii) $\overline{\operatorname{rg} T}=Y \Longleftrightarrow T^{\prime}$ is injective.
(iv) ${ }^{\circ}\left(\operatorname{rg} T^{\prime}\right) \cap \mathcal{D}(T)=\operatorname{ker} T$.
(v) $\overline{\operatorname{rg} T^{\prime}} \subseteq(\operatorname{ker} T)^{\circ}$

Proof. (i) The first equality is clear. The second equality follows from

$$
\begin{aligned}
\varphi \in \operatorname{rg}(T)^{\circ} & \Longleftrightarrow \quad \forall y \in \operatorname{rg}(T) \quad \varphi(y)=0 \\
& \Longleftrightarrow \quad \forall x \in \mathcal{D}(T) \quad \varphi(T x)=0 \\
& \Longleftrightarrow \quad \varphi \in \mathcal{D}\left(T^{\prime}\right), T^{\prime} \varphi=0 \\
& \Longleftrightarrow \quad \varphi \in \operatorname{ker}\left(T^{\prime}\right) .
\end{aligned}
$$

(ii) $\overline{\operatorname{rg} T}={ }^{\circ}\left((\operatorname{rg} T)^{\circ}\right)={ }^{\circ}\left(\operatorname{ker} T^{\prime}\right)$ by (i) and Remark 4.62.
(iii) $\mathrm{By}(\mathrm{ii}), \overline{\operatorname{rg} T}=Y$ if and only if ${ }^{\circ}\left(\operatorname{ker} T^{\prime}\right)=Y$. This is the case if and only if $\varphi(y)=0$ for all $\varphi \in \operatorname{ker} T^{\prime}$ and $y \in Y$, that is, if and only if $\operatorname{ker} T^{\prime}=\{0\}$.
(iv) Let $x \in \operatorname{ker}(T)$ and $x^{\prime} \in \operatorname{rg} T^{\prime}$. Choose $y^{\prime} \in \mathcal{D}\left(T^{\prime}\right)$ with $T^{\prime} y^{\prime}=x^{\prime}$. Then $x^{\prime} x=\left(T^{\prime} y^{\prime}\right) x=y^{\prime}(T x)=y^{\prime}(0)=0$, hence $x \in^{\circ}(\operatorname{rg} T)^{\prime}$.
Now let $x \in{ }^{\circ}\left(\operatorname{rg} T^{\prime}\right) \cap \mathcal{D}(T)$. Then $y^{\prime}(T x)=\left(T^{\prime} y^{\prime}\right) x=0$ for all $y^{\prime} \in Y^{\prime}$. Since $T$ is closed, it follows by Lemma 4.63 that $T x=0$, hence $x \in \operatorname{ker} T$.
(v) Let $x^{\prime} \in \operatorname{rg}\left(T^{\prime}\right)$ and $x \in \operatorname{ker} T$. Choose $y^{\prime} \in \mathcal{D}\left(T^{\prime}\right)$ such that $T^{\prime} y^{\prime}=x^{\prime}$. Then $x^{\prime} x=\left(T^{\prime} y^{\prime}\right) x=y^{\prime}(T x)=y^{\prime}(0)=0$. It follows that $\operatorname{rg}\left(T^{\prime}\right) \subseteq(\operatorname{ker} T)^{\circ}$, and since $(\operatorname{ker} T)^{\circ}$ is closed, the statement is proved.

Theorem 4.65 (Phillips). Let $X, Y$ be a Banach spaces, $T(X \rightarrow Y)$ a densely defined injective linear operator with $\operatorname{rg}(T)=Y$. Then

$$
\begin{equation*}
\left(T^{\prime}\right)^{-1}=\left(T^{-1}\right)^{\prime} \tag{4.2}
\end{equation*}
$$

and $T^{-1}$ is bounded if and only if $T$ is closed and $\left(T^{\prime}\right)^{-1}$ is bounded on $X^{\prime}$. ( $T^{-1}$ denotes the inverse of $T: \mathcal{D}(T) \rightarrow \operatorname{rg}(T)$, similar for $\left.\left(T^{\prime}\right)^{-1}.\right)$

Proof.
Theorem 4.66 (Closed range theorem). Let $X, Y$ be reflexive Banach spaces and $T: X \supseteq \mathcal{D}(T) \rightarrow Y$ a closed densely defined linear operator. The following is equivalent:
(i) $\operatorname{rg}(T)$ is closed.
(ii) $\operatorname{rg}\left(T^{\prime}\right)$ is closed.
(iii) $T: X \supseteq \mathcal{D}(T) \rightarrow \overline{\operatorname{rg}(T)}$ is open.
(iv) $T^{\prime}: Y^{\prime} \supseteq \mathcal{D}\left(T^{\prime}\right) \rightarrow \overline{\operatorname{rg}\left(T^{\prime}\right)}$ is open.
(v) $\operatorname{rg}(T)={ }^{\circ}\left(\operatorname{ker} T^{\prime}\right)$.
(vi) $\operatorname{rg}\left(T^{\prime}\right)=(\operatorname{ker} T)^{\circ}$.

Proof. (i) $\Longleftrightarrow$ (iii) $\quad$ Since $T$ is closed, $\left(\mathcal{D}(T),\|\cdot\|_{T}\right)$ is a Banach space and

$$
\widetilde{T}:\left(\mathcal{D}(T),\|\cdot\|_{T}\right) \rightarrow \operatorname{rg} T, \quad \widetilde{T} x=T x
$$

is continuous (Lemma 3.32). Observe that also $i:\left(\mathcal{D}(T),\|\cdot\|_{T}\right) \rightarrow X, x \mapsto x$ is continuous and that $T=\widetilde{T} \circ i^{-1}: X \supseteq \mathcal{D}(T) \rightarrow Y$. Note that $\overline{\operatorname{rg} T}$ is a Banach space.
If $\operatorname{rg} T$ is closed, then $\widetilde{T}:\left(\mathcal{D},\|\cdot\|_{T}\right) \rightarrow \operatorname{rg} T$ is open by the open mapping theorem (Theorem 3.22), then also $T=\widetilde{T} \circ i^{-1}: X \supseteq \mathcal{D}(T) \rightarrow \operatorname{rg} T$ is open as composition of open maps. If $T: \mathcal{D}(T) \rightarrow \overline{\operatorname{rg} T}$ is open, then it is surjective, hence $\operatorname{rg} T$ is closed. Note that $T^{\prime}$ is closed (Theorem 4.57), hence (ii) $\Longleftrightarrow$ (iv) is proved analogously.
(i) $\Longleftrightarrow$ (v) follows from theorem 4.64 (ii).
(ii) $\Longleftrightarrow$ (vi) follows from theorem 4.64 (ii)

$$
\overline{\operatorname{rg}\left(T^{\prime}\right)}={ }^{\circ}\left(\operatorname{ker} T^{\prime \prime}\right)=(\operatorname{ker} T)^{\circ} .
$$

(iii) $\Longleftrightarrow$ (iv) Recall that $T$ is open if and only if there exists an, $r>0$ such that the image of the open ball in $X$ with centre 0 and radius $r$ contains the open unit ball in $Y$. That is, there exists a $r>0$ such that $T\left(B_{X}(0, r)\right) \supseteq B_{Y}(0,1)$. Assume that $T$ is open and let $r$ as above.
To show that $T^{\prime}$ is open, we have to show that for every $x_{0}^{\prime} \in \operatorname{rg}\left(T^{\prime}\right)$ with $\left\|x_{0}^{\prime}\right\|<1$, there exists a $y_{0}^{\prime} \in \mathcal{D}\left(T^{\prime}\right)$ with $T^{\prime} y_{0}^{\prime}=x_{0}^{\prime}$ and $\left\|y_{0}^{\prime}\right\|<r$. Define a linear functional
$\varphi$ on $\operatorname{rg}(T)$ as follows: for $y \in \operatorname{rg} T$ with $\|y\|<1$ choose $x \in \mathcal{D}(T)$ such that $\|x\|<r$ and $T x=y$. Set $\varphi(y)=x_{0}^{\prime} x$ and extend $\varphi$ linearly to $\operatorname{rg} T$. Note that $|\varphi(y)|=\left|x_{0}^{\prime} x\right| \leq\left\|x_{0}^{\prime}\right\|\|x\| \leq r\|y\|, \varphi$ is bounded, so by the theorem of Hahn-Banach $|\varphi(y)|=\left|x_{0} x\right| \leq\left\|x_{0}\right\|\|x\| \leq r\|y\|, \varphi$ is bounded, so by the theorem of
it can be extended to a functional $y_{0}^{\prime} \in Y^{\prime}$ with $\left\|y_{0}^{\prime}\right\| \leq r$. Note that

$$
\mathcal{D}(T) \rightarrow \mathbb{K}, \quad \mapsto y_{0}^{\prime}(T x)=\varphi(T x)=x_{0}^{\prime} x
$$

is continuous, so $y_{0}^{\prime} \in \mathcal{D}(T)$.
(iv) $\Longleftrightarrow$ (iii) Follows analogously if we note that $T^{\prime \prime}=T$ by the reflexivity of $X$ and $Y$.
Definition 4.67. Let $H_{1}, H_{2}$ be Hilbert spaces and $\mathcal{D}(T) \subseteq H_{1}$ a dense subspace. For a linear map $T: H_{1} \supseteq \mathcal{D}(T) \rightarrow H_{2}$ its Hilbert space adjoint $T^{*}$ is defined by

$$
\begin{aligned}
\mathcal{D}\left(T^{*}\right):= & \left\{y \in H_{2}: x \mapsto\langle T x, y\rangle \text { is a bounded on } \mathcal{D}(T)\right\}, \\
& T^{*}: H_{2} \supseteq \mathcal{D}\left(T^{*}\right) \rightarrow H_{1}, \quad T^{*} y=y^{*},
\end{aligned}
$$

where $y^{*} \in H_{1}$ such that $\langle T x, y\rangle=\left\langle x, y^{*}\right\rangle$ for all $x \in \mathcal{D}(T)$.
Note that for $y \in \mathcal{D}\left(T^{*}\right)$ the map $x \mapsto\langle T x, y\rangle$ is continuous and densely defined and can therefore be extended uniquely to an element $\varphi_{y} \in H_{1}^{\prime}$. By the Riesz representation theorem (Theorem 4.20) there exists exactly one $y^{*} \in H_{1}$ as desired.

Definition 4.68. Let $H_{1}, H_{2}$ be Hilbert spaces and $\mathcal{D}(T) \subseteq H_{1}, \mathcal{D}(S) \subseteq H_{2}$ subspaces. The linear maps $T: H_{1} \supseteq \mathcal{D}(T) \rightarrow H_{2}$ and $S: H_{2} \supseteq \mathcal{D}(S) \rightarrow H_{1}$ are called formally adjoint if

$$
\langle T x, y\rangle_{H_{2}}=\langle x, S y\rangle_{H_{1}}, \quad x \in \mathcal{D}(T), y \in \mathcal{D}(S)
$$

Note that the formal adjoint of a non-densely defined linear operator is not unique; in particular, the operator trivial operator with $\mathcal{D}=\{0\}$ is formally adjoint to every If $T$ is densely defined, then its adjoint $T^{*}$ is its maximal formally adjoint operator.

Lemma 4.69. Let $H_{1}$ and $H_{2}$ be Hilbert spaces and define

$$
U: H_{1} \times H_{2} \rightarrow H_{2} \times H_{1}, \quad(x, y) \mapsto(y,-x)
$$

If $T\left(H_{1} \rightarrow H_{2}\right)$ is a densely defined linear operator, then

$$
\begin{equation*}
G\left(T^{*}\right)=U\left(G(T)^{\perp}\right)=[U(G(T))]^{\perp} . \tag{4.3}
\end{equation*}
$$

Proof. Observe that $U$ is unitary, hence $U\left(G(T)^{\perp}\right)=[U(G(T))]^{\perp}$. The first equality in (4.3) follows from

$$
\begin{aligned}
\left(y_{0}, x_{0}\right) \in G\left(T^{*}\right) & \Longleftrightarrow\left\langle T x, y_{0}\right\rangle_{Y}=\left\langle x, x_{0}\right\rangle_{X}, \quad x \in \mathcal{D}(T) \\
& \Longleftrightarrow\left\langle T x, y_{0}\right\rangle-\left\langle x, x_{0}\right\rangle=0, \quad x \in \mathcal{D}(T) \\
& \Longleftrightarrow\left\langle(T x,-x),\left(y_{0}, x_{0}\right)\right\rangle_{H_{2} \times H_{1}}=0, \quad x \in \mathcal{D}(T) \\
& \Longleftrightarrow\left\langle U(x, T x),\left(y_{0}, x_{0}\right)\right\rangle_{H_{2} \times H_{1}}=0, \quad x \in \mathcal{D}(T) \\
& \Longleftrightarrow\left(y_{0}, x_{0}\right) \in[U(G(T))]^{\perp} .
\end{aligned}
$$

Theorem 4.70. Let $H_{1}$ and $H_{2}$ be Hilbert spaces. For a densely defined linear operator $T(X \rightarrow Y)$ the following holds:
(i) $T^{*}$ is closed.
(ii) If $T$ is closable, then $T^{*}$ is densely defined and $T^{* *}=\bar{T}$.

Proof. (i) follows immediately from (4.3).
(ii) Let $y_{0} \in \mathcal{D}\left(T^{*}\right)^{\perp}$. Then $\left\langle y_{0}, y\right\rangle=0$ for all $y \in \mathcal{D}(T)$. This implies
$0=\left\langle\left(0, y_{0}\right),(-z, y)\right\rangle_{H_{1} \times H_{2}}=\left\langle\left(0, y_{0}\right), U(y, z)\right\rangle_{H_{1} \times H_{2}}, \quad(y, z) \in G\left(T^{*}\right)$.
Hence by Lemma 4.69,

$$
\left(0, y_{0}\right) \in\left[U^{-1}\left(G\left(T^{*}\right)\right)\right]^{\perp}=G(T)^{\perp \perp}=\overline{G(T)}=G(\bar{T})
$$

It follows that $y_{0}=\bar{T} 0=0$, so $\overline{\mathcal{D}\left(T^{*}\right)}=Y$. Let

$$
V: H_{2} \times H_{1} \rightarrow H_{1} \times H_{2}, \quad V(y, x)=(x,-y)
$$

Obviously $V U=-\operatorname{id}_{H_{1} \times H_{2}}$ and application of Lemma 4.69 to $T^{*}$ yields

$$
\begin{aligned}
G\left(T^{* *}\right) & =\left[V\left(G\left(T^{*}\right)\right)\right]^{\perp}=\left[V U\left(G(T)^{\perp}\right)\right]^{\perp}=\left[-\left(G(T)^{\perp}\right)\right]^{\perp}=G(T)^{\perp \perp}=\overline{G(T)} \\
& =G(\bar{T}) .
\end{aligned}
$$

hence $T^{* *}=\bar{T}$.

## Theorem 4.71. Let $H_{1}, H_{2}, H_{3}$ be Hilbert spaces.

(i) Let $T\left(H_{1} \rightarrow H_{2}\right)$ and $S\left(H_{1} \rightarrow H_{2}\right)$ be densely defined linear operators. If $S \subseteq T$ then $T^{*} \subseteq S^{*}$.
(ii) Assume $S\left(H_{1} \rightarrow H_{2}\right)$ and $T\left(H_{2} \rightarrow H_{3}\right)$ are densely defined with $\overline{T S}=H_{1}$. Then $S^{*} T^{*} \subseteq(T S)^{*}$.
(iii) Assume $S\left(H_{1} \rightarrow H_{2}\right)$ and $T\left(H_{1} \rightarrow H_{2}\right)$ are densely defined with $\overline{T+S}=H_{1}$. Then $\left(T^{*}+S^{*}\right) \subseteq(S+T)^{*}$.
If $S$ and $T$ are bounded, then " $=$ " holds in (ii) and (iii).
Proof. As is in the Banach space case.
Corollary 4.72. Let $H$ be a Hilbert space, $T$ a densely defined linear operator in $H$ with bounded inverse $T^{-1} \in L(H)$. Then $T^{*}$ is invertible and

$$
\left(T^{*}\right)^{-1}=\left(T^{-1}\right)^{*}=: T^{-*}
$$

Proof. By Theorem 4.71 (ii) it follows that $\left(T^{-1}\right)^{*} T^{*} \subseteq\left(T T^{-1}\right)^{*}=\operatorname{id}_{H^{*}}=\operatorname{id}_{H}$ hence $\left(T^{-1}\right)^{*} T^{*}=\operatorname{id}_{\mathcal{D}\left(T^{*}\right.}$.
Again by Theorem 4.71 (ii) we find $T^{*}\left(T^{-1}\right)^{*} \subseteq\left(T^{-1} T\right)^{*}=\operatorname{id}_{\mathcal{D}(T)}^{*}=\operatorname{id}_{H}$, so it suffices to show $\mathcal{D}\left(T^{*}\left(T^{-1}\right)^{*}\right)=\mathcal{D}\left(T^{*}\right)$. Let $y \in \mathcal{D}\left(T^{*}\right)$ and $z=\left(T^{-1}\right)^{*} y$. For every $x \in \mathcal{D}(T)$ it follows that $\langle T x, z\rangle=\left\langle T x,\left(T^{-1}\right)^{*} y\right\rangle=\left\langle T^{-1} T x, y\right\rangle=\langle x, y\rangle$, so $z \in \mathcal{D}\left(T^{*}\right)$ which implies $\mathcal{D}\left(T^{*}\left(T^{-1}\right)^{*}\right)=\mathcal{D}\left(T^{*}\right)$.
Theorem 4.73. Let $H_{1}, H_{2}$ be Hilbert spaces, $T\left(H_{1} \rightarrow H_{2}\right)$ a densely defined closed linear operator. Then the following holds.
(i) $\operatorname{rg}(T)^{\perp}=\overline{\operatorname{rg}(T)}{ }^{\perp}=\operatorname{ker} T^{*}$.
(ii) $\overline{\operatorname{rg}(T)}=\left(\operatorname{ker} T^{*}\right)^{\perp}$.
(iii) $\operatorname{rg}\left(T^{*}\right)^{\perp}=\operatorname{ker} T$.
(iv) $\overline{\operatorname{rg}\left(T^{*}\right)}=(\operatorname{ker} T)^{\perp}$.

Proof. (i) Note that $y \in \operatorname{rg}(T)^{\perp}$ if and only if $\langle T x, y\rangle$ for all $x \in \mathcal{D}(T)$. This is equivalent to $y \in \mathcal{D}\left(T^{*}\right)$ and $T^{*} y=0$.
(ii) By (i) $\overline{\operatorname{rg}(T)}=\overline{\operatorname{rg}(T)}{ }^{\perp \perp}=\left(\operatorname{ker} T^{*}\right)^{\perp}$.
(iii) By Theorem $4.70 T^{*}$ is closed and densely defined and $T^{* *}=T$. Application of (i) to $T^{*}$ shows $\operatorname{rg}\left(T^{*}\right)^{\perp}=\operatorname{ker} T$.
(iv) Application of (ii) to $T^{*}$ shows $\overline{\operatorname{rg}\left(T^{*}\right)}=(\operatorname{ker} T)^{\perp}$.

## Example 4.74. Let $H=L_{2}[0,1]$. Let

$\mathcal{D}\left(T_{1}\right):=W_{2}^{1}(0,1)=\left\{x \in L_{2}[0,1]: x\right.$ absolutely continuous, $\left.x^{\prime} \in L_{2}[0,1]\right\}$,
$\mathcal{D}\left(T_{2}\right):=\mathcal{D}\left(T_{1}\right) \cap\left\{x \in L_{2}[0,1]: x(0)=x(1)\right\}$
$\mathcal{D}\left(T_{3}\right):=\mathcal{D}\left(T_{1}\right) \cap\left\{x \in L_{2}[0,1]: x(0)=x(1)=0\right\}$.
For $k=1,2,3$ let

$$
T_{k}: H \supseteq \mathcal{D}\left(T_{k}\right) \rightarrow H, \quad T_{k} x=\mathrm{i} x^{\prime}
$$

Obviously, the $T_{k}$ are well-defined and $\mathcal{D}\left(T_{k}\right)$ is dense in $H$ (Theorem ??). We will show: $T_{1}^{*}=T_{3}, T_{3}^{*}=T_{1}, T_{2}^{*}=T_{2}$, in particular all $T_{k}$ are closed.

Proof. Let $x, y \in \mathcal{D}\left(T_{1}\right)$. Then, using integration by parts,

$$
\begin{aligned}
\left\langle T_{1} x, y\right\rangle & =\int_{0}^{1} \mathrm{i} x^{\prime}(t) \overline{y(t)} \mathrm{d} t=\left.\mathrm{i} x(t) \overline{y(t)}\right|_{0} ^{1}-\int_{0}^{1} \mathrm{i} x(t) \overline{y^{\prime}(t)} \mathrm{d} t \\
& =\mathrm{i} x(1) \overline{y(1)}-\mathrm{i} x(0) \overline{y(0)}+\left\langle x, T_{1} y\right\rangle .
\end{aligned}
$$

In particular we obtain

$$
\begin{array}{ll}
\langle T x, y\rangle=\langle x, T y\rangle, & x \in \mathcal{D}\left(T_{1}\right), y \in \mathcal{D}\left(T_{3}\right), \\
\langle T x, y\rangle=\langle x, T y\rangle, & x, y \in \mathcal{D}\left(T_{2}\right) .
\end{array}
$$

This shows that

$$
\mathcal{D}\left(T_{3}\right) \subseteq \mathcal{D}\left(T_{1}^{*}\right), \quad \mathcal{D}\left(T_{2}\right) \subseteq \mathcal{D}\left(T_{2}^{*}\right) \quad \text { and } \quad \mathcal{D}\left(T_{1}\right) \subseteq \mathcal{D}\left(T_{3}^{*}\right)
$$

and $\left.T_{1}^{*}\right|_{\mathcal{D}\left(T_{3}\right)}=T_{3},\left.T_{3}^{*}\right|_{\mathcal{D}\left(T_{3}\right)}=T_{1}$ and $\left.T_{2}^{*}\right|_{\mathcal{D}\left(T_{3}\right)}=T_{2}$
To prove the inclusion $\mathcal{D}\left(T_{1}^{*}\right) \subseteq \mathcal{D}\left(T_{3}\right)$ let $g \in \mathcal{D}\left(T_{1}^{*}\right)$ and $\varphi=T_{1}^{*} g$. Define $\Phi(t)=$
$\int_{0}^{t} \varphi(s) \mathrm{d} s$. Then $\Phi$ is absolutely continuous and $\Phi^{\prime}=\varphi$. For $x \in \mathcal{D}\left(T_{1}\right)$

$$
\begin{aligned}
\int_{0}^{1} \mathrm{i} x^{\prime}(t) \overline{g(t)} \mathrm{d} t & =\left\langle T_{1} x, g\right\rangle=\langle x, \varphi\rangle=\int_{0}^{1} \mathrm{i} x(t) \overline{\varphi(t)} \mathrm{d} t \\
& =\left.x(t) \overline{\Phi(t)}\right|_{0} ^{1}-\int_{0}^{1} \mathrm{i} x^{\prime}(t) \overline{\Phi(t)} \mathrm{d} t \\
& =x(1) \overline{\Phi(1)}-\int_{0}^{1} \mathrm{i} x^{\prime}(t) \overline{\Phi(t)} \mathrm{d} t .
\end{aligned}
$$

Note that $\Phi(1)=0$ as can be seen if $x$ is chosen to be a constant function. Hence

$$
\int_{0}^{1} \mathrm{i} x^{\prime}(t) \overline{(g(t) \mathrm{i} \Phi(x))} \mathrm{d} t=0, \quad x \in \mathcal{D}\left(T_{1}\right)
$$

implying that $g+\mathrm{i} \Phi \in \operatorname{rg}\left(T_{1}\right)^{\perp}=\{0\}$. It follows that $g$ is absolutely continuous and $g(0)=\mathrm{i} \varphi(0)=0, g(1)=\mathrm{i} \varphi(1)=0$, so $g \in \mathcal{D}\left(T_{3}\right)$.
Analogously, $T_{2}^{*}=T_{2}$ and $T_{3}^{*}=T_{1}$ can be shown.

Definition 4.75. Let $H$ be a Hilbert spaces, $\mathcal{D}(T) \subseteq H$ a dense subspace and $T: H \supseteq \mathcal{D}(T) \rightarrow H$ a linear map.
(i) $T$ is called symmetric if $T \subseteq T^{*}$.
(ii) $T$ is called selfadjoint if $T=T^{*}$.
(iii) $T$ is called essentially selfadjoint if $\bar{T}=T^{*}$.

The operator $T_{2}$ in the example above is selfadjoint, the operator $T_{3}$ is symmetric.

Remark 5.3. If $T$ is closed, then $(T-\lambda)^{-1}$ is closed if it exists. Therefore, by the closed graph theorem,

$$
\rho(T)=\left\{\lambda \in \mathbb{C}: T-\lambda \text { is injective and }(T-\lambda)^{-1} \in L(X)\right\} .
$$

## Chapter 5

## Spectrum of linear operators

If not stated explicitely otherwise, all Hilbert and Banach spaces in this chapter are assumed to be complex vector spaces.

### 5.1 The spectrum of a linear operator

Definition 5.1. Let $X$ be a Banach space and $T(X \rightarrow X)$ a densely defined linear operator.

$$
\begin{array}{ll}
\rho(T):=\{\lambda \in \mathbb{C}: \lambda \mathrm{id}-T \text { is bijective }\} & \text { resolvent set of } T \\
\sigma(T):=\mathbb{C} \backslash \rho(T) & \text { spectrum of } T .
\end{array}
$$

The spectrum of $T$ is further divided in point spectrum $\sigma_{\mathrm{p}}(T)$, continuous spectrum $\sigma_{\mathrm{c}}(T)$ and residual spectrum $\sigma_{\mathrm{r}}(T)$ :
$\sigma_{\mathrm{p}}(T):=\{\lambda \in \mathbb{C}: \lambda \mathrm{id}-T$ is not injective $\}$,
$\sigma_{c}(T):=\{\lambda \in \mathbb{C}: \lambda$ id $-T$ is injective, $\operatorname{rg}(T-\lambda \mathrm{id}) \neq X, \overline{\operatorname{rg}(T-\lambda \mathrm{id})}=X\}$,
$\sigma_{\mathrm{r}}(T):=\{\lambda \in \mathbb{C}: \lambda \mathrm{id}-T$ is injective, $\overline{\operatorname{rg}(T-\lambda \mathrm{id})} \neq X\}$.
It follows immediately from the definition that

$$
\sigma(T)=\sigma_{\mathrm{p}}(T) \dot{\cup} \sigma_{\mathrm{c}}(T) \dot{\cup} \sigma_{\mathrm{r}}(T) .
$$

In the following, we often write $\lambda-T$ instead of $\lambda$ id $-T$.
Definition 5.2. (i) Elements $\lambda \in \sigma_{\mathrm{p}}(T)$ are called eigenvalues of $T$.
(ii) For $\lambda \in \sigma_{\mathrm{p}}(T)$ we define the geometric eigenspace of $T$ in $\lambda, N_{\lambda}(T)$, and the algebraic eigenspace of $T$ in $\lambda, A_{\lambda}(T)$, by

$$
\begin{aligned}
& N_{\lambda}(T):=\operatorname{ker}(T-\lambda), \\
& A_{\lambda}(T):=\left\{x \in X:(T-\lambda)^{n} x=0 \text { for some } n \in \mathbb{N}\right\} .
\end{aligned}
$$

(iii) For $\lambda \in \rho(T)$ the resolvent of $T$ in $\lambda$ is $(\lambda \mathrm{id}-T)^{-1}:=R(\lambda, T)$. The map

$$
\rho(T) \rightarrow L(X), \quad \lambda \mapsto R(\lambda, T)
$$

is the resolvent map.
Remark 5.4. Often the resolvent set of a linear operator is defined slightly differ ently: Let $T(X \rightarrow X)$ is a densely defined linear operator. Then $\lambda \in \rho(T)$ if and only if $\lambda-T$ is bijective and $(\lambda-T) \in L(X)$. With this definition it follows that $\rho(T)=\emptyset$ for every non-closed $T(X \rightarrow X)$ because one of the following cases holds
(i) $\lambda-T$ is not bijective $\Longrightarrow \lambda \notin \rho(T)$;
(ii) $\lambda-T$ is bijective, then $(\lambda-T)^{-1}$ is defined everywhere and not closed, so it cannot be bounded, which implies $\lambda \notin \rho(T)$.

Remark 5.5. If $\operatorname{dim} X<\infty$, then $\sigma_{\mathrm{c}}(T)=\sigma_{\mathrm{r}}(T)=\emptyset$ and $\sigma_{\mathrm{p}}(T)$ is the set of all eigenvalues of $T$.

Theorem 5.6 (Spectral mapping theorem for polynomials). Let $X$ be a Banach space, $T \in L(X)$ and $P \in \mathbb{C}[X]$ a polynomial. Then

$$
\sigma(P(T))=P(\sigma(T))
$$

Proof. Let $\lambda \in \mathbb{C}$. Then there exists a polynomial $Q$ such that $P(X)-P(\lambda)=$ $(X-\lambda) Q(X)$. In particular, $P(T)-P(\lambda)=(T-\lambda) Q(T)=Q(T)(T-\lambda)$. Hence if $\lambda \in \sigma(T)$, then $(T-\lambda)$ is not bijective, so $P(T)-P(\lambda)$ is not bijective which implies $P(\sigma(T)) \subseteq \sigma(P(T))$.
Now assume $\mu \in \sigma(P(T))$. There exist $a, \lambda_{1}, \ldots, \lambda_{n} \in \mathbb{C}$ such that $P(X)-\mu=$ $a\left(X-\lambda_{1}\right) \cdots\left(X-\lambda_{n}\right)$. Since $P(T)-\mu$ is not invertible, at least one of the terms $\lambda_{j}-T$ cannot be invertible, that is at least one $\lambda_{j}$ must belong to the spectrum of $T$ and $\mu=P\left(\lambda_{j}\right) \in P(\sigma(T))$.

### 5.2 The resolvent

In this section we will study the resolvent map $\rho(T) \rightarrow L(X), \lambda \mapsto R(\lambda, T)=$ $(\lambda-T)^{-1}$. We will show that its domain is open and that it is analytic.

Lemma 5.7. Let $X$ be a Banach space and $T(X \rightarrow X)$ a closed linear operator
(i) $\left\|R\left(\lambda_{0}, T\right)\right\| \geq \frac{1}{\operatorname{dist}\left(\lambda_{0}, \sigma(T)\right)}$ for all $\lambda_{0} \in \rho(T)$.
(ii) For $\lambda_{0} \in \rho(T)$ and $\lambda \in \mathbb{C}$ with $\left|\lambda-\lambda_{0}\right|<\left\|R\left(\lambda_{0}, T\right)\right\|^{-}$

$$
R(\lambda, T)=\sum_{n=0}^{\infty}\left(\lambda_{0}-\lambda\right)^{n}\left(R\left(\lambda_{0}, T\right)\right)^{n+1} .
$$

Note that (ii) shows that locally around a $\lambda_{0} \in \rho(T)$ the resolvent has a power series expansion with coefficients depending only on $\lambda_{0}$ and $T$.
Proof of Lemma 5.7. Recall that for a bounded linear operator $S \in L(X)$ with $\|S\|<1$ the operator (id $-S)^{-1} \in L(X)$ and it is given explicitly by the Neumann series (Theorem 2.10)

$$
(\mathrm{id}-S)^{-1}=\sum_{n=0}^{\infty} S^{n} .
$$

Let $\lambda_{0} \in \rho(T)$. For $\lambda \in \mathbb{C}$ we find

$$
\lambda-T=\lambda_{0}-T-\left(\lambda_{0}-\lambda\right)=\left[\operatorname{id}-\left(\lambda_{0}-\lambda\right)\left(\lambda_{0}-T\right)^{-1}\right]\left(\lambda_{0}-T\right) .
$$

If $\left|\lambda_{0}-\lambda\right|<\left\|\left(\lambda_{0}-T\right)^{-1}\right\|^{-1}$, then the term in brackets is invertible, hence so is If $\left|\lambda_{0}-\lambda\right|<T$ and we obtain

$$
\begin{aligned}
(\lambda-T)^{-1} & =\left(\lambda_{0}-T\right)^{-1}\left[\mathrm{id}-\left(\lambda_{0}-\lambda\right)\left(\lambda_{0}-T\right)^{-1}\right]^{-1} \\
& =\left(\lambda_{0}-T\right)^{-1}\left(\sum_{n=0}^{\infty}\left(\lambda_{0}-\lambda\right)^{n}\left(\lambda_{0}-T\right)^{-n}\right) \\
& =\sum_{n=0}^{\infty}\left(\lambda_{0}-\lambda\right)^{n}\left(\lambda_{0}-T\right)^{-(n+1)}
\end{aligned}
$$

which proves (ii). If $\mu \in \mathbb{C}$ with $|\mu|<\left\|\left(T-\lambda_{0}\right)^{-1}\right\|^{-1}$, then $\lambda_{0}+\mu \in \rho(T)$, hence $\operatorname{dist}\left(\lambda_{0}, \sigma(T)\right) \geq\left\|\left(T-\lambda_{0}\right)^{-1}\right\|^{-1}$, so also (i) is proved.
As a corollary we obtain the following theorem.
Theorem 5.8. Let $X$ be a Banach space and $T(X \rightarrow X)$ a closed linear operator (i) $\sigma(T)$ is closed.
(ii) If $T \in L(X)$, then $\sigma(T)$ is compact.

Proof. (i) $\mathbb{C} \backslash \sigma(T)=\rho(T)$ is open by Lemma 5.7.
(ii) Let $\lambda \in \mathbb{C}$ with $|\lambda|>\|T\|$. Then $\lambda-T=\lambda\left(\mathrm{id}-\lambda^{-1} T\right)$ is invertible since $\left\|\lambda^{-1} T\right\|<1$ (Neumann series, Theorem 2.10), hence $\lambda \in \rho(T)$ It follows that $\{\lambda \in \mathbb{C}:|\lambda|>\|T\|\} \supseteq \rho(T)$. Since $\sigma$ is closed and bounded, it is compact.
Next we prove the so-called resolvent identities.
Theorem 5.9. Let $X$ be a Banach space and $T(X \rightarrow X), S(X \rightarrow X)$ a linear operators with $\mathcal{D}(S)=\mathcal{D}(T)$.
(i) 1st resolvent identity:

$$
R(\lambda, T)-R(\mu, T)=(\mu-\lambda) R(\lambda, T) R(\mu, T), \quad \lambda, \mu \in \rho(T)
$$

In particular, the resolvents commute.
(ii) 2nd resolvent identity:

$$
R(\lambda, T)-R(\lambda, S)=R(\lambda, T)(T-S) R(\lambda, S), \quad \lambda \in \rho(T) \cap \rho(S) .
$$

Proof. (i) follows from a straightforward calculation:

$$
\begin{aligned}
R(\lambda, T)-R(\mu, T) & =(\lambda-T)^{-1}-(\mu-T)^{-1} \\
& =(\lambda-T)^{-1}[\mu-T-(\lambda-T)](\mu-T)^{-1} \\
& =(\mu-\lambda) R(\lambda, T) R(\mu, T) .
\end{aligned}
$$

(ii) is shown similarly:

$$
\begin{aligned}
R(\lambda, T)-R(\lambda, S) & =(\lambda-T)^{-1}-(\lambda-S)^{-1} \\
& =(\lambda-T)^{-1}[\lambda-S-(\lambda-T)](\lambda-S)^{-1} \\
& =R(\lambda, T)(T-S) R(\lambda, S),
\end{aligned}
$$

Next we study properties of the resolvent map $\rho(T) \rightarrow L(X), \lambda \mapsto R(\lambda, T)$. By Lemma 5.7 we already now that its domain is open and that it is analytic, that is, locally it has a power series representation.
Definition 5.10. Let $\Omega \in \mathbb{C}$ be an open set, $X$ a Banach space and $f: \Omega \rightarrow X$.
(i) $f$ is called holomorphic in $z_{0} \in \Omega$ if and only if the limit

$$
\lim _{z \rightarrow z_{0}} \frac{f(z)-f\left(z_{0}\right)}{z-z_{0}}
$$

exists in the norm topology. $f$ is called holomorphic if and only if it is holomorphic in every $z_{0} \in \Omega$.
(ii) $f$ is called weakly holomorphic in $z_{0} \in \Omega$ if and only if the limit

$$
\lim _{z \rightarrow z_{0}} \frac{f(z)-f\left(z_{0}\right)}{z-z_{0}}
$$

exists in the weak topology. $f$ is called weakly holomorphic if and only if it is weakly holomorphic in every $z_{0} \in \Omega$. Hence, for every $\varphi \in X^{\prime}$ the map $\Omega \rightarrow \mathbb{C}, z \mapsto \varphi(f(z))$ is holomorphic in the usual sense.
Lemma 5.11. Let $X$ be a Banach space. A sequence $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq X$ is a Cauchy sequence if and only if the sequence $\left(\varphi\left(x_{n}\right)\right)_{n \in \mathbb{N}} \subseteq X$ is uniformly Cauchy for $\varphi \in X$ with $\|\varphi\| \leq 1$ (that is, for every $\varepsilon>0$ exists a $N \in \mathbb{N}$ such that $\left|\varphi\left(x_{n}\right)-\varphi\left(x_{m}\right)\right|<\varepsilon$ for all $m, n \geq N$ and all $\varphi \in X^{\prime}$ with $\|\varphi\| \leq 1$ ).
Proof. Assume that $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq X$ is a Cauchy sequence and let $\varepsilon>0$. Then there exists a $N \in \mathbb{N}$ such that $\left\|x_{n}-x_{m}\right\|<\varepsilon$ for $m, n \geq N$. It follows that $\left\|\varphi\left(x_{n}\right)-\varphi\left(x_{m}\right)\right\| \leq\|\varphi\|\left\|x_{n}-x_{m}\right\|<\varepsilon$ for all $m, n \geq N$ and all $\varphi \in X^{\prime}$ with $\|\varphi\| \leq 1$.
Now let $\varepsilon>0$ and assume that there exists an $N \in \mathbb{N}$ such that $\left|\varphi\left(x_{n}\right)-\varphi\left(x_{m}\right)\right|<\varepsilon$ Now let $\varepsilon>0$ and assume that there exists an $N \in \mathbb{N}$ such that $\left|\varphi\left(x_{n}\right)-\varphi\left(x_{m}\right)\right|<\varepsilon$
for all $m, n \geq N$ and all $\varphi \in X^{\prime}$ with $\|\varphi\| \leq 1$. Recall that the map $J_{X}: X \rightarrow X^{\prime \prime}$ is an isometry. It follows for $m, n \geq N$

$$
\begin{aligned}
\left\|x_{n}-x_{m}\right\| & =\left\|J_{X} x_{n}-J_{X} x_{m}\right\|=\sup \left\{\left|\left(J_{X} x_{n}-J_{X} x_{m}\right) \varphi\right|: \varphi \in X^{\prime},\|\varphi\| \leq 1\right\} \\
& =\sup \left\{\left|\varphi\left(x_{n}\right)-\varphi\left(x_{m}\right)\right|: \varphi \in X^{\prime},\|\varphi\| \leq 1\right\}<\varepsilon
\end{aligned}
$$

Recall the following fundamental theorem of complex analysis.
Theorem 5.12 (Cauchy's integral formula). Let $\Omega \in \mathbb{C}$ open and let $f: \Omega \rightarrow \mathbb{C}$ holomorphic. Let $z_{0} \in \Omega$ and $r>0$ such that $K_{r}\left(z_{0}\right):=\left\{z \in \mathbb{C}:\left|z-z_{0}\right| \leq r\right\} \subseteq \Omega$. Then

$$
\begin{equation*}
f(a)=\frac{1}{2 \pi \mathrm{i}} \int_{\Gamma_{r}\left(z_{0}\right)} \frac{f(z)}{z-a} \mathrm{~d} z, \quad a \in B_{r}\left(z_{0}\right) \tag{5.1}
\end{equation*}
$$

where $\Gamma_{r}\left(z_{0}\right)$ is the positively oriented boundary of $K_{r}\left(z_{0}\right)$. More generally, for $n \in \mathbb{N}_{0}$,

$$
\begin{equation*}
f^{(n)}(a)=\frac{n!}{2 \pi \mathrm{i}} \int_{\Gamma_{r}\left(z_{0}\right)} \frac{f(z)}{(z-a)^{n+1}} \mathrm{~d} z, \quad a \in B_{r}\left(z_{0}\right) \tag{5.2}
\end{equation*}
$$

Theorem 5.13 (Dunford). Let $X$ be a Banach space and let $\Omega \in \mathbb{C}$ open. A map $f: \Omega \rightarrow X$ is holomorphic if and only if it is weakly holomorphic.

Proof. Clearly, holomorphy of $f$ implies weak holomorphy. Now assume that $f$ is weakly holomorphic. Let $z_{0} \in \Omega$. Choose $r>0$ such that $K_{r}\left(z_{0}\right)=\{z \in \mathbb{C}$ $\left.\left|z-z_{0}\right| \leq r\right\} \in \Omega$. and let $\Gamma_{r}\left(z_{0}\right)$ be the positively oriented boundary of $K_{r}\left(z_{0}\right)$. For every $\varphi \in X^{\prime}$ Cauchy's integral formula (5.1) yields

$$
\varphi(f(a))=\frac{1}{2 \pi \mathrm{i}} \int_{\Gamma_{r}\left(z_{0}\right)} \frac{\varphi(f(z))}{z-a} \mathrm{~d} z, \quad a \in B_{r}\left(z_{0}\right) .
$$

For $a \in B_{r}\left(z_{0}\right)$ and $0<|h|<r-\left|z_{0}-a\right|$ it follows that $a+h \in K_{r}\left(z_{0}\right)$, hence with Cauchy's integral formula we obtain

$$
\begin{aligned}
& \frac{1}{h}(\varphi(f(a+h))-\varphi(f(a)))-(\varphi \circ f)^{\prime}(a) \\
&=\frac{1}{2 \pi \mathrm{i}} \int_{\Gamma_{r}\left(z_{0}\right)} \frac{1}{h}\left[\frac{1}{z-a-h}-\frac{1}{z-a}-\frac{h}{(z-a)^{2}}\right] \varphi(f(z)) \mathrm{d} z \\
&=\frac{1}{2 \pi \mathrm{i}} \int_{\Gamma_{r}\left(z_{0}\right)}\left[\frac{1}{(z-a)(z-a-h)}-\frac{1}{(z-a)^{2}}\right] \varphi(f(z)) \mathrm{d} z \\
&=\frac{h}{2 \pi \mathrm{i}} \int_{\Gamma_{r}\left(z_{0}\right)} \frac{\varphi(f(z))}{(z-a)^{2}(z-a-h)} \mathrm{d} z .
\end{aligned}
$$

Since $z \mapsto \varphi(f(z))$ is holomorphic in a neighbourhood of $\Gamma_{r}\left(z_{0}\right)$, it is in particular continuous. Hence there exists $C_{\varphi}$ such that

$$
|\varphi(f(z))|<C_{\varphi}, \quad z \in \Gamma_{r}\left(z_{0}\right) .
$$

By a corollary to the theorem of Banach-Steinhaus (Corollary 3.8), there exists $C>0$ such that

$$
\|f(z)\|<C, \quad z \in \Gamma_{r}\left(z_{0}\right)
$$

Hence we obtain

$$
\left|\frac{1}{h}(\varphi(f(a+h))-\varphi(f(a)))-\frac{\mathrm{d}}{\mathrm{~d} z}(\varphi \circ f)(a)\right| \leq h\|\varphi\| C^{\prime}
$$

This implies that

$$
\lim _{h \rightarrow 0} \varphi\left(\frac{1}{h}(f(a+h)-f(a))\right)=\lim _{h \rightarrow 0} \frac{1}{h}(\varphi(f(a+h))-\varphi(f(a)))=(\varphi \circ f)^{\prime}(a),
$$

uniformly for $\varphi \in X^{\prime},\|\varphi\| \leq 1$. Therefore, by Lemma 5.11, $\lim _{h \rightarrow 0} \frac{1}{h}(f(a+h)-f(a))$ exists.

Theorem 5.14 (Dunford). Let $X$ be a Banach space, $\Omega \subseteq \mathbb{C}$ open and $T: \Omega \rightarrow$ $L(X)$. Then the following is equivalent:
(i) $T$ is holomorphic in the operator norm.
(ii) $T$ is strongly holomorphic.
(iii) $T$ is weakly holomorphic.

Proof. (i) $\Longrightarrow$ (ii) follows from the definition. (ii) $\Longleftrightarrow$ (iii) follows form Theorem 5.13. It remains to prove (iii) $\Longrightarrow$ (i). As in the proof of Theorem 5.13 we obtain for $x \in X$ and $\varphi \in X^{\prime}$
$\frac{1}{h}(\varphi(T(a+h) x-T(a) x))-\left.\frac{\mathrm{d}}{\mathrm{d} z}\right|_{z=a}(\varphi T(z) x)=\frac{h}{2 \pi \mathrm{i}} \int_{\Gamma_{r}\left(z_{0}\right)} \frac{\varphi(T(z) x)}{(z-a)^{2}(z-a-h)} \mathrm{d} z$.

Since $z \mapsto \varphi(T(z) x)$ is holomorphic in a neighbourhood of $\Gamma_{r}\left(z_{0}\right)$, it is continuous, so there exists $C_{x, \varphi}$ such that

$$
|\varphi(T(z) x)|<C_{x, \varphi}, \quad z \in \Gamma_{r}\left(z_{0}\right) .
$$

By a corollary to the theorem of Banach-Steinhaus (Corollary 3.8), there exists $C_{x}>0$ such that

$$
\|T(z) x\|<C_{x}, \quad z \in \Gamma_{r}\left(z_{0}\right)
$$

and by the theorem of Banach-Steinhaus (Theorem 3.7), there exists $C>0$ such that

$$
\|T(z)\|<C, \quad z \in \Gamma_{r}\left(z_{0}\right) .
$$

This implies that

$$
\lim _{h \rightarrow 0} \frac{1}{h}(\varphi(T(a+h) x-T(a) x))=\varphi\left(\lim _{h \rightarrow 0} \frac{1}{h}(T(a+h) x-T(a) x)\right)
$$

exists, uniformly for $\varphi \in X^{\prime},\|\varphi\| \leq 1$. Therefore, by Lemma 5.11,

$$
\lim _{h \rightarrow 0} \frac{1}{h}(T(a+h) x-T(a) x)
$$

exists and convergence is uniform for $x \in X$ with $\|x\|=1$. Analogously as in the proof of Lemma 5.11 it follows the existence of

$$
\lim _{h \rightarrow 0} \frac{1}{h}(T(a+h)-T(a))
$$

$$
\square
$$

Theorem 5.15. Let $X$ be a Banach space, $T(X \rightarrow X)$ a densely defined closed linear operator. Then the resolvent map

$$
\rho(T) \rightarrow L(X), \quad \lambda \mapsto R(\lambda, T)=(\lambda-T)^{-1}
$$

## is holomorphic.

Proof. Let $\lambda_{0} \in \rho(T)$ and $\lambda \in \mathbb{C}$ with $\left|\lambda-\lambda_{0}\right|<\left\|R\left(\lambda_{0}, T\right)\right\|$. For fixed $x \in X$ and $\varphi \in X^{\prime}$ we have by Lemma 5.7

$$
\begin{aligned}
\varphi(R(\lambda, T) x) & =\varphi\left(\left(\sum_{n=0}^{\infty}\left(\lambda-\lambda_{0}\right)^{n}\left(R\left(\lambda_{0}, T\right)\right)^{n+1}\right) x\right) \\
& =\sum_{n=0}^{\infty}\left(\lambda-\lambda_{0}\right)^{n} \varphi\left(\left(R\left(\lambda_{0}, T\right)\right)^{n+1} x\right)
\end{aligned}
$$

where we used that the operator series converges and $\varphi$ is continuous. Since the last sum is absolutely convergent, it follows that $\lambda \rightarrow \varphi(R(\lambda, T) x)$ is analytic locally at $\lambda_{0}$, hence holomorphic. Since weak holomorphy is equivalent to holomorphy in the operator norm (Theorem 5.14), the theorem is proved.
The preceding theorem allows us to apply theorems of complex analysis to the resolvent map.
Theorem 5.16. Let $X$ be a Banach space and $T \in L(X)$. Then $\sigma(T) \neq \emptyset$.

Proof. Assume $\sigma(T)=\emptyset$. Observe that this implies $X \neq\{0\}$ and $T^{-1} \in L(X)$. Let $\lambda \in \mathbb{C}$ with $|\lambda|>\|T\|$. Then $\lambda \in \rho(T)$ and using the Neumann series

$$
\|R(\lambda, T)\|=\left\|\sum_{n=0}^{\infty} \lambda^{n} T^{-(n+1)}\right\| \leq \sum_{n=0}^{\infty}\left|\lambda^{n}\right|\|T\|^{-(n+1)}=\frac{1}{\|T\|-|\lambda|}
$$

In particular, $\|R(\lambda, T)\| \rightarrow 0$ for $|\lambda| \rightarrow \infty$. Hence for every $x \in X$ and $\varphi \in X^{\prime}$ the map $\lambda \rightarrow \varphi(R(\lambda, T) x)$ is holomorphic and bounded in $\mathbb{C}$, so constant by the Liouville theorem. Since $\varphi(R(\lambda, T) x) \rightarrow 0$ for $|\lambda| \rightarrow \infty$, it follows that $\varphi(R(\lambda, T) x)=0$ for all $\lambda \in \mathbb{C}, x \in X$ and $\varphi \in X^{\prime}$. By a corollary to the Hahn-Banach theorem (Corollary 2.16) it follows that $R(\lambda, T) x=0$ for all $x \in X$ and $\lambda \in \mathbb{C}$, hence $R(\lambda, T)=0, \lambda \in \mathbb{C}$. This contradicts the fact that $1=\left\|T T^{-1}\right\| \leq\|T\|\left\|T^{-1}\right\|=$
0.
$\square$ 0.

The following example shows that for unbounded linear operators the cases $\sigma(T)=\emptyset$ and $\sigma(T)=\mathbb{C}$ are possible.

Examples 5.17. (i) Let $X=C([0,1])$ and

$$
T: X \supseteq C^{1}([0,1]) \rightarrow X, \quad T x=x^{\prime}
$$

Then $T$ is unbounded and closed and $\sigma(T)=\sigma_{\mathrm{p}}(T)=\mathbb{C}$.
(ii) Let $X=\{x \in C([0,1]): x(0)=0\}, \mathcal{D}(T)=\left\{x \in X \cap C^{1}([0,1]): x^{\prime} \in X\right\}$ and

$$
T: X \supseteq \mathcal{D}(T) \rightarrow X, \quad T x=x^{\prime}
$$

Then $T$ is unbounded and closed and $\sigma(T)=\emptyset$.
Proof. (i) Obviously, $T$ is unbounded and densely defined. If $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq \mathcal{D}(T)$ such that $x_{n} \rightarrow x$ and $T x_{n} \rightarrow y \in X$, then, by a theorem of Analysis $1, x$ is differentiable hence in $\mathcal{D}(T)$ and $T x=x^{\prime}=y$ which implies that $T$ is closed.
For every $\lambda \in \mathbb{C}$ the differential equation $x^{\prime}-\lambda x=0$ has the solution $x_{\lambda}(t)=\mathrm{e}^{\lambda t}$ Note that $x_{\lambda} \in \mathcal{D}(T)$ and $(T-\lambda) x_{\lambda}=0$, so $\lambda \in \sigma_{\mathrm{p}}(T)$.
(ii) Obviously, $T$ is unbounded and densely defined. If $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq \mathcal{D}(T)$ such that $x_{n} \rightarrow x$ and $T x_{n} \rightarrow y \in X$, then, by a theorem of Analysis $1, x$ is differentiable and $x^{\prime}=y$. Moreover, $x(0)=\lim _{n \rightarrow \infty} x_{n}(0)=0$, so in $\mathcal{D}(T)$ and $T x=x^{\prime}=y$ which implies that $T$ is closed.
For every $\lambda \in \mathbb{C}$ and every $y \in X$ the initial value problem $x^{\prime}-\lambda x=y, x(0)$ has exactly one solution $x_{\lambda}$ given by

$$
x_{\lambda}(t)=\mathrm{e}^{\lambda t} \int_{0}^{t} \mathrm{e}^{-\lambda s} y(s) \mathrm{d} s
$$

Obviously $x_{\lambda} \in C^{1}[0,1], x_{\lambda}(0)=0$ and $x_{\lambda}^{\prime}(0)=\lambda x_{\lambda}(0)+y(0)=0$. Hence $T-\lambda$ is
bijective, in particular $\lambda \in \rho(T)$. Note that in the last example the continuity of $(T-\lambda)$ can be seen immediately:

$$
\begin{aligned}
\left\|(T-\lambda)^{-1} y\right\|_{\infty} & =\left\|x_{\lambda}\right\|_{\infty}=\sup \left\{\left|\mathrm{e}^{\lambda t} \int_{0}^{t} \mathrm{e}^{-\lambda s} y(s) \mathrm{d} s\right|: t \in[0,1]\right\} \\
& \leq\|y\|_{\infty} \max \left\{1, \mathrm{e}^{\lambda}\right\} \int_{0}^{1} \mathrm{e}^{-\lambda s} \mathrm{~d} s .
\end{aligned}
$$

Definition 5.18. Let $X$ be a Banach space The spectral radius of $T \in L(X)$ is

$$
r(T):=\lim \sup \left\|T^{n}\right\|^{\frac{1}{n}}
$$

Theorem 5.19. Let $X$ be a Banach space, $T \in L(X)$ and $r(T)$ its spectral radius. (i) $r(T) \leq\left\|T^{m}\right\|^{1 / m} \leq\|T\|$ for all $m \in \mathbb{N}$, in particular $r(T)=\lim _{m \rightarrow \infty}\left\|T^{m}\right\|^{1 / m}$.
(ii) $\sigma(T) \subseteq\{\lambda \in \mathbb{C}:|\lambda| \leq r(T)\}$.
(iii) If $X$ is a complex Banach space, then there exists a $\lambda \in \sigma(T)$ such that $|\lambda|=r(T)$, in particular

$$
r(T)=\max \{|\lambda|: \lambda \in \sigma(T)\} .
$$

(iv) If $X$ is Hilbert space and $T$ is normal, then $r(T)=\|T\|$
(v) If $X$ is a complex Hilbert space and $T$ is normal with $r(T)=0$, then $T=0$.

Proof. (i) Let $m \in \mathbb{N}$ arbitrary. For every $n \in \mathbb{N}$ there exist $p_{n}, q_{n} \in \mathbb{N}_{0}$ with $q_{n}<m$ and $n=p_{n} m+q_{n}$. Let $M:=\max \left\{1,\|T\|, \ldots,\left\|T^{m-1}\right\|\right\}$. Then

$$
\left\|T^{n}\right\|=\left\|T^{p_{n} m+q_{n}}\right\| \leq\left\|T^{p_{n} m}\right\|\left\|T^{q_{n}}\right\| \leq M\left\|T^{m}\right\|^{p_{n}} .
$$

This implies $r(T)=\underset{n \rightarrow \infty}{\limsup }\left\|T^{n}\right\|^{\frac{1}{n}} \leq \underset{n \rightarrow \infty}{\lim \sup } M^{\frac{1}{2}}\left\|T^{m}\right\|^{\frac{1}{m}-\frac{q_{m}}{n m}}=\left\|T^{m}\right\|^{\frac{1}{m}}$.
(ii) By the formula of Hadamard, the radius of convergence of $\sum_{n=0}^{n \rightarrow \infty} z^{n+1}\left\|T^{n}\right\|$ is $\left(\limsup _{n \rightarrow \infty}\left\|T^{n}\right\|^{\frac{1}{n}}\right)^{-1}=r(T)^{-1}$. Hence for all $\lambda \in \mathbb{C},|\lambda|>r(T)$, the series $\sum_{n=0}^{\infty}{ }^{n \rightarrow \infty} \lambda^{-(n+1)} T^{n}=: A$ converges in norm. By Theorem 2.10 (Neumann series), $A$ is the inverse of $\lambda-T$. Because $T$ is closed, it follows that $\{\lambda \in \mathbb{C}:|\lambda|>r(T)\} \subseteq \rho(T)$, or equivalently $\{\lambda \in \mathbb{C}:|\lambda| \leq r(T)\} \subseteq \sigma(T)$.
(iii) Let $r_{0}:=\max \{|\lambda|: \lambda \in \sigma(T)\}$. It follows from (ii) that $r_{0} \leq r(T)$. Now choose any $\mu \in \mathbb{C}$ with $|\mu|>r_{0}$. We have to show that $|\mu|>r(T)$. Observe that by definition of $R(T)$ and by the formula of Hadamard

$$
\begin{equation*}
(\lambda-T)^{-1}=\sum_{n=0}^{\infty} \lambda^{-(n+1)} T^{n}, \quad|\lambda|>r(T), \tag{5.3}
\end{equation*}
$$

where the series on the right hand side converges in norm. In particular, for every $\varphi \in L(X)^{\prime}$

$$
\varphi(\lambda-T)^{-1}=\sum_{n=0}^{\infty} \lambda^{-(n+1)} \varphi\left(T^{n}\right), \quad|\lambda|>r(T) .
$$

Hence $\lambda \mapsto \varphi(T-\lambda)^{-1}$ defines an analytic function for $|\lambda|>r(T)$. It follows from complex analysis that then the equality in (5.3) holds for all $\lambda$ in the largest ${ }^{\text {open }} \infty$ $\sum_{n=0}^{\infty} \mu^{-(n+1)} \varphi\left(T^{n}\right)$ converges for every $\varphi \in L(X)^{\prime}$, hence it is weakly convergent, weakly convergent to 0 , hence it is bounded (Corollary 3.9). Let $M \in \mathbb{R}$ such that $\left\|\mu^{-(n+1)}\right\| T^{n} \|<M, n \in \mathbb{N}$. Then $\left\|\left\|T^{n}\right\|^{\frac{1}{n}}<M^{\frac{1}{n}} \mu^{1+\frac{1}{n}}\right.$ for all $n \in \mathbb{N}$, in particular $r(T)=\lim _{n \rightarrow \infty}\| \| T^{n} \|^{\frac{1}{n}} \leq \mu$.
(iv) Recall that $\left\|T T^{*}\right\|=\|T\|^{2}$ for a normal operator $T$ (Theorem 4.39). Hence

$$
\left\|T^{2}\right\|^{2}=\left\|T^{2}\left(T^{*}\right)^{2}\right\|=\left\|\left(T T^{*}\right)^{2}\right\|=\left\|\left(T T^{*}\right)\right\|^{2}=\|T\|^{4}
$$

hence $\left\|T^{2}\right\|=\|T\|^{2}$. By induction, it can be shown that hence $\left\|T^{2^{n}}\right\|=\|T\|^{2^{n}}$ for all $n \in \mathbb{N}$, implying that

$$
r(T)=\lim _{n \rightarrow \infty}\left\|T^{n}\right\|^{\frac{1}{n}}=\lim _{n \rightarrow \infty}\left\|T^{2^{n}}\right\|^{\frac{1}{2^{n}}}=\lim _{n \rightarrow \infty}\|T\|=\|T\| .
$$

(v) follows directly from (iv).

Note that in general $r(T)<\|T\|$, for example $r(T)=0$ for every nilpotent linear operator.

### 5.3 The spectrum of the adjoint operator

Lemma 5.20. (i) Let $X$ be a Banach space and $T(X \rightarrow X)$ a densely defined closed linear operator. Then $\sigma\left(T^{\prime}\right)=\sigma(T)$ and $R(\lambda, T)^{\prime}=R\left(\lambda, T^{\prime}\right)$ for $\lambda \in$ $\rho(T)$.
(ii) Let $H$ be a Hilbert space and $T(H \rightarrow H)$ a densely defined closed linear operator. Then $\sigma\left(T^{*}\right)=\overline{\sigma(T)}=\{\lambda \in \mathbb{C}: \bar{\lambda} \in \sigma(T)\}$ and $R(\lambda, T)^{*}=$ operator. Then $\sigma\left(\left(^{*}\right)\right.$.
$R\left(\lambda^{*}, T^{*}\right)$ for $\lambda \in \rho(T)$.

Proof. The assertions follow from Theorem 4.65.
Lemma 5.21. Let $X$ be a Banach space and $T(X \rightarrow X)$ densely defined and closed.
(i) $\lambda \in \sigma_{p}(T) \Longrightarrow \lambda \in \sigma_{p}\left(T^{\prime}\right) \cup \sigma_{r}\left(T^{\prime}\right)$
(ii) $\lambda \in \sigma_{r}(T) \Longrightarrow \lambda \in \sigma_{p}\left(T^{\prime}\right)$.

Proof. (i) If $\lambda \in \sigma_{\mathrm{p}}(T)$, then $\operatorname{ker}(\lambda-T) \supsetneq\{0\}, \overline{\operatorname{rg}\left(\lambda-T^{\prime}\right)} \subseteq \operatorname{ker}(T)^{\circ} \neq X$. It follows that $\lambda \in \sigma_{\mathrm{p}}\left(T^{\prime}\right)$ or $\lambda \in \sigma_{\mathrm{r}}\left(T^{\prime}\right)$
(i) If $\lambda \in \sigma_{\mathrm{r}}(T)$, then $\overline{\operatorname{rg}(\lambda-T)} \neq X$. By Theorem $4.64 \overline{\operatorname{rg}(\lambda-T)}=X$ if and only if $(\lambda-T)^{\prime}=\lambda-T^{\prime}$ is not injective, hence $\lambda \in \sigma_{\mathrm{p}}\left(T^{\prime}\right)$.
Theorem 5.22. Let $H$ be a complex Hilbert space, $T(H \rightarrow H)$ a symmetric operator and $\lambda \in \mathbb{C} \backslash \mathbb{R}$.
(i) $\|(\lambda-T) x\| \geq|\operatorname{Im}(\lambda)|\|x\|$ for all $x \in \mathcal{D}(T)$.

In particular $T-\lambda: \mathcal{D}(T) \rightarrow \operatorname{rg}(T-\lambda)$ is invertible with continuous inverse and the point spectrum of $T$ is real.
(ii) If $T$ is closed, then $\operatorname{rg}(\lambda-T)$ is closed.

Proof. (i) For all $x \in \mathcal{D}(T)$
$\|(\lambda-T) x\|\|x\| \geq|\langle(\lambda-T) x, x\rangle|=|\langle(\operatorname{Re} \lambda-T) x, x\rangle+\mathrm{i}\langle\operatorname{Im} \lambda x, x\rangle|$ $\geq|\operatorname{Im} \lambda|| | x \mid$.
In particular, $\lambda-T$ is injective, which implies that $\lambda \notin \sigma_{\mathrm{p}}(T)$.
(i) If $(\lambda-T)$ is continuous and closed, to its domain $\operatorname{rg}(\lambda-T)$ is closed.

Theorem 5.23. Let $H$ be a complex Hilbert space and $T(H \rightarrow H)$ a symmetric operator. Then the following is equivalent.
(i) $T$ is selfadjoint.
(ii) $\operatorname{rg}(\lambda-T)=H$ for all $z \in \mathbb{C} \backslash \mathbb{R}$.
(iii) $\operatorname{rg}( \pm \mathrm{i}-T)=H$.
(iv) There exist $z_{ \pm} \in \mathbb{C}$ with $\operatorname{Im} z_{+}>0$ and $\operatorname{Im} z_{-}<0$ such that $\operatorname{rg}\left(z_{ \pm}-T\right)=H$.
(v) $\sigma(T) \subseteq \mathbb{R}$.
(vi) $T$ is closed and $\operatorname{ker}\left( \pm \mathrm{i}-T^{*}\right)=H$.

Proof. (i) $\Longrightarrow$ (ii) Let $\lambda \in \mathbb{C} \backslash \mathbb{R}$. Then $\operatorname{rg}(\lambda-T) \neq H$ is closed by Theorem 5.22 and $\lambda^{*} \notin \sigma_{\mathrm{p}}(T)$. It follows by Theorem 4.73 that

$$
\operatorname{rg}(\lambda-T)=\operatorname{rg}(\lambda-T)^{\perp \perp}=\operatorname{ker}\left(\lambda^{*}-T^{*}\right)^{\perp}=\operatorname{ker}\left(\lambda^{*}-T\right)^{\perp}=\{0\}^{\perp}=H
$$

(ii) $\Longrightarrow$ (i) By assumption, $T$ is symmetric, hence $T \subseteq T^{*}$, so it suffices to show that $\mathcal{D}\left(T^{*}\right) \subseteq \mathcal{D}(T)$. Let $\lambda \in \mathbb{C} \backslash \mathbb{R}$. Then $\lambda-T$ and $\bar{\lambda}-T$ are bijective. For $x \in \mathcal{D}\left(T^{*}\right)$ there exists a $y \in \mathcal{D}(T)$ such that $\left(\lambda-T^{*}\right) x=(\lambda-T) y$. Since $T \subseteq T^{*}$, it follows that $T y=T^{*}$, hence $x-y \in \operatorname{ker}\left(\lambda-T^{*}\right)=\{0\}$ which implies $x=y \in \mathcal{D}(T)$. (ii) $\Longrightarrow$ (iii) $\Longrightarrow$ (iv) is obvious.
(iv) $\Longrightarrow$ (v) Let $z_{ \pm} \in \mathbb{C}$ with $\operatorname{Im} z_{+}>0$ and $\operatorname{Im} z_{-}<0$ such that $\operatorname{rg}\left(z_{ \pm}-T\right)=H$. By Theorem 5.22 , it follows that $z_{ \pm}-T$ is injective and its inverse is bounded by $\left|\Im z_{ \pm}\right|$. Hence, by Lemma 5.7 , every $\lambda \in \mathbb{C}$ with $\left|\lambda-z_{ \pm}\right|<\left|\Im z_{ \pm}\right|$belongs to $\rho(T)$. Given any $\lambda \in \mathbb{C} \backslash \mathbb{R}$, repeating the argument above finitely many times shows that $\lambda \in \rho(T)$.
(v) $\Longrightarrow$ (ii) is obvious
(vi) $\Longrightarrow$ (iii) Since $T$ is closed, the range of $\pm \mathrm{i}-T$ is closed by Theorem 5.22. Therefore $\operatorname{rg}( \pm \mathrm{i}-T)=\operatorname{rg}( \pm \mathrm{i}-T)^{\perp \perp}=\operatorname{ker}\left(\mp \mathrm{i}-T^{*}\right)^{\perp}=\{0\}^{\perp}=H$.
(i) $\Longrightarrow($ vi $) \quad$ Since $T=T^{*}$, it is closed and $\mathbb{C} \backslash \mathbb{R} \subseteq \rho(T)$, in particular $\operatorname{ker}( \pm \mathrm{i}-T)=$
$\{0\}$. $\{0\}$.
Analogously, we find a characterisation of essentially selfadjoint operators.
Theorem 5.24. Let $H$ be a complex Hilbert space and $T(H \rightarrow H)$ a symmetric operator. Then the following is equivalent.
(i) $T$ is essentially selfadjoint.
(ii) $\overline{\operatorname{rg}(\lambda-T)}=H$ for all $z \in \mathbb{C} \backslash \mathbb{R}$.
(iii) $\overline{\operatorname{rg}( \pm \mathrm{i}-T)}=H$.
(iv) There exist $z_{ \pm} \in \mathbb{C}$ with $\operatorname{Im} z_{+}>0$ and $\operatorname{Im} z_{-}<0$ such that $\overline{\operatorname{rg}\left(z_{ \pm}-T\right)}=H$.
(v) $\sigma(\bar{T}) \subseteq \mathbb{R}$
(vi) $\operatorname{ker}\left( \pm \mathrm{i}-T^{*}\right)=H$.

Definition 5.25. Let $X$ be a Banach space and $T(X \rightarrow X)$ densely defined and closed. $\lambda \in \mathbb{C}$ is called approximate eigenvalue if there exists a sequence $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq$ $X$ such that $\left\|x_{n}\right\|=1$ for all $n \in \mathbb{N}$ and $\lim _{n \rightarrow \infty}(T-\lambda) x_{n}=0$. The set of all approximate eigenvalues is denoted by $\sigma_{\mathrm{ap}}(T)$.

Proposition 5.26. (i) Every approximate eigenvalue belongs to $\sigma(T)$.
(ii) Every boundary point of $\sigma(T) \subseteq \mathbb{C}$ is an approximate eigenvalue of $T$.
(iii) If $X$ is a Hilbert space and if $T$ is selfadjoint, then every $\lambda \in \sigma(T)$ is an approximate eigenvalue of $T$.

Proof. (i) Let $\lambda$ be an approximate eigenvalue of $T$. Choose a sequence $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq$ $\mathcal{D}(T)$ such that $\left\|x_{n}\right\|=1$ for all $n \in \mathbb{N}$ and $(\lambda-T) x_{n} \rightarrow 0$. Assume that $\lambda \in \rho(T)$. Then $R(\lambda, T)=(\lambda-T)^{-1}$ is bounded, therefore

$$
\lim _{n \rightarrow \infty} x_{n}=\lim _{n \rightarrow \infty} R(\lambda-T)(\lambda-T) x_{n}=R(\lambda-T) \lim _{n \rightarrow \infty}(\lambda-T) x_{n}=0
$$

in contradiction to $\left\|x_{n}\right\|=1$ for all $n \in \mathbb{N}$.

\left\|(\lambda-T) y_{n}\right\| & \leq\left\|\left(\lambda-\lambda_{n}\right) y_{n}\right\|+\left\|\left(\lambda_{n}-T\right) y_{n}\right\| \\
& =\left|\lambda-\lambda_{n}\right|+\left\|R\left(\lambda_{n}-T\right) x_{n}\right\|^{-1} \\
& \leq\left|\lambda-\lambda_{n}\right|+2\left\|R\left(\lambda_{n}-T\right)\right\|^{-1} \longrightarrow 0, \quad n \rightarrow \infty .
\end{aligned}
$$

Hence $\lambda \in \sigma_{\text {ap }}(T)$.
(iii) By Theorem 5.23 the spectrum of a selfadjoint operator is real, so $\sigma(T)=$
$\partial \sigma(T) \subseteq \sigma_{\text {ap }}(T) \subseteq \sigma(T)$.

Lemma 5.27. Let $H$ be Hilbert space and $T \in L(H)$ selfadjoint. Then $\sigma(T) \subseteq$ $[m, M]$ where $m:=\inf \{\langle T x, x\rangle:\|x\|=1\}$ and $M:=\sup \{\langle T x, x\rangle:\|x\|=1\}$ Moreover, $m, M \in \sigma(T)$.

Proof. Let $\lambda \in \mathbb{R}, \lambda<m$. Then $\lambda-T$ is injective because for all $x \in X$

$$
\begin{equation*}
\|(\lambda-T) x\|\|x\| \geq\langle(\lambda-T) x, x\rangle \geq(\lambda-m)\|x\|^{2} \tag{5.4}
\end{equation*}
$$

In particular, $\operatorname{rg}(\lambda-T)=\mathcal{D}\left((\lambda-T)^{-1}\right)$ is closed because $(\lambda-T)^{-1}: \operatorname{rg}(\lambda-T) \rightarrow H$ is closed and continuous by (5.4). Hence $\operatorname{rg}(\lambda-T)=\overline{\operatorname{rg}(\lambda-T)}=\operatorname{ker}(\lambda-T)^{\perp}=H$. It follows that $(-\infty, m) \in \rho(T)$. Analogously $(M, \infty) \in \rho(T)$ is shown.
Now we show that $m \in \sigma(T)$. By Proposition 5.26 it suffices to show that $m \in$ $\sigma_{\text {ap }}(T)$. By definition of $m$ there exists a sequence $\left(x_{n}\right)_{n \in \mathbb{N}}$ such that $\left\|x_{n}\right\|=1$ for all $n \in \mathbb{N}$ and $\left.\left\langle T x_{n}, x_{n}\right\rangle\right\rangle m$. Since $s(x, y):=\langle(T-m) x, y\rangle$ defines a positive semidefinite sesquilinear form, Cauchy-Schwarz inequality implies

$$
\begin{aligned}
\left\|(T-m) x_{n}\right\|^{2} & =\left|s\left(x_{n},(T-m) x_{n}\right)\right| \leq s\left(x_{n}, x_{n}\right)^{\frac{1}{2}} s\left((T-m) x_{n}\right)^{\frac{1}{2}} \\
& =\left\langle(T-m) x_{n}, x_{n}\right\rangle^{\frac{1}{2}}\left\langle(T-m)^{2} x_{n},(T-m) x_{n}\right\rangle^{\frac{1}{2}} .
\end{aligned}
$$

Since the first term in the product tends to 0 for $n \rightarrow \infty$ and the second term is bounded by $(\|T\|-m)^{\frac{3}{2}}<\infty$, it follows that $\left\|(T-m) x_{n}\right\|$ tends to 0 for $n \rightarrow \infty$. This shows that $m \in \sigma_{\text {ap }}(T)$. The proof of $M \in \sigma(T)$ is analogous. $\qquad$

### 5.4 Compact operators

Recall that a metric space $M$ is compact if and only if every open cover of $M$ contains a finite cover. $M$ is called totally bounded if and only if every for every $\varepsilon>0$ there exists a covering of $M$ with finitely many open balls of radius $\varepsilon . M$ is called precompact (or precompact) if and only if $\bar{M}$ is compact. It can be shown that a totally bounded metric $M$ is compact if and only if $M$ is complete. In particular, a subset of a complete metric space is totally bounded if and only if its closure is compact. A subset of a metric space is called relatively compact if and only if its closure is compact.

Definition 5.28. Let $X, Y$ be normed spaces. An operator $T \in L(X, Y)$ is called compact if for every bounded set $A \subseteq X$ the set $T(A)$ is relatively compact. The set of all compact operators from $X$ to $Y$ is denoted by $K(X, Y)$.
Remark 5.29. Sometimes compact operators are called completely continuous.
Remarks 5.30. (i) Every compact linear operator is bounded.
(ii) $T \in L(X, Y)$ is compact if and only if for every bounded sequence $\left(x_{n}\right)_{n \in \mathbb{N}}$ the sequence $\left(T x_{n}\right)_{n \in \mathbb{N}}$ contains a convergent subsequence.
(iii) $T \in L(X, Y)$ is compact if and only if $T\left(B_{X}(0,1)\right)$ is relatively compact.
(iv) Let $T \in L(X, Y)$ with finite dimensional $\operatorname{rg}(T)$. The $T$ is compact.
(v) The identity map id $\in L(X)$ is compact if and only if $X$ is finite-dimensional.

Theorem 5.31. Let $X, Y$ be Banach spaces. Then $K(X, Y)$ is a closed subspace of $L(X, Y)$.

Proof. Obviously, $0 \in K(X, Y)$ and Remark 5.30 (ii) implies that the linear combination of compact operators is compact. Now let $\left(T_{n}\right)_{n \in \mathbb{N}} \subseteq K(X, Y)$ a Cauchy sequence. Since $L(X, Y)$ is complete, there exists a $T \in L(X, Y)$ such that $T_{n} \rightarrow T$ sequence. Since $L(X, Y)$ is complete, there exists a $T \in L(X, Y)$ such that $I_{n} \rightarrow T$.
We have to show $T \in K(X, Y)$. Take an arbitrary bounded sequence $\left(x_{n}\right)_{n \in \mathbb{N}} \subset X$ and choose $M \in \mathbb{R}$ such that $\left\|x_{n}\right\| \leq M, n \in \mathbb{N}$. Since $T_{1}$ is compact, there exists a subsequence $\left(x_{n}^{(1)}\right)$ such that $\left(T_{1} x_{n}^{(1)}\right)_{n \in \mathbb{N}}$ converges. Continuing like this, for every $k \geq 2$ we find a subsequence $\left(x_{n}^{(k)}\right)$ of $\left(x_{n}^{(k-1)}\right)$ such that $\left(T_{k} x_{n}^{(k)}\right)_{n \in \mathbb{N}}$ converges. Let $\left(y_{n}\right)_{n \in \mathbb{N}}=\left(x_{n}^{(n)}\right)_{n \in \mathbb{N}}$ the diagonal sequence. Then, for every $k \in \mathbb{N}$, the sequence $\left(T_{k} y_{n}\right)_{n \in \mathbb{N}}$ converges. Let $\varepsilon>0$. Choose $k \in \mathbb{N}$ such that $\left\|T-T_{k}\right\|<\frac{\varepsilon}{3 M}$ and $N \in \mathbb{N}$ such that $\left\|T_{k} x_{n}-T_{k} x_{m}\right\| \leq \frac{\varepsilon}{3}$ for $m, n \geq N$. Then, for all $m, n \geq N$,

$$
\begin{aligned}
\left\|T y_{n}-T y_{m}\right\| & \leq\left\|T y_{n}-T_{k} y_{n}\right\|+\left\|T_{k} y_{n}-T_{k} y_{m}\right\|+\left\|T_{k} y_{m}-T y_{m}\right\| \\
& \leq \frac{M \varepsilon}{3 M}+\frac{\varepsilon}{3}+\frac{M \varepsilon}{3 M}=\varepsilon .
\end{aligned}
$$

Hence $\left(T y_{n}\right)_{n \in \mathbb{N}}$ is Cauchy sequence in the Banach space $Y$, hence convergent. $\square$
Lemma 5.32. Let $X, Y, Z$ be Banach spaces, $S \in L(X, Y)$ and $T \in L(Y, Z)$. Then $T S$ is compact if at least one of the operators $S$ or $T$ is compact.

Proof. Let $\left(x_{n}\right)_{n \in \mathbb{N}}$ be a bounded sequence in $X$. If $S$ is compact, then there exists a subsequence $\left(x_{n_{k}}\right)_{k \in \mathbb{N}}$ such that $\left(S x_{n_{k}}\right)_{k \in \mathbb{N}}$ converges. By continuity of $T$, also $\left(T S x_{n_{k}}\right)_{k \in \mathbb{N}}$ converges.
Now assume that $T$ is compact. Since $S$ is bounded, $\left(S x_{n}\right)_{k \in \mathbb{N}}$ is bounded, hence there exists a subsequence $\left(x_{n_{k}}\right)_{k \in \mathbb{N}}$ such that $\left(T S x_{n_{k}}\right)_{k \in \mathbb{N}}$ converges.

Theorem 5.33 (Schauder). Let $X, Y$ be Banach space and $T \in L(X, Y)$. Then $T$ is compact if and only if $T^{\prime}$ is compact.

For the proof we use the Ascoli-Arzelá theorem.
Theorem 5.34 (Arzelá-Ascoli). Let $(M, d)$ be a compact metric space and $A \subseteq$ $C(M)$ a family of real or complex valued continuous functions on $M$ such that
(i) $A$ is bounded,
(ii) $A$ is closed,
(iii) $A$ is equicontinuous, that is,

$$
\forall \varepsilon>0 \quad \exists \delta>0 \quad \forall f \in A \quad d(x, y)<\delta \Longrightarrow \mid f(x)-f(y)<\varepsilon .
$$

Then $A$ is compact.
Proof. See, e. g., [Rud91] or [Yos95].
Proof of Theorem 5.33. First assume that $T$ is compact. Let $K_{X}(0,1):=\{x \in$ $X:\|x\|<1\}$ be the closed unit ball in $X$. By assumption $K:=\overline{T\left(K_{X}(0,1)\right)}$ is compact in $Y$ and bounded by $\|T\|$. Now let $\left(\varphi_{n}\right)_{n \in \mathbb{N}} \subseteq Y^{\prime}$ be a bounded sequence and $M \in \mathbb{R}$ such that $\left\|\varphi_{n}\right\| \leq M, n \in \mathbb{N}$. We define the functions

$$
f_{n}: K \rightarrow \mathbb{K}, \quad f_{n}(y):=\varphi_{n}(y)
$$

Then $\left(f_{n}\right)_{n \in \mathbb{N}}$ is bounded by $M$ and equicontinuous because $\left|f\left(y_{1}\right)-f\left(y_{2}\right)\right| \leq$ $C\left\|y_{1}-y_{2}\right\|, y_{1}, y_{2} \in K$. By the Ascoli-Arzelá, $\left(f_{n}\right)_{n \in \mathbb{N}}$ is compact, so there exists a convergent subsequence $\left(f_{n_{k}}\right)_{k \in \mathbb{N}}$. Then also $\left(T^{\prime} \varphi_{n_{k}}\right)_{k \in \mathbb{N}}$ converges because

$$
\begin{aligned}
\left\|T^{\prime} \varphi_{n_{k}}-T^{\prime} \varphi_{n_{m}}\right\| & =\sup \left\{\left\|\varphi_{n_{k}}(T x)-\varphi_{n_{m}}(T x)\right\|: x \in K_{X}(0,1)\right\} \\
& =\sup \left\{\left\|\varphi_{n_{k}}(y)-\varphi_{n_{m}}(y)\right\|: y \in K\right\}=\left\|f_{n_{k}}-f_{n_{m}}\right\| .
\end{aligned}
$$

Now assume that $T^{\prime}$ is compact. Then $T^{\prime \prime} \in L\left(X^{\prime \prime}, Y^{\prime \prime}\right)$ is compact. By Lemma 5.32 $T^{\prime \prime} \circ J_{X}$ is compact. Recall that $J_{Y} \circ T=T \circ J_{X}$ (Lemma 2.33), so $J_{Y} \circ T: X \rightarrow Y^{\prime \prime}$ is compact. Since $Y$ is closed in $Y^{\prime \prime}, T: X \rightarrow Y$ is compact.

Example 5.35. Let $k \in C\left([0,1]^{2}\right)$ and

$$
T_{k}: C([0,1]) \rightarrow C([0,1]), \quad\left(T_{k} x\right)(t)=\int_{0}^{1} k(s, t) x(s) \mathrm{d} s
$$

Then $T_{k}$ is compact.
Proof. Obviously $T_{k}$ is well-defined and bounded. Let $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq C([0,1])$ a bounded sequence with bound $M$. Hence $\left(T_{k} x_{n}\right)_{n \in \mathbb{N}}$ is bounded. To show that it is equicon tinuous fix $\varepsilon>0$. Since $k$ is uniformly continuous, there exists a $\delta>0$ such that $\left|k(s, t)-k\left(s^{\prime}, t^{\prime}\right)\right|<\varepsilon$ if $\left\|(s, t)-\left(s^{\prime}, t^{\prime}\right)\right\|<\delta$. Now for $t_{1}, t_{2} \in[0,1]$ with $\left|t_{1}-t_{2}\right|<\delta$ and $n \in \mathbb{N}$ we obtain

$$
\left|T_{k} x_{n}\left(t_{1}\right)-T_{k} x_{n}\left(t_{2}\right)\right| \leq \int_{0}^{1}\left|k\left(s, t_{1}\right)-k\left(s, t_{2}\right)\right|\left|x_{n}(s)\right| \mathrm{d} s<\varepsilon\left\|x_{n}\right\|_{\infty} \leq M \varepsilon .
$$

By the Ascoli-Arzelá theorem it follows that $\left(T_{k} x_{n}\right)_{n \in \mathbb{N}}$ is relatively compact, hence it contains a convergent subsequence.

Let $X$ be vector space and $T: X \rightarrow X$ a linear operator. Then obviously

$$
\begin{aligned}
& \{0\} \subseteq \operatorname{ker} T \subseteq \operatorname{ker} T^{2} \subseteq \operatorname{ker} T^{3} \subseteq \ldots \\
& X \supseteq \operatorname{rg} T \supseteq \operatorname{rg} T^{2} \supseteq \operatorname{rg} T^{3} \supseteq \ldots
\end{aligned}
$$

Lemma 5.36. Let $X$ a vector space and $T: X \rightarrow X$ a linear operator.
(i) Assume that $\operatorname{ker} T^{k+1}=\operatorname{ker} T^{k}$ for some $k \in \mathbb{N}_{0}$. Then $\operatorname{ker} T^{n}=\operatorname{ker} T^{k}$ for all integer $n \geq k$.
(ii) Assume that $\operatorname{rg} T^{k+1}=\operatorname{rg} T^{k}$ for some $k \in \mathbb{N}_{0}$. Then $\operatorname{rg} T^{n}=\operatorname{rg} T^{k}$ for all integer $n \geq k$.
Proof. We prove the lemma by induction. The case when $n=k$ is clear by assumption.
(i) Assume that $n>k$ and $\operatorname{ker} T^{n}=\operatorname{ker} T^{k}$. Then
$\operatorname{ker} T^{n+1}=\left\{x \in X: T^{n+1} x=0\right\}=\left\{x \in X: T x \in \operatorname{ker} T^{k}\right\}=\operatorname{ker} T^{k+1}=\operatorname{ker} T^{k}$.
(i) Assume that $n>k$ and $\operatorname{rg} T^{n}=\operatorname{rg} T^{k}$. Then

$$
\operatorname{rg} T^{n+1}=T\left(\operatorname{rg} T^{n}\right)=T\left(\operatorname{rg} T^{k}\right)=\operatorname{rg} T^{k+1}=\operatorname{rg} T^{k} .
$$

Definition 5.37. Let $X$ be a vector space and $T: X \rightarrow X$ a linear operator. We define
ascent of $T:=\alpha(T):= \begin{cases}\min \left\{k \in \mathbb{N}_{0}: \operatorname{ker} T^{k}=\operatorname{ker} T^{k+1}\right\}, & \text { if the minimum exists, } \\ \infty & \text { else }\end{cases}$
descent of $T:=\delta(T):= \begin{cases}\min \left\{k \in \mathbb{N}_{0}: \operatorname{rg} T^{k}=\operatorname{rg} T^{k+1}\right\}, & \text { if the minimum exists, } \\ \infty & \text { else. }\end{cases}$
Lemma 5.38. Let $X$ be a vector space and $T: X \rightarrow X$ a linear operator. If both the ascent $\alpha(T)$ and the descent $\delta(T)$ are finite, then $\alpha(T)=\delta(T)=: p$ and $X=\operatorname{rg}\left(T^{p}\right) \oplus \operatorname{ker}\left(T^{p}\right)$.

Proof. Let $p:=\alpha(T)$ and $q:=\delta(T)$. We divide the proof in several steps.
Step 1. $\operatorname{rg}\left(T^{p}\right) \cap \operatorname{ker}\left(T^{n}\right)=\{0\}$ for every $n \in \mathbb{N}_{0}$.
To see this, choose $x \in \operatorname{rg}\left(T^{p}\right) \cap \operatorname{ker}\left(T^{n}\right)$. Then there exists a $y \in X$ such that $x=T^{p} y$, so $0=T^{n} x=T^{p+n} y$. Hence $y \in \operatorname{ker} T^{p+n}=\operatorname{ker} T^{p}$ by Lemma 5.36 i . It follows that $x=T^{p} y=0$.
Step 2. $X=\operatorname{rg}\left(T^{n}\right)+\operatorname{ker}\left(T^{q}\right)$ for every $n \in \mathbb{N}_{0}$.
For the proof fix $x \in X$. Then $T^{q} x \subseteq \operatorname{rg}\left(T^{q}\right)=\operatorname{rg}\left(T^{q+n}\right)$. Hence there exists $y \in X$ such that $T^{q} x=T^{q+n} y$. Then $T^{q}\left(x-T^{n} y\right)=0$, and therefore $x=T^{n} y+\left(x-T^{n} y\right) \in$ $\operatorname{rg}\left(T^{n}\right)+\operatorname{ker}\left(T^{q}\right)$.
Step 3. $\alpha(T) \leq \delta(T)=q$.
Let $x \in \operatorname{ker} T^{q+1}$. We have to show $x \in \operatorname{ker} T^{q}$. By step 2, with $n=p$, there exist $x_{1} \in \operatorname{rg}\left(T^{p}\right)$ and $x_{2} \in \operatorname{ker}\left(T^{q}\right)$ such that $x=x_{1}+x_{2}$. Hence $x_{1}=x-x_{2} \subseteq$ $\operatorname{ker}\left(T^{q+1}\right) \cap \operatorname{rg}\left(T^{p}\right)=\{0\}$ by step 1. Therefore $x=x_{2} \in \operatorname{ker}\left(T^{q}\right)$.
Step 4. $\delta(T) \leq \alpha(T)=p$.
By step 1 and step 2, we have that $X=\operatorname{rg}\left(T^{p}\right) \oplus \operatorname{ker}\left(T^{q}\right)$. Since $\operatorname{rg}\left(T^{p+1}\right) \cap$ $\operatorname{ker}\left(T^{q}\right) \subset \operatorname{rg}\left(T^{p}\right) \cap \operatorname{ker}\left(T^{q}\right)=\{0\}$, we also have $X=\operatorname{rg}\left(T^{q+1}\right) \oplus \operatorname{ker}\left(T^{q}\right)$, implying $\operatorname{rg} R\left(T^{p+1}\right)=\operatorname{rg}\left(T^{p}\right)$, hence $\delta \leq p$.
Theorem 5.39. Let $X$ be a Banach space, $T \in L(X)$ a compact operator and $\lambda \in \mathbb{C} \backslash\{0\}$.
(i) $\operatorname{ker}(\lambda-T)^{n}$ is finite dimensional for every $n \in \mathbb{N}_{0}$.
(ii) If $U \subseteq X$ is a closed subspace with $U \cap \operatorname{ker}(\lambda-T)^{n}=\{0\}$, then $(\lambda-T)(U)$ is closed and $\lambda-T: U \rightarrow \operatorname{rg}\left(\left.(\lambda-T)\right|_{U}\right.$ has a bounded inverse.

## (iii) $\operatorname{rg}(\lambda-T)^{n}$ is closed for every $n \in \mathbb{N}_{0}$.

Proof. Note that $(\lambda-T)^{n}=\lambda^{n}-\sum_{n=1}^{n}\binom{n}{k} \lambda^{n-k} T^{k}$ and the operator sum is compact. Hence it suffices to show the assertions for $n=1$.
(i) Observe that $\left.T\right|_{\operatorname{ker}(\lambda-T)}=\left.\lambda \operatorname{id}\right|_{\operatorname{ker}(\lambda-T)}$. Hence $\left.\lambda \operatorname{id}\right|_{\operatorname{ker}(\lambda-T)}$ is compact. By
Remark 5.30 (v) this is case if and only if $\operatorname{ker}(\lambda-T)$ is finite dimensional. Remark $5.30(\mathrm{v})$ this is case if and only if $\operatorname{ker}(\lambda-T)$ is finite dimensional.
(ii) Since $U \cap \operatorname{ker}(\lambda-T)=\{0\}$, the restriction $\left.(\lambda-T)\right|_{U}$ is invertible. We will show that its inverse is bounded. Assume $\left(\left.(\lambda-T)\right|_{U}\right)^{-1}$ is not bounded. Then there exists a sequence $\left(x_{n}\right)_{n \in \mathbb{N}}$ such that $\left\|x_{n}\right\|=1$ for all $n \in \mathbb{N}$ and $\lim _{n \rightarrow \infty}(\lambda-T) x_{n}=0$. Since $T$ is compact, there exists a convergent subsequence $\left(T x_{n_{k}}\right)_{k \in \mathbb{N}}$. Hence

$$
\lambda x_{n_{k}}=T x_{n_{k}}+\underbrace{(\lambda-T) x_{n_{k}}}_{\rightarrow 0} \longrightarrow \lim _{n \rightarrow \infty} T x_{n_{k}}=: y .
$$

Note that $y \in U$ because $U$ is closed. Moreover, $y \in \operatorname{ker}(\lambda-T)$ because

$$
(\lambda-T) y=(\lambda-T) \lim _{n \rightarrow \infty} x_{n_{k}}=\lim _{n \rightarrow \infty}(\lambda-T) x_{n_{k}}=0
$$

Hence $y \in \operatorname{ker}(\lambda-T) \cap U=\{0\}$ in contradiction to $\|y\|=\lim _{n \rightarrow \infty}\left\|\lambda x_{n}\right\|=\lambda \neq 0$. Hence $\left(\left.(\lambda-T)\right|_{U}\right)^{-1}:\left.\operatorname{rg}(\lambda-T)\right|_{U} \rightarrow U$ is bounded. Since it is also closed, its domain $\left.\operatorname{rg}(\lambda-T)\right|_{U}$ must be closed.
(iii) By (i) we already know that $\operatorname{dim} \operatorname{ker}(\lambda-T)<\infty$. Then by the following lemma 5.40 there exists a closed subspace $U \subseteq X$ such that $X=\operatorname{ker}(\lambda-T) \oplus U$ Hence $\operatorname{rg}(\lambda-T)=\operatorname{rg}\left(\left.(\lambda-T)\right|_{U}\right)$ is closed by (ii)

Lemma 5.40. Let $X$ be a Banach space and $M \subseteq X$ a finite dimensional subspace. Then there exists a closed subspace $U$ of $X$ such that $X=M \oplus U$.

Proof. Let $x_{1}, \ldots, x_{n}$ a basis of $M$. Then there exist $\varphi_{1}, \ldots, \varphi_{n} \in M^{\prime}$ such that $\left\|\varphi_{k}\right\|=1$ and $\varphi_{k}\left(x_{j}\right) \delta_{k j}$ for all $j, k=1, \ldots, n$. By the Hahn-Banach theorem the $\varphi_{k}$ can be extended to functionals $\psi_{k} \in X^{\prime}$ with $\left\|\psi_{k}\right\|=1, k=1, \ldots, n$. Le $P: X \rightarrow X, P x=\sum_{j=1}^{n} \varphi_{j}(x) x$. Obviously $P=P^{2}$, hence $P$ is a projection. Note that $M=P(X)$. Hence $X=\operatorname{rg}(P) \oplus \operatorname{ker} P=M \oplus \operatorname{ker} P$.

Theorem 5.41. Let $X$ be a Banach space, $T \in L(X)$ a compact operator and $\lambda \in \mathbb{C} \backslash\{0\}$. Then $\alpha(\lambda-T)=\delta(\lambda-T)=p<\infty$ and $X=\operatorname{ker}(\lambda-T)^{p} \oplus \operatorname{rg}(\lambda-T)^{p}$.

The number $p=\alpha(\lambda-T)=\delta(\lambda-T)$ is called the Riesz index of $\lambda-T$.
Proof. By Lemma 5.38 it suffices to show that $\alpha(T)$ and $\delta(T)$ are finite.
Assume that $\alpha$ is not finite. Since in this case $\operatorname{ker}(\lambda-T) \subsetneq \operatorname{ker}(\lambda-T)^{2} \subsetneq \ldots$ we can find a sequence $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq X$ such that for all $n \in \mathbb{N}$
$\left\|x_{n}\right\|=1, \quad x_{n} \in \operatorname{ker}(\lambda-T)^{n}, \quad$ and $\quad\left\|x_{n}-z\right\| \geq \frac{1}{2}$ for all $z \in \operatorname{ker}(\lambda-T)^{n-1}$.
The last condition can be satisfied by the Riesz lemma (Theorem 1.21) because $\operatorname{ker}(\lambda-T)^{n}$ is closed for all $n \in \mathbb{N}$. Then for all $1 \leq m<n$

$$
\left\|T x_{n}-T x_{m}\right\|=\|\lambda x_{n} \underbrace{-\lambda x_{m}-(\lambda-T) x_{n}+(\lambda-T) x_{m}}_{\in \operatorname{ker}(\lambda-T)^{n-1}}\| \geq \frac{1}{2} .
$$

Therefore $\left(T x_{n}\right)_{n \in \mathbb{N}}$ does not contain a convergent subsequence in contradiction to $T$ being compact.

Assume that $\delta$ is not finite. Since in this case $\operatorname{rg}(\lambda-T) \supsetneq \operatorname{rg}(\lambda-T)^{2} \supsetneq \ldots$ we can choose a sequence $\left(x_{n}\right)_{n \in \mathbb{N}} \subseteq X$ such that for all $n \in \mathbb{N}$

$$
\left\|x_{n}\right\|=1, \quad x_{n} \in \operatorname{rg}(\lambda-T)^{n}, \quad \text { and } \quad\left\|x_{n}-z\right\| \geq \frac{1}{2} \text { for all } z \in \operatorname{rg}(\lambda-T)^{n+1}
$$

The last condition can be satisfied by the Riesz lemma because $\operatorname{rg}(\lambda-T)^{n}$ is closed for all $n \in \mathbb{N}$ by Theorem 5.39. Then for all $1 \leq m<n$

$$
\left\|T x_{n}-T x_{m}\right\|=\|\lambda x_{n} \underbrace{-\lambda x_{m}-(\lambda-T) x_{n}+(\lambda-T) x_{m}}_{\epsilon \operatorname{rg}(\lambda-T)^{n+1}}\| \geq \frac{1}{2} .
$$

Therefore $\left(T x_{n}\right)_{n \in \mathbb{N}}$ does not contain a convergent subsequence in contradiction to $T$ being compact.

Theorem 5.42 (Spectrum of a compact operator). Let $X$ be a Banach space. For a compact operator $T \in L(X)$ the following holds.
(i) If $\lambda \in \mathbb{C} \backslash\{0\}$, then $\lambda$ either belongs to $\rho(T)$ or it is an eigenvalue of $T$, that is $\mathbb{C} \backslash\{0\} \subseteq \rho(T) \cup \sigma_{p}(T)$.
(ii) The spectrum of $T$ is at most countable and 0 is the only possible accumulation point.
(iii) If $\lambda \in \sigma(T) \backslash\{0\}$, then the dimension of the algebraic eigenspace $\mathcal{A}_{\lambda}(T)$ is finite and $\mathcal{A}_{\lambda}(T)=\operatorname{ker}(\lambda-T)^{p}$ where $p$ is the Riesz index of $\lambda-T$.
(iv) $X=\operatorname{ker}(\lambda-T)^{p} \oplus \operatorname{rg}(\lambda-T)^{p}$ for $\lambda \in \sigma(T) \backslash\{0\}$ where $p$ is the Riesz index of $\lambda-T$ and $\operatorname{ker}(\lambda-T)^{p}$ and $\operatorname{rg}(\lambda-T)^{p}$ are $T$-invariant.
(v) $\sigma_{p}(T) \backslash\{0\}=\sigma_{p}\left(T^{\prime}\right) \backslash\{0\}$ and $\sigma(T)=\sigma\left(T^{\prime}\right)$. If H is a Hilbert space then $\sigma_{p}(T) \backslash\{0\}=\left\{\lambda \in \mathbb{C}: \bar{\lambda} \in \sigma_{p}\left(T^{*}\right)\right\} \backslash\{0\}=\overline{\sigma_{p}\left(T^{*}\right)} \backslash\{0\}$, where the bar denotes complex conjugation, and $\sigma(T)=\left\{\lambda \in \mathbb{C}: \bar{\lambda} \in \sigma\left(T^{*}\right)\right\}=\overline{\sigma\left(T^{*}\right)}$

Proof. (i) Let $\lambda \in \mathbb{C} \backslash\{0\}$. By Theorem 5.41 the Riesz index $p$ of $\lambda-T$ is finite. If $p=0$, then $X=\operatorname{rg}(\lambda-T)$ by the proof of Lemma 5.38 (step 2), hence $\lambda \in \rho(T)$. If $p \neq 0$, then $\lambda \in \sigma_{\mathrm{p}}(T)$.
(ii) It suffices to show that for every $\varepsilon>0$ the set $\{\lambda \in \sigma(T):|\lambda|>\varepsilon\}$ is finite. Assume there exists an $\varepsilon>0$ such that the set is not finite. Then there exists a sequence $\left(\lambda_{n}\right)_{n \in \mathbb{N}}$ such that $\lambda_{n} \neq \lambda_{m}$ for $n \neq m$ and $\left|\lambda_{n}\right|>\varepsilon, n \in \mathbb{N}$. Since $\sigma(T) \backslash\{0\}$ consists of eigenvalues, we can choose eigenvectors $x_{n}$ of $T$ with eigenvalues $\lambda_{n}$. Note that the $x_{n}$ are linearly independent because $\lambda_{n} \neq \lambda_{m}$ for $n \neq m$. Le
$U_{n}:=\operatorname{span}\left\{x_{1}, \ldots, x_{n}\right\}$. Note that all $U_{n}$ are $T$-invariant, closed and that $U_{1}$ $U_{2} \subsetneq U_{3} \subsetneq \ldots$. Using the Riesz Lemma, we can choose a sequence $\left(y_{n}\right)_{n \in \mathbb{N}}$ such that for all $n \in \mathbb{N}$

$$
\left\|y_{n}\right\|=1, \quad y_{n} \in U_{n}, \quad \text { and } \quad\left\|y_{n}-z\right\| \geq \frac{1}{2} \text { for all } z \in U_{n-1} .
$$

Let $1 \leq m<n$. Note that $T y_{m} \in U_{m}$. Let $y_{n}=\sum_{j=1}^{n} \alpha_{j} x_{j}$ for some $\alpha_{j} \in \mathbb{C}$. Then

$$
\left(\lambda_{n}-T\right) y_{n}=\alpha_{n}\left(\lambda_{n}-T\right) x_{n}+\sum_{j=1}^{n} \alpha_{j}\left(T-\lambda_{n}\right) x_{j}=\sum_{j=1}^{n} \alpha_{j}\left(\lambda_{j}-\lambda_{n}\right) x_{j} \in U_{n-1}
$$ Hence

$$
\begin{equation*}
\left\|T y_{n}-T y_{m}\right\|=\|\lambda_{n} y_{n} \underbrace{-\left(\lambda_{n}-T\right) y_{n}-T y_{m}}_{C_{I}}\| \geq \frac{1}{2} . \tag{5.5}
\end{equation*}
$$

Therefore $\left(T x_{n}\right)_{n \in \mathbb{N}}$ does not contain a convergent which contradicts the assumption that $T$ is compact.
(iii) and (iv) follow from Theorem 5.42.
(v) By Schauder's theorem $T^{\prime}$ is compact (theorem 5.33) Hence for $\lambda \in \mathbb{C}$ it follows that

$$
\begin{aligned}
\lambda \in \rho(T) & \Longleftrightarrow \quad \operatorname{ker}(\lambda-T)=\{0\} \text { and } \operatorname{rg}(\lambda-T)=X \\
& \Longleftrightarrow{ }^{\circ} \operatorname{rg}\left(\lambda-T^{\prime}\right)=\{0\} \text { and }{ }^{\circ} \operatorname{ker}\left(\lambda-T^{\prime}\right)=X \\
& \Longleftrightarrow \operatorname{rg}\left(\lambda-T^{\prime}\right)=X^{\prime} \text { and } \operatorname{ker}\left(\lambda-T^{\prime}\right)=\{0\} \\
& \Longleftrightarrow \lambda \in \rho(T)
\end{aligned}
$$

Theorem 5.43 (Fredholm alternative; Riesz-Schauder theory). Let $X$ be a Banach space, $T \in L(X)$ a compact operator and $\lambda \in \mathbb{C} \backslash\{0\}$. Then exactly one of the following is true:
(i) For every $y \in X$ the equation $(\lambda-T) x=y$ has exactly one solution $x \in X$.
(ii) $(\lambda-T) x=0$ has a non-trivial solution $x \in X$.

Proof. (i) is equivalent to $\lambda \in \rho(T)$ and (ii) is equivalent to $\lambda \in \sigma_{\mathrm{p}}(T)$. Since $\lambda \neq 0$, the latter is equivalent to $\lambda \in \sigma(T)$. The assertion follows from Theorem 5.42. $\square$ A more precise formulation of the Fredholm alternative is the following.

Theorem 5.44. Let $X$ be a Banach space, $T \in L(X)$ a compact operator and $\lambda \in \mathbb{C} \backslash\{0\}$. For $x, y, \in X$ and $\varphi, \eta \in X^{\prime}$ consider the equations
(A) $(\lambda-T) x=y$,
(C) $\left(\lambda-T^{\prime}\right) \varphi=\eta$,
(B) $(\lambda-T) x=0$,
(D) $\left(\lambda-T^{\prime}\right) \varphi=0$.

Then
(i) For $y \in X$ the following is equivalent:
(a) (A) has a solution $x$.
(b) $\varphi(y)=0$ for every solution $\varphi$ of (D).
(ii) For $\eta \in X^{\prime}$ the following is equivalent:
(a) (C) has a solution $\varphi$.
(b) $\eta(x)=0$ for every solution $x$ of (B).
(iii) Fredholm alternative: Exactly one of the following holds:
(a) For all $y \in X$ and $\eta \in X^{\prime}$ the equations (A) and (C) have exactly one solution (in particular (B) and (D) have only the trivial solutions).
(b) (B) and (D) have non-trivial solutions. In this case $\operatorname{dim}(\operatorname{ker}(\lambda-T))=$ $\operatorname{dim}\left(\operatorname{ker}\left(\lambda-T^{\prime}\right)\right)>0$ and (A) and (C) have solutions if and only if

$$
\begin{array}{ll}
\varphi(y)=0 & \text { for all solutions } \varphi \text { of (D) } \\
\eta(x)=0 & \text { for all solutions } x \text { of (B). }
\end{array}
$$

Definition 5.45. Let $X, Y$ be Banach spaces. $T \in L(X)$ is called Fredholm operator if $\operatorname{rg}(T)$ is closed and $n(T):=\operatorname{dim}(\operatorname{ker} T)<\infty$ and $d(T):=\operatorname{codim}_{Y}(\operatorname{rg} T):=$ $\operatorname{dim}(Y / \operatorname{rg}(T))<\infty$. In this case, $\chi(T):=n(T)-d(T)$ is called the Fredholm index.

Proof of Theorem 5.44.
. .............

Now we return to the spectrum of compact operators.
Lemma 5.46. Let $H$ be Hilbert space, $\neq\{0\}$, and $T \in L(H)$ a selfadjoint compact operator. Then at least one the values $\|T\|$ or $-\|T\|$ is an eigenvalue of $T$. In particular, if $T \neq 0$, then $T$ has at least one eigenvalue distinct from 0 .

Proof. If $\|T\|=0$, the assertion is clear. Now assume that $\|T\| \neq 0$. Recall that $\|T\|=\sup \{|\langle T x, x\rangle|: x \in X,\|x\|=1\}$ (Theorem 4.45).
By Lemma 5.27 the numbers $m=\inf \{\langle T x, x\rangle: x \in X,\|x\|=1\}$ and $M=$ $\inf \{\langle T x, x\rangle: x \in X,\|x\|=1\}$ belong to the spectrum of $T$. Since $T$ is compact and $\|T\| \neq 0$, it follows that $\emptyset \neq\{ \pm\|T\|\} \cap \sigma(T)=\{ \pm\|T\|\} \cap \sigma_{\mathrm{p}}(T)$.

Theorem 5.47 (Spectral theorem for compact selfadjoint operators). Let $H$ be a Hilbert space and $T \in L(H)$ a compact selfadjoint operator.
(i) There exists an orthonormal system $\left(\mathrm{e}_{n}\right)_{n=1}^{N}$ of eigenvectors of $T$ with eigen values $\left(\lambda_{n}\right)_{n=1}^{N}$ where $N \in \mathbb{N} \cup\{\infty\}$ such that

$$
\begin{equation*}
T x=\sum_{n=1}^{N} \lambda_{n}\left\langle x, \mathrm{e}_{n}\right\rangle \mathrm{e}_{n}, \quad x \in H . \tag{5.6}
\end{equation*}
$$

The $\lambda_{n}$ can be chosen such that $\left|\lambda_{1}\right| \geq\left|\lambda_{2}\right| \geq \cdots>0$. The only possible accumulation point of the sequence $\left(\lambda_{n}\right)_{n \in \mathbb{N}}$ is 0 .
(ii) If $P_{0}$ is the orthogonal projection on $\operatorname{ker} T$, then

$$
\begin{equation*}
x=P_{0} x+\sum_{n=1}^{N}\left\langle x, \mathrm{e}_{n}\right\rangle \mathrm{e}_{n}, \quad x \in H . \tag{5.7}
\end{equation*}
$$

(iii) If $\lambda \in \rho(T), \lambda \neq 0$

$$
(\lambda-T)^{-1} x=\lambda^{-1} P_{0} x+\sum_{n=1}^{N} \frac{\left\langle x, \mathrm{e}_{n}\right\rangle}{\lambda_{n}-\lambda} \mathrm{e}_{n}, \quad x \in H .
$$

Proof. (i) Let $X_{1}=X$ and $T_{1}=T$. If $T \neq 0$, then there exists a $\lambda_{1} \in \sigma_{\mathrm{p}}\left(T_{1}\right)$ such that $\left|\lambda_{1}\right|=\left\|T_{1}\right\| \neq 0$. Let $B_{1}$ be an orthonormal basis of $\operatorname{ker}\left(\lambda_{1}-T_{1}\right)$. Note $\frac{\text { that } B_{1} \text { is finite because } T \text { is compact (Theorem 5.42). Let } X_{1}:=\operatorname{ker}\left(\lambda_{1}-T\right)^{\perp}=, ~=~}{\operatorname{rg}\left(\lambda_{1}-T\right)}-$ $\frac{\operatorname{rg}\left(\lambda_{1}-T\right)}{r \mid r g} \operatorname{rg}\left(\lambda_{1}-T\right)$. Here we used that $T$ is selfadjoint and consequently $\lambda \in \sigma_{\mathrm{p}}(T) \subseteq \mathbb{R}$. By Theorem 5.42, $X_{2}$ is $T_{1}$-invariant, hence $T_{2}:=T_{1} \mid X_{2} \in L\left(X_{2}\right)$. Obviously, $T_{2}$ is selfadjoint and compact. If $T_{2} \neq 0$, then there exists a $\lambda_{2} \in \sigma_{\mathrm{p}}\left(T_{2}\right)$ such that $\left|\lambda_{2}\right|=\left\|T_{2}\right\| \neq 0$. Let $B_{2}$ be an orthonormal basis of $\operatorname{ker}\left(\lambda_{2}-T_{2}\right)$. Note that $B_{1}$ is finite because $T$ is compact (Theorem 5.42). Hence $B_{1} \cup B_{2}$ is an orthonorma basis of $\operatorname{span}\left\{\operatorname{ker}\left(\lambda_{1}-T\right), \operatorname{ker}\left(\lambda_{2}-T\right)\right\}$. Let $X_{3}:=\operatorname{span}\left\{\operatorname{ker}\left(\lambda_{1}-T\right), \operatorname{ker}\left(\lambda_{2}-T\right)\right\}$ and $T_{3}:=\left.T_{2}\right|_{X_{3}}$. Continuing like this we obtain a sequence of Banach spaces $X_{n}$ and a sequence of compact selfadjoint operators $T_{n} \in L\left(X_{n}\right)$. Let $x \in X$. Define

$$
x_{n+1}=x-\sum_{\mathrm{e}_{n} \in B_{1} \cup \ldots B_{n}}\left\langle x, \mathrm{e}_{n}\right\rangle \mathrm{e}_{n} \in X_{n+1} .
$$

It follows that

$$
\left\|T x-T \sum_{\mathrm{e}_{n} \in B_{1} \cup \ldots B_{n}}\left\langle x, \mathrm{e}_{n}\right\rangle \mathrm{e}_{n}\right\|=\left\|T_{n+1} x_{n+1}\right\| \leq\left|\lambda_{n+1}\right|\|x\| \longrightarrow 0, \quad n \rightarrow \infty .
$$

This implies that

$$
T x=\sum_{n=1}^{N}\left\langle x, \mathrm{e}_{n}\right\rangle T \mathrm{e}_{n}=\sum_{n=1}^{N} \lambda_{n}\left\langle x, \mathrm{e}_{n}\right\rangle \mathrm{e}_{n} .
$$

(ii) Note that ...
(iii)

Corollary 5.48. Let $H$ be a Hilbert space and $T \in L(H)$ a compact selfadjoint operator. There exists a sequence $\left(P_{n}\right)_{n=1}^{N}$ of pairwise orthogonal projections with $N \in \mathbb{N} \cup\{\infty\}$ and a sequence $\left|\lambda_{1}\right| \geq\left|\lambda_{2}\right| \geq \ldots$ such that

$$
\begin{equation*}
T=\sum_{n=1}^{N} \lambda_{n} P_{n} \tag{5.8}
\end{equation*}
$$

where the series converges to $T$ in the operator norm. If $\left(\lambda_{n}\right)_{n}$ is an infinite sequence, then $\lim _{n \rightarrow \infty} \lambda_{n}=0$. The representation (5.8) is unique if the $\lambda_{n}$ are pairwise distinct.

Proof. If the series is a finite sum, the assertion is clear. Now assume that the series is an infinite. Note that for every $k \in \mathbb{N}$ the operator $\sum_{n=k}^{\infty} \lambda_{n} P_{n}$ is normal and that the norm of a normal operator is equal to maximum of the moduli of the elements of its spectrum (Theorem 5.19). Since $\left|\lambda_{k+1}\right| \rightarrow 0$ for $k \rightarrow \infty$ the claim follows from

$$
\left\|T-\sum_{n=1}^{k} \lambda_{n} P_{n}\right\|=\sup \left\{\left|\lambda_{n}\right|: n \geq k+1\right\}=\left|\lambda_{k+1}\right| .
$$

The representation (5.8) allows us to define the root of a positive compact selfadjoint operator.

Theorem 5.49. Let $H$ be a Hilbert space and $K \in L(H)$ a compact operator.
(i) $T$ is positive $\Longleftrightarrow$ all eigenvalues of $T$ are positive.
$T$ is strictly positive $\Longleftrightarrow$ all eigenvalues of $T$ are strictly positive.
(ii) If $T$ is positive and $k \in \mathbb{N}$ then there exists exactly one positive compact selfadjoint operator $R$ such that $R^{k}=T$

Note that the theorem does not imply that there cannot be non-compact operators $A \in L(H)$ such that $A^{2}=T$. In Corollary 5.60 we will show that every bounded positive selfadjoint operator has a unique positive root.

Proof of Theorem 5.49. Recall that a linear operator $T$ is positive if and only if $\langle T x, x\rangle \geq 0$ for all $x \in H$. Let $P_{0}, \lambda_{n}$ and $\mathrm{e}_{n}$ as in (5.7). Then (i) follows from

$$
\langle T x, x\rangle=\left\langle\sum_{n} \lambda_{n}\left\langle x, \mathrm{e}_{n}\right\rangle \mathrm{e}_{n}, P_{0} x+\sum_{n} \lambda_{n}\left\langle x, \mathrm{e}_{n}, \mathrm{e}\right\rangle_{n}\right\rangle=\sum_{n} \lambda_{n}\left|\left\langle x, \mathrm{e}_{n}\right\rangle\right|^{2} \geq 0 .
$$

For the proof of (ii) define $R=\sum_{n} \lambda_{n}^{1 / k}\left\langle\cdot, \mathrm{e}_{n}\right\rangle \mathrm{e}_{n}$. Obviously $R^{k}=T$. To show uniqueness, assume that there exists a compact selfadjoint positive linear operator
$S$ such that $S^{k}=T$. Since $S$ is compact, it has a representation $S=\sum_{n} \mu_{n} Q_{n}$ with pairwise orthogonal projections $Q_{n}$. By assumption

$$
T=S^{k}=\sum_{n} \mu_{n}^{k} Q_{n}
$$

Hence the $\mu_{n}$ are the $k$ th roots the eigenvalues $\lambda_{n}$ of $T$, so $S=R$.
Definition 5.50. Let $H$ be a Hilbert space and $T \in L(H)$ a positive selfadjoint compact operator. Then $|T|:=\left(T^{*} T\right)^{\frac{1}{2}}$. The non-zero eigenvalues $s_{n}$ of $|T|$ are the singular values of $T$.
Obviously $|T|$ and $\left|T^{*}\right|$ are positive selfadjoint compact operators.
Lemma 5.51. (i) $\||T| x\|=\|T x\|$ and $\left\|\left|T^{*}\right| y\right\|=\left\|T^{*} y\right\|$ and for $x \in H_{1}$ and $y \in H_{2}$.
(ii) $s$ is a singular value of $T$ if and only if $s^{2}$ is an eigenvalue of $T^{*} T$ and $T T^{*}$.

Proof. (i) For all $x \in H_{1}$

$$
\left.\||T| x\|^{2}=\langle | T|x,|T| x\rangle=\left.\langle | T\right|^{2} x, x\right\rangle=\left\langle T^{*} T x, x\right\rangle=\|T x\|^{2} .
$$

An analogous calculation shows $\left\|\left|T^{*}\right| y\right\|=\left\|T^{*} y\right\|$ and for $y \in H_{2}$.
(ii) follows from the uniqueness of the representation (5.8).

Note that $|T|$ can be defined more generally for positive selfadjoint operators on a Hilbert space $H$, see Definition 5.61.
A representation similar to (5.6) exists for arbitrary compact operators
Theorem 5.52. Let $H_{1}, H_{2}$ be Hilbert spaces and $T \in L\left(H_{1}, H_{2}\right)$ a compact operator.
(i) Let $s_{1} \geq s_{2} \geq \cdots>0$ be the singular values of $T$ and $\left(\varphi_{n}\right)_{n=1}^{N} \subseteq H_{1}$ and $\left(\psi_{n}\right)_{n=1}^{N} \subseteq H_{2}$ such that

$$
\begin{aligned}
T x & =\sum_{n=1}^{N} s_{n}\left\langle x, \varphi_{n}\right\rangle \psi_{n}, \\
& x \in H_{1}, \\
T^{*} y & =\sum_{n=1}^{N} s_{n}\left\langle y, \psi_{n}\right\rangle \varphi_{n},
\end{aligned} \quad y \in H_{2} .
$$

If there are infinitely many $s_{n}$, then $\lim _{n \rightarrow \infty} s_{n}=0$.
(ii) The non-zero eigenvalues of $|T|$ and $\left|T^{*}\right|$ coincide and are equal to the $s_{n}$ The $s_{n}^{2}$ are the eigenvalues of $T^{*} T$ and $T T^{*}$. Moreover, the $\psi_{n}=\frac{1}{s_{n}} T \varphi_{n}$ are eigenvectors of $T^{*}$.

Proof. (i) Let $\left(\varphi_{n}\right)_{n \in \mathbb{N}} \subseteq H_{1}$ a ONS such that, see Theorem 5.47,

$$
|T| x=\sum_{n=1}^{N} s_{n}\left\langle x, \varphi_{n}\right\rangle \varphi_{n}, \quad T^{*} T x=\sum_{n=1}^{N} s_{n}^{2}\left\langle x, \varphi_{n}\right\rangle \varphi_{n} .
$$

Let $\psi_{n}:=\frac{1}{x_{n}} T \varphi_{n}$. Then $\left(\psi_{n}\right)_{n \in \mathbb{N}}$ is an ONS in $H_{2}$ because

$$
\left\langle\psi_{n}, \psi_{m}\right\rangle=\frac{1}{s_{n}^{2}}\left\langle T \varphi_{n}, T \varphi_{m}\right\rangle=\frac{1}{s_{n}^{2}}\left\langle T^{*} T \varphi_{n}, \varphi_{m}\right\rangle=\frac{1}{s_{n}^{2}} s_{n}^{2} \delta_{n m}=\delta_{n m} .
$$

Moreover

$$
T T^{*} \psi_{n}=\frac{1}{s_{n}} T T^{*} T \varphi_{n}=\frac{s_{n}^{2}}{s_{n}} T \varphi_{n}=s_{n}^{2} \psi_{n}
$$

Hence $\sigma_{\mathrm{p}}\left(T^{*} T\right) \backslash\{0\}=\left\{s_{n}^{2}: 1 \leq n \leq N\right\} \subseteq \sigma_{\mathrm{p}}\left(T T^{*}\right) \backslash\{0\}$. Similarly the reverse inclusion can be shown, so that $\sigma_{\mathrm{p}}\left(T^{*} T\right) \backslash\{0\} \subseteq \sigma_{\mathrm{p}}\left(T T^{*}\right) \backslash\{0\}$.
(ii) ..

Theorem 5.53 (Min-Max-Principle). Let $H_{1}, H_{2}$ be Hilbert spaces, $K \in L\left(H_{1}, H_{2}\right)$ a compact operator with singular values $s_{1} \geq s_{2} \geq s_{3} \geq \ldots$ Then $s_{1}=\|K\|$ and for $n \geq 2$

$$
s_{n+1}=\inf _{x_{1}, \ldots x_{n} \in H_{1}} \sup \left\{\|K x\|: x \in H_{1}, x \perp \operatorname{span}\left\{x_{1}, \ldots, x_{n}\right\},\|x\|=1\right\} .
$$

Proof. ...

### 5.5 Hilbert-Schmidt operators

Definition 5.54. Let $H_{1}, H_{2}$ be Hilbert spaces and $K \in L\left(H_{1}, H_{2}\right) . K$ is called a Hilbert-Schmidt operator if and only if there exists an ONB $\left(\mathrm{e}_{\lambda}\right)_{\lambda \in \Lambda}$ of $H_{1}$ such that

$$
\sum_{\lambda \in \Lambda}\left\|K \mathrm{e}_{\lambda}\right\|^{2}<\infty
$$

The set of all Hilbert-Schmidt operators from $H_{1}$ to $H_{2}$ is denoted by $\operatorname{HS}\left(H_{1}, H_{2}\right)$.
Theorem 5.55. Let $H_{1}, H_{2}$ be Hilbert spaces.
(i) A operator $K \in L\left(H_{1}, H_{2}\right)$ is a Hilbert-Schmidt operator if and only if $K^{*}$ is a Hilbert-Schmidt operator. In this case:

$$
\sum_{\alpha \in A}\left\|K \mathrm{e}_{\alpha}\right\|^{2}=\sum_{\beta \in B}\left\|K \mathrm{e}_{\beta}\right\|^{2}=\sum_{\lambda \in \Lambda}\left\|K \mathrm{e}_{\lambda}\right\|^{2}<\infty
$$

for all ONBes $\left(\mathrm{e}_{\alpha}\right)_{\alpha \in A}$ of $H_{1}$ and $\left(\mathrm{e}_{\beta}\right)_{\beta \in B}$ of $H_{2}$.
(ii) Every Hilbert-Schmidt operator is compact.
(iii) Let $K \in L\left(H_{1}, H_{2}\right)$ be a compact operator with singular values $x_{1} \geq x_{2} \geq$ $s_{3} \geq \ldots$. Then $K$ is a Hilbert-Schmidt operator if and only if $K^{*}$ is a Hilbert Schmidt operator if and only if

$$
\sum_{n} s_{n}^{2}<\infty
$$

Theorem 5.55 (i) shows that for $K \in \operatorname{HS}\left(H_{1}, H_{2}\right)$ the Hilbert-Schmidt norm

$$
\|K\|_{\mathrm{H} S}:=\left(\sum_{\alpha \in A}\left\|K \mathrm{e}_{\alpha}\right\|^{2}\right)^{\frac{1}{2}} \quad \text { for an ONB } \quad\left(\mathrm{e}_{\alpha}\right)_{\alpha \in A} .
$$

is well-defined.

Proof of Theorem 5.55. (i) Let $K$ be a Hilbert-Schmidt operator and $\left(\mathrm{e}_{\lambda}\right)_{\lambda \in \Lambda}$ an ONB of $H_{1}$ such that $\sum_{\lambda \in \Lambda}\left\|K \mathrm{e}_{\lambda}\right\|^{2}<\infty$. For an arbritray ONB $\left(\psi_{\beta}\right)_{\beta \in B}$ of $H_{2}$ we find, using Parseval's equality (Theorem 4.31) First we show that $K^{*}$ is also a Hilbert-Schmidt operator.

$$
\begin{aligned}
\sum_{\beta \in B}\left\|K^{*} \psi_{\beta}\right\|^{2} & =\sum_{\beta \in B}\left\|\sum_{\lambda \in \Lambda}\left\langle K^{*} \psi_{\beta}, \mathrm{e}_{\lambda}\right\rangle \mathrm{e}_{\lambda}\right\|^{2}=\sum_{\lambda \in \Lambda} \sum_{\beta \in B}\left|\left\langle K^{*} \psi_{\beta}, \mathrm{e}_{\lambda}\right\rangle\right|^{2} \\
& =\sum_{\lambda \in \Lambda} \sum_{\beta \in B}\left|\left\langle\psi_{\beta}, K \mathrm{e}_{\lambda}\right\rangle\right|^{2}=\sum_{\lambda \in \Lambda}\left\|K \psi_{\lambda}\right\|^{2}<\infty .
\end{aligned}
$$

In particular, the Hilbert-Schmidt norm of $K^{*}$ does not depend on the chosen ONB of $H_{2}$. Applying the same proof to $K^{*}$, it follows that the Hilbert-Schmidt norm of $K=K^{* *}$ does not depend on the chosen ONB of $H_{1}$. For the proof of $\|K\| \leq\|K\|_{H S}$ we observe that every $x \in H_{1}$ with $\|x\|=1$ can be extended to a ONB of $H_{1}$. Hence

$$
\|K\|_{H S} \geq\|K x\| \geq \sup \left\{\|K y\|: y \in H_{1},\|y\|=1\right\}=\|K\|
$$

(ii) Let $\left(\mathrm{e}_{\lambda}\right)_{\lambda \in \Lambda}$ an ONS of $H_{1}$ and $\left(\mathrm{e}_{n}\right)_{n \in \mathbb{N}}$ a subset containing all $\mathrm{e}_{\lambda}$ with $K \mathrm{e}_{\lambda} \neq$ 0 (this family is at most countable by Lemma 4.27). For $n \in \mathbb{N}$ let $P_{n}$ be the orthogonal projection on $\left\{\mathrm{e}_{1}, \ldots, \mathrm{e}_{n}\right\}$. Note that all $P_{n}$ are compact because they have finite-dimensional range. Since $K$ is a Hilbert-Schmidt operator, we find that

$$
\left\|K-K P_{n}\right\|^{2}=\left\|K\left(\mathrm{id}-P_{n}\right)\right\|^{2} \leq\left\|K\left(\mathrm{id}-P_{n}\right)\right\|_{\mathrm{H} S}^{2}=\sum_{m=n+1}^{\infty}\left\|K \mathrm{e}_{n}\right\|^{2} \longrightarrow \infty,
$$

in particular $K$ is compact because it is the norm limit of compact operators.
(iii) Assume that $K$ is compact. By Theorem 5.52 we can choose ONSs $\left(\varphi_{n}\right)_{\lambda \in \mathbb{N}}$ of $H_{1}$ and $\left(\psi_{n}\right)_{\lambda \in \mathbb{N}}$ of $H_{2}$ such that $K x=\sum_{n \in \mathbb{N}} s_{n}\left\langle x, \varphi_{n}\right\rangle \psi_{n}$ where $s_{1} \geq s_{2} \geq \cdots \geq 0$ are the singular values of $K$.
If $K$ is a Hilbert-Schmidt operator, then

$$
\sum_{n=1}^{N} s_{n}^{2}=\sum_{n=1}^{N}\left\|K \varphi_{n}\right\|^{2} \leq\|K\|_{\text {HS }}^{2}<\infty .
$$

Now assume that $\sum_{n=1}^{N} s_{n}^{2}<\infty$ and choose an arbitrary ONB of $H_{1}$ containing $\left(\varphi_{n}\right)_{n \in \mathbb{N}}$. It follows that

$$
\sum_{\lambda \in \Lambda}\left\|K \varphi_{\lambda}\right\|^{2}=\sum_{n=1}^{N}\left\|K \varphi_{n}\right\|^{2} \leq\|K\|_{\text {HS }}^{2}=\sum_{n=1}^{N} s_{n}^{2}<\infty
$$

implying that $K$ is a Hilbert-Schmidt operator.
Lemma 5.56. The finite-rank operators are dense in the Hilbert-Schmidt operators.
Proof. Let $H$ be a Hilbert space and $S \in \mathrm{H} S(H)$. In particular, $S$ is compact and there exist ONBs $\left(\varphi_{n}\right)_{n \in \mathbb{N}}$ and $\left(\psi_{n}\right)_{n \in \mathbb{N}}$ such that $S=\sum_{n=1}^{N} s_{n}\left\langle\cdot, \varphi_{n}\right\rangle \psi_{n}$. For $M \in \mathbb{N}$ let us define $S_{M}=\sum_{n=1}^{M} s_{n}\left\langle\cdot, \varphi_{n}\right\rangle \psi_{n}$. Then $\left\|S-S_{M}\right\|^{2} \leq\left\|S-S_{M}\right\|_{\mathrm{H} S}^{2}=$ $\sum_{n=M+1}^{N} s_{n}^{2} \rightarrow 0$ for $M \rightarrow \infty$,

An important class of examples is given in the following theorem
Theorem 5.57. Let $H=L_{2}(0,1)$ and $T \in L(H)$. Then the following is equivalent:
(i) $T$ is a Hilbert-Schmidt operator.
(ii) There exists a $k \in L_{2}(0,1)^{2}$ such that

$$
(T x)(t)=\int_{0}^{1} k(s, t) x(s) \mathrm{d} s .
$$

In this case we write $T_{k}$ for $T$
If one of the equivalent conditions holds, then

$$
\|T\|=\left(\int_{0}^{1} \int_{0}^{1}|k(s, t)|^{2} \mathrm{~d} s . \mathrm{d} t\right)^{2}=\|k\|_{L_{2}(0,1)^{2}}
$$

Proof. (ii) $\Longrightarrow$ (i) Let $\left(\mathrm{e}_{n}\right)_{n}$ be an ONB of $L_{2}(0,1)$. Then also $\left(\overline{\mathrm{e}_{n}}\right)_{n}$ is an ONB of $L_{2}(0,1)$ (where $\overline{\mathrm{e}_{n}}$ denotes the to $\mathrm{e}_{n}$ complex conjugated function) and we find

$$
\begin{align*}
\sum_{n=1}^{\infty}\left\|T \mathrm{e}_{n}\right\|^{2} & =\sum_{n=1}^{\infty} \int_{0}^{1}\left|\int_{0}^{1} k(s, t) \mathrm{e}_{n}(s) \mathrm{d} s\right|^{2} \mathrm{~d} t=\sum_{n=1}^{\infty} \int_{0}^{1}\left|\left\langle k(\cdot, t), \overline{\mathrm{e}_{n}}\right\rangle\right|^{2} \mathrm{~d} t \\
& =\int_{0}^{1} \sum_{n=1}^{\infty}\left|\left\langle k(\cdot, t), \overline{\mathrm{e}_{n}}\right\rangle\right|^{2} \mathrm{~d} t  \tag{5.9}\\
& =\int_{0}^{1}\|k(\cdot, t)\|^{2} \mathrm{~d} t  \tag{5.10}\\
& =\int_{0}^{1} \int_{0}^{1}|k(s, t)|^{2} \mathrm{~d} s \mathrm{~d} t=\|k\|_{L_{2}(0,1)^{2}}
\end{align*}
$$

In (5.9) we have used the monotone convergence theorem to exchange the sum and the integral (Theorem ??) and in (5.10) we used Parseval's equality (Theorem 4.31). It follows that $T$ is a Hilbert-Schmidt operator and that $\|T\|_{H S}=\|k\|_{L_{2}(0,1)^{2}}$.
(i) $\Longrightarrow$ (ii) By the proof we have an isometry

$$
\Psi: L_{2}(0,1)^{2} \rightarrow \mathrm{H} S\left(L_{2}(0,1)\right), \quad \Psi k=T_{k} .
$$

We will show that the range of $\Psi$ is dense in $\mathrm{H} S(H)$. By Lemma 5.56 it suffices to show that $\operatorname{rg}(\Psi)$ contains the finite-rank operators. Let $T$ be of finite rank. Then $T$ is of the form $T=\sum_{n=1}^{n_{0}}\left\langle\cdot, x_{n}\right\rangle y_{n}$ so that for every $f \in H$
$T f(t)=\sum_{n=1}^{n_{0}}\left\langle f, x_{n}\right\rangle y_{n}(t)=\sum_{n=1}^{n_{0}} \int_{0}^{1} f(s) x_{n}(s) y_{n}(t) \mathrm{d} s=\int_{0}^{1}\left(\sum_{n=1}^{n_{0}} x_{n}(s) y_{n}(t)\right) f(s) \mathrm{d} s$. This shows that $T \in \operatorname{rg} \Psi$. Fix $S \in \mathrm{H} S(H)$ and choose a sequence $\left(S_{n}\right)_{n \in \mathbb{N}}$ in the range of $\Psi$. Since $\Psi_{n}$ is an isometry, it follows that $\left(\Psi^{-1} S_{n}\right)_{n \in \mathbb{N}}$ is Cauchy sequence in $H$, hence its limit exists. Using the continuity of $\Psi$ we find

$$
S=\lim _{n \rightarrow \infty} S_{n}=\lim _{n \rightarrow \infty} \Psi \Psi^{-1} S_{n}=\Psi\left(\lim _{n \rightarrow \infty} \Psi^{-1} S_{n}\right) \in \operatorname{rg}(\Psi)
$$

Theorem 5.58. Let $H_{1}, H_{2}$ be Hilbert spaces
(i) $\left(\mathrm{H} S\left(H_{1}, H_{2}\right),\|\cdot\|_{\mathrm{HS}}\right)$ is a normed spaces. The norm is induced by the inner product

$$
\langle S, T\rangle_{\mathrm{H} S}=\sum_{\alpha}\left\langle S \mathrm{e}_{\alpha}, T \mathrm{e}_{\alpha}\right\rangle, \quad S, T \in \mathrm{H} S\left(H_{1}, H_{2}\right),
$$

for an arbitrary $O N B\left(\mathrm{e}_{\alpha}\right)_{\alpha \in A}$ of $H_{1}$.
(ii) Let $T \in \operatorname{HS}\left(H_{1}, H_{2}\right)$ and $A$ a bounded linear operator between appropriate Hilbert spaces. Then AT and TA are Hilbert-Schmidt operators and

$$
\|A T\|_{\mathrm{H} S} \leq\|A\|\|T\|_{\mathrm{H} S}, \quad\|T A\|_{\mathrm{H} S} \leq\|A\|\|T\|_{\mathrm{H} S}
$$

(iii) $\mathrm{H} S(H)$ is a two-sided ideal in $L(H)$.

Proof. Note that $(a+b)^{2}=a^{2}+b^{2}+2 a b=a^{2}+b^{2}-(a-b)^{2}+a^{2}+b^{2} \leq 2\left(a^{2}+b^{2}\right)$ for $a, b \in \mathbb{R}$.
(i) Let $S, T \in \operatorname{H} S\left(H_{1}, H_{2}\right)$ and $\lambda \in \mathbb{C}$. Then obviously $\lambda S \in \mathrm{H} S\left(H_{1}, H_{2}\right)$. To show that $S+T \in \operatorname{HS}\left(H_{1}, H_{2}\right)$ fix an ONS $\left(\mathrm{e}_{\lambda}\right)_{\lambda \in \Lambda}$ of $H_{1}$. Using the above remark is follows that

$$
\sum_{\lambda \in \Lambda}\left\|(S+T) \mathrm{e}_{\lambda}\right\|^{2} \leq \sum_{\lambda \in \Lambda}\left(\left\|S \mathrm{e}_{\lambda}\right\|+\left\|T \mathrm{e}_{\lambda}\right\|\right)^{2} \leq 2 \sum_{\lambda \in \Lambda}\left\|S \mathrm{e}_{\lambda}\right\|^{2}+\left\|T \mathrm{e}_{\lambda}\right\|^{2}<\infty .
$$

It follows that $\langle\cdot, \cdot\rangle_{\mathrm{HS}}$ is well-defined. The properties of an inner product are clear In particular, $\|T\|_{\mathrm{H} S}=\langle T, T\rangle_{\mathrm{H} S}$ for $T \in \operatorname{HS}\left(H_{1}, H_{2}\right)$.
(ii) Note that

$$
\sum_{\lambda \in \Lambda}\left\|A T \mathrm{e}_{\lambda}\right\|^{2} \leq\|A\|^{2} \sum_{\lambda \in \Lambda}\left\|T \mathrm{e}_{\lambda}\right\|^{2}=\|A\|^{2}\|T\|_{\mathrm{HS}}^{2},
$$

so $A T$ is a Hilbert-Schmidt operator. It follows that $T A=\left(A^{*} T^{*}\right)^{*}$ is also a Hilbert-Schmidt operator with norm $\|T A\|_{\text {HS }}=\left\|\left(A^{*} T^{*}\right)^{*}\right\|_{\text {HS }}=\left\|A^{*} T^{*}\right\|_{\text {HS }} \leq$ $\left\|A^{*}\right\|\left\|T^{*}\right\|_{\mathrm{H} S} \leq=\|A\|\|T\|_{\mathrm{H} S}$.
(iii) is a consequence of (i) and (ii).

### 5.6 Polar decomposition

Theorem 5.59. Let $H$ be a Hilbert space and $T \in L(H)$ a selfadjoint operator with $T \geq 0$. Then there exists exactly one $R \in L(H)$ such that $R \geq 0 R^{2}=T$.
In addition, if $S \in L(H)$ commutes with $T$, then $S$ commutes with $R$.
the operator $R$ is called the root of $T$ and is denoted by $\sqrt{T}$.
Proof. Without restriction we can assume $\|T\| \leq 1$, hence $0 \leq T \leq \mathrm{id}$. Now assume that a solution $R \in \mathrm{~L}(H)$ of $R^{2}=T$ exists. Let $A:=\mathrm{id}-T$ and $X:=\mathrm{id}-R$. Note that

$$
\text { id }-A=T=R^{2}=(1-X)^{2}=\text { id }-2 X+X^{2} .
$$

Note that $0 \leq R \leq$ id if and only if $0 \leq X \leq i d$. Hence $R$ is a non-negative solution of $R^{2}=T$ if and only if $X$ is a non-negative solution of

$$
\begin{equation*}
X=\frac{1}{2}\left(A+X^{2}\right) . \tag{5.11}
\end{equation*}
$$

Step 1. Construction of a solution of (5.11)
We define

$$
X_{0}:=\mathrm{id}, \quad X_{n}:=\frac{1}{2}\left(A+X_{n-1}^{2}\right), \quad n \in \mathbb{N} .
$$

Note that every $X_{n}$ is a polynomial in $A$ with positive coefficients and that $X_{n} X_{m}=$ $X_{m} X_{n}$ for all $n, m \in \mathbb{N}$. Since $A$ is positive, this implies that all $X_{n}$ are positive. We will show the following properties of the sequence $\left(X_{n}\right)_{n \in \mathbb{N}}$ by induction.
(i) $X_{n}-X_{n-1}$ is a polynomial in $A$ with positive coefficients, so that in particular $X_{n}-X_{n-1} \geq 0$.
(ii) $\left\|X_{n}\right\| \leq 1$.

All assertions are clear in the case $n=0$ (with $X_{-1}:=0$ ). Now assume that the assertions are true for some $n \in \mathbb{N}$. Note that

$$
\begin{aligned}
X_{n+1}-X_{n} & =\frac{1}{2}\left(A+X_{n}^{2}\right)-\frac{1}{2}\left(A+X_{n-1}^{2}\right)=\frac{1}{2}\left(X_{n}^{2}-X_{n-1}^{2}\right) \\
& =\frac{1}{2}\left(X_{n}-X_{n-1}\right)\left(X_{n}+X_{n-1}\right) .
\end{aligned}
$$

Since by induction hypothesis both terms in the second line are polynomials in $A$ with positive coefficients, (i) is proved for $n+1$. (ii) follows from $\left\|X_{n+1}\right\| \leq$ $\frac{1}{2}\left(\|A\|+\left\|X_{n+1}\right\|\right) \leq 1$.
Since $\left(X_{n}\right)_{n \in \mathbb{N}}$ is uniformely bounded monotonically increasing sequence in, there exists an $X \in L(H)$ such that $X=s-\lim _{n \rightarrow \infty} X_{n}$ and $\|X\| \leq \liminf _{n \rightarrow \infty}\left\|X_{n}\right\| \leq 1$ (see Exercise 4.25).
Now let $S \in L(H)$ with $S T=T S$. By definition of $A$, then also $S A=A S$ and $X_{n} S=X_{n} S$ for all $X_{n}$ since the $X_{n}$ are polynomials in $A$. For every $x \in H$ we therefore obtain

$$
0 \leq\|S X x-X S x\|=\lim _{n \rightarrow \infty}\left\|S X_{n} x-X_{n} S x\right\|=\lim _{n \rightarrow \infty}\left\|S X_{n} x-S X_{n} x\right\|=0
$$

Since all $X_{n}$ commute with $T$, it follows that $X_{n} X=X_{n} X$ for all $n \in \mathbb{N}$, so that for all $x \in X$
$\left\|\left(X_{n}^{2}-X^{2}\right) x\right\|=\left\|\left(X_{n}-X\right)\left(X_{n}+X\right) x\right\| \leq 2\left\|\left(X_{n}-X\right)^{2} x\right\| \longrightarrow 0, \quad n \rightarrow \infty$,
which shows that $X^{2}=s-\lim _{n \rightarrow \infty} X_{n}^{2}$. Therefore $X$ solves (5.11) because

$$
X=s-\lim _{n \rightarrow \infty} X_{n}=s-\lim _{n \rightarrow \infty} \frac{1}{2}\left(A+X_{n}^{2}\right)=\frac{1}{2}\left(A+s_{n \rightarrow \infty} \lim _{n \rightarrow \infty} X_{n}^{2}\right)=\frac{1}{2}\left(A+X^{2}\right) .
$$

Setting $R=$ id $-X$ we obtain a bounded selfadjoint solution of $R^{2}=T$ with $0 \leq$ $R \leq$ id.

Step 2. Uniqueness of the solution.
Let $R^{\prime} \in L(H)$ be solution of $R^{2}=T$ with $R^{\prime} \geq 0$. Then $R$ and $R^{\prime}$ commute because

$$
R^{\prime} A=R^{\prime}\left(R^{\prime}\right)^{2}=\left(R^{\prime}\right)^{2} R^{\prime}=A R^{\prime} .
$$

It follows that

$$
\left(R-R^{\prime}\right) R\left(R-R^{\prime}\right)+\left(R-R^{\prime}\right) R^{\prime}\left(R-R^{\prime}\right)=\left(R^{2}-R^{\prime 2}\right)\left(R-R^{\prime}\right)=0
$$

Since both operators on the left hand side are non-negative, it follows that both of them are 0 and therefore

$$
\left(R-R^{\prime}\right)^{4}=\left(R-R^{\prime}\right) R\left(R-R^{\prime}\right)-\left(R-R^{\prime}\right) R^{\prime}\left(R-R^{\prime}\right)=0 .
$$

Since $R-R^{\prime}$ is normal, it follows that $\left\|\left(R-R^{\prime}\right)\right\|^{4}=\left\|\left(R-R^{\prime}\right)\right\|^{4}$.
Corollary 5.60. If $S, T \in L(H)$ are positive and $S T=T S$, then also $S T$ is positive.

Proof. By Theorem 5.59 the root of $T$ exists, is selfadjoiunt and commutes with $S$ Hence for all $x \in H$

$$
\langle S T x, x\rangle=\langle S \sqrt{T} \sqrt{T} x, x\rangle=\langle\sqrt{T} S \sqrt{T} x, x\rangle=\langle S \sqrt{T} x, \sqrt{T} x\rangle \geq 0
$$

Definition 5.61. For $T \in L(H)$ we define $|T|:=\left(T^{*} T\right)^{\frac{1}{2}}$.
Definition 5.62. Let $H_{1}, H_{2}$ be Hilbert spaces and $U \in L\left(H_{1}, H_{2}\right) . U$ is called a partial isometry if $\left.U\right|_{(\operatorname{ker} U)^{\perp}}$ is an isometry. $\operatorname{ker} U \perp$ is called its initial space.

Note that $U$ is an partial isometry if and only if

$$
\left.U\right|_{(\operatorname{ker} U)^{\perp}}:(\operatorname{ker} U)^{\perp} \rightarrow \operatorname{rg}(U)
$$

is unitary.
Theorem 5.63 (Polar decomposition). Let $H_{1}, H_{2}$ be Hilbert spaces and $T \in$ $L\left(H_{1}, H_{2}\right)$. Then there exists a partial isometry $U \in L\left(H_{1}, H_{2}\right)$ such that $T=U|T|$ If in addition the initial space of $U$ is $(\operatorname{ker} T)^{\perp}$, then $U$ is unique.
Proof. Note that $\||T| x\|^{2}=\|T x\|^{2}$ for all $x \in H_{1}$ because
$\||T| x\|^{2}=\langle | T|x,|T| x\rangle=\left\langle\left(T^{*} T\right)^{\frac{1}{2}} x,\left(T^{*} T\right)^{\frac{1}{2}} x\right\rangle=\left\langle T^{*} T x, x\right\rangle=\langle T x, T x\rangle=\|T x\|^{2}$.
We define

$$
U: \operatorname{rg}(|T|) \rightarrow \operatorname{rg}(T), \quad U(|T| x)=T x
$$

$U$ is well-defined because for $x, y \in H_{1}$ with $|T| x=|T| y$ it follows that $\|T x-T y\|=$ $\||||x-|T| y \|=0$ hence $T x=T y . U$ is and isometry because $\|T x\|=\||T| x\|$ for all $x \in H$ as shown above. In particular, $\|U\|=1$ and has a unique continuous extension to $\overline{\operatorname{rg}(|T|)} \rightarrow \overline{\operatorname{rg}(T)}$. Now we extend $U$ to $H_{1}$ by setting $U x=0$ for all $x \in \overline{\operatorname{rg}(|T|)}^{\perp}=\operatorname{ker}(|T|)=\operatorname{ker} T$.
